## HOUSE AMENDMENTS TO HOUSE BILL 2208

On page 1 of the printed bill, delete lines 5 through 29 and delete page 2 and insert: 1 2 "SECTION 1. ORS 414.577 is added to and made a part of ORS chapter 414. "SECTION 2. ORS 414.577 is amended to read: 3 "414.577. (1) As used in this section: 4 5 "(a) 'Local mental health authority' has the meaning given that term in ORS 430.630. 6 "(b) 'Local planning committee' has the meaning given that term in ORS 430.306. 7 "[(1)] (2) A coordinated care organization shall collaborate with local public health authorities, community mental health programs, local planning committees and hospitals located in areas 8 9 served by the coordinated care organization to conduct a community health assessment and adopt 10 a community health improvement plan, shared with and endorsed by the coordinated care organiza-11 tion, local public health authorities, community mental health programs, local planning com-12mittees and hospitals, to serve as a strategic population health and health care services plan for 13 the residents of the areas served by the coordinated care organization, local public health authori-14 ties, community mental health programs, local planning committees and hospitals. The com-15munity health improvement plan must include strategies for achieving shared priorities. 16"(3)(a) Local public health authorities, community mental health programs and coordi-17 nated care organizations shall include in the community health improvement plan any be-18 havioral health plans required by law or by the Oregon Health Authority, including: 19 "(A) Comprehensive local plans adopted by local mental health authorities under ORS 20 430.630 (9); and 21"(B) Comprehensive behavioral health plans developed by coordinated care organizations. "(b) The inclusion in the community health improvement plan of the behavioral health 22plans described in paragraph (a) of this subsection does not change the party that is re-2324sponsible for developing or implementing a behavioral health plan described in paragraph (a) 25of this subsection. 26"[(2)] (4) The coordinated care organization shall post the community health improvement plan 27to the coordinated care organization's website. 28"[(3)] (5) The [Oregon Health] authority [may] shall prescribe by rule requirements for com-29munity health improvement plans and provide guidance for aligning: 30 "(a) The timelines for the development of the community health assessments and community 31 health improvement plans by coordinated care organizations, local public health authorities, com-32munity mental health programs, local planning committees and hospitals; and 33 (b) The requirements of this section with other planning or reporting requirements that coordinated care organizations are subject to, including planning or reporting requirements 34 35 regarding:

- 1 "(A) Health inequities;
- 2 "(B) Social determinants of health;
- 3 "(C) Health technology;
- 4 "(D) Payment models;
- 5 "(E) Oral health integration;
- 6 "(F) Language access; and
- 7 "(G) Traditional health worker integration and utilization.
- 8 "SECTION 3. The amendments to ORS 414.577 by section 2 of this 2025 Act apply to

9 community health improvement plans adopted on or after the effective date of this 2025

- 10 Act.".
