## **HOUSE AMENDMENTS TO** HOUSE BILL 2210

On page 1 of the printed bill, line 2, delete "creating new provisions; amending ORS 430.637;". 1 2 Delete lines 5 through 27 and delete pages 2 through 4 and insert: "SECTION 1. (1) As used in this section, 'coordinated care organization' has the meaning 3 given that term in ORS 414.025. 4 5 "(2) The Task Force on Provider Credentialing is established. 6 "(3) The task force consists of 15 members appointed by the Governor as follows: "(a) Four representatives of coordinated care organizations, including at least two rep-7 resentatives of coordinated care organizations or the holding companies of coordinated care 8 9 organizations that have less than 100,000 members; 10 "(b) Three representatives of mental health treatment providers that contract with more 11 than one coordinated care organization; "(c) Three representatives of substance use disorder providers that contract with more 1213 than one coordinated care organization; 14 "(d) Three representatives of other health care providers or entities, including dental 15care organizations or hospitals, that contract with more than one coordinated care organ-16 ization; 17 "(e) One representative of the Oregon Health Authority who is responsible for updating 18 the database described in ORS 430.637; and "(f) One representative of the authority who is responsible for providing training and 19 20 education to providers and coordinated care organizations about the database described in ORS 430.637. 21"(4) The task force shall develop recommendations for: 22"(a) Expanding the database described in ORS 430.637 to include other types of providers; 2324"(b) Functionally changing the database to make it usable by both coordinated care or-25ganizations and providers; 26"(c) The types of audit or other compliance materials that should be included in the da-27tabase; and 28"(d) Requiring the authority to engage with coordinated care organizations and providers to ensure that the database content and functionality remain up-to-date and that the data-29base is accessible and meets the needs of the Oregon Integrated and Coordinated Health Care 30 31 Delivery System established by ORS 414.570. 32"(5) A majority of the members of the task force constitutes a quorum for the transaction of business. 33 (6) Official action by the task force requires the approval of a majority of the members 34of the task force.

1 "(7) The task force shall elect one of its members to serve as chairperson.

2 "(8) If there is a vacancy for any cause, the Governor shall make an appointment to be-3 come immediately effective.

4 "(9) The task force shall meet at times and places specified by the call of the chairperson
5 or of a majority of the members of the task force.

"(10) The task force may adopt rules necessary for the operation of the task force.

"(11)(a) The task force shall submit an initial report in the manner provided in ORS
192.245 to the interim committees of the Legislative Assembly related to health no later than
December 31, 2025.

"(b) The task force shall submit subsequent reports no later than February 1 of each
year, beginning in 2026.

12 "(12) The authority shall provide staff support to the task force.

"(13) Members of the task force are not entitled to compensation or reimbursement for
 expenses and serve as volunteers on the task force.

15 "(14) All agencies of state government, as defined in ORS 174.111, are directed to assist 16 the task force in the performance of the duties of the task force and, to the extent permitted 17 by laws relating to confidentiality, to furnish information and advice the members of the task 18 force consider necessary to perform their duties.

19 "SECTION 2. Section 1 of this 2025 Act is repealed on January 2, 2029.

20 "SECTION 3. This 2025 Act being necessary for the immediate preservation of the public 21 peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect 22 on its passage.".
