

House Bill 2435

Sponsored by Representative YUNKER; Representatives BOICE, WRIGHT, Senators NASH, SMITH DB (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Tells the SOS to publish a monthly report on voter data in each county. Specifies the data to be included in the report. (Flesch Readability Score: 66.4).

Requires the Secretary of State to publish a monthly statistical report on voter registrations for each county in this state. Specifies the statistical information to be included in the monthly report.

2 Relating to monthly statistical report on voter registrations.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Secretary of State shall publish each month on the website main-**
5 **tained by the secretary a statistical report on voter registrations for each county in this**
6 **state.**

7 **(2) The report published under subsection (1) of this section must include, for the pre-**
8 **ceding month:**

9 **(a) The number of registration cards, as defined in ORS 247.002, received;**

10 **(b) The number of registration cards rejected;**

11 **(c) The number of voter registration transactions as follows:**

12 **(A) New voter registrations;**

13 **(B) Address changes;**

14 **(C) Political party affiliation changes; and**

15 **(D) Name changes;**

16 **(d) The number of registration cancellations for the following reasons:**

17 **(A) Residential address changes outside of the county;**

18 **(B) Death; and**

19 **(C) Any other reason identified by the secretary in the report; and**

20 **(e) The number of political party affiliations, listed by political party, as of the end of the**
21 **reporting period, including:**

22 **(A) Active registrations;**

23 **(B) Inactive registrations; and**

24 **(C) Total number of active and inactive registrations.**

25 **(3) The secretary shall establish by rule the process by which each county clerk in this**
26 **state shall provide each month to the secretary the information required under subsection**
27 **(2) of this section to be published in the report required under subsection (1) of this section.**

28 **SECTION 2. (1) Section 1 of this 2025 Act becomes operative on July 1, 2026.**

29 **(2) The Secretary of State may take any action before the operative date specified in**
