

# House Bill 2444

Sponsored by Representatives YUNKER, DIEHL; Representatives BOICE, WRIGHT, Senators NASH, SMITH DB  
(Pre-session filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

**Digest:** The Act tells a person to show certain forms to register to vote. The Act ends the electronic voter registration system. The Act declares an emergency and becomes law when the Governor signs it. (Flesch Readability Score: 63.4).

Requires evidence of citizenship for persons registering to vote in this state. Specifies when registration of qualified person occurs. Repeals the electronic voter registration system.

Declares an emergency, effective on passage.

## A BILL FOR AN ACT

2 Relating to providing proof of United States citizenship when registering to vote; creating new  
3 provisions; amending ORS 247.012, 247.025, 247.171 and 260.993; repealing ORS 247.019; and de-  
4 claring an emergency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1. Section 2 of this 2025 Act is added to and made a part of ORS chapter 247.**

7 **SECTION 2. (1) A person who is registering to vote in accordance with ORS 247.012 (1)**  
8 **must provide evidence of the person's United States citizenship with the registration.**

9 **(2) For purposes of subsection (1) of this section, evidence of United States citizenship**  
10 **may include:**

11 **(a) Any form of identification issued in accordance with the requirements of the federal**  
12 **Real ID Act of 2005, 119 Stat. 231, that indicates the person is a United States citizen;**

13 **(b) A valid United States passport;**

14 **(c) A United States military identification card, together with a United States military**  
15 **record of service showing that the person's place of birth was in the United States;**

16 **(d) A valid government-issued photo identification card issued by a federal, state or tribal**  
17 **government showing that the person's place of birth was in the United States;**

18 **(e) A valid government-issued photo identification card issued by a federal, state or tribal**  
19 **government, other than an identification described in paragraphs (a) to (d) of this subsection,**  
20 **if also presented together with one or more of the following:**

21 **(A) A certified birth certificate, including any legal documentation proving that the**  
22 **person's legal name has changed since birth;**

23 **(B) An extract from a United States hospital record of birth created at the time of the**  
24 **applicant's birth that indicates that the applicant's place of birth was in the United States;**

25 **(C) A final adoption decree showing the person's name and that the person was born in**  
26 **the United States;**

27 **(D) A consular report of birth abroad for a citizen of the United States or a certification**  
28 **of the person's report of birth of a United States citizen issued by the United States Secre-**

2 **(E) A naturalization certificate or certificate of citizenship issued by the Secretary of**  
 3 **Homeland Security or any other document or method of proof of United States citizenship**  
 4 **issued by the federal government under the federal Immigration and Nationality Act (8**  
 5 **U.S.C. 1101 et seq.) (1952); or**

6 **(F) A United States Bureau of Indian Affairs card number, tribal treaty card number or**  
 7 **tribal enrollment number.**

8 **SECTION 3.** ORS 247.171 is amended to read:

9 247.171. (1) Except as provided in this subsection, the Secretary of State shall design, prepare  
 10 and distribute state voter registration cards. The Secretary of State shall also distribute federal  
 11 registration cards. Any person may apply in writing to the Secretary of State for permission to print,  
 12 copy or otherwise prepare and distribute the registration cards designed by the Secretary of State.  
 13 The secretary may revoke any permission granted under this subsection at any time. All registration  
 14 cards shall be distributed to the public without charge.

15 (2) The Secretary of State shall approve any voter registration application form developed for  
 16 use by any agency designated as a voter registration agency under ORS 247.208.

17 (3) Each voter registration card designed or approved by the Secretary of State shall describe

 11 person's registration card contains a signature, if the person's registration card is legible, accurate  
 12 and contains, at a minimum, the registrant's name, residence address and date of birth[.]; **and**

13 **(b) For a person registering to vote in this state, if the person's registration card is ac-**  
 14 **companied by evidence of United States citizenship.**

15 [(b)] **(4)** If the information **or evidence of United States citizenship** required under [paragraph  
 16 (a)(A) of this] subsection **(3) of this section** is missing [from the registration card] or the date of  
 17 birth is incomplete, or if the signature of a person described in [paragraph (a)(B) of this] subsection  
 18 **(3) of this section** has not been submitted, the county clerk shall attempt to obtain the missing or  
 19 incomplete information from all sources available to the county clerk, including but not limited to  
 20 current and previous addresses and phone numbers of the registrant. The county clerk may also  
 21 supply the registrant's date of birth from any previous registration of the registrant. If the missing  
 22 or incomplete information cannot be obtained from sources available to the county clerk, the county

1 an office or location described in ORS 247.012 not later than the time the office or location closes  
2 for business on the 21st day immediately preceding the election, but in no case later than midnight  
3 of the 21st day immediately preceding the election; **or**

4 (2) **Except as provided in ORS 247.012 (10)**, a person's registration card must be postmarked  
5 not later than the 21st day immediately preceding the election and be addressed to an office of any  
6 county clerk, the Office of the Secretary of State, an office of the Department of Transportation or  
7 any designated voter registration agency as described in ORS 247.208[; or].

8 *[(3) A person's registration card must be delivered electronically as described in ORS 247.019 not  
9 later than 11:59 p.m. of the 21st day immediately preceding the election.]*

10 **SECTION 9.** ORS 260.993 is amended to read:

11 260.993. (1) The penalty for violation of ORS 260.532 is limited to that provided in ORS 260.532  
12 (6) and (8).

13 (2) Violation of ORS 247.125 (1), 247.171 [(5)] **(6)**, 247.420 (2), 253.710, 260.402, 260.555, 260.558,  
14 260.575, 260.645 or 260.665 (2) or (3) involving any action described in ORS 260.665 (2)(d) to (f) or  
15 260.715 is a Class C felony.

16 (3) Violation of ORS 260.695 (5) is a Class A misdemeanor.

17 (4) Violation of ORS 247.171 [(6)] **(7)** is a Class C misdemeanor.

18 **SECTION 10.** (1) **Section 2 of this 2025 Act applies to persons who register to vote in this  
19 state on or after the operative date of section 2 of this 2025 Act.**

20 (2) **The amendments to ORS 247.171 by sections 3 and 4 of this 2025 Act apply to voter  
21 registration cards designed, prepared or distributed on or after the operative date of the  
22 amendments to ORS 247.171 by sections 3 and 4 of this 2025 Act and to persons who register  
23 to vote in this state on or after the operative date of the amendments to ORS 247.171 by  
24 sections 3 and 4 of this 2025 Act.**

25 (3) **The amendments to ORS 247.012 by sections 5 and 6 of this 2025 Act apply to voter  
26 registration cards received, delivered or completed on or after the operative date of the  
27 amendments to ORS 247.012 by sections 5 and 6 of this 2025 Act.**

28 **SECTION 11.** **This 2025 Act being necessary for the immediate preservation of the public  
29 peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect  
30 on its passage.**
