House Bill 2513

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of House Interim Committee on Education for ACT Education Corp)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Allows ODE to contract with a benefit company to give tests. (Flesch Readability Score: 64.9).

Allows the Department of Education to enter into a contract with a benefit company to administer a nationally normed assessment to all students in grade 10 who are enrolled in a public school. Declares an emergency, effective on passage.

A BILL FOR AN ACT

Relating to contracts to administer a nationally normed assessment; amending ORS 329.488; and
 declaring an emergency.

4 Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 329.488 is amended to read:

6 329.488. (1) The Department of Education shall contract with a nonprofit entity or a benefit

7 company that is incorporated, organized, formed or created under ORS 60.754 to administer

8 a nationally normed assessment, in collaboration with the department, to all students in grade 10

9 who are enrolled in a public school. The purpose of the assessment is to predict the success of stu-10 dents on, and provide practice for students taking, college entrance exams.

(2) The department shall base the selection of the contractor under subsection (1) of this sectionon all of the following criteria:

(a) The contractor must be able to provide to the department statewide data containing the re-sults of the assessment;

15 (b) The contractor shall provide an assessment that:

16 (A) Identifies students with high potential to excel in advanced placement (AP) or other honors

17 courses based on a research-based correlation of scores on the grade 10 assessment to advanced 18 placement examinations;

(B) Examines students in mathematics, reading and writing; and

20 (C) Provides results that can be used by Oregon's higher education institutions to recruit stu-21 dents to attend college;

(c) The contractor must be able to supply schools with an item-by-item analysis of student per formance on the assessment; and

(d) The contractor must be able to make available to each student taking the assessment a freecareer assessment and online exploration of colleges and career opportunities.

(3)(a) In lieu of using the contractor selected by the department under subsection (1) of this
section, a school district may apply to the department for a waiver to allow the district to enter into
a contract with [a different nonprofit entity] an alternative contractor that is a nonprofit entity

This 2025 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect 2627on its passage. 28
