 - "(b) An ombudsman's office within the office of the State Court Administrator to receive and respond to comments and concerns regarding court experiences;
 - "(c) Rules and standards governing the resolution of concerns regarding judicial performance;
 - "(d) Individualized action plans applicable to judges, including mandatory plans of education, coaching or mentoring; and
 - "(e) Rules regarding the availability or confidentiality of information obtained or generated by the ombudsman's office.
 - "(2) Nothing in this section prevents the Chief Justice or any other individual from referring a matter to the Commission on Judicial Fitness and Disability.
 - "SECTION 6. Notwithstanding any other provision of law, the General Fund appropriation made to the Judicial Department by section 1 (1), chapter ____, Oregon Laws 2025 (Enrolled House Bill 5012), for the biennium beginning July 1, 2025, for judicial compensation, is increased by \$11,328,430 for implementation of the amendments to ORS 292.406, 292.411, 292.416 and 292.426 by sections 1 to 4 of this 2025 Act.
- 44 "SECTION 7. Notwithstanding any other provision of law, the General Fund appropriation made to the Judicial Department by section 1 (2), chapter ____, Oregon Laws 2025 (Enrolled
