SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act would change the law to reflect the use of PEO agreements to assign employer duties between a PEO and its clients for some or all of the client's workers. (Flesch Readability Score: 60.7).

[Digest: The Act would change the law to reflect the use of PEOs by businesses to coemploy workers. (Flesch Readability Score: 70.1).]

Changes the term "worker leasing company" to "professional employer organization" in statute to reflect the use of *[PEOs by businesses to coemploy workers]* **agreements under which professional employer organizations and client employers allocate employer responsibilities for some or all of the client employer's workers.**

Takes effect on the 91st day following adjournment sine die.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1. Section 2 of this 2025 Act is added to and made a part of ORS chapter 656.**

8 **SECTION 2. As used in ORS 656.018, 656.403, 656.702, 656.850, 656.855 and 737.270 and this**
9 **section:**

10 (1) "Client worker" means an individual who performs services for compensation for the
11 client of a professional employer organization.

12 (2) "Covered employee" means a client worker for whom a PEO has assumed employer
13 responsibilities under a PEO relationship.

14 (3) "Direct hire employee" means a client worker for whom a PEO has not assumed
15 employer responsibilities under a PEO relationship.

16 (4) "Multiple coordinated policy basis" means an arrangement under which a separate
17 policy for workers' compensation coverage is issued to or on behalf of each client or group
18 of affiliated clients of a PEO, which coordinates the premium obligations and stated policy
19 communications with respect to the policy.

20 (5) "PEO relationship" means an agreement between a PEO and a client employer under
21 which certain employer responsibilities for some or all of the client employer's workers are
22 allocated.

23 (6)(a) "Professional employer organization" or "PEO" means a person that enters into a

1 PEO relationship with a client employer.

2 (b) "Professional employer organization" or "PEO" does not mean a person that solely
3 provides workers to a client on a temporary basis or a person that provides payroll pro-
4 cessing or similar administrative services without assuming employer responsibilities for
5 client workers.

6 (7) "Temporary basis" means providing workers to a client:

7 (a) For special situations, including but not limited to employee absences, employee
8 leaves, professional skill shortages, seasonal workloads and special assignments and projects
9 with the expectation that the position will be terminated when the special situation ends.

10 (b) As probationary new hires with a reasonable expectation of transitioning to perma-
11 nent employment with the client, if the client uses a preestablished probationary period in
12 its overall employment selection program.

13 (8) "Temporary service provider" means a person that:

14 (a) Regardless of the terminology the parties use to describe the relationship, enters into
15 contracts with clients under which:

16 (A) The person provides workers to the client on a temporary basis;

17 (B) The worker's contract of employment is with the person rather than the person's
18 client; and

19 (C) The person retains all employer responsibilities for the worker, except to the extent
20 necessary to allow the person's client to direct and control the services provided by the
21 worker for the client; and

22 (b) Customarily attempts to reassign the person's workers to other clients when the
23 workers finish each assignment, except for workers provided as described in subsection (7)(b)
24 of this section.

25 **SECTION 3.** ORS 656.850 is amended to read:

26 656.850. [(1) As used in this section and ORS 656.018, 656.403, 656.855 and 737.270:]

27 [(a) "Worker leasing company" means a person who provides workers, by contract and for a fee,
28 to work for a client but does not include a person who provides workers to a client on a temporary
29 basis.]

30 [(b) "Temporary basis" means providing workers to a client for special situations such as to cover
31 employee absences, employee leaves, professional skill shortages, seasonal workloads and special as-
32 signments and projects with the expectation that the position or positions will be terminated upon
33 completion of the special situation. Workers also are provided on a temporary basis if they are provided
34 as probationary new hires with a reasonable expectation of transitioning to permanent employment with
35 the client and the client uses a preestablished probationary period in its overall employment selection
36 program.]

37 [(c) "Temporary service provider" means a person who provides workers, by contract and for a fee,
38 to a client on a temporary basis.]

39 [(2) No person shall perform services as a worker leasing company in this state without first having
40 obtained a license therefor from the Director of the Department of Consumer and Business Services.
41 No person required by this section to obtain a license shall fail to comply with this section or ORS
42 656.855, or any rule adopted pursuant thereto.]

43 [(3) When a worker leasing company provides workers to a client, the worker leasing company
44 shall satisfy the requirements of ORS 656.017 and 656.407 and provide workers' compensation coverage
45 for those workers and any subject workers employed by the client unless during the term of the lease

1 *arrangement the client has proof of coverage on file with the director that extends coverage to subject*
2 *workers employed by the client and any workers leased by the client. If the client allows the coverage*
3 *to expire and continues to employ subject workers or has leased workers, the client shall be considered*
4 *a noncomplying employer unless the worker leasing company has complied with subsection (5) of this*
5 *section.]*

6 *[(4) When a worker leasing company provides workers for a client, the worker leasing company*
7 *shall assure that the client provides adequate training, supervision and instruction for those workers*
8 *to meet the requirements of ORS chapter 654.]*

9 *[(5) When a worker leasing company provides subject workers to work for a client and also pro-*
10 *vides workers' compensation coverage for those workers, the worker leasing company shall notify the*
11 *director in writing. The notification shall be given in such manner as the director may prescribe. A*
12 *worker leasing company may terminate its obligation to provide workers' compensation coverage for*
13 *workers provided to a client by giving to the client and the director written notice of the termination.*
14 *A notice of termination shall state the effective date and hour of the termination, but the termination*
15 *shall be effective not less than 30 days after the notice is received by the director. Notice to the client*
16 *under this section shall be given by mail, addressed to the client at the client's last-known address. If*
17 *the client is a partnership, notice may be given to any of the partners. If the client is a corporation,*
18 *notice may be given to any agent or officer of the corporation upon whom legal process may be*
19 *served.]*

20 **(1)(a) A person may not provide services as a professional employer organization (PEO)**
21 **in this state without first having obtained a license from the Director of the Department of**
22 **Consumer and Business Services.**

23 **(b) No person required to obtain a license under this section shall fail to comply with this**
24 **section or ORS 656.855 or any rule adopted pursuant to such sections.**

25 **(2)(a) When a PEO enters into a PEO relationship, the PEO shall satisfy the require-**
26 **ments of ORS 656.017 and 656.407 and provide workers' compensation coverage for all of the**
27 **client's covered employees and direct hire employees unless, during the term of the PEO's**
28 **agreement with the client, the client has proof of coverage on file with the director.**

29 **(b) If the client has proof of coverage on file with the director, the client's coverage shall**
30 **extend to all of the client's covered employees and direct hire employees.**

31 **(c) If the client allows the coverage to expire and continues to employ covered employees**
32 **or direct hire employees, the client shall be considered a noncomplying employer unless the**
33 **PEO has complied with subsection (4) of this section.**

34 **(3) When a PEO enters into a PEO relationship, the PEO shall ensure that the client**
35 **provides adequate training, supervision and instruction for the client's covered employees to**
36 **meet the requirements of ORS chapter 654.**

37 **(4) If a PEO enters into a PEO relationship and the PEO is responsible for providing**
38 **workers' compensation coverage to the client under subsection (2) of this section, the PEO**
39 **shall:**

40 **(a) If the PEO is a carrier-insured employer, notify the insurer in writing. The insurer**
41 **shall file proof of coverage with the director within 30 days after workers' compensation**
42 **coverage of the client becomes effective.**

43 **(b) If the PEO is a self-insured employer, notify the director in writing.**

44 **(5)(a) A PEO's responsibility to provide workers' compensation coverage under sub-**
45 **section (2) of this section shall continue until the earlier of the date on which:**

- 1 **(A) The client obtains alternate coverage; or**
2 **(B) The PEO terminates its responsibility to provide coverage.**
3 **(b) For purposes of paragraph (a)(A) of this subsection, if a client obtains alternate**
4 **workers' compensation coverage, the PEO's responsibility to provide coverage ends on:**
5 **(A) The effective date of a policy for which an insurer makes a proof of coverage filing**
6 **on behalf of the employer;**
7 **(B) The date on which another PEO becomes responsible for providing coverage to the**
8 **client; or**
9 **(C) The date on which the client becomes a self-insured employer.**
10 **(c) For purposes of paragraph (a)(B) of this subsection:**
11 **(A) A PEO may terminate its responsibility to provide coverage by giving written notice**
12 **of the termination to:**
13 **(i) If the PEO is a carrier-insured employer, the client, the director and the insurer. The**
14 **insurer shall file notice of termination with the director within 10 calendar days after the**
15 **effective date of the termination or the date on which the insurer receives notice from the**
16 **PEO, whichever is later.**
17 **(ii) If the PEO is a self-insured employer, the client and the director.**
18 **(B) Unless a later date is specified, the termination shall become effective at 12 midnight**
19 **on the 30th day after the date on which the notice is received by:**
20 **(i) An authorized representative of the insurer; or**
21 **(ii) If the PEO is a self-insured employer, the director.**
22 **(6) When a PEO satisfies its responsibility to provide workers' compensation coverage**
23 **to a client under subsection (2) of this section by obtaining a workers' compensation insur-**
24 **ance policy, coverage of the client under the policy shall continue until:**
25 **(a) The PEO's coverage under the policy ends under ORS 656.419 (4); or**
26 **(b) The PEO's responsibility to provide workers' compensation coverage ends under sub-**
27 **section (5) of this section.**
28 **(7)(a) A PEO shall submit reports to the director that list:**
29 **(A) All clients with which the PEO has entered into a PEO relationship;**
30 **(B) Each client to which the PEO provides workers' compensation coverage; and**
31 **(C) The date on which the coverage begins.**
32 **(b) The director shall prescribe the interval and form of these reports by rule.**
33 **(8) The director may adopt any rules necessary for the implementation of this section,**
34 **including but not limited to:**
35 **(a) Prescribing the form and content of notices required under this section, including**
36 **requiring electronic transmission and filing; and**
37 **(b) Requiring insurers that provide coverage to PEOs to do so on a multiple coordinated**
38 **policy or other basis.**
39 **(9)(a) Notice to the client under this section shall be given by mail, addressed to the cli-**
40 **ent at the client's last-known address.**
41 **(b) If the client is a partnership, notice may be given to any of the partners.**
42 **(c) If the client is a corporation, notice may be given to any agent or officer of the cor-**
43 **poration upon whom legal process may be served.**
44 **(d) If the client is a limited liability company, notice may be given to any manager.**
45 **(e) If the client is a member-managed limited liability company, notice may be given to**

1 **any member.**

2 **SECTION 4.** ORS 656.702 is amended to read:

3 656.702. (1)[(a)] The records of the State Accident Insurance Fund Corporation are subject to
4 ORS 192.311 to 192.478.

5 [(b)] **(2)(a)** Notwithstanding ORS 192.355, the State Accident Insurance Fund Corporation shall
6 make the accident experience records of the corporation available to a bona fide rating organization
7 to assist in making workers' compensation rates. Costs involved in making the records available
8 shall be borne by the rating organization.

9 **(b)** Accident experience records of carrier-insured employers shall also be available on the same
10 terms to assist in making such rates.

11 [(2)] **(3)** Disclosure of workers' compensation claim records of the Department of Consumer and
12 Business Services is governed by ORS 192.355 (20).

13 **(4)(a) When records obtained by the Director of the Department of Consumer and Busi-**
14 **ness Services indicate that a professional employer organization's responsibility to provide**
15 **workers' compensation coverage to a client has been terminated under ORS 656.850 (5)(a)(A),**
16 **the director may disclose the name of the client and the date of termination to the profes-**
17 **sional employer organization's insurer.**

18 **(b) Information disclosed to an insurer under this subsection may be used only to vali-**
19 **date the accuracy of the insurer's coverage records and may not be disclosed to any other**
20 **party.**

21 **SECTION 5.** ORS 656.018 is amended to read:

22 656.018. (1)(a) **Except as specifically provided otherwise in this chapter,** the liability of every
23 employer who satisfies the duty required [by] **under** ORS 656.017 (1) is exclusive and in place of all
24 other liability arising out of injuries, diseases, symptom complexes or similar conditions arising out
25 of and in the course of employment that are sustained by subject workers, the workers' beneficiaries
26 and anyone otherwise entitled to recover damages from the employer on account of such conditions
27 or claims resulting therefrom, specifically including claims for contribution or indemnity asserted
28 by third persons from whom damages are sought on account of such conditions[, *except as specifically*
29 *provided otherwise in this chapter*].

30 (b) This subsection shall not apply to claims for indemnity or contribution asserted by a rail-
31 road, as defined in ORS 824.020, or by a corporation, individual or association of individuals which
32 is subject to regulation [*pursuant to*] **under** ORS chapter 757 or 759.

33 (c) Except as provided in paragraph (b) of this subsection, all agreements or warranties contrary
34 to the provisions of paragraph (a) of this subsection entered into after July 19, 1977, are void.

35 (2) The rights given to a subject worker and the beneficiaries of the subject worker under this
36 chapter for injuries, diseases, symptom complexes or similar conditions arising out of and in the
37 course of employment are in lieu of any remedies they might otherwise have for such injuries, dis-
38 eases, symptom complexes or similar conditions against the worker's employer under ORS 654.305
39 to 654.336 or other laws, common law or statute, except to the extent the worker is expressly given
40 the right under this chapter to bring suit against the employer of the worker for an injury, disease,
41 symptom complex or similar condition.

42 **(3)(a)** The exemption from liability given an employer under this section is also extended to the
43 employer's insurer, the self-insured employer's claims administrator, the Department of Consumer
44 and Business Services, and to the contracted agents, employees, partners, limited liability company
45 members, general partners, limited liability partners, limited partners, officers and directors of the

1 employer, the employer's insurer, the self-insured employer's claims administrator and the depart-
2 ment.], *except that*

3 **(b) Notwithstanding paragraph (a) of this subsection**, the exemption from liability shall not
4 apply **if**:

5 [(a)] **(A)** [If] The willful and unprovoked aggression by a person otherwise exempt under this
6 subsection is a substantial factor in causing the injury, disease, symptom complex or similar condi-
7 tion;

8 [(b)] **(B)** [If] The worker and the person otherwise exempt under this subsection are not engaged
9 in the furtherance of a common enterprise or the accomplishment of the same or related objectives;

10 [(c)] **(C)** [If] The failure of the employer to comply with a notice posted pursuant to ORS 654.082
11 is a substantial factor in causing the injury, disease, symptom complex or similar condition; or

12 [(d)] **(D)** [If] The negligence of a person otherwise exempt under this subsection is a substantial
13 factor in causing the injury, disease, symptom complex or similar condition and the negligence oc-
14 curs outside of the capacity that qualifies the person for exemption under this section.

15 (4) The exemption from liability given an employer under this section applies to a [*worker leas-*
16 *ing company and the client to whom workers are provided when the worker leasing company*] **pro-**
17 **fessional employer organization and the client with which the professional employer**
18 **organization has entered into a PEO relationship when the professional employer organiza-**
19 **tion** and the client comply with ORS 656.850 [(3)] **(2)**.

20 (5)(a) The exemption from liability given an employer under this section applies to a temporary
21 service provider[, *as that term is used in ORS 656.850,*] and also extends to the client to whom
22 workers are provided when the temporary service provider complies with ORS 656.017.

23 (b)(A) The exemption from liability given a client under paragraph (a) of this subsection is also
24 extended to the client's insurer, the self-insured client's claims administrator, the department, and
25 the contracted agents, employees, officers and directors of the client, the client's insurer, the self-
26 insured client's claims administrator and the department.], *except that*

27 **(B) Notwithstanding subparagraph (A) of this paragraph**, the exemption from liability shall
28 not apply **if**:

29 [(A)] **(i)** [If] The willful and unprovoked aggression by a person otherwise exempt under this
30 subsection is a substantial factor in causing the injury, disease, symptom complex or similar condi-
31 tion;

32 [(B)] **(ii)** [If] The worker and the person otherwise exempt under this subsection are not engaged
33 in the furtherance of a common enterprise or the accomplishment of the same or related objectives;

34 [(C)] **(iii)** [If] The failure of the client to comply with a notice posted pursuant to ORS 654.082
35 is a substantial factor in causing the injury, disease, symptom complex or similar condition; or

36 [(D)] **(iv)** [If] The negligence of a person otherwise exempt under this subsection is a substantial
37 factor in causing the injury, disease, symptom complex or similar condition and the negligence oc-
38 curs outside of the capacity that qualifies the person for exemption under this subsection.

39 (6) Nothing in this chapter shall prohibit payment, voluntarily or otherwise, to injured workers
40 or their beneficiaries in excess of the compensation required to be paid under this chapter.

41 (7) The exclusive remedy provisions and limitation on liability provisions of this chapter apply
42 to all injuries and to diseases, symptom complexes or similar conditions of subject workers arising
43 out of and in the course of employment whether or not they are determined to be compensable under
44 this chapter.

45 **SECTION 6.** ORS 656.403 is amended to read:

1 656.403. (1) A self-insured employer directly assumes the responsibility for providing compen-
2 sation due subject workers and their beneficiaries under this chapter.

3 (2) The claims of subject workers and their beneficiaries resulting from injuries while employed
4 by a self-insured employer shall be handled in the manner provided by this chapter. A self-insured
5 employer is subject to the rules of the Director of the Department of Consumer and Business Ser-
6 vices with respect to such claims.

7 (3) Security deposited by a self-insured employer shall not relieve any such employer from full
8 and primary responsibility for claims administration and payment of compensation under this chap-
9 ter. This subsection applies to a self-insured employer even though the self-insured employer insures
10 or reinsures all or any portion of risks under this chapter with an insurance company authorized
11 to do business in this state or with any other insurer with whom insurance can be placed or secured
12 pursuant to ORS 744.305 to 744.405 (1985 Replacement Part).

13 (4) When a self-insured employer is a [*worker leasing company*] **professional employer organ-**
14 **ization** required to be licensed [*pursuant to*] by ORS 656.850 and 656.855, the [*company also shall*]
15 **professional employer organization shall also** comply with the [*worker leasing company*] regula-
16 tory provisions of ORS chapters 656 and 737 **pertaining to professional employer organizations**
17 and with such rules as may be adopted pursuant to ORS 656.726 and 731.244 for the supervision and
18 regulation of [*worker leasing companies*] **professional employer organizations.**

19 **SECTION 7.** ORS 656.855 is amended to read:

20 656.855. (1) In accordance with any applicable provision of ORS chapter 183, the Director of the
21 Department of Consumer and Business Services, by rule, shall establish a licensing system for
22 [*worker leasing companies*] **professional employer organizations.**

23 (2) [*Such system*] **The system established by the director** shall include, but not be limited to:

24 (a) Prescribing the form and content of and the times and procedures for submitting applications
25 for license issuance or renewal.

26 (b) Prescribing the term of the license and the fee for original issuance and renewal of the li-
27 cense. The fees shall be set in an amount necessary to support the administration of this section and
28 ORS 656.850.

29 (c) Prescribing those violations of this section or of ORS 656.850 for which the director may
30 refuse to issue or renew or may suspend or revoke a license.

31 (d) Prescribing the form and contents of records a licensee is required to maintain and specify-
32 ing the times, places and manner of audit by the director of those records.

33 [2] (3) All moneys received by the director pursuant to this section shall be credited to the
34 Consumer and Business Services Fund and are appropriated continuously to the director to carry
35 out the provisions of this section and ORS 656.850.

36 **SECTION 8.** ORS 737.270 is amended to read:

37 737.270. (1) When a [*worker leasing company*] **professional employer organization** required to
38 be licensed by ORS 656.850 [*provides workers to work for*] **enters into a PEO relationship with** a
39 client and also provides the workers' compensation coverage for [*those workers*] **the client**, the in-
40 surance premium for the client's exposure shall be based on the client's own experience rating, in
41 the same manner as required for employers insuring directly employed workers.

42 (2) An insurer that provides workers' compensation to a [*worker leasing company*] **professional**
43 **employer organization** shall maintain and report to the licensed workers' compensation rating or-
44 ganization of which the insurer is a member separate statistical experience for each client of the
45 [*worker leasing company*] **professional employer organization** according to the uniform statistical

1 plan prescribed by the Director of the Department of Consumer and Business Services according to
2 ORS 737.225 (4).

3 (3) To reimburse expenses incurred by the insurer in segregating client experience, the insurer
4 shall be permitted to charge the *[worker leasing company]* **professional employer organization** a
5 reasonable fee as determined by the director.

6 (4) The *[worker leasing company]* **professional employer organization** shall earn a separate
7 experience rating for any administrative personnel the *[company]* **professional employer organ-**
8 **ization directly** employs.

9 **SECTION 9.** ORS 743.521 is amended to read:

10 743.521. (1)(a) A *[leasing company]* **professional employer organization** may offer group health
11 insurance to its *[leased workers]* **clients' covered employees**.

12 (b) If the *[leasing company]* **professional employer organization** does not offer group health
13 insurance to its *[leased workers]* **clients' covered employees**, the client employer may offer group
14 health insurance to the *[leased workers]* **covered employees**.

15 (2) If a *[leasing company]* **professional employer organization** offers group health insurance to
16 *[its leased workers]* **any of its clients' covered employees**, the *[leasing company]* **professional**
17 **employer organization** shall offer group health insurance to all its *[leased workers]* **clients' cov-**
18 **ered employees** in the same manner.

20 743.522. (1) As used in this section and ORS 743.521:

21 (a) "Client employer" means an employer *[to whom workers are provided under contract and for*
22 *a fee on a leased basis by a worker leasing company]* **with which a professional employer organ-**
23 **ization required to be** licensed under ORS 656.850 **has a PEO relationship**.

24 (b) "Covered employee" **has the meaning given that term in section 2 of this 2025 Act.**

25 *[(b)]* (c) "Employee" may include a retired employee.

26 *[(c) "Leased worker" means a worker provided by a worker leasing company licensed under ORS*
27 *656.850.]*

28 (d) "PEO relationship" **has the meaning given that term in section 2 of this 2025 Act.**

29 (e) "Professional employer organization" **has the meaning given that term in section 2**
30 **of this 2025 Act.**

31 (2) Group health insurance may be offered to a resident of this state under a group health in-
32 surance policy issued to a group other than one of the groups described in ORS 731.098 if:

33 (a) The Director of the Department of Consumer and Business Services finds that:

34 (A) The issuance of the policy is in the best interest of the public;

35 (B) The issuance of the policy would result in economies of acquisition or administration; and

43 identical or substantially similar trade names or service marks, both as defined in ORS 647.005.

44 (2)(a) "Employee" means an employee, as defined in ORS 652.310, who is employed in a retail
45 establishment, a hospitality establishment or a food services establishment and is engaged in pro-

1 viding services relating to:

2 (A) Retail trade, as that term is used in the 2012 North American Industry Classification System

4 (B) Hotels and motels, as those terms are used in the 2012 North American Industry Classifica-

41 (8) A person licensed or registered in one of the following trades or professions when operating
42 within the scope of that license or registration:

43 (a) An architect registered by the State Board of Architect Examiners.

44 (b) A professional engineer registered by the State Board of Examiners for Engineering and
45 Land Surveying.

- 1 (c) A water well contractor licensed by the Water Resources Department.
- 2 (d) A sewage disposal system installer licensed by the Department of Environmental Quality.
- 3 (e) A landscape contracting business licensed under ORS 671.510 to 671.760.
- 4 (f) A pesticide operator licensed under ORS 634.116 who does not conduct inspections for wood
5 destroying organisms for the transfer of real estate.
- 6 (g) An appraiser certified or licensed under ORS chapter 674 or an appraiser assistant registered
7 under ORS chapter 674 by the Appraiser Certification and Licensure Board.
- 8 (9) A landscape contracting business operating within the scope of a license issued under ORS
9 671.510 to 671.760 that:
- 10 (a) Constructs fences, decks, arbors, patios, landscape edging, driveways, walkways or retaining
11 walls and meets the applicable bonding requirements under ORS 671.690; or
- 12 (b) Subcontracts to a licensed plumbing contractor, or otherwise arranges for a licensed plumb-
13 ing contractor to perform, the installation of an irrigation system described in ORS 671.540 (1)(m)
14 or the repair or maintenance of an irrigation system.
- 15 (10) A person who performs work subject to this chapter as an employee of a contractor.
- 16 (11) A manufacturer of a manufactured home constructed under standards established by the
17 federal government.
- 18 (12) A person involved in the movement of:
- 19 (a) Modular buildings or structures other than manufactured structures not in excess of 14 feet
20 in width.
- 21 (b) Structures not in excess of 16 feet in width when the structures are being moved by their
22 owner if the owner is not a contractor required to be licensed under this chapter.
- 23 (13) A surety company, commercial lending institution, holding company for a commercial lend-
24 ing institution, subsidiary of a commercial lending institution or subsidiary of a holding company for
25 a commercial lending institution that arranges for completion, repair or remodeling by one or more
26 licensed contractors of a structure in which the company, institution, holding company or subsidiary
27 holds a legal or security interest. As used in this subsection, "commercial lending institution"
28 means any bank, mortgage banking company, trust company, savings bank, savings and loan asso-
29 ciation, credit union, national banking association, federal savings and loan association, insurance
30 company or federal credit union maintaining an office in this state.
- 31 (14) A real estate licensee who engages in the management of rental real estate as defined in
32 ORS 696.010 or the employee of that licensee when performing work on a structure that the real
33 estate licensee manages under a contract.
- 34 (15) Units of government other than those specified in ORS 701.005 (5)(c) and (d).
- 35 (16) A qualified intermediary in a property exchange that qualifies under section 1031 of the
36 Internal Revenue Code as amended and in effect on January 1, 2004, if the qualified intermediary
37 is not performing construction activities.
- 38 (17) A [*worker leasing company*] **professional employer organization** or temporary service
39 provider, [*both as defined in ORS 656.850,*] **as defined in section 2 of this 2025 Act**, that supplies
40 personnel to a licensed contractor for the performance of work under the direction and supervision
41 of the contractor **or that has entered into a PEO relationship with the contractor.**
- 42 (18) City or county inspectors acting under ORS 701.225 or inspectors described in ORS 455.715.
- 43 (19) A person performing work for purposes of agricultural drainage, agricultural trenching or
44 agricultural irrigation or involving the construction of agricultural fences to control livestock.
- 45 (20) A person performing work that is subject to ORS 527.610 to 527.770 on forestlands for which

1 notice of operation has been filed under ORS 527.670.

2 **SECTION 19.** ORS 701.035 is amended to read:

3 701.035. (1) An applicant must qualify as an independent contractor under ORS 670.600 to be
4 eligible for a license with the Construction Contractors Board.

5 (2) The board shall establish two classes of independent contractor:

6 (a) The nonexempt class is composed of the following entities:

7 (A) Sole proprietorships, partnerships, corporations and limited liability companies:

8 (i) With one or more employees; or

9 (ii) That [*utilize one or more workers supplied by a worker leasing company*] **have a PEO re-**
10 **lationship.**

11 (B) Partnerships, corporations and limited liability companies with more than two partners,
12 corporate officers or members, if any of the partners, corporate officers or members are not part of

15 (b) The exempt class is composed of all sole proprietorships, partnerships, corporations and
16 limited liability companies that do not qualify as nonexempt.

17 (3)(a) If a person who is licensed as exempt under subsection (2)(b) of this section hires one or
18 more employees, [*utilizes one or more workers supplied by a worker leasing company*] **enters into a**
19 **PEO relationship** or falls into any of the categories set out in subsection (2)(a)(B) of this section,
20 the person is subject to penalties under ORS 701.992 for improper licensing.

21 (b) If a person who is licensed as exempt under subsection (2)(b) of this section hires one or
22 more employees, or [*utilizes one or more workers supplied by a worker leasing company*] **enters into**
23 **a PEO relationship**, the person is also subject to licensing sanctions under ORS 701.098.

24 (c) [*The*] **A person described in this subsection** must reapply to the board in the correct class.

25 (4) The decision of the board that a person is an independent contractor applies only when the
26 person is performing work of the nature described in ORS 701.021.

28 licensed as a commercial contractor shall procure and maintain workers' compensation insurance
29 as authorized by ORS 656.128.

31 701.098. (1) The Construction Contractors Board may revoke, suspend, condition or refuse to
32 issue or reissue a license and may assess a civil penalty as provided in ORS 701.992 if the board
33 determines after notice and opportunity for hearing that a licensee or applicant:

34 (a) Violated a provision of this chapter.

35 (b) Violated a rule or order of the board.

36 (c) Entered into a settlement agreement with another person under ORS 701.145 but failed to
37 comply with the terms of the settlement agreement.

38 (d) Is a business entity or is the owner, director, officer or partner of a business entity or of a
39 reorganized business entity, as defined in ORS 305.330, that was subject to a revocation or suspen-
40 sion of a license, or subject to a civil or criminal penalty, imposed under this chapter or ORS
41 chapter 447, 455, 460 or 693, or under the laws of another state, and the revocation, suspension or
42 civil or criminal penalty was related to the licensee's or applicant's engaging in construction.

43 (e) Submitted an application to the board that, at the time the board issued or renewed the li-
44 cense or denied the application, was incomplete in any material respect or included a statement that
45 was incorrect or misleading in light of the circumstances in which the licensee or applicant made

1 the statement.

2 (f) Knowingly assisted an unlicensed person to act in violation of this chapter.

3 (g) Knowingly assisted a licensed contractor to perform work for which the contractor is not
4 properly endorsed.

5 (h) Wrongfully failed to perform a contractual duty to pay money to a person and the failure
6 caused the person to file a lien on a structure under ORS 87.001 to 87.093.

7 (i) Knowingly provided false information to the board.

8 (j) Worked without a construction permit where a permit is required and the work resulted in
9 a complaint being filed with the board under ORS 701.139. For purposes of this paragraph, "con-
10 struction permit" includes a building permit, electrical permit, mechanical permit or plumbing per-
11 mit.

12 (k) Worked together with another contractor on the same task on the same job site, where one
13 of the contractors was classed as exempt under ORS 701.035 (2)(b) and the number of contractors
14 working together exceeded the following:

15 (A) Two sole proprietors;

16 (B) One partnership;

17 (C) One corporation; or

18 (D) One limited liability company.

19 (L) Was convicted, or an owner, director, officer or partner of the licensee or applicant was
20 convicted, consistent with ORS 670.280, of one of the following crimes in this state or an equivalent
21 crime in another state:

22 (A) Murder;

23 (B) Assault in the first degree;

24 (C) Kidnapping;

25 (D) Rape, sodomy or unlawful sexual penetration;

26 (E) Sexual abuse;

27 (F) Arson in the first degree;

28 (G) Robbery in the first degree;

29 (H) Theft in the first degree; or

30 (I) Extortion.

31 (m) Did not pay another person for supplying labor or materials contracted for under a public
32 improvement contract, plus the amount of interest due, within 90 days after receiving payment from
33 a contracting agency or, if the licensee or applicant was a subcontractor, from a contractor.

34 (n) Repeatedly reported bad faith or false complaints of nonpayment against contractors or
35 subcontractors.

36 (o) Engaged in conduct as a contractor that was dishonest or fraudulent and that the board finds
37 injurious to the welfare of the public.

38 (p) Hired employees while licensed as exempt under ORS 701.035.

39 (q) [*Used one or more workers supplied by a worker leasing company*] **Entered into a PEO re-**
40 **lationship** while licensed as exempt under ORS 701.035.

41 (2) The board may revoke, suspend, condition or refuse to issue or reissue a license if the board
42 determines after notice and opportunity for hearing that a licensee or applicant is unfit for licensure
43 based upon information submitted to the board under ORS 701.046, submitted in a registration of
44 securities described in ORS 701.046 (2) or discovered by a board investigation under ORS 701.225.

45 (3) The board may assess a civil penalty against any person as provided in ORS 701.992 if the

1 board determines after notice and opportunity for hearing that the person violated ORS 701.021.

2 (4)(a) The administrator of the board, in accordance with administrative rules adopted by the
3 board and after setting forth specific reasons for the findings, may suspend or refuse to renew a li-
4 cense without hearing in any case where the administrator finds a serious danger to the public
5 welfare, including but not limited to:

6 (A) Lack of a surety bond required by ORS 701.068;

7 (B) Lack of liability insurance required by ORS 701.073;

8 (C) Hiring employees while classed as exempt under ORS 701.035;

15 (b) If the licensee or applicant demands a hearing within 90 days after the date of notice to the
16 licensee or applicant of the suspension or refusal to renew, then a hearing must be granted to the
17 licensee or applicant as soon as practicable after the demand, and the administrator shall issue,
18 pursuant to the hearing as required by ORS chapter 183, an order confirming, altering or revoking
19 the administrator's earlier order. Notwithstanding ORS 670.325, a hearing need not be held where

1 (8) If the board suspends or revokes the license of an individual contractor or contractor busi-

3 cense unless the individual contractor or a responsible managing individual for the contractor
4 business has successfully completed the training and testing described in ORS 701.122.

5 **SECTION 21.** ORS 701.470 is amended to read:

6 701.470. (1) As used in this section:

7 (a)(A) “Construction flagger” means an individual who, for compensation or with the expectation
8 of compensation, directs or controls the flow of motor vehicle traffic on a public roadway to prevent
9 or reduce conflict between the flow of traffic and construction activity on or near the roadway.

10 (B) “Construction flagger” does not mean an individual performing work for the federal gov-
11 ernment, a public body as defined in ORS 174.109 or a business regulated by the Public Utility
12 Commission.

13 (b) “Construction flagging contractor” means a person who employs, contracts with, or [*obtains*
14 *through a worker leasing company*] **enters into a PEO relationship with respect to**, one or more
15 individuals to act as construction flaggers.

16 (2) Except as provided in this section, a person may not undertake, offer to undertake or submit
17 a bid to do work as a construction flagging contractor unless the person holds a construction flag-
18 ging contractor license issued by the Construction Contractors Board.

19 (3) This section does not require a person to obtain a construction flagging contractor license
20 if the person holds a valid license and endorsement as a:

21 (a) Residential general contractor;

22 (b) Commercial general contractor level 1;

23 (c) Commercial specialty contractor level 1;

24 (d) Commercial general contractor level 2; or

25 (e) Commercial specialty contractor level 2.

26 (4) An applicant for a construction flagging contractor license must:

27 (a) Submit an application in the manner described in ORS 701.046;

28 (b) Obtain a surety bond under ORS 701.068 in the amount of \$25,000; and

29 (c) Obtain general liability insurance under ORS 701.073 in an amount of not less than \$500,000.

30 (5) A construction flagging contractor license authorizes a person to act as a construction
31 flagging contractor but does not authorize the person to engage in any other activities that require

35 or a responsible managing individual for the contractor.

44 (2)(a) “Beneficiary” means an injured worker, and the spouse in a marriage, child or dependent
45 of a worker, who is entitled to receive payments under this chapter.

1 (b) "Beneficiary" does not include a person who intentionally causes the compensable injury to
2 or death of an injured worker.

3 (3) "Board" means the Workers' Compensation Board.

4 (4) "Carrier-insured employer" means an employer who provides workers' compensation cover-
5 age with the State Accident Insurance Fund Corporation or an insurer authorized under ORS
6 chapter 731 to transact workers' compensation insurance in this state.

7 (5) "Child" means a child of an injured worker, including:

8 (a) A posthumous child;

9 (b) A child legally adopted before the injury;

10 (c) A child toward whom the worker stands in loco parentis;

11 (d) A child born out of wedlock;

12 (e) A stepchild, if the stepchild was, at the time of the injury, a member of the worker's family
13 and substantially dependent upon the worker for support; and

14 (f) A child of any age who was incapacitated at the time of the accident and thereafter remains
15 incapacitated and substantially dependent on the worker for support.

16 (6) "Claim" means a written request for compensation from a subject worker or someone on the
17 worker's behalf, or any compensable injury of which a subject employer has notice or knowledge.

18 (7)(a) A "compensable injury" is an accidental injury, or accidental injury to prosthetic appli-
19 ances, arising out of and in the course of employment requiring medical services or resulting in
20 disability or death. An injury is accidental if the result is an accident, whether or not due to acci-
21 dental means, if it is established by medical evidence supported by objective findings, subject to the
22 following limitations:

23 (A) An injury or disease is not compensable as a consequence of a compensable injury unless
24 the compensable injury is the major contributing cause of the consequential condition.

25 (B) If an otherwise compensable injury combines at any time with a preexisting condition to
26 cause or prolong disability or a need for treatment, the combined condition is compensable only if,
27 so long as and to the extent that the otherwise compensable injury is the major contributing cause
28 of the disability of the combined condition or the major contributing cause of the need for treatment
29 of the combined condition.

30 (b) "Compensable injury" does not include:

31 (A) Injury to any active participant in assaults or combats that are not connected to the job
32 assignment and that amount to a deviation from customary duties;

33 (B) Injury incurred while engaging in or performing, or as the result of engaging in or per-
34 forming, any recreational or social activities primarily for the worker's personal pleasure; or

35 (C) Injury the major contributing cause of which is demonstrated to be by a preponderance of
36 the evidence the injured worker's consumption of alcoholic beverages or cannabis or the unlawful
37 consumption of any controlled substance, unless the employer permitted, encouraged or had actual
38 knowledge of such consumption.

39 (c) A "disabling compensable injury" is an injury that entitles the worker to compensation for
40 disability or death. An injury is not disabling if no temporary benefits are due and payable, unless
41 there is a reasonable expectation that permanent disability will result from the injury.

42 (d) A "nondisabling compensable injury" is any injury that requires medical services only.

43 (8) "Compensation" includes all benefits, including medical services, provided for a compensable
44 injury to a subject worker or the worker's beneficiaries by an insurer or self-insured employer pur-
45 suant to this chapter.

1 (9) "Department" means the Department of Consumer and Business Services.

2 (10) "Dependent" means any of the following individuals who, at the time of an accident, de-
3 pended in whole or in part for the individual's support on the earnings of a worker who dies as a
4 result of an injury:

5 (a) A parent of a worker or the parent's spouse or domestic partner;

6 (b) A grandparent of a worker or the grandparent's spouse or domestic partner;

7 (c) A grandchild of a worker or the grandchild's spouse or domestic partner;

8 (d) A sibling or stepsibling of a worker or the sibling's or stepsibling's spouse or domestic
9 partner; and

10 (e) Any individual related by blood or affinity whose close association with a worker is the
11 equivalent of a family relationship.

12 (11) "Director" means the Director of the Department of Consumer and Business Services.

13 (12)(a) "Doctor" or "physician" means a person duly licensed to practice one or more of the
14 healing arts in any country or in any state, territory or possession of the United States within the
15 limits of the license of the licensee.

16 (b) Except as otherwise provided for workers subject to a managed care contract, "attending
17 physician" means a doctor, physician or physician associate who is primarily responsible for the
18 treatment of a worker's compensable injury and who is:

19 (A) A physician licensed under ORS 677.100 to 677.228 by the Oregon Medical Board, or a
20 podiatric physician and surgeon licensed under ORS 677.805 to 677.840 by the Oregon Medical
21 Board, an oral and maxillofacial surgeon licensed by the Oregon Board of Dentistry or a similarly
22 licensed doctor in any country or in any state, territory or possession of the United States;

23 (B) For a cumulative total of 60 days from the first visit on the initial claim or for a cumulative
24 total of 18 visits, whichever occurs first, to any of the medical service providers listed in this sub-
25 paragraph, a:

26 (i) Doctor or physician licensed by the State Board of Chiropractic Examiners for the State of
27 Oregon under ORS chapter 684 or a similarly licensed doctor or physician in any country or in any
28 state, territory or possession of the United States; or

29 (ii) Doctor of naturopathy or naturopathic physician licensed by the Oregon Board of
30 Naturopathic Medicine under ORS chapter 685 or a similarly licensed doctor or physician in any
31 country or in any state, territory or possession of the United States; or

32 (C) For a cumulative total of 180 days from the first visit on the initial claim, a physician as-
33 sociate licensed by the Oregon Medical Board in accordance with ORS 677.505 to 677.525 or a sim-
34 ilarly licensed physician associate in any country or in any state, territory or possession of the
35 United States.

36 (c) Except as otherwise provided for workers subject to a managed care contract, "attending
37 physician" does not include a physician who provides care in a hospital emergency room and refers
38 the injured worker to a primary care physician for follow-up care and treatment.

39 (d) "Consulting physician" means a doctor or physician who examines a worker or the worker's
40 medical record to advise the attending physician or nurse practitioner authorized to provide
41 compensable medical services under ORS 656.245 regarding treatment of a worker's compensable
42 injury.

43 (13)(a) "Employer" means any person, including receiver, administrator, executor or trustee, and
44 the state, state agencies, counties, municipal corporations, school districts and other public corpo-
45 rations or political subdivisions, that contracts to pay a remuneration for the services of any

1 worker.

2 (b) Notwithstanding paragraph (a) of this subsection, for purposes of this chapter, the client of
3 a temporary service provider is not the employer of temporary workers provided by the temporary
4 service provider.

5 (c) As used in paragraph (b) of this subsection, “temporary service provider” has the meaning
6 given that term in [ORS 656.850] **section 2 of this 2025 Act.**

7 (d) For the purposes of this chapter, “subject employer” means an employer that is subject to
8 this chapter as provided in ORS 656.023.

9 (14) “Insurer” means the State Accident Insurance Fund Corporation or an insurer authorized
10 under ORS chapter 731 to transact workers’ compensation insurance in this state or an assigned
11 claims agent selected by the director under ORS 656.054.

12 (15) “Consumer and Business Services Fund” means the fund created by ORS 705.145.

13 (16) “Incapacitated” means an individual is physically or mentally unable to earn a livelihood.

14 (17) “Medically stationary” means that no further material improvement would reasonably be
15 expected from medical treatment or the passage of time.

16 (18) “Noncomplying employer” means a subject employer that has failed to comply with ORS
17 656.017.

18 (19) “Objective findings” in support of medical evidence are verifiable indications of injury or
19 disease that may include, but are not limited to, range of motion, atrophy, muscle strength and
20 palpable muscle spasm. “Objective findings” does not include physical findings or subjective re-
21 sponses to physical examinations that are not reproducible, measurable or observable.

22 (20) “Palliative care” means medical service rendered to reduce or moderate temporarily the
23 intensity of an otherwise stable medical condition, but does not include those medical services ren-
24 dered to diagnose, heal or permanently alleviate or eliminate a medical condition.

25 (21) “Party” means a claimant for compensation, the employer of the injured worker at the time
26 of injury and the insurer, if any, of the employer.

27 (22) “Payroll” means a record of wages payable to workers for their services and includes
28 commissions, value of exchange labor and the reasonable value of board, rent, housing, lodging or
29 similar advantage received from the employer. However, “payroll” does not include overtime pay,
30 vacation pay, bonus pay, tips, amounts payable under profit-sharing agreements or bonus payments
31 to reward workers for safe working practices. Bonus pay is limited to payments that are not antic-
32 ipated under the contract of employment and that are paid at the sole discretion of the employer.
33 The exclusion from payroll of bonus payments to reward workers for safe working practices is only
34 for the purpose of calculations based on payroll to determine premium for workers’ compensation
35 insurance, and does not affect any other calculation or determination based on payroll for the pur-
36 poses of this chapter.

37 (23) “Person” includes a partnership, joint venture, association, limited liability company and
38 corporation.

39 (24)(a) “Preexisting condition” means, for all industrial injury claims, any injury, disease, con-
40 genital abnormality, personality disorder or similar condition that contributes to disability or need
41 for treatment, provided that:

42 (A) Except for claims in which a preexisting condition is arthritis or an arthritic condition, the
43 worker has been diagnosed with the condition, or has obtained medical services for the symptoms
44 of the condition regardless of diagnosis; and

45 (B)(i) In claims for an initial injury or omitted condition, the diagnosis or treatment precedes

1 the initial injury;

2 (ii) In claims for a new medical condition, the diagnosis or treatment precedes the onset of the
3 new medical condition; or

4 (iii) In claims for a worsening pursuant to ORS 656.273 or 656.278, the diagnosis or treatment
5 precedes the onset of the worsened condition.

6 (b) "Preexisting condition" means, for all occupational disease claims, any injury, disease, con-
7 genital abnormality, personality disorder or similar condition that contributes to disability or need
8 for treatment and that precedes the onset of the claimed occupational disease, or precedes a claim
9 for worsening in such claims pursuant to ORS 656.273 or 656.278.

10 (c) For the purposes of industrial injury claims, a condition does not contribute to disability or
11 need for treatment if the condition merely renders the worker more susceptible to the injury.

12 (25) "Self-insured employer" means an employer or group of employers certified under ORS
13 656.430 as meeting the qualifications set out by ORS 656.407.

14 (26) "State Accident Insurance Fund Corporation" and "corporation" mean the State Accident
15 Insurance Fund Corporation created under ORS 656.752.

16 (27) "Wages" means the money rate at which the service rendered is recompensed under the
17 contract of hiring in force at the time of the accident, including reasonable value of board, rent,
18 housing, lodging or similar advantage received from the employer, and includes the amount of tips
19 required to be reported by the employer pursuant to section 6053 of the Internal Revenue Code of
20 1954, as amended, and the regulations promulgated pursuant thereto, or the amount of actual tips
21 reported, whichever amount is greater. The State Accident Insurance Fund Corporation may estab-
22 lish assumed minimum and maximum wages, in conformity with recognized insurance principles, at
23 which any worker shall be carried upon the payroll of the employer for the purpose of determining
24 the premium of the employer.

25 (28)(a) "Worker" means any person, other than an independent contractor, who engages to fur-
26 nish services for a remuneration, including a minor whether lawfully or unlawfully employed and
27 salaried, elected and appointed officials of the state, state agencies, counties, cities, school districts
28 and other public corporations, but does not include any person whose services are performed as an
29 adult in custody or ward of a state institution or as part of the eligibility requirements for a general
30 or public assistance grant.

31 (b) For the purpose of determining entitlement to temporary disability benefits or permanent
32 total disability benefits under this chapter, "worker" does not include a person who has withdrawn
33 from the workforce during the period for which such benefits are sought.

34 (c) For the purposes of this chapter, "subject worker" means a worker who is subject to this
35 chapter as provided in ORS 656.027.

36 (29) "Independent contractor" has the meaning given that term in ORS 670.600.

3 **SECTION 24. This 2025 Act takes effect on the 91st day after the date on which the 2025**
4 **regular session of the Eighty-third Legislative Assembly adjourns sine die.**
