6	"FUNDING PROVIDED BY SPARC
7	
8	"SECTION 15. (1) SPARC shall distribute moneys, by grant, to develop and operate public
9	safety projects as described in this section.
10	"(2) Before distributing moneys under this section, SPARC shall, in collaboration with
11	the Department of Public Safety Standards and Training and the advisory board convened
12	under section 19 of this 2025 Act, develop construction standards for projects, which may
13	include, without limitation, seismic standards, durability standards and standards for
14	portions of newly constructed buildings that may be used as emergency evacuation facilities.
15	A recipient of grant funding under this section must agree to construct the project in ac-
16	cordance with applicable standards developed by SPARC.
17	"(3) On or before July 1, 2027, SPARC shall make the following grants, subject to sub-
18	section (2) of this section:
19	"(a) \$20,000,000 to the Department of Public Safety Standards and Training for a facility
20	in Salem.
21	"(b) \$20,000,000 to the Central Oregon Intergovernmental Council to be used for the
22	CORE3 center in Deschutes County.
23	"(c) \$20,000,000 to the Rogue Siskiyou Regional Training Center.
24	"(4) In the biennium beginning July 1, 2027, SPARC shall make additional grants for the
25	projects specified in subsection (3) of this section to fund operational costs of the projects.
26	SPARC shall determine the amount of the grants based on the need demonstrated by the
27	projects and legislative budgetary authorization.
28	"(5) On or before July 1, 2030, SPARC shall make two grants of up to \$20,000,000 each to
29	recipients determined through a competitive process. SPARC shall adopt rules governing the
30	competitive process and shall select recipients so as to maximize the emergency readiness
31	of the state, taking into consideration the severity and types of hazards that may affect
32	various regions of the state. SPARC may not make grants under this subsection for projects
33	that received grants under subsection (3) of this section.
34	"(6) On or before July 1, 2032, SPARC shall make two grants of up to \$20,000,000 each to
35	recipients determined through a competitive process as described in subsection (5) of this

section. SPARC may not make grants under this subsection for projects that received grants
 under subsections (3) or (5) of this section.

3 "<u>SECTION 16.</u> (1) For the biennium beginning July 1, 2025, at the request of the Depart-4 ment of Public Safety Standards and Training, the State Treasurer is authorized to issue 5 lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$60,000,000 6 in net proceeds for the purposes described in subsection (2) of this section, plus an additional 7 amount estimated by the State Treasurer to be necessary to pay bond-related costs.

8 "(2) Net proceeds of lottery bonds issued under this section must be transferred to the 9 department to be used by SPARC to issue grants under section 15 of this 2025 Act.

"(3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs,
further economic development, finance public education or restore and protect parks,
beaches, watersheds and native fish and wildlife, and is authorized based on the following
findings:

"(a) Developing public safety projects in Oregon will create employment opportunities in
 construction and public safety professions;

"(b) Public safety projects will help to protect natural resources in Oregon, including
 native fish and wildlife, against natural and man-made disasters; and

18 "(c) Enhancing Oregon's ability to prepare for and recover from emergencies will in-19 crease investment, business activity and economic development in the state.

"(4) The Legislative Assembly declares its current intention to authorize bonding necessary to fund the grants described in section 15 (5) and (6) of this 2025 Act, including any bond-related costs.

23 "<u>SECTION 17.</u> Sections 15 and 16 of this 2025 Act are repealed on January 2, 2034.".

"DPSST ADVISORY BOARD

<u>* SECTION 19.</u> (1) The Department of Public Safety Standards and Training shall convene
 an advisory board to advise the department on emergency resilience strategy. The advisory
 board may advise on any of the following, without limitation:

31 "(a) Strategic investments and objectives in the short, medium and long term;

32 "(b) Placement and distribution of facilities, equipment and supplies;

33 "(c) Standards for regional training; and

"(d) Recommendations for legislative changes associated with statewide emergency
 resilience.

36 "(2) The department may appoint members to the advisory board as the department 37 deems necessary or convenient. The department shall consider, but is not required to ap-38 point, the following as advisory board members:

- 39 "(a) The State Resilience Officer;
- 40 "(b) The SPARC facilitator;
- 41 "(c) A member with expertise in capital projects;
- 42 "(d) A representative of the Oregon Military Department;
- 43 "(e) A representative of the Department of the State Fire Marshal;
- 44 "(f) A representative of the Department of State Police;

5	"(3) All agencies of state government, as defined in ORS 174.111, are directed to assist
6	the advisory board in the performance of the duties of the advisory board and, to the extent
7	permitted by laws relating to confidentiality, to furnish information and advice the members
8	of the advisory board consider necessary to perform their duties.

10	"SRO AND SPARC REPORTING
11	
12	"SECTION 20. (1) On or before January 30, 2027, the State Resilience Officer shall report
13	to the standing or interim committees of the Legislative Assembly related to emergency
14	management on whether the staffing levels of the office of the State Resilience Officer are
15	sufficient to carry out the duties of the office.
16	"(2) On or before January 30, 2027, SPARC shall report to the standing or interim com-
17	mittees of the Legislative Assembly related to emergency management on the amount of
18	state funding necessary or advisable for operational costs of the projects described in section
19	15 (3) of this 2025 Act.".
