

# House Bill 3084

Sponsored by Representative LEVY E, Senator BROADMAN, Representative KROPF (Pre-session filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act tells state agencies to help with the CORE3 center in various ways. (Flesch Readability Score: 71.7).

Directs specified state agencies to collaborate with local and regional officials to develop the CORE3 center.

Directs state agencies to incorporate the CORE3 center in agency emergency planning.

Directs specified state agencies to evaluate whether financial participation in the CORE3 center is advisable.

Directs the Oregon Department of Administrative Services to issue a grant for the CORE3 center.

## A BILL FOR AN ACT

2 Relating to emergency management.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) As used in this section, "CORE3 center" means the multiagency coordi-**  
5 **nation center for emergency operations under development in Deschutes County.**

6 **(2) The following state agencies shall work collaboratively with local and regional officials**  
7 **in coordinating and planning the development of the CORE3 center:**

8 **(a) The Oregon Department of Emergency Management;**

9 **(b) The Department of the State Fire Marshal;**

10 **(c) The State Forestry Department;**

11 **(d) The Oregon Military Department;**

12 **(e) The Department of State Police;**

13 **(f) The Department of Public Safety Standards and Training;**

14 **(g) The Department of Corrections;**

15 **(h) The Department of Human Services;**

16 **(i) The Department of Transportation; and**

17 **(j) The Department of Environmental Quality.**

18 **(3) State agencies shall incorporate the CORE3 center as an element of the agencies'**  
19 **plans related to emergencies and disasters.**

20 **(4) Each state agency specified in subsection (2) of this section shall evaluate whether**  
21 **financial participation by the agency in the construction or operation of the CORE3 center**  
22 **is in the long-term interest of Oregon residents. The agencies shall report their conclusions**  
23 **to the standing or interim committees of the Legislative Assembly related to emergency**  
24 **management as soon as practicable.**

25 **(5) The Oregon Department of Administrative Services shall issue a grant to the Central**  
26 **Oregon Intergovernmental Council to be used for planning, developing or constructing the**  
27 **CORE3 center.**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1        **SECTION 2.** In addition to and not in lieu of any other appropriation, there is appropri-  
2        ated to the Oregon Department of Administrative Services, for the biennium beginning July  
3        1, 2025, out of the General Fund, the amount of \$15,750,000 to carry out the provisions of  
4        section 1 (5) of this 2025 Act.
