# House Bill 3096

Sponsored by Representatives LEWIS, SMITH G; Representative LEVY B, Senators NASH, WEBER (Presession filed.)

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes a new tax credit for apprenticeships. (Flesch Readability Score: 66.1). Creates income tax credit for taxpayers that provide apprenticeship opportunities. Applies to all tax years beginning on or after January 1, 2026. Takes effect on the 91st day following adjournment sine die.

### A BILL FOR AN ACT

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> Section 2 of this 2025 Act is added to and made a part of ORS chapter 315.

6 **SECTION 2. (1)** As used in this section:

7 (a) "Apprentice" has the meaning given that term in ORS 660.010.

(b) "Qualifying apprentice" means an apprentice who is at least 16 years of age but not
more than 30 years of age at the close of the tax year.

10 (2) A credit against taxes that are otherwise due under ORS chapter 316 or, if the tax-11 payer is a corporation, under ORS chapter 317 or 318, is allowed to a taxpayer that employs

12 qualifying apprentices during the tax year.

(3) The credit allowed under this section is \$1000 per qualifying apprentice employed by
 the taxpayer, provided that each qualifying apprentice is employed by the taxpayer for at
 least 500 hours during the tax year.

(4) Prior to claiming the credit allowed under this section, a taxpayer is required to re ceive written certification of eligibility from the Department of Revenue.

(5) The credit allowed under this section may not exceed the tax liability of the taxpayer
 for the tax year.

(6) Any tax credit otherwise allowable under this section that is not used by the taxpayer in a particular tax year may be carried forward and offset against the taxpayer's tax liability for the next succeeding tax year. Any credit remaining unused in the next succeeding tax year may be carried forward and used in the second succeeding tax year, and likewise any credit not used in that second succeeding tax year may be carried forward and used in the third succeeding tax year but may not be carried forward for any tax year thereafter.

(7) A nonresident shall be allowed the credit under this section. The credit shall be
computed in the same manner and be subject to the same limitations as the credit granted
to a resident. However, the credit shall be prorated using the proportion provided in ORS
316.117.

1 (8) If a change in the taxable year of the taxpayer occurs as described in ORS 314.085, 2 or if the Department of Revenue terminates the taxpayer's taxable year under ORS 314.440, 3 the credit allowed by this section shall be prorated or computed in a manner consistent with 4 ORS 314.085.

5 (9) If a change in the status of a taxpayer from resident to nonresident or from nonres-6 ident to resident occurs, the credit allowed by this section shall be determined in a manner 7 consistent with ORS 316.117.

8 (10) The Department of Revenue shall adopt rules for the purposes of this section, in-9 cluding policies and procedures for certifying taxpayers as eligible for the credit allowed un-10 der this section as required in subsection (4) of this section.

SECTION 3. ORS 314.772 is amended to read:

12 314.772. (1) Except as provided in ORS 314.766 (5)(b), the tax credits allowed or allowable to a 13 C corporation for purposes of ORS chapter 317 or 318 shall not be allowed to an S corporation. The 14 business tax credits allowed or allowable for purposes of ORS chapter 316 shall be allowed or are 15 allowable to the shareholders of the S corporation.

(2) In determining the tax imposed under ORS chapter 316, as provided under ORS 314.763, on income of the shareholder of an S corporation, there shall be taken into account the shareholder's pro rata share of business tax credit (or item thereof) that would be allowed to the corporation (but for subsection (1) of this section) or recapture or recovery thereof. The credit (or item thereof), recapture or recovery shall be passed through to shareholders in pro rata shares as determined in the manner prescribed under section 1377(a) of the Internal Revenue Code.

(3) The character of any item included in a shareholder's pro rata share under subsection (2)
of this section shall be determined as if such item were realized directly from the source from which
realized by the corporation, or incurred in the same manner as incurred by the corporation.

(4) If the shareholder is a nonresident and there is a requirement applicable for the business tax
credit that in the case of a nonresident the credit be allowed in the proportion provided in ORS
316.117, then that provision shall apply to the nonresident shareholder.
