SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act would make it so that only commercial property may get the tax break for historic property. (Flesch Readability Score: 61.6).

Limits the property tax special assessment program for historic property to commercial property. Makes other structural changes to the program.

Takes effect on the 91st day following adjournment sine die.

Be It Enacted by the People of the State of Oregon:

6 **SECTION 1.** ORS 358.480 is amended to read:

7 358.480. As used in ORS 358.480 to 358.545, unless the context requires otherwise:

8 [(1) "*Americans with Disabilities Act*" means the *Americans with Disabilities Act of 1990 (P.L.*
9 *101-336), as amended.*]

10 [(2) "*Certify,*" "*certified*" and "*certification*" refer to the approval of historic property by the State
11 *Historic Preservation Officer for classification and special assessment under ORS 358.495.*]

12 [(3) "*Classified*" and "*classification*" refer to the recognition of property by the State Historic
13 *Preservation Officer as historic property as defined in this section.*]

14 [(4) "*Commercial building*" means improved property used in a trade or business or held for the
15 *production of income, not including residential rental property.*]

16 (1)(a) **"Commercial property" means improved real property that is used in a trade or**
17 **business or held for the production of income, including but not limited to:**

18 (A) **Single-family or multifamily residential rental property.**

19 (B) **Office buildings, retail buildings, hotels, banks, restaurants, service outlets and**
20 **dwelling units inside such buildings.**

21 (b) **"Commercial property" does not mean an owner-occupied private residence.**

22 [(5) "*Condominium*" means, with respect to property submitted to the provisions of ORS 100.005 to
23 *100.627.*]

24 [(a) *The land, if any, whether fee simple, leasehold, easement or other interest or combination*

2 *[(b) Any buildings, improvements and structures on the property; and]*

3 *[(c) Any easements, rights and appurtenances belonging to the property.]*

4 *[(6) "Condominium unit" means a part of the property:]*

5 *[(a) That is described in ORS 100.020 (3);]*

6 *[(b) That is intended for any type of independent ownership; and]*

7 *[(c) The boundaries of which are described pursuant to ORS 100.105 (1)(d).]*

8 *[(7) "Condominium unit owner" means, except to the extent the declaration or bylaws provide oth-*
9 *erwise, the person owning fee simple interest in a condominium unit, the holder of a vendee's interest*
10 *in a condominium unit under a recorded installment contract of sale or, in the case of a leasehold*
11 *condominium, the holder of the leasehold estate in a condominium unit.]*

12 *[(8) (2) "Contributing resource" means a building, site or structure that adds to the historic*
13 *significance of [a] an historic property or historic district.*

14 **(3) "Date of application" means the date on which the State Historic Preservation Officer**
15 **determines under ORS 358.490 that an application for classification and special assessment**
16 **as historic property meets the requirements of ORS 358.487.**

17 *[(9) "Developer" means, with respect to a condominium, a declarant who records a declaration*
18 *under ORS 100.100 or a supplemental declaration under ORS 100.110 or any person who purchases*
19 *an interest in a condominium from a declarant, successor declarant or subsequent developer for the*
20 *primary purpose of resale.]*

21 *[(10) (4) "Governing body" means the city or county legislative body having jurisdiction over*
22 *the property that is the subject of an application for **classification and special assessment as***
23 *historic property [special assessment] under ORS 358.487 to 358.543.*

24 *[(11) "Historic property" means real property that:]*

25 *[(a) Is currently listed, either individually or as a contributing resource, in the National Register*
26 *of Historic Places established and maintained under the National Historic Preservation Act of 1966*
27 *(P.L. 89-665);]*

28 *[(b) Is currently not a contributing resource in a listed national register district or property but*
29 *that, in the opinion of the State Historic Preservation Officer, is eligible to become a contributing re-*
30 *source as a result of a proposed preservation plan; or]*

31 *[(c) Has been determined to be eligible for listing in the National Register of Historic Places by the*
32 *State Historic Preservation Officer.]*

33 *[(12) (5) "Historic rehabilitation standards" means the United States Secretary of the Interior's*
34 *Standards for Rehabilitation as in effect on [September 28, 2009] **the effective date of this 2025***
35 **Act.**

36 *[(13) (6) "Maintenance" means action taken to:*

37 **(a)** Mitigate wear and deterioration of [a] **an** historic property without altering the historic
38 character of the property[, *including action taken to*]; **or**

39 **(b)** Protect and repair the condition of the property with the least possible impact on the his-
40 toric character of the property.

41 *[(14) "Owner" means a purchaser of real property under a recorded instrument of sale. In the case*
42 *of multiple purchasers, "owner" may be a designee of the purchasers.]*

43 **(7)(a) "Owner" means:**

44 **(A) A person holding fee simple absolute or fee simple defeasible estate title to real**
45 **property as shown in the property tax records of the county in which the property is located,**

1 including, but not limited to, trusts, limited liability corporations and any other legally or-
2 ganized entity that may hold such title in the State of Oregon.

3 (B) The purchaser of real property under a recorded land sale contract in force for the
4 real property.

5 (C) If the property is owned by the trustee of a revocable trust, the settlor of the
6 revocable trust.

7 (D) The trustee of an irrevocable trust.

8 (b) "Owner" does not mean:

9 (A) Individuals, partnerships, corporations or public agencies holding easements on the
10 property or less than fee interests, including leaseholds, of any nature.

11 (B) The life tenant of a life estate.

12 (8) "Owner's legal representative" means a person who has the legal authority to act on
13 behalf of the owner.

14 [(15)] (9)(a) "Preservation"[:]

15 [(a)] means the act or process of applying measures necessary to sustain the existing form, in-
16 tegrity and materials of an historic property, including but not limited to the ongoing maintenance
17 and repair of historic materials.

18 (b) "Preservation" does not include the extensive replacement of historic materials or new
19 construction.

20 [(16)] "Preservation plan" means a written document, photographs and drawings that outline the
21 work of preservation, maintenance and rehabilitation proposed for completion while the property is re-
22 ceiving historic property special assessment or completed not more than 24 months before the date of
23 application for historic property special assessment.]

24 (10) "Preservation plan" means a written document, photographs and drawings that
25 outline the work of preservation, maintenance and rehabilitation that is proposed for com-
26 pletion during the period for which the property is granted special assessment as historic
27 property.

28 [(17)] (11) "Rehabilitation" means the process of repairing or altering [a] an historic property
29 in order to return the property to a state of utility in which an efficient contemporary use is pos-
30 sible, while preserving those portions and features of the property that are significant to the his-
31 toric, architectural and cultural values of the property.

32 [(18)] (12) "Seismic improvement" means construction or other measures that improve the seis-
33 mic performance or structural stability of property or that reduce the potential for heavy structural
34 damage to property or harm to people in or adjacent to the property in the event of an earthquake.

35 [(19)] "Sustainability" means, with respect to historic property, fulfilling present and future needs
36 by using, without harming, renewable resources and unique human and environmental systems of a
37 site, including air, water, land, energy, human ecology and other sustainable systems.]

38 **SECTION 2.** ORS 358.487 is amended to read:

39 358.487. (1) An owner of [historic] **commercial** property [desiring] **may seek** classification and
40 special assessment **as historic property** under ORS 358.487 to 358.543 for the property [shall
41 apply] **by applying** to the State Historic Preservation Officer on forms approved by the officer.

42 (2) The application must include or be accompanied by:

43 (a) A preservation plan [as defined in ORS 358.480. The preservation plan must commit the ap-
44 plicant to expend, within the first five years for which historic property special assessment is granted,
45 an amount not less than 10 percent of the historic property's real market value determined as of the

1 *assessment date for the first tax year to which the historic property special assessment applies.] that:*

2 **(A) Commits the applicant to expend, within the first five years for which historic prop-**
3 **erty special assessment is granted, an amount not less than 10 percent of the historic**
4 **property's real market value on the last certified assessment and tax roll as of the date of**
5 **application;**

6 **(B)** *[The focus of the preservation plan must be]* **Focuses** on exterior features, especially those
7 visible from a public way, and **on** structural members of the property[.];

8 **(C) Meets the historic rehabilitation standards with respect to work proposed in the plan;**

9 **(D) May include** the treatment of significant interior features, as determined by the State His-
10 toric Preservation Officer[, *may also be included in the plan, but unless specifically required by the*
11 *officer, work in bathrooms, kitchens, basements and attics is not included in the preservation plan.*
12 *Work proposed in the plan must meet the historic rehabilitation standards.]; and*

13 **(E) May address compliance with the Americans with Disabilities Act of 1990 (P.L.**
14 **101-336), as amended, seismic improvements and improvements in energy and water conser-**
15 **vation.**

16 (b) *[Payment of]* An application fee *[equal to:]* **established by the State Historic Preservation**
17 **Officer by rule.**

18 *[(A) One-tenth of one percent of the assessed value of the property, as of the assessment date, for*
19 *the year in which application is made; or]*

20 *[(B) For property that does not have an assessed value, one-tenth of one percent of the product of*
21 *the real market value of the property for the tax year in which the application is made multiplied by*
22 *the ratio of the average maximum assessed value over the average real market value for that tax year*
23 *of property in the same area and property class.]*

24 (c) A copy of the property's current **property** tax statement.

25 *[(d) Proof that the owner has property insurance on the property in an amount equal to the re-*
26 *placement value of the property.]*

27 **(d) Proof that the owner has property insurance on the property in an amount at least**
28 **equal to the real market value of the property on the last certified assessment and tax roll**
29 **as of the date of application.**

30 (e) The written consent of the owner to the viewing of the property by the State Historic Pres-
31 ervation Officer.

32 *[(3) The application must be made before April 1 of the assessment year for which classification*
33 *and special assessment as historic property are desired.]*

34 **(3) The application must be received on or before March 1 of the assessment year for**
35 **which classification and special assessment as historic property are sought.**

36 (4)(a) Property must be classified as historic property in order to be *[certified for]* **specially as-**
37 **essed as** historic property *[special assessment]*.

38 *[(b) Notwithstanding paragraph (a) of this subsection, property may be certified for historic prop-*
39 *erty special assessment upon a determination of eligibility by the State Historic Preservation Officer*
40 *under ORS 358.480 (11)(b) or (c). Property certified under this paragraph must become listed in the*
41 *National Register of Historic Places within two years of certification under ORS 358.490.]*

42 **(b) Property may be classified as historic property if the property:**

43 **(A) Is currently listed, either individually or as a contributing resource, in the National**
44 **Register of Historic Places established and maintained under the National Historic Preser-**
45 **vation Act of 1966 (P.L. 89-665);**

1 **(B) Is a building, structure, object or site that is on or within an historic property cur-**
2 **rently listed in the National Register of Historic Places; or**

3 **(C) In the opinion of the State Historic Preservation Officer, is eligible:**

4 **(i) To become a contributing resource as a result of a proposed preservation plan; or**

5 **(ii) For listing in the National Register of Historic Places.**

6 **(c) Property classified under paragraph (b)(C) of this subsection must become listed in**
7 **the National Register of Historic Places within two years following the property's classifica-**
8 **tion as historic property under ORS 358.490.**

9 *[(5) Classification and special assessment pursuant to an application made under this section are*
10 *granted for 10 consecutive property tax years, starting in the tax year beginning on July 1 of the as-*
11 *essment year described in subsection (3) of this section.]*

12 **(5) An owner of historic property that has been granted historic property special as-**
13 **essment may reapply for another term of special assessment for the property to begin fol-**
14 **lowing the completion of the current term.**

15 *[(6)]* **(6)(a) The application fee required under subsection (2) of this section becomes**
16 **nonrefundable after approval under ORS 358.490 of the application to which the fee relates.**

17 **(b) The application fee** shall be deposited in the State Parks and Recreation Department Fund
18 for use by the State Parks and Recreation Director or for transfer to the Oregon Property Man-
19 agement Account established under ORS 358.680 to 358.690*[, upon the advice of the State Advisory*
20 *Committee on Historic Preservation. The application fee becomes nonrefundable after certification as*
21 *described in ORS 358.495].*

22 **SECTION 3.** ORS 358.490 is amended to read:

23 358.490. (1)(a) After an application is *[submitted]* **filed** under ORS 358.487, the State Historic
24 Preservation Officer:

25 **(A)** Shall *[first review the application to]* determine whether the application meets the require-
26 ments of ORS 358.487; and

27 **(B)** May view the premises **of the property that is the subject of the application.**

28 (b) If the officer determines that the application does not meet the requirements of ORS 358.487,
29 the officer shall *[return the application]* **provide the applicant** with *[an]* **a written** explanation for
30 the *[nonacceptance]* **determination.**

31 (c) If the officer determines that the application *[is complete]* **meets the requirements of ORS**
32 **358.487**, the officer shall mail or otherwise transmit copies of the application to the appropriate
33 county assessor, local landmark commission and governing body.

34 (2) Within 30 days *[from]* **after** the date **on which** the State Historic Preservation Officer
35 transmits the copy of the application under subsection (1)(c) of this section*[,]:*

36 **(a)** The county assessor shall review the application for accuracy and completeness of de-
37 scription and other matters within the expertise of the county assessor*[,]* and shall make recom-
38 mendations regarding the validity and appropriateness of the application to the officer.

39 *[(3)]* **(b)** *[Within 30 days from the date the State Historic Preservation officer transmits the copy*
40 *of the application under subsection (1) of this section,]* The governing body shall review the applica-
41 tion for matters relating to public benefit and shall make recommendations regarding the classi-
42 fication to the officer.

43 *[(4)]* **(3)** During the review process of each application, the State Historic Preservation Officer
44 shall consider the county assessor's and governing body's recommendations submitted under *[sub-*
45 *sections (2) and (3)]* **subsection (2)** of this section.

1 [(5)(a)] **(4)(a)** After *[receiving]* **considering the** recommendations from the county assessor and
 2 governing body under *[subsections (2) and (3)]* **subsection (3)** of this section, the State Historic
 3 Preservation Officer shall approve or deny the application or approve the application with condi-
 4 tions.

5 (b) The officer may approve the application with respect to only part of the property that is the
 6 subject of the application. However, if any part of the application is denied, the applicant may
 7 withdraw the application.

8 (c) The officer may not *[disapprove the]* **deny an** application solely because of the potential loss
 9 of revenue that might result from granting the *[application]* **special assessment**.

10 **(d) An application that has not been denied under paragraph (a) of this subsection on or**
 11 **before July 1 of the assessment year is deemed approved.**

12 **(e) The approval of an application under this section has the effect of classifying the**
 13 **property that is the subject of the application as historic property and granting the property**
 14 **special assessment under ORS 358.487 to 358.543.**

15 [(6)] **(5)** Property classified as historic property *[under ORS 358.487 to 358.543]* **and granted**
 16 **special assessment under this section** is entitled to any other exemption or special assessment
 17 provided by law **for which the property is eligible**.

18 [(7)] **(6)** A preservation plan that has been approved by the State Historic Preservation Officer
 19 may be amended from time to time, *[either]* at the request of the owner or *[at the request of the State*
 20 *Historic Preservation]* **the** officer. The amendments may be approved, approved in part or *[disap-*
 21 *proved]* **denied** by the *[State Historic Preservation]* officer. *[To the extent the]* **Any** amendments **that**
 22 are approved, *[amendments shall]* become part of the preservation plan *[that must be carried out in*
 23 *order that the property not be disqualified as historic property]* **and are subject to all applicable**
 24 **requirements as if the amendments had been included in the original preservation plan.**

25 **SECTION 4.** ORS 358.495 is amended to read:

26 358.495. [(1)(a)] **(1)** *[Immediately]* **As soon as practicable** following approval or *[disapproval]*
 27 **denial** of an application under ORS 358.490, **but in no event later than July 1 of the property**
 28 **tax year for which classification and special assessment as historic property are first sought,**
 29 the State Historic Preservation Officer shall notify *[the county assessor,]* **in writing:**

30 **(a)** The governing body and the applicant of the decision *[in writing not later than July 1 of the*
 31 *tax year for which classification and special assessment are first desired.]; and*

32 **(b) If the application is approved, the county assessor.**

33 *[(b) An application not denied on or before July 1 pursuant to paragraph (a) of this subsection is*
 34 *deemed approved, and the property that is the subject of the application is historic property that qual-*
 35 *ifies under ORS 358.487 to 358.543.]*

36 (2) *[If the State Historic Preservation officer determines that the historic property qualifies under*
 37 *ORS 358.487 to 358.543, the officer shall,]* **For each application that is approved:**

38 **(a)** Not later than July 1 of the **first property** tax year for which the property **that is the**
 39 **subject of the application** is *[first certified for]* **granted** historic property special assessment, **the**
 40 **State Historic Preservation Officer shall:**

41 [(a)] **(A)** Notify the local landmark commission **in writing** that the property *[is certified.]* **has**
 42 **been classified and granted special assessment as historic property;**

43 *[(b) Certify the property's qualification in writing and file a copy of the certificate with the county*
 44 *assessor and the governing body. The certificate shall state the facts and list any condition on which*
 45 *the approval is based.]*

1 (B) Create a written record that states the facts and lists any condition on which the
2 special assessment is based; and

3 (C) Provide a written statement to the county assessor and the governing body that the
4 property has been classified and granted special assessment as historic property, and provide
5 a copy of the written statement to the owner of the historic property.

6 [(c)] (b) Within 90 days after providing the written statement under paragraph (a)(C) of
7 this subsection, the officer shall record a notice with the county clerk in the county in which the
8 [certified] historic property is located stating that the property [is certified for] has been classified
9 and granted special assessment as historic property [special assessment].

10 [(d)] (c) Within one year after receiving the copy of the written statement under para-
11 graph (a)(C) of this subsection, [provide the owner of the property with a plaque.] the owner shall
12 install [the] a plaque on the historic property in a location that is visible from a public right of way.

13 (3) The county assessor shall assess [historic property certified under this section on the basis
14 provided in] historic property granted special assessment under ORS 358.490 in accordance
15 with ORS 358.505, and, for each property tax year that the historic property is [classified and

17 property is being specially assessed as historic property, and is subject to potential additional taxes
18 as provided in ORS 358.525, by adding the notation “historic property (potential additional tax).”

21 the State Historic Preservation Officer shall give written notice of the denial to the applicant. The

23 [(5)(a)] (5) Any owner, governing body or county assessor [affected] aggrieved by a determi-
24 nation of the State Historic Preservation Officer made under ORS 358.487 to 358.543 may request
25 [review of the determination:] a contested case hearing of the determination according to the
26 provisions of ORS chapter 183. The administrative law judge presiding at the contested case
27 hearing shall determine the final order in the case.

28 [(A) Pursuant to an appeal process established by the local governing body, if any; or]

36 from special assessment as provided under ORS 358.487 to 358.543 as those sections were in existence
37 and in effect on December 31, 1992.]

38 [(2)] (1) Property may be classified and specially assessed as historic property under ORS
39 358.487 to 358.543 pursuant to an application filed under ORS 358.487 on or after September 9, 1995,
40 and first applicable for the property tax year 1996-1997 or any property tax year thereafter.

41 [(3)] (2) Property may not be classified and specially assessed as historic property pursuant to
42 an application filed under ORS [358.487 or] 358.540, [if the application is filed] as in effect on the
43 day that is immediately before the effective date of this 2025 Act, on or after July 1, [2024]
44 2031, for property tax years beginning on or after July 1, [2025] 2032.

3 358.500. (1)(a) The owner of property [*certified for special assessment as historic property under*
4 *ORS 358.490*] **classified and specially assessed as historic property under ORS 358.480 to**
5 **358.545** shall submit written progress reports concerning the preservation plan to the State Historic
6 Preservation Officer in a form, **on a schedule and including content** prescribed by the officer, on
7 or before December 31 [*of*] **for the property tax years ending on June 30 of** the third, sixth and
8 ninth years of the **period for which the** historic property [*special assessment period under ORS*
9 *358.487 to 358.543*] **is specially assessed.**

20 [*property for historic*] property **for** classification and special assessment **as historic property.** [*The*
21 *content of reports and times for reporting under this subsection shall be determined by the officer.*]

23 **fails** to comply with the officer's demand, the officer shall immediately notify the **county** assessor

4 OR PARCEL, TO VERIFY THE EXISTENCE OF FIRE PROTECTION FOR STRUCTURES AND
5 TO INQUIRE ABOUT THE RIGHTS OF NEIGHBORING PROPERTY OWNERS, IF ANY, UNDER
6 ORS 195.300, 195.301 AND 195.305 TO 195.336 AND SECTIONS 5 TO 11, CHAPTER 424, OREGON
7 LAWS 2007, SECTIONS 2 TO 9 AND 17, CHAPTER 855, OREGON LAWS 2009, AND SECTIONS
8 2 TO 7, CHAPTER 8, OREGON LAWS 2010.”

9 (3) In all owners’ sale agreements and earnest money receipts **related to property** subject to
10 ORS 358.505, there shall be included in the body of the instrument or by addendum the following
11 statement: “THE PROPERTY DESCRIBED IN THIS INSTRUMENT IS SUBJECT TO SPECIAL
12 ASSESSMENT UNDER ORS 358.505.”

13 (4) An action may not be maintained against the county recording officer for recording an in-
14 strument that does not contain the statement required in subsection (1) or (2) of this section.

15 (5) An action may not be maintained against any person for failure to include in the instrument
16 the statement required in subsection (1) or (2) of this section, or for recording an instrument that
17 does not contain the statement required in subsection (1) or (2) of this section, unless the person
18 acquiring or agreeing to acquire fee title to the real property would not have executed or accepted
19 the instrument but for the absence in the instrument of the statement required by subsection (1) or
20 (2) of this section. An action may not be maintained by the person acquiring or agreeing to acquire
21 fee title to the real property against any person other than the person transferring or contracting
22 to transfer fee title to the real property.

23 (6) A transfer [of] **on** death deed and an instrument revoking a transfer [of] **on** death deed are
24 not instruments subject to this section.

25 **SECTION 17.** ORS 215.213 is amended to read:

26 215.213. (1) In counties that have adopted marginal lands provisions under ORS 197.247 (1991
27 Edition), the following uses may be established in any area zoned for exclusive farm use:

28 (a) Churches and cemeteries in conjunction with churches.

29 (b) The propagation or harvesting of a forest product.

30 (c) Utility facilities necessary for public service, including wetland waste treatment systems but
31 not including commercial facilities for the purpose of generating electrical power for public use by
32 sale or transmission towers over 200 feet in height. A utility facility necessary for public service
33 may be established as provided in:

34 (A) ORS 215.275; or

35 (B) If the utility facility is an associated transmission line, as defined in ORS 215.274 and
36 469.300.

37 (d) A dwelling on real property used for farm use if the dwelling is occupied by a relative of the
38 farm operator or the farm operator’s spouse, which means a child, parent, stepparent, grandchild,
39 grandparent, stepgrandparent, sibling, stepsibling, niece, nephew or first cousin of either, if the farm
40 operator does or will require the assistance of the relative in the management of the farm use and
41 the dwelling is located on the same lot or parcel as the dwelling of the farm operator.
42 Notwithstanding ORS 92.010 to 92.192 or the minimum lot or parcel size requirements under ORS
43 215.780, if the owner of a dwelling described in this paragraph obtains construction financing or
44 other financing secured by the dwelling and the secured party forecloses on the dwelling, the se-
45 cured party may also foreclose on the homesite, as defined in ORS 308A.250, and the foreclosure

1 shall operate as a partition of the homesite to create a new parcel.

2 (e) Nonresidential buildings customarily provided in conjunction with farm use.

3 (f) Subject to ORS 215.279, primary or accessory dwellings customarily provided in conjunction
4 with farm use. For a primary dwelling, the dwelling must be on a lot or parcel that is managed as
5 part of a farm operation and is not smaller than the minimum lot size in a farm zone with a minimum
6 lot size acknowledged under ORS 197.251.

7 (g) Operations for the exploration for and production of geothermal resources as defined by ORS
8 522.005 and oil and gas as defined by ORS 520.005, including the placement and operation of
9 compressors, separators and other customary production equipment for an individual well adjacent
10 to the wellhead. Any activities or construction relating to such operations shall not be a basis for
11 an exception under ORS 197.732 (2)(a) or (b).

12 (h) Operations for the exploration for minerals as defined by ORS 517.750. Any activities or
13 construction relating to such operations shall not be a basis for an exception under ORS 197.732
14 (2)(a) or (b).

15 (i) One manufactured dwelling or recreational vehicle, or the temporary residential use of an
16 existing building, in conjunction with an existing dwelling as a temporary use for the term of a
17 hardship suffered by the existing resident or a relative of the resident. Within three months of the
18 end of the hardship, the manufactured dwelling or recreational vehicle shall be removed or demol-
19 ished or, in the case of an existing building, the building shall be removed, demolished or returned
20 to an allowed nonresidential use. The governing body or its designee shall provide for periodic re-
21 view of the hardship claimed under this paragraph. A temporary residence approved under this
22 paragraph is not eligible for replacement under paragraph (q) of this subsection.

23 (j) Climbing and passing lanes within the right of way existing as of July 1, 1987.

24 (k) Reconstruction or modification of public roads and highways, including the placement of
25 utility facilities overhead and in the subsurface of public roads and highways along the public right
26 of way, but not including the addition of travel lanes, where no removal or displacement of buildings
27 would occur, or no new land parcels result.

28 (L) Temporary public road and highway detours that will be abandoned and restored to original
29 condition or use at such time as no longer needed.

30 (m) Minor betterment of existing public road and highway related facilities, such as maintenance
31 yards, weigh stations and rest areas, within right of way existing as of July 1, 1987, and contiguous
32 public-owned property utilized to support the operation and maintenance of public roads and high-
33 ways.

34 (n) A replacement dwelling to be used in conjunction with farm use if the existing dwelling has
35 been [*listed in a county inventory as historic property as defined in ORS 358.480*] **classified as his-**
36 **toric property as described in ORS 358.487 (4).**

37 (o) Creation, restoration or enhancement of wetlands.

38 (p) A winery, as described in ORS 215.452 or 215.453.

39 (q) Alteration, restoration or replacement of a lawfully established dwelling, as described in ORS
40 215.291.

41 (r) Farm stands if:

42 (A) The structures are designed and used for the sale of farm crops or livestock grown on the
43 farm operation, or grown on the farm operation and other farm operations in the local agricultural
44 area, including the sale of retail incidental items and fee-based activity to promote the sale of farm
45 crops or livestock sold at the farm stand if the annual sale of incidental items and fees from pro-

1 motional activity do not make up more than 25 percent of the total annual sales of the farm stand;
2 and

3 (B) The farm stand does not include structures designed for occupancy as a residence or for
4 activity other than the sale of farm crops or livestock and does not include structures for banquets,
5 public gatherings or public entertainment.

6 (s) An armed forces reserve center, if the center is within one-half mile of a community college.
7 For purposes of this paragraph, "armed forces reserve center" includes an armory or National
8 Guard support facility.

9 (t) A site for the takeoff and landing of model aircraft, including such buildings or facilities as
10 may reasonably be necessary. Buildings or facilities shall not be more than 500 square feet in floor
11 area or placed on a permanent foundation unless the building or facility preexisted the use approved
12 under this paragraph. The site shall not include an aggregate surface or hard surface area unless
13 the surface preexisted the use approved under this paragraph. An owner of property used for the
14 purpose authorized in this paragraph may charge a person operating the use on the property rent
15 for the property. An operator may charge users of the property a fee that does not exceed the
16 operator's cost to maintain the property, buildings and facilities. As used in this paragraph, "model
17 aircraft" means a small-scale version of an airplane, glider, helicopter, dirigible or balloon that is
18 used or intended to be used for flight and is controlled by radio, lines or design by a person on the
19 ground.

20 (u) A facility for the processing of farm products as described in ORS 215.255.

21 (v) Fire service facilities providing rural fire protection services.

22 (w) Irrigation reservoirs, canals, delivery lines and those structures and accessory operational
23 facilities, not including parks or other recreational structures and facilities, associated with a dis-
24 trict as defined in ORS 540.505.

25 (x) Utility facility service lines. Utility facility service lines are utility lines and accessory fa-
26 cilities or structures that end at the point where the utility service is received by the customer and
27 that are located on one or more of the following:

28 (A) A public right of way;

29 (B) Land immediately adjacent to a public right of way, provided the written consent of all ad-
30 jacent property owners has been obtained; or

31 (C) The property to be served by the utility.

32 (y) Subject to the issuance of a license, permit or other approval by the Department of Envi-
33 ronmental Quality under ORS 454.695, 459.205, 468B.050, 468B.053 or 468B.055, or in compliance with
34 rules adopted under ORS 468B.095, and as provided in ORS 215.246 to 215.251, the land application
35 of reclaimed water, agricultural or industrial process water or biosolids, or the onsite treatment of
36 septage prior to the land application of biosolids, for agricultural, horticultural or silvicultural pro-
37 duction, or for irrigation in connection with a use allowed in an exclusive farm use zone under this
38 chapter. For the purposes of this paragraph, onsite treatment of septage prior to the land application
39 of biosolids is limited to treatment using treatment facilities that are portable, temporary and
40 transportable by truck trailer, as defined in ORS 801.580, during a period of time within which land
41 application of biosolids is authorized under the license, permit or other approval.

42 (z) Dog training classes or testing trials, which may be conducted outdoors or in farm buildings
43 in existence on January 1, 2019, when:

44 (A) The number of dogs participating in training does not exceed 10 dogs per training class and
45 the number of training classes to be held on-site does not exceed six per day; and

1 (B) The number of dogs participating in a testing trial does not exceed 60 and the number of
2 testing trials to be conducted on-site is limited to four or fewer trials per calendar year.

3 (aa) A cider business, as described in ORS 215.451.

4 (bb) A farm brewery, as described in ORS 215.449.

5 (2) In counties that have adopted marginal lands provisions under ORS 197.247 (1991 Edition),
6 the following uses may be established in any area zoned for exclusive farm use subject to ORS
7 215.296:

8 (a) A primary dwelling in conjunction with farm use or the propagation or harvesting of a forest
9 product on a lot or parcel that is managed as part of a farm operation or woodlot if the farm op-
10 eration or woodlot:

11 (A) Consists of 20 or more acres; and

12 (B) Is not smaller than the average farm or woodlot in the county producing at least \$2,500 in
13 annual gross income from the crops, livestock or forest products to be raised on the farm operation
14 or woodlot.

15 (b) A primary dwelling in conjunction with farm use or the propagation or harvesting of a forest
16 product on a lot or parcel that is managed as part of a farm operation or woodlot smaller than re-
17 quired under paragraph (a) of this subsection, if the lot or parcel:

18 (A) Has produced at least \$20,000 in annual gross farm income in two consecutive calendar
19 years out of the three calendar years before the year in which the application for the dwelling was
20 made or is planted in perennials capable of producing upon harvest an average of at least \$20,000
21 in annual gross farm income; or

22 (B) Is a woodlot capable of producing an average over the growth cycle of \$20,000 in gross an-
23 nual income.

24 (c) Commercial activities that are in conjunction with farm use, including the processing of farm
25 crops into biofuel not permitted under ORS 215.203 (2)(b)(K) or 215.255.

26 (d) Operations conducted for:

27 (A) Mining and processing of geothermal resources as defined by ORS 522.005 and oil and gas
28 as defined by ORS 520.005, not otherwise permitted under subsection (1)(g) of this section;

29 (B) Mining, crushing or stockpiling of aggregate and other mineral and other subsurface re-
30 sources subject to ORS 215.298;

31 (C) Processing, as defined by ORS 517.750, of aggregate into asphalt or portland cement; and

32 (D) Processing of other mineral resources and other subsurface resources.

33 (e) Community centers owned by a governmental agency or a nonprofit community organization
34 and operated primarily by and for residents of the local rural community, hunting and fishing pre-
35 serves, public and private parks, playgrounds and campgrounds. Subject to the approval of the
36 county governing body or its designee, a private campground may provide yurts for overnight
37 camping. No more than one-third or a maximum of 10 campsites, whichever is smaller, may include
38 a yurt. The yurt shall be located on the ground or on a wood floor with no permanent foundation.
39 Upon request of a county governing body, the Land Conservation and Development Commission may
40 provide by rule for an increase in the number of yurts allowed on all or a portion of the
41 campgrounds in a county if the commission determines that the increase will comply with the stan-
42 dards described in ORS 215.296 (1). A public park or campground may be established as provided
43 under ORS 195.120. As used in this paragraph, "yurt" means a round, domed shelter of cloth or
44 canvas on a collapsible frame with no plumbing, sewage disposal hookup or internal cooking appli-
45 ance.

1 (f) Golf courses on land determined not to be high-value farmland as defined in ORS 195.300.

2 (g) Commercial utility facilities for the purpose of generating power for public use by sale. If the
3 area zoned for exclusive farm use is high-value farmland, a photovoltaic solar power generation fa-
4 cility may be established as a commercial utility facility as provided in ORS 215.447. A renewable
5 energy facility as defined in ORS 215.446 may be established as a commercial utility facility.

6 (h) Personal-use airports for airplanes and helicopter pads, including associated hangar, main-
7 tenance and service facilities. A personal-use airport as used in this section means an airstrip re-
8 stricted, except for aircraft emergencies, to use by the owner, and, on an infrequent and occasional
9 basis, by invited guests, and by commercial aviation activities in connection with agricultural op-
10 erations. No aircraft may be based on a personal-use airport other than those owned or controlled
11 by the owner of the airstrip. Exceptions to the activities permitted under this definition may be
12 granted through waiver action by the Oregon Department of Aviation in specific instances. A
13 personal-use airport lawfully existing as of September 13, 1975, shall continue to be permitted sub-
14 ject to any applicable rules of the Oregon Department of Aviation.

15 (i) A facility for the primary processing of forest products, provided that such facility is found
16 to not seriously interfere with accepted farming practices and is compatible with farm uses de-
17 scribed in ORS 215.203 (2). Such a facility may be approved for a one-year period which is
18 renewable. These facilities are intended to be only portable or temporary in nature. The primary
19 processing of a forest product, as used in this section, means the use of a portable chipper or stud
20 mill or other similar methods of initial treatment of a forest product in order to enable its shipment
21 to market. Forest products, as used in this section, means timber grown upon a parcel of land or
22 contiguous land where the primary processing facility is located.

23 (j) A site for the disposal of solid waste approved by the governing body of a city or county or
24 both and for which a permit has been granted under ORS 459.245 by the Department of Environ-
25 mental Quality together with equipment, facilities or buildings necessary for its operation.

26 (k)(A) Commercial dog boarding kennels; or

27 (B) Dog training classes or testing trials that cannot be established under subsection (1)(z) of
28 this section.

29 (L) Residential homes as defined in ORS 197.660, in existing dwellings.

30 (m) The propagation, cultivation, maintenance and harvesting of aquatic species that are not
31 under the jurisdiction of the State Fish and Wildlife Commission or insect species. Insect species
32 shall not include any species under quarantine by the State Department of Agriculture or the United
33 States Department of Agriculture. The county shall provide notice of all applications under this
34 paragraph to the State Department of Agriculture. Notice shall be provided in accordance with the
35 county's land use regulations but shall be mailed at least 20 calendar days prior to any administra-
36 tive decision or initial public hearing on the application.

37 (n) Home occupations as provided in ORS 215.448.

38 (o) Transmission towers over 200 feet in height.

39 (p) Construction of additional passing and travel lanes requiring the acquisition of right of way
40 but not resulting in the creation of new land parcels.

41 (q) Reconstruction or modification of public roads and highways involving the removal or dis-
42 placement of buildings but not resulting in the creation of new land parcels.

43 (r) Improvement of public road and highway related facilities such as maintenance yards, weigh
44 stations and rest areas, where additional property or right of way is required but not resulting in
45 the creation of new land parcels.

1 (s) A destination resort that is approved consistent with the requirements of any statewide
2 planning goal relating to the siting of a destination resort.

3 (t) Room and board arrangements for a maximum of five unrelated persons in existing resi-
4 dences.

5 (u) A living history museum related to resource based activities owned and operated by a gov-
6 ernmental agency or a local historical society, together with limited commercial activities and fa-
7 cilities that are directly related to the use and enjoyment of the museum and located within
8 authentic buildings of the depicted historic period or the museum administration building, if areas
9 other than an exclusive farm use zone cannot accommodate the museum and related activities or if
10 the museum administration buildings and parking lot are located within one quarter mile of the
11 metropolitan urban growth boundary. As used in this paragraph:

12 (A) "Living history museum" means a facility designed to depict and interpret everyday life and
13 culture of some specific historic period using authentic buildings, tools, equipment and people to
14 simulate past activities and events; and

15 (B) "Local historical society" means the local historical society, recognized as such by the
16 county governing body and organized under ORS chapter 65.

17 (v) Operations for the extraction and bottling of water.

18 (w) An aerial fireworks display business that has been in continuous operation at its current
19 location within an exclusive farm use zone since December 31, 1986, and possesses a wholesaler's
20 permit to sell or provide fireworks.

21 (x) A landscape contracting business, as defined in ORS 671.520, or a business providing land-
22 scape architecture services, as described in ORS 671.318, if the business is pursued in conjunction
23 with the growing and marketing of nursery stock on the land that constitutes farm use.

24 (y) Public or private schools for kindergarten through grade 12, including all buildings essential
25 to the operation of a school, primarily for residents of the rural area in which the school is located.

26 (z) Equine and equine-affiliated therapeutic and counseling activities, provided:

27 (A) The activities are conducted in existing buildings that were lawfully constructed on the
28 property before January 1, 2019, or in new buildings that are accessory, incidental and subordinate
29 to the farm use on the tract; and

30 (B) All individuals conducting therapeutic or counseling activities are acting within the proper
31 scope of any licenses required by the state.

32 (aa) Child care facilities, preschool recorded programs or school-age recorded programs that are:

33 (A) Authorized under ORS 329A.250 to 329A.450;

34 (B) Primarily for the children of residents and workers of the rural area in which the facility
35 or program is located; and

36 (C) Colocated with a community center or a public or private school allowed under this sub-
37 section.

38 (3) In counties that have adopted marginal lands provisions under ORS 197.247 (1991 Edition),
39 a single-family residential dwelling not provided in conjunction with farm use may be established
40 on a lot or parcel with soils predominantly in capability classes IV through VIII as determined by
41 the Agricultural Capability Classification System in use by the United States Department of Agri-
42 culture Soil Conservation Service on October 15, 1983. A proposed dwelling is subject to approval
43 of the governing body or its designee in any area zoned for exclusive farm use upon written findings
44 showing all of the following:

45 (a) The dwelling or activities associated with the dwelling will not force a significant change in

1 or significantly increase the cost of accepted farming practices on nearby lands devoted to farm use.

2 (b) The dwelling is situated upon generally unsuitable land for the production of farm crops and
3 livestock, considering the terrain, adverse soil or land conditions, drainage and flooding, location
4 and size of the tract. A lot or parcel shall not be considered unsuitable solely because of its size
5 or location if it can reasonably be put to farm use in conjunction with other land.

6 (c) Complies with such other conditions as the governing body or its designee considers neces-
7 sary.

8 (4) In counties that have adopted marginal lands provisions under ORS 197.247 (1991 Edition),
9 one single-family dwelling, not provided in conjunction with farm use, may be established in any
10 area zoned for exclusive farm use on a lot or parcel described in subsection (7) of this section that
11 is not larger than three acres upon written findings showing:

12 (a) The dwelling or activities associated with the dwelling will not force a significant change in
13 or significantly increase the cost of accepted farming practices on nearby lands devoted to farm use;

14 (b) If the lot or parcel is located within the Willamette River Greenway, a floodplain or a
15 geological hazard area, the dwelling complies with conditions imposed by local ordinances relating
16 specifically to the Willamette River Greenway, floodplains or geological hazard areas, whichever is
17 applicable; and

18 (c) The dwelling complies with other conditions considered necessary by the governing body or
19 its designee.

20 (5) Upon receipt of an application for a permit under subsection (4) of this section, the governing
21 body shall notify:

22 (a) Owners of land that is within 250 feet of the lot or parcel on which the dwelling will be es-
23 tablished; and

24 (b) Persons who have requested notice of such applications and who have paid a reasonable fee
25 imposed by the county to cover the cost of such notice.

26 (6) The notice required in subsection (5) of this section shall specify that persons have 15 days
27 following the date of postmark of the notice to file a written objection on the grounds only that the
28 dwelling or activities associated with it would force a significant change in or significantly increase
29 the cost of accepted farming practices on nearby lands devoted to farm use. If no objection is re-
30 ceived, the governing body or its designee shall approve or disapprove the application. If an ob-
31 jection is received, the governing body shall set the matter for hearing in the manner prescribed in
32 ORS 215.402 to 215.438. The governing body may charge the reasonable costs of the notice required
33 by subsection (5)(a) of this section to the applicant for the permit requested under subsection (4) of
34 this section.

35 (7) Subsection (4) of this section applies to a lot or parcel lawfully created between January 1,
36 1948, and July 1, 1983. For the purposes of this section:

37 (a) Only one lot or parcel exists if:

38 (A) A lot or parcel described in this section is contiguous to one or more lots or parcels de-
39 scribed in this section; and

40 (B) On July 1, 1983, greater than possessory interests are held in those contiguous lots, parcels
41 or lots and parcels by the same person, spouses or a single partnership or business entity, separately
42 or in tenancy in common.

43 (b) "Contiguous" means lots, parcels or lots and parcels that have a common boundary, including
44 but not limited to, lots, parcels or lots and parcels separated only by a public road.

45 (8) A person who sells or otherwise transfers real property in an exclusive farm use zone may

1 retain a life estate in a dwelling on that property and in a tract of land under and around the
2 dwelling.

3 (9) No final approval of a nonfarm use under this section shall be given unless any additional
4 taxes imposed upon the change in use have been paid.

5 (10) Roads, highways and other transportation facilities and improvements not allowed under
6 subsections (1) and (2) of this section may be established, subject to the approval of the governing
7 body or its designee, in areas zoned for exclusive farm use subject to:

8 (a) Adoption of an exception to the goal related to agricultural lands and to any other applicable
9 goal with which the facility or improvement does not comply; or

10 (b) ORS 215.296 for those uses identified by rule of the Land Conservation and Development
11 Commission as provided in section 3, chapter 529, Oregon Laws 1993.

12 (11) The following agri-tourism and other commercial events or activities that are related to and
13 supportive of agriculture may be established in any area zoned for exclusive farm use:

14 (a) A county may authorize a single agri-tourism or other commercial event or activity on a
15 tract in a calendar year by an authorization that is personal to the applicant and is not transferred
16 by, or transferable with, a conveyance of the tract, if the agri-tourism or other commercial event
17 or activity meets any local standards that apply and:

18 (A) The agri-tourism or other commercial event or activity is incidental and subordinate to ex-
19 isting farm use on the tract;

20 (B) The duration of the agri-tourism or other commercial event or activity does not exceed 72
21 consecutive hours;

22 (C) The maximum attendance at the agri-tourism or other commercial event or activity does not
23 exceed 500 people;

24 (D) The maximum number of motor vehicles parked at the site of the agri-tourism or other
25 commercial event or activity does not exceed 250 vehicles;

26 (E) The agri-tourism or other commercial event or activity complies with ORS 215.296;

27 (F) The agri-tourism or other commercial event or activity occurs outdoors, in temporary
28 structures, or in existing permitted structures, subject to health and fire and life safety require-
29 ments; and

30 (G) The agri-tourism or other commercial event or activity complies with conditions established
31 for:

32 (i) Planned hours of operation;

33 (ii) Access, egress and parking;

34 (iii) A traffic management plan that identifies the projected number of vehicles and any antic-
35 ipated use of public roads; and

36 (iv) Sanitation and solid waste.

37 (b) In the alternative to paragraphs (a) and (c) of this subsection, a county may authorize,
38 through an expedited, single-event license, a single agri-tourism or other commercial event or ac-
39 tivity on a tract in a calendar year by an expedited, single-event license that is personal to the ap-
40 plicant and is not transferred by, or transferable with, a conveyance of the tract. A decision
41 concerning an expedited, single-event license is not a land use decision, as defined in ORS 197.015.
42 To approve an expedited, single-event license, the governing body of a county or its designee must
43 determine that the proposed agri-tourism or other commercial event or activity meets any local
44 standards that apply, and the agri-tourism or other commercial event or activity:

45 (A) Must be incidental and subordinate to existing farm use on the tract;

- 1 (B) May not begin before 6 a.m. or end after 10 p.m.;
- 2 (C) May not involve more than 100 attendees or 50 vehicles;
- 3 (D) May not include the artificial amplification of music or voices before 8 a.m. or after 8 p.m.;
- 4 (E) May not require or involve the construction or use of a new permanent structure in con-
- 5 nection with the agri-tourism or other commercial event or activity;
- 6 (F) Must be located on a tract of at least 10 acres unless the owners or residents of adjoining
- 7 properties consent, in writing, to the location; and
- 8 (G) Must comply with applicable health and fire and life safety requirements.
- 9 (c) In the alternative to paragraphs (a) and (b) of this subsection, a county may authorize up to
- 10 six agri-tourism or other commercial events or activities on a tract in a calendar year by a limited
- 11 use permit that is personal to the applicant and is not transferred by, or transferable with, a
- 12 conveyance of the tract. The agri-tourism or other commercial events or activities must meet any
- 13 local standards that apply, and the agri-tourism or other commercial events or activities:
- 14 (A) Must be incidental and subordinate to existing farm use on the tract;
- 15 (B) May not, individually, exceed a duration of 72 consecutive hours;
- 16 (C) May not require that a new permanent structure be built, used or occupied in connection
- 17 with the agri-tourism or other commercial events or activities;
- 18 (D) Must comply with ORS 215.296;
- 19 (E) May not, in combination with other agri-tourism or other commercial events or activities
- 20 authorized in the area, materially alter the stability of the land use pattern in the area; and
- 21 (F) Must comply with conditions established for:
- 22 (i) The types of agri-tourism or other commercial events or activities that are authorized during
- 23 each calendar year, including the number and duration of the agri-tourism or other commercial
- 24 events and activities, the anticipated daily attendance and the hours of operation;
- 25 (ii) The location of existing structures and the location of proposed temporary structures to be
- 26 used in connection with the agri-tourism or other commercial events or activities;
- 27 (iii) The location of access and egress and parking facilities to be used in connection with the
- 28 agri-tourism or other commercial events or activities;
- 29 (iv) Traffic management, including the projected number of vehicles and any anticipated use of
- 30 public roads; and
- 31 (v) Sanitation and solid waste.
- 32 (d) In addition to paragraphs (a) to (c) of this subsection, a county may authorize agri-tourism
- 33 or other commercial events or activities that occur more frequently or for a longer period or that
- 34 do not otherwise comply with paragraphs (a) to (c) of this subsection if the agri-tourism or other
- 35 commercial events or activities comply with any local standards that apply and the agri-tourism or
- 36 other commercial events or activities:
- 37 (A) Are incidental and subordinate to existing commercial farm use of the tract and are neces-

- 43 (12) A holder of a permit authorized by a county under subsection (11)(d) of this section must
- 44 request review of the permit at four-year intervals. Upon receipt of a request for review, the county
- 45 shall:

1 (a) Provide public notice and an opportunity for public comment as part of the review process;
2 and

3 (b) Limit its review to events and activities authorized by the permit, conformance with condi-
4 tions of approval required by the permit and the standards established by subsection (11)(d) of this
5 section.

6 (13) For the purposes of subsection (11) of this section:

7 (a) A county may authorize the use of temporary structures established in connection with the
8 agri-tourism or other commercial events or activities authorized under subsection (11) of this sec-

21 events and activities.

22 **SECTION 18.** ORS 215.283 is amended to read:

23 215.283. (1) The following uses may be established in any area zoned for exclusive farm use:

24 (a) Churches and cemeteries in conjunction with churches.

25 (b) The propagation or harvesting of a forest product.

26 (c) Utility facilities necessary for public service, including wetland waste treatment systems but
27 not including commercial facilities for the purpose of generating electrical power for public use by
28 sale or transmission towers over 200 feet in height. A utility facility necessary for public service
29 may be established as provided in:

30 (A) ORS 215.275; or

31 (B) If the utility facility is an associated transmission line, as defined in ORS 215.274 and
32 469.300.

33 (d) A dwelling on real property used for farm use if the dwelling is occupied by a relative of the
34 farm operator or the farm operator’s spouse, which means a child, parent, stepparent, grandchild,
35 grandparent, stepgrandparent, sibling, stepsibling, niece, nephew or first cousin of either, if the farm
36 operator does or will require the assistance of the relative in the management of the farm use and
37 the dwelling is located on the same lot or parcel as the dwelling of the farm operator.
38 Notwithstanding ORS 92.010 to 92.192 or the minimum lot or parcel size requirements under ORS
39 215.780, if the owner of a dwelling described in this paragraph obtains construction financing or
40 other financing secured by the dwelling and the secured party forecloses on the dwelling, the se-
41 cured party may also foreclose on the homesite, as defined in ORS 308A.250, and the foreclosure
42 shall operate as a partition of the homesite to create a new parcel.

43 (e) Subject to ORS 215.279, primary or accessory dwellings and other buildings customarily
44 provided in conjunction with farm use.

45 (f) Operations for the exploration for and production of geothermal resources as defined by ORS

1 522.005 and oil and gas as defined by ORS 520.005, including the placement and operation of
2 compressors, separators and other customary production equipment for an individual well adjacent
3 to the wellhead. Any activities or construction relating to such operations shall not be a basis for
4 an exception under ORS 197.732 (2)(a) or (b).

5 (g) Operations for the exploration for minerals as defined by ORS 517.750. Any activities or
6 construction relating to such operations shall not be a basis for an exception under ORS 197.732
7 (2)(a) or (b).

8 (h) Climbing and passing lanes within the right of way existing as of July 1, 1987.

9 (i) Reconstruction or modification of public roads and highways, including the placement of
10 utility facilities overhead and in the subsurface of public roads and highways along the public right
11 of way, but not including the addition of travel lanes, where no removal or displacement of buildings
12 would occur, or no new land parcels result.

13 (j) Temporary public road and highway detours that will be abandoned and restored to original
14 condition or use at such time as no longer needed.

15 (k) Minor betterment of existing public road and highway related facilities such as maintenance
16 yards, weigh stations and rest areas, within right of way existing as of July 1, 1987, and contiguous
17 public-owned property utilized to support the operation and maintenance of public roads and high-
18 ways.

19 (L) A replacement dwelling to be used in conjunction with farm use if the existing dwelling has
20 been *[listed in a county inventory as historic property as defined in ORS 358.480]* **classified as his-**
21 **toric property as described in ORS 358.487 (4).**

22 (m) Creation, restoration or enhancement of wetlands.

23 (n) A winery, as described in ORS 215.452 or 215.453.

24 (o) Farm stands if:

25 (A) The structures are designed and used for the sale of farm crops or livestock grown on the
26 farm operation, or grown on the farm operation and other farm operations in the local agricultural
27 area, including the sale of retail incidental items and fee-based activity to promote the sale of farm
28 crops or livestock sold at the farm stand if the annual sale of incidental items and fees from pro-
29 motional activity do not make up more than 25 percent of the total annual sales of the farm stand;
30 and

31 (B) The farm stand does not include structures designed for occupancy as a residence or for
32 activity other than the sale of farm crops or livestock and does not include structures for banquets,
33 public gatherings or public entertainment.

34 (p) Alteration, restoration or replacement of a lawfully established dwelling, as described in ORS
35 215.291.

36 (q) A site for the takeoff and landing of model aircraft, including such buildings or facilities as
37 may reasonably be necessary. Buildings or facilities shall not be more than 500 square feet in floor
38 area or placed on a permanent foundation unless the building or facility preexisted the use approved
39 under this paragraph. The site shall not include an aggregate surface or hard surface area unless
40 the surface preexisted the use approved under this paragraph. An owner of property used for the
41 purpose authorized in this paragraph may charge a person operating the use on the property rent
42 for the property. An operator may charge users of the property a fee that does not exceed the
43 operator's cost to maintain the property, buildings and facilities. As used in this paragraph, "model
44 aircraft" means a small-scale version of an airplane, glider, helicopter, dirigible or balloon that is
45 used or intended to be used for flight and is controlled by radio, lines or design by a person on the

1 ground.

2 (r) A facility for the processing of farm products as described in ORS 215.255.

3 (s) Fire service facilities providing rural fire protection services.

4 (t) Irrigation reservoirs, canals, delivery lines and those structures and accessory operational
5 facilities, not including parks or other recreational structures and facilities, associated with a dis-
6 trict as defined in ORS 540.505.

7 (u) Utility facility service lines. Utility facility service lines are utility lines and accessory fa-
8 cilities or structures that end at the point where the utility service is received by the customer and
9 that are located on one or more of the following:

10 (A) A public right of way;

11 (B) Land immediately adjacent to a public right of way, provided the written consent of all ad-
12 jacent property owners has been obtained; or

13 (C) The property to be served by the utility.

14 (v) Subject to the issuance of a license, permit or other approval by the Department of Envi-
15 ronmental Quality under ORS 454.695, 459.205, 468B.050, 468B.053 or 468B.055, or in compliance with
16 rules adopted under ORS 468B.095, and as provided in ORS 215.246 to 215.251, the land application
17 of reclaimed water, agricultural or industrial process water or biosolids, or the onsite treatment of
18 septage prior to the land application of biosolids, for agricultural, horticultural or silvicultural pro-
19 duction, or for irrigation in connection with a use allowed in an exclusive farm use zone under this
20 chapter. For the purposes of this paragraph, onsite treatment of septage prior to the land application
21 of biosolids is limited to treatment using treatment facilities that are portable, temporary and
22 transportable by truck trailer, as defined in ORS 801.580, during a period of time within which land
23 application of biosolids is authorized under the license, permit or other approval.

24 (w) A county law enforcement facility that lawfully existed on August 20, 2002, and is used to
25 provide rural law enforcement services primarily in rural areas, including parole and post-prison
26 supervision, but not including a correctional facility as defined under ORS 162.135.

27 (x) Dog training classes or testing trials, which may be conducted outdoors or in preexisting
28 farm buildings, when:

29 (A) The number of dogs participating in training does not exceed 10 dogs per training class and
30 the number of training classes to be held on-site does not exceed six per day; and

31 (B) The number of dogs participating in a testing trial does not exceed 60 and the number of
32 testing trials to be conducted on-site is limited to four or fewer trials per calendar year.

33 (y) A cider business, as described in ORS 215.451.

34 (z) A farm brewery, as described in ORS 215.449.

35 (2) The following nonfarm uses may be established, subject to the approval of the governing body
36 or its designee in any area zoned for exclusive farm use subject to ORS 215.296:

37 (a) Commercial activities that are in conjunction with farm use, including the processing of farm
38 crops into biofuel not permitted under ORS 215.203 (2)(b)(K) or 215.255.

39 (b) Operations conducted for:

40 (A) Mining and processing of geothermal resources as defined by ORS 522.005 and oil and gas
41 as defined by ORS 520.005 not otherwise permitted under subsection (1)(f) of this section;

42 (B) Mining, crushing or stockpiling of aggregate and other mineral and other subsurface re-
43 sources subject to ORS 215.298;

44 (C) Processing, as defined by ORS 517.750, of aggregate into asphalt or portland cement; and

45 (D) Processing of other mineral resources and other subsurface resources.

1 (c) Private parks, playgrounds, hunting and fishing preserves and campgrounds. Subject to the
2 approval of the county governing body or its designee, a private campground may provide yurts for
3 overnight camping. No more than one-third or a maximum of 10 campsites, whichever is smaller,
4 may include a yurt. The yurt shall be located on the ground or on a wood floor with no permanent
5 foundation. Upon request of a county governing body, the Land Conservation and Development
6 Commission may provide by rule for an increase in the number of yurts allowed on all or a portion
7 of the campgrounds in a county if the commission determines that the increase will comply with the
8 standards described in ORS 215.296 (1). As used in this paragraph, "yurt" means a round, domed
9 shelter of cloth or canvas on a collapsible frame with no plumbing, sewage disposal hookup or
10 internal cooking appliance.

11 (d) Parks and playgrounds. A public park may be established consistent with the provisions of
12 ORS 195.120.

13 (e) Community centers owned by a governmental agency or a nonprofit community organization
14 and operated primarily by and for residents of the local rural community. A community center au-
15 thorized under this paragraph may provide services to veterans, including but not limited to emer-
16 gency and transitional shelter, preparation and service of meals, vocational and educational
17 counseling and referral to local, state or federal agencies providing medical, mental health, disability
18 income replacement and substance abuse services, only in a facility that is in existence on January
19 1, 2006. The services may not include direct delivery of medical, mental health, disability income
20 replacement or substance abuse services.

21 (f) Golf courses on land:

22 (A) Determined not to be high-value farmland, as defined in ORS 195.300 (10); or

23 (B) Determined to be high-value farmland described in ORS 195.300 (10)(c) if the land:

24 (i) Is not otherwise described in ORS 195.300 (10);

25 (ii) Is surrounded on all sides by an approved golf course; and

26 (iii) Is west of U.S. Highway 101.

27 (g) Commercial utility facilities for the purpose of generating power for public use by sale. If the
28 area zoned for exclusive farm use is high-value farmland, a photovoltaic solar power generation fa-
29 cility may be established as a commercial utility facility as provided in ORS 215.447. A renewable
30 energy facility as defined in ORS 215.446 may be established as a commercial utility facility.

31 (h) Personal-use airports for airplanes and helicopter pads, including associated hangar, main-
32 tenance and service facilities. A personal-use airport, as used in this section, means an airstrip re-
33 stricted, except for aircraft emergencies, to use by the owner, and, on an infrequent and occasional
34 basis, by invited guests, and by commercial aviation activities in connection with agricultural op-
35 erations. No aircraft may be based on a personal-use airport other than those owned or controlled
36 by the owner of the airstrip. Exceptions to the activities permitted under this definition may be
37 granted through waiver action by the Oregon Department of Aviation in specific instances. A
38 personal-use airport lawfully existing as of September 13, 1975, shall continue to be permitted sub-
39 ject to any applicable rules of the Oregon Department of Aviation.

40 (i) Home occupations as provided in ORS 215.448.

41 (j) A facility for the primary processing of forest products, provided that such facility is found
42 to not seriously interfere with accepted farming practices and is compatible with farm uses de-
43 scribed in ORS 215.203 (2). Such a facility may be approved for a one-year period which is
44 renewable. These facilities are intended to be only portable or temporary in nature. The primary
45 processing of a forest product, as used in this section, means the use of a portable chipper or stud

1 mill or other similar methods of initial treatment of a forest product in order to enable its shipment
2 to market. Forest products, as used in this section, means timber grown upon a parcel of land or
3 contiguous land where the primary processing facility is located.

4 (k) A site for the disposal of solid waste approved by the governing body of a city or county or
5 both and for which a permit has been granted under ORS 459.245 by the Department of Environ-
6 mental Quality together with equipment, facilities or buildings necessary for its operation.

7 (L) One manufactured dwelling or recreational vehicle, or the temporary residential use of an
8 existing building, in conjunction with an existing dwelling as a temporary use for the term of a
9 hardship suffered by the existing resident or a relative of the resident. Within three months of the
10 end of the hardship, the manufactured dwelling or recreational vehicle shall be removed or demol-
11 ished or, in the case of an existing building, the building shall be removed, demolished or returned
12 to an allowed nonresidential use. The governing body or its designee shall provide for periodic re-
13 view of the hardship claimed under this paragraph. A temporary residence approved under this
14 paragraph is not eligible for replacement under subsection (1)(p) of this section.

15 (m) Transmission towers over 200 feet in height.

16 (n)(A) Commercial dog boarding kennels; or

17 (B) Dog training classes or testing trials that cannot be established under subsection (1)(x) of
18 this section.

19 (o) Residential homes as defined in ORS 197.660, in existing dwellings.

20 (p) The propagation, cultivation, maintenance and harvesting of aquatic species that are not
21 under the jurisdiction of the State Fish and Wildlife Commission or insect species. Insect species
22 shall not include any species under quarantine by the State Department of Agriculture or the United
23 States Department of Agriculture. The county shall provide notice of all applications under this
24 paragraph to the State Department of Agriculture. Notice shall be provided in accordance with the
25 county's land use regulations but shall be mailed at least 20 calendar days prior to any administra-
26 tive decision or initial public hearing on the application.

27 (q) Construction of additional passing and travel lanes requiring the acquisition of right of way
28 but not resulting in the creation of new land parcels.

29 (r) Reconstruction or modification of public roads and highways involving the removal or dis-
30 placement of buildings but not resulting in the creation of new land parcels.

31 (s) Improvement of public road and highway related facilities, such as maintenance yards, weigh
32 stations and rest areas, where additional property or right of way is required but not resulting in
33 the creation of new land parcels.

34 (t) A destination resort that is approved consistent with the requirements of any statewide
35 planning goal relating to the siting of a destination resort.

36 (u) Room and board arrangements for a maximum of five unrelated persons in existing resi-
37 dences.

38 (v) Operations for the extraction and bottling of water.

39 (w) Expansion of existing county fairgrounds and activities directly relating to county
40 fairgrounds governed by county fair boards established pursuant to ORS 565.210.

41 (x) A living history museum related to resource based activities owned and operated by a gov-
42 ernmental agency or a local historical society, together with limited commercial activities and fa-
43 cilities that are directly related to the use and enjoyment of the museum and located within
44 authentic buildings of the depicted historic period or the museum administration building, if areas
45 other than an exclusive farm use zone cannot accommodate the museum and related activities or if

1 the museum administration buildings and parking lot are located within one quarter mile of an ur-
2 ban growth boundary. As used in this paragraph:

3 (A) "Living history museum" means a facility designed to depict and interpret everyday life and
4 culture of some specific historic period using authentic buildings, tools, equipment and people to
5 simulate past activities and events; and

6 (B) "Local historical society" means the local historical society recognized by the county gov-
7 erning body and organized under ORS chapter 65.

8 (y) An aerial fireworks display business that has been in continuous operation at its current
9 location within an exclusive farm use zone since December 31, 1986, and possesses a wholesaler's
10 permit to sell or provide fireworks.

11 (z) A landscape contracting business, as defined in ORS 671.520, or a business providing land-
12 scape architecture services, as described in ORS 671.318, if the business is pursued in conjunction
13 with the growing and marketing of nursery stock on the land that constitutes farm use.

14 (aa) Public or private schools for kindergarten through grade 12, including all buildings essential
15 to the operation of a school, primarily for residents of the rural area in which the school is located.

16 (bb) Equine and equine-affiliated therapeutic and counseling activities, provided:

17 (A) The activities are conducted in existing buildings that were lawfully constructed on the
18 property before January 1, 2019, or in new buildings that are accessory, incidental and subordinate
19 to the farm use on the tract; and

20 (B) All individuals conducting therapeutic or counseling activities are acting within the proper
21 scope of any licenses required by the state.

22 (cc) Guest ranches in eastern Oregon, as described in ORS 215.461.

23 (dd) Child care facilities, preschool recorded programs or school-age recorded programs that are:

24 (A) Authorized under ORS 329A.250 to 329A.450;

25 (B) Primarily for the children of residents and workers of the rural area in which the facility
26 or program is located; and

27 (C) Colocated with a community center or a public or private school allowed under this sub-
28 section.

29 (3) Roads, highways and other transportation facilities and improvements not allowed under
30 subsections (1) and (2) of this section may be established, subject to the approval of the governing
31 body or its designee, in areas zoned for exclusive farm use subject to:

32 (a) Adoption of an exception to the goal related to agricultural lands and to any other applicable
33 goal with which the facility or improvement does not comply; or

34 (b) ORS 215.296 for those uses identified by rule of the Land Conservation and Development
35 Commission as provided in section 3, chapter 529, Oregon Laws 1993.

36 (4) The following agri-tourism and other commercial events or activities that are related to and
37 supportive of agriculture may be established in any area zoned for exclusive farm use:

38 (a) A county may authorize a single agri-tourism or other commercial event or activity on a
39 tract in a calendar year by an authorization that is personal to the applicant and is not transferred
40 by, or transferable with, a conveyance of the tract, if the agri-tourism or other commercial event
41 or activity meets any local standards that apply and:

42 (A) The agri-tourism or other commercial event or activity is incidental and subordinate to ex-
43 isting farm use on the tract;

44 (B) The duration of the agri-tourism or other commercial event or activity does not exceed 72
45 consecutive hours;

1 (C) The maximum attendance at the agri-tourism or other commercial event or activity does not
2 exceed 500 people;

3 (D) The maximum number of motor vehicles parked at the site of the agri-tourism or other
4 commercial event or activity does not exceed 250 vehicles;

5 (E) The agri-tourism or other commercial event or activity complies with ORS 215.296;

6 (F) The agri-tourism or other commercial event or activity occurs outdoors, in temporary
7 structures, or in existing permitted structures, subject to health and fire and life safety require-
8 ments; and

9 (G) The agri-tourism or other commercial event or activity complies with conditions established
10 for:

11 (i) Planned hours of operation;

12 (ii) Access, egress and parking;

13 (iii) A traffic management plan that identifies the projected number of vehicles and any antic-
14 ipated use of public roads; and

15 (iv) Sanitation and solid waste.

16 (b) In the alternative to paragraphs (a) and (c) of this subsection, a county may authorize,
17 through an expedited, single-event license, a single agri-tourism or other commercial event or ac-
18 tivity on a tract in a calendar year by an expedited, single-event license that is personal to the ap-
19 plicant and is not transferred by, or transferable with, a conveyance of the tract. A decision
20 concerning an expedited, single-event license is not a land use decision, as defined in ORS 197.015.
21 To approve an expedited, single-event license, the governing body of a county or its designee must
22 determine that the proposed agri-tourism or other commercial event or activity meets any local
23 standards that apply, and the agri-tourism or other commercial event or activity:

15 other commercial events or activities:

16 (A) Are incidental and subordinate to existing commercial farm use of the tract and are neces-
17 sary to support the commercial farm uses or the commercial agricultural enterprises in the area;

18 (B) Comply with the requirements of paragraph (c)(C), (D), (E) and (F) of this subsection;

19 (C) Occur on a lot or parcel that complies with the acknowledged minimum lot or parcel size;
20 and

21 (D) Do not exceed 18 events or activities in a calendar year.

22 (5) A holder of a permit authorized by a county under subsection (4)(d) of this section must re-
23 quest review of the permit at four-year intervals. Upon receipt of a request for review, the county
24 shall:

25 (a) Provide public notice and an opportunity for public comment as part of the review process;
26 and

27 (b) Limit its review to events and activities authorized by the permit, conformance with condi-
28 tions of approval required by the permit and the standards established by subsection (4)(d) of this
29 section.

30 (6) For the purposes of subsection (4) of this section:

31 (a) A county may authorize the use of temporary structures established in connection with the
32 agri-tourism or other commercial events or activities authorized under subsection (4) of this section.
33 However, the temporary structures must be removed at the end of the agri-tourism or other event
34 or activity. The county may not approve an alteration to the land in connection with an agri-tourism
35 or other commercial event or activity authorized under subsection (4) of this section, including, but
36 not limited to, grading, filling or paving.

37 (b) The county may issue the limited use permits authorized by subsection (4)(c) of this section
38 for two calendar years. When considering an application for renewal, the county shall ensure com-
39 pliance with the provisions of subsection (4)(c) of this section, any local standards that apply and
40 conditions that apply to the permit or to the agri-tourism or other commercial events or activities
41 authorized by the permit.

42 (c) The authorizations provided by subsection (4) of this section are in addition to other au-
43 thorizations that may be provided by law, except that “outdoor mass gathering” and “other gather-
44 ing,” as those terms are used in ORS 197.015 (10)(d), do not include agri-tourism or other commercial
45 events and activities.

1 **SECTION 19.** ORS 447.145 is amended to read:

2 447.145. (1) All new fixtures approved for installation during construction, reconstruction, al-
3 teration and repair of buildings and other structures under ORS 447.020 shall comply with rules
4 adopted by the Director of the Department of Consumer and Business Services. The rules shall be
5 consistent with performance requirements and test procedures established by the American National
6 Standards Institute, or other equivalent recognized North American standards and procedures. Ex-
7 cept for used fixtures allowed under subsection (4) of this section, the average amount of water used
8 by new or replacement fixtures under the applicable test procedures shall not exceed:

- 9 (a) 1.6 gallons or 6.06 liters per flush for toilets;
10 (b) 1.0 gallons or 3.785 liters per flush for urinals;
11 (c) 2.5 gallons or 9.46 liters per minute for shower heads; and
12 (d) 2.5 gallons or 9.46 liters per minute for interior faucets.

13 (2) Notwithstanding subsection (1) of this section, the director by rule shall provide for ex-
14 emptions to the requirements under subsection (1) of this section if:

15 (a) The reconstruction, alteration or repair of a building does not include the installation of new
16 or replacement toilets or urinals, shower heads or faucets within the building;

17 (b) Due to the capacity, design or installation of the plumbing or sewage system within an ex-
18 isting building, toilets or urinals required by subsection (1) of this section would, if installed in the
19 building, be unable to meet the performance requirements of the American National Standards In-
20 stitute or other equivalent recognized North American standards as adopted by rule;

21 (c) The fixtures and fittings necessary to perform a specialized function, including but not lim-
22 ited to emergency showers and aspirator faucets, cannot meet the requirements;

23 (d) The installation of fixtures that do not comply with subsection (1) of this section is necessary
24 to maintain the historic character of a structure [*listed*] **classified as historic property** under ORS
25 358.480 to 358.545; or

26 (e) The fixtures and fittings to be installed are specifically designed to withstand unusual abuse
27 or installation in a penal institution or are located in an area with special needs, such as a labo-
28 ratory, hospital, nursing home or other health care facility.

29 (3) No person shall sell or offer for sale any new toilet, urinal, shower head or faucet that has
30 not been approved under ORS 447.020.

31 (4) On or after December 31, 1995, no person shall sell or offer for sale any used toilet, urinal,
32 shower head or interior faucet that does not meet the conservation standards established in sub-
33 section (1) of this section.

34 (5) The director shall adopt rules and regulations for marking, labeling or otherwise identifying
35 fixtures that meet the standards of this section.

36 **SECTION 20.** ORS 358.511, 358.540 and 358.541 are repealed.

37 **SECTION 21.** ORS 358.480, 358.499 and 358.545 are added to and made a part of ORS
38 358.487 to 358.543.

39 **SECTION 22.** The amendments to ORS 93.040, 215.213, 215.283, 358.475, 358.480, 358.487,
40 358.490, 358.495, 358.499, 358.500, 358.505, 358.509, 358.515, 358.525, 358.528, 358.543, 358.545 and
41 447.145 and section 2, chapter 50, Oregon Laws 2022, by sections 1 to 19 of this 2025 Act and
42 the repeal of ORS 358.511, 358.540 and 358.541 by section 20 of this 2025 Act apply to applica-
43 tions for classification and special assessment under ORS 358.480 to 358.545 filed on or after
44 the effective date of this 2025 Act for property tax years beginning on or after July 1, 2026.

45 **SECTION 23.** Nothing in the amendments to ORS 93.040, 215.213, 215.283, 358.475, 358.480,

1 358.487, 358.490, 358.495, 358.499, 358.500, 358.505, 358.509, 358.515, 358.525, 358.528, 358.543,
2 358.545 and 447.145 and section 2, chapter 50, Oregon Laws 2022, by sections 1 to 19 of this
3 2025 Act and the repeal of ORS 358.511, 358.540 and 358.541 by section 20 of this 2025 Act af-
4 fects the classification of property as historic property under ORS 358.480 to 358.545 before
5 the effective date of this 2025 Act. Such property may continue to receive special assessment
6 under ORS 358.480 to 358.545 until the completion of the term of special assessment under
7 ORS 358.480 to 358.545 as in effect on the day before the effective date of this 2025 Act.

8 SECTION 24. This 2025 Act takes effect on the 91st day after the date on which the 2025
9 regular session of the Eighty-third Legislative Assembly adjourns sine die.
