SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes changes to laws about the child support program. (Flesch Readability Score: 80.3).

Modifies provisions of law regarding child support program administration.

17 **SECTION 3.** ORS 25.785 is amended to read:

18 25.785. (1) Any state agency, board or commission that is authorized to issue an occupational,
19 professional, recreational or driver license, certificate, permit or registration subject to suspension
20 under ORS 25.750 to 25.783 shall require that an individual's Social Security number be recorded
21 on an application for, or form for renewal of, a license, certificate, permit or registration and to the
22 maximum extent feasible shall include the Social Security number in automated databases containing
23 information about the individual. **If the individual does not have a Social Security number, the**
24 **state agency, board or commission may accept the individual's federal individual taxpayer**
25 **identification number or identification issued by the federal government.**

26 (2) **If an individual does not have a Social Security number, a federal individual taxpayer**
27 **identification number or identification issued by the federal government,** a state agency, board
28 or commission described in subsection (1) of this section may accept a written statement from *[ar]*

8 **SECTION 4.** ORS 25.095 is amended to read:

9 25.095. (1) As used in this section:

10 (a) “Administrator” has the meaning given that term in ORS 25.010.

11 (b) “Child support judgment” has the meaning given that term in ORS 25.089.

12 (2) Notwithstanding the provisions of ORS 25.089, 25.091 and 25.531 to the contrary, the terms
13 of a child support judgment [*originating under ORS 25.529*] are terminated by the terms of a later-
14 issued child support judgment [*of a court*] if:

15 (a) The two child support judgments involve:

16 **(A) The same obligor [and], child and [the same] period; or**

17 **(B) The same parties, child and period and the later-issued child support judgment**
18 **changed the child support obligation from one parent to another parent but did not expressly**
19 **terminate the former obligation;**

20 (b) The administrator is providing services under ORS 25.080;

21 (c) The administrator or a court gives the later-issued child support judgment precedence over
22 the earlier-issued child support judgment [*originating under ORS 25.529*]; and

23 (d) All parties had an opportunity to challenge the amount of child support ordered in the
24 later-issued child support judgment.

25 (3) Notwithstanding the provisions of ORS 25.091 (11) and 25.531 (7), for purposes of reconciling
26 any support payment records under the two child support judgments described in subsection (2) of
27 this section:

28 (a) The terms of the child support judgment [*originating under ORS 25.529*] are deemed termi-
29 nated on the effective date of the later-issued child support judgment; and

30 (b) Entry of the later-issued child support judgment does not affect the amount of any support
31 payment arrearage or credit that has accrued under the earlier-issued child support judgment[
32 *originating under ORS 25.529*].

33 (4) Any arrearage that accrued under a judgment that is terminated as provided in subsection
34 (2) of this section or that is explicitly terminated by any other later-issued court judgment is
35 subsumed by the later-issued court judgment and is enforceable in the court case in which the

40 **SECTION 5.** ORS 25.010 is amended to read:

41 25.010. As used in [*ORS 25.501 to 25.556 and*] ORS chapters 25, 107 and 109 and any other
42 statutes providing for support payments or [*support enforcement*] **child support** procedures, unless
43 the context requires otherwise:

44 (1) “Administrator” means either the Administrator of the Division of Child Support of the De-
45 partment of Justice or a district attorney, or the administrator’s or a district attorney’s authorized

1 representative.

2 (2) "Attorney" includes an associate member of the Oregon State Bar practicing law within the
3 member's approved scope of practice.

4 (3) "Child" has the meaning given that term in ORS 110.503.

5 (4) "Child support rights" means the right to establish or enforce an obligation imposed or
6 impossible by law to provide support, including but not limited to medical support as defined in ORS
7 25.321 and an unsatisfied obligation to provide support.

8 [(5) "Department" means the Department of Justice.]

9 [(6)] (5) "Disposable income" means that part of the income of an individual remaining after the
10 deduction from the income of any amounts required to be withheld by law except laws enforcing
11 spousal or child support and any amounts withheld to pay medical or dental insurance premiums.

12 [(7)] (6) "Employer" means any entity or individual who engages an individual to perform work
13 or services for which compensation is given in periodic payments or otherwise.

14 [(8)] (7) "Income" is any monetary obligation in excess of \$4.99 after the fee described in ORS
15 25.414 (6) has been deducted that is in the possession of a third party owed to a person and includes
16 but is not limited to:

17 (a) Compensation paid or payable for personal services whether denominated as wages, salary,
18 commission, bonus or otherwise;

19 (b) Periodic payments pursuant to a pension or retirement program;

20 (c) Cash dividends arising from stocks, bonds or mutual funds;

21 (d) Interest payments;

22 (e) Periodic payments from a trust account;

23 (f) Any program or contract to provide substitute wages during times of unemployment or disa-
24 bility;

25 (g) Any payment pursuant to ORS chapter 657; or

26 (h) Amounts payable to independent contractors.

27 [(9)] (8) "Obligee" has the meaning given that term in ORS 110.503.

28 [(10)] (9) "Obligor" has the meaning given that term in ORS 110.503.

29 [(11)] (10) "Order to withhold" means an order or other legal process that requires a withholder
30 to withhold support from the income of an obligor.

31 [(12) "Public assistance" has the meaning given that term in ORS 25.501.]

32 (11)(a) **"Public assistance" means any money payments made by the state that are paid**
33 **to or for the benefit of any dependent child, including but not limited to payments made so**
34 **that food, shelter, medical care, clothing, transportation or other necessary goods, services**
35 **or items may be provided, and payments made in compensation for the provision of the ne-**
36 **cessities.**

37 (b) **"Public assistance" does not include money payments made by the state to or for the**
38 **benefit of a dependent child as the result of the child's removal from the parent's home**
39 **against the wishes of the parent, if the Department of Human Services determines after**
40 **completion of a child protective services assessment that the report of abuse is unfounded**
41 **according to rules adopted by the department.**

42 [(13)] (12) "Withholder" means any person who disburses income and includes but is not limited
43 to an employer, conservator, trustee or insurer of the obligor.

44 **SECTION 6.** ORS 25.015 is amended to read:

45 25.015. (1) The Department of Justice shall notify the parties to a support order that payment

1 is to commence on the first due date following the date of the notice when:

2 (a) The department receives a copy of a support order of a court that requires payments to be
3 made through the department or for which there is an application for [*support enforcement*] **child**
4 **support** services;

5 (b) The department commences accounting services; and

6 (c) The order has been entered within the previous 180 days.

7 (2) The department shall include in the notice under subsection (1) of this section a statement
8 that the department will adjust the account to reflect an accrued arrearage for the period of time
9 between the effective date of the order and the date of the notice unless, within 30 days after the
10 date of the notice, a party requests that the department establish the arrearage on the account as
11 provided in ORS 25.167 or 25.540.

12 (3) If, within 30 days after the date of the notice under subsection (1) of this section, a party
13 requests the department to establish the arrearage as provided in ORS 25.167 or 25.540, the de-
14 partment may not reflect an accrued arrearage on the account until the arrearage has been estab-
15 lished.

16 (4) If a party does not request the department to establish the arrearage as provided in sub-
17 section (3) of this section, the department shall adjust the account to reflect the arrearage for the
18 period of time between the effective date of the order and the date of the notice.

19 **SECTION 7.** ORS 25.020 is amended to read:

20 25.020. (1) Support payments for or on behalf of any person that are ordered, registered or filed
21 under [*ORS 25.501 to 25.556 or*] this chapter or ORS chapter 107, 108, 109, 110, 419B or 419C, unless
22 otherwise authorized by ORS 25.030, shall be made to the Department of Justice as the state dis-
23 bursement unit:

24 (a) During periods for which support is assigned under ORS 412.024, 418.032 or 419B.406;

25 (b) As provided by rules adopted under ORS 180.345, when public assistance is provided to a
26 person who receives or has a right to receive support payments on the person's own behalf or on
27 behalf of another person;

28 (c) After the assignment of support terminates for as long as amounts assigned remain owing;

29 (d) For any period during which [*support enforcement*] **child support** services are provided under
30 ORS 25.080;

31 (e) When ordered by the court under ORS 419B.400;

32 (f) When a support order that is entered or modified on or after January 1, 1994, includes a
33 provision requiring the obligor to pay support by income withholding; or

34 (g) When ordered by the court under any other applicable provision of law.

35 (2)(a) The Department of Justice shall disburse payments, after lawful deduction of fees and in
36 accordance with applicable statutes and rules, to those persons and entities that are lawfully enti-
37 tled to receive such payments.

38 (b) During a period for which support is assigned under ORS 412.024, for an obligee described
39 in subsection (1)(b) of this section, the department shall disburse to the obligee, from child support
40 collected each month, \$50 for each child up to a maximum of \$200 per family.

41 (3)(a) When the administrator is providing [*support enforcement*] **child support** services under
42 ORS 25.080, the obligee may enter into an agreement with a collection agency, as defined in ORS
43 697.005, for assistance in collecting child support payments.

44 (b) The collection agency:

45 (A) May provide investigative and location services to the obligee and disclose relevant infor-

1 mation from those services to the administrator for purposes of providing [*support enforcement*] **child**
2 **support** services under ORS 25.080;

3 (B) May not charge interest or a fee for its services exceeding 29 percent of each support pay-
4 ment received unless the collection agency, if allowed by the terms of the agreement between the
5 collection agency and the obligee, hires an attorney to perform legal services on behalf of the
6 obligee;

7 (C) May not initiate, without written authorization from the administrator, any enforcement
8 action relating to support payments on which [*support enforcement*] **child support** services are pro-
9 vided by the administrator under ORS 25.080; and

10 (D) Shall include in the agreement with the obligee a notice printed in type size equal to at least
11 12-point type that provides information on the fees, penalties, termination and duration of the
12 agreement.

13 (c) The administrator may use information disclosed by the collection agency to provide [*support*
14 *enforcement*] **child support** services under ORS 25.080.

15 (4) The Department of Justice may immediately transmit to the obligee payments received from
16 any obligor without waiting for payment or clearance of the check or instrument received if the
17 obligor has not previously tendered any payment by a check or instrument that was not paid or was
18 dishonored.

19 (5) The Department of Justice shall [*notify*] **provide notice to** each obligor and obligee [*by*
20 *mail*] when support payments [*shall*] **must** be made to the department and when the obligation to
21 make payments in this manner [*shall cease*] **ceases. The department may provide the notice by**
22 **regular first class mail or, if authorized by the recipient, electronic mail or other electronic**
23 **delivery method as described by the administrator by rule.**

24 (6)(a) The administrator shall provide information about a child support account directly to a
25 party to the support order regardless of whether the party is represented by an attorney. As used
26 in this subsection, "information about a child support account" means the:

- 27 (A) Date of issuance of the support order.
- 28 (B) Amount of the support order.
- 29 (C) Dates and amounts of payments.
- 30 (D) Dates and amounts of disbursements.
- 31 (E) Payee of any disbursements.
- 32 (F) Amount of any arrearage.
- 33 (G) Source of any collection, to the extent allowed by federal law.

34 (b) Nothing in this subsection limits the information the administrator may provide by law to a
35 party who is not represented by an attorney.

36 (7) Any pleading for the entry or modification of a support order must contain a statement that
37 payment of support under a new or modified order will be by income withholding unless an excep-
38 tion to payment by income withholding is granted under ORS 25.396.

39 (8)(a) Except as provided in paragraphs (d) and (e) of this subsection, a judgment or order es-
40 tablishing parentage or including a provision concerning support must contain:

- 41 (A) The residence, mailing or contact address, final four digits of the Social Security number,
42 telephone number and final four digits of the driver license number of each party;
- 43 (B) The name, address and telephone number of all employers of each party;
- 44 (C) The names and dates of birth of the joint children of the parties; and
- 45 (D) Any other information required by rule adopted by the Chief Justice of the Supreme Court

1 under ORS 1.002.

2 (b) The judgment or order [*shall*] **must** also include notice that the obligor and obligee:

3 (A) Must inform the court and the administrator in writing of any change in the information
4 required by this subsection within 10 days after the change; and

5 (B) May request that the administrator review the amount of support ordered after three years,
6 or such shorter cycle as determined by rule of the Department of Justice, or at any time upon a
7 substantial change of circumstances.

8 (c) The administrator may require of the parties any additional information that is necessary for
9 the provision of [*support enforcement*] **child support** services under ORS 25.080.

10 (d)(A) Upon a finding, which may be made ex parte, that the health, safety or liberty of a party
11 or child would unreasonably be put at risk by the disclosure of information specified in this sub-
12 section or by the disclosure of other information concerning a child or party to a parentage or
13 support proceeding or if an existing order so requires, a court or administrator or administrative
14 law judge, when the proceeding is administrative, shall order that the information not be contained
15 in any document provided to another party or otherwise disclosed to a party other than the state.

16 (B) The Department of Justice shall adopt rules providing for similar confidentiality for infor-
17 mation described in subparagraph (A) of this paragraph that is maintained by an entity providing
18 [*support enforcement*] **child support** services under ORS 25.080.

19 (e) The Chief Justice of the Supreme Court may, in consultation with the Department of Justice,
20 adopt rules under ORS 1.002 to designate information specified in this subsection as confidential and
21 require that the information be submitted through an alternate procedure to ensure that the infor-
22 mation is exempt from public disclosure under ORS 192.355.

23 (9)(a) Except as otherwise provided in paragraph (b) of this subsection, in any subsequent child
24 support enforcement action, the court or administrator, upon a showing of diligent effort made to
25 locate the obligor or obligee, may deem due process requirements to be met by [*mailing*] **providing**
26 notice **by regular first class mail** to the last-known residential, mailing or employer address or
27 contact address as provided in ORS 25.085.

28 (b) Service of an order directing an obligor to appear in a contempt proceeding is subject to
29 ORS 33.015 to 33.155.

30 (10) Subject to ORS 25.030, this section, to the extent it imposes any duty or function upon the
31 Department of Justice, shall be deemed to supersede any provisions of ORS 25.501 to 25.556 and ORS
32 chapters 107, 108, 109, 110, 419A, 419B and 419C that would otherwise impose the same duties or
33 functions upon the county clerk or the Department of Human Services.

34 (11) Except as provided for in subsections (12), (13) and (14) of this section, credit may not be
35 given for payments not made to the Department of Justice as required under subsection (1) of this
36 section.

37 (12)(a) The Department of Justice shall give credit for payments not made to the department:

38 (A) When payments are not assigned to this or another state and the party to whom unpaid
39 support is owed and the obligor agree in writing that specific payments were made and should be
40 credited;

41 (B) When payments are assigned to another state and that state verifies that payments not paid
42 to the department were received by the other state; or

43 (C) As provided by rule adopted under ORS 180.345.

44 (b) The credit under this subsection may not exceed the current unpaid balance of support owed
45 to the party that has agreed in writing that payments were made and should be credited.

1 (13) An obligor may apply to the Department of Justice for credit for payments made other than
2 to the Department of Justice. If the party to whom unpaid support is owed does not provide the
3 agreement or verification required by subsection (12) of this section, credit may be given pursuant
4 to order of an administrative law judge assigned from the Office of Administrative Hearings after
5 notice and opportunity to object and be heard are given to both the obligor and the party to whom
6 unpaid support is owed. Notice shall be served upon the party to whom unpaid support is owed as
7 provided by ORS 25.085. Notice to the obligor may be **provided** by *[regular mail at the address*
8 *provided in the application for credit]* **regular first class mail or, if authorized by the obligor,**
9 **by electronic mail or other electronic delivery method as described by the administrator by**
10 **rule.** A hearing conducted under this subsection is a contested case hearing and ORS 183.413 to
11 183.470 apply. Any party may seek a hearing de novo in the circuit court.

12 (14) Nothing in this section precludes the Department of Justice from giving credit for payments
13 not made to the department when there has been a judicially determined credit or satisfaction or
14 when there has been a satisfaction of support executed by the person to whom support is owed.

15 (15) The Department of Justice shall adopt rules that:

16 (a) Direct how support payments that are made through or credited by the department are to
17 be applied and, if applicable, disbursed; and

18 (b) Are consistent with federal regulations.

19 **SECTION 8.** ORS 25.075 is amended to read:

20 25.075. (1) Notwithstanding the provisions of ORS 25.080, the Department of Justice may enter
21 into cooperative agreements with Indian tribes or tribal organizations within the borders of this
22 state, if the Indian tribe or tribal organization demonstrates that the tribe or organization has an
23 established tribal court system or a Court of Indian Offenses with the authority to:

24 (a) Establish parentage;

25 (b) Establish, modify and enforce support orders; and

26 (c) Enter support orders in accordance with child support guidelines established by the tribe or
27 organization.

28 (2) The agreements must provide for the cooperative delivery of child support *[enforcement]*
29 services and for the forwarding of all child support collections pursuant to the functions performed
30 by the tribe or organization to the department, or conversely, by the department to the tribe or
31 organization, which shall distribute the child support collections in accordance with the agreement.

32 **SECTION 9.** ORS 25.080 is amended to read:

33 25.080. (1) The following entity is primarily responsible for providing the *[support enforcement]*
34 **child support** services described in subsection (4) of this section when an application as described
35 in ORS 25.084 is made, or when an assignment of support rights is made to the state:

36 (a) The Division of Child Support of the Department of Justice:

37 (A) If support rights are, or were within the past five months, assigned to this or another state;
38 or

39 (B) In any case where arrearage under a support order is assigned or owed to or the right to
40 recover back support or state debt is held by this state or another state.

41 (b) Except as provided in subsection (6) of this section, the district attorney in cases other than
42 those described in paragraph (a) of this subsection if an application as described in ORS 25.084 is
43 made by the obligee, by the obligor, by a person having physical custody of a minor child or by a
44 child attending school, as defined in ORS 107.108.

45 (2) The provisions of this section apply to *[support enforcement]* **child support** services for any

1 order or judgment that is or could be entered under ORS 25.501 to 25.556 or 419B.400 or ORS
 2 chapter 107, 108, 109 or 110. The entity specified in subsection (1) of this section shall provide the
 3 *[support enforcement]* **child support** services on behalf of the State of Oregon and not on behalf of
 4 any other party or on behalf of a parent. The Department of Justice shall adopt rules addressing the
 5 provision of *[support enforcement]* **child support** services when the purposes of the state in providing
 6 those services may be contradictory in individual cases.

7 (3) Notwithstanding the division of responsibility for providing *[support enforcement]* **child sup-**
 8 **port** services between the Division of Child Support and the district attorney as described in sub-
 9 section (1) of this section, provision of *[support enforcement]* **child support** services may not be
 10 challenged on the basis that the entity providing the services in a particular case is not the entity
 11 responsible for the case under subsection (1) of this section.

12 (4) When responsible for providing *[support enforcement]* **child support** services and there is
 13 sufficient evidence available to support the action to be taken, the entity described in subsection (1)
 14 of this section:

15 (a) Shall establish and enforce any child support obligation;

16 (b) Shall establish paternity;

17 (c) Shall enforce spousal support when the obligee is living with the obligor's child for whom
 18 *[support enforcement]* **child support** services are being provided and those services are funded in
 19 part by federal moneys;

20 (d) May enforce any other order or judgment for spousal support;

21 (e) Shall, on behalf of the state, initiate and respond to child support modification proceedings
 22 based upon a substantial change of circumstances;

23 (f) Shall, on behalf of the state, initiate and respond to child support modification proceedings
 24 based upon a modification conducted under ORS 25.287 concerning existing child support orders;

25 (g) Shall establish and enforce obligations to provide medical insurance coverage for dependent
 26 children;

27 (h) Shall ensure compliance with the provisions of 42 U.S.C. 651 to 669 and 45 C.F.R. Chapter
 28 III as authorized by state law;

29 (i) Shall carry out the policy of the State of Oregon regarding child support obligations as ex-
 30 pressed in ORS 25.502; and

31 (j) Shall ensure that child support orders are in compliance with the formula established by this
 32 chapter.

33 (5) In any proceeding under subsection (4) of this section, the parties are those described in ORS
 34 25.503.

35 (6) The district attorney of any county and the Department **of Justice** may provide by agree-
 36 ment for assumption by the Division of Child Support of the functions of the district attorney under
 37 subsection (1) of this section or for redistribution between the district attorney and the Division of
 38 Child Support of all or any portion of the duties, responsibilities and functions set forth in sub-
 39 sections (1) and (4) of this section.

40 (7) All county governing bodies and all district attorneys shall enter into child support cooper-
 41 ative agreements with the Department **of Justice**. The following apply to this subsection:

42 (a) The agreements *[shall]* **must** contain appropriate terms and conditions sufficient for the state
 43 to comply with all child *[support enforcement]* **support** service requirements under federal law; and

44 (b) If this state loses any federal funds due to the failure of a county governing body or district
 45 attorney to either enter into an agreement under this subsection or to provide sufficient *[support*

1 *enforcement service*] **child support services**, the county shall be liable to the department for, and
 2 the liability shall be limited to, the amount of money the state determines it lost because of the
 3 failure. The state shall offset the loss from any moneys the state is holding for or owes the county
 4 or from any moneys the state would pay to the county for any purpose.

5 (8) The Department of Justice shall enter into an agreement with the Oregon District Attorneys
 6 Association to establish a position or positions to act as a liaison between the Division of Child
 7 Support and those district attorneys who provide [*support enforcement*] **child support** services under
 8 this section. The department shall fund the position or positions. The Oregon District Attorneys
 9 Association shall administer the liaison position or positions under the agreement. The liaison shall
 10 work to:

11 (a) Enhance the participation and interaction of the district attorneys in the development and
 12 implementation of **the policies of and services provided by the Oregon Child Support Program**
 13 [*policies and services*]; and

14 (b) Increase the effectiveness of child support [*enforcement*] services provided by the district at-
 15 torneys.

16 (9) The district attorney or the Division of Child Support, whichever is appropriate, shall pro-
 17 vide the **child support** services specified in subsections (1) and (4) of this section to any applicant,
 18 but may in their discretion, upon a determination and notice to the applicant that the prospect of
 19 successful recovery from the obligor of a portion of the delinquency or future payments is remote,
 20 require payment to the district attorney or the Division of Child Support of an application fee, in
 21 accordance with an application fee schedule established by rule by the Department of **Justice**. If
 22 service performed results in the district attorney or the Division of Child Support recovering any
 23 support enforcement fees, the fees shall be paid to the applicant in an amount equal to the amount
 24 of the application fee.

34 (b) The Supplemental Nutrition Assistance Program under ORS 411.806 to 411.845.

35 [(6)] (5) In addition to any penalty to which an individual may be subject under ORS 25.990, an
36 employee of the Department of Justice, of a district attorney or of the Department of Human Ser-
37 vices who discloses or uses the contents of any records in violation of subsection [(2)] (1) of this
38 section is subject to discipline, up to and including dismissal from employment.

39 [(7)] (6) The Department of Justice shall adopt rules consistent with federal regulations gov-
40 erning confidentiality of **Oregon** Child Support Program information.

36 (L) A statement that if the parent has any questions, the parent should telephone or visit the
37 appropriate office or consult an attorney; and

38 (m) Such other information as the administrator finds appropriate.

39 (3) If the paternity of the dependent child has not been legally established, the notice and
40 [*finding of financial responsibility shall]* **proposed order must** also include:

41 (a) An allegation that the person is the parent of the dependent child;

42 (b) The name of the child's other parent;

43 (c) The child's date of birth;

44 (d) The probable time or period of time during which conception took place; and

45 (e) A statement that if the alleged parent or the obligee does not timely send to the office is-

1 suing the notice a written response that denies paternity and requests a hearing, then the adminis-
2 trator, without further notice to the alleged parent, or to the obligee, may enter an order that
3 declares and establishes the alleged parent as the legal parent of the child.

4 (4) The statement of monthly future support required under subsection (2)(b) and the statement
5 of past support required under subsection (2)(c) of this section are to be computed as follows:

6 (a) If there is sufficient information available concerning the parent's financial and living situ-
7 ation, the formula provided for in ORS 25.275 and 25.280 shall be used; or

6 (a) The effect of a judgment on real property as described in ORS 18.150 (2) and (3) for the
7 county in which the judgment is entered, and as described in ORS 18.152 (2) and (3) for a county in

9 (b) A support arrearage lien attaching to real property under ORS 18.150 (3) or 18.152 (3).

13 (12) "Legal authority" means:

14 (a) A statute;

15 (b) An Oregon Rule of Civil Procedure;

18 (13) "Limited judgment" means:

19 (a) A judgment entered under ORCP 67 B or 67 G;

20 (b) A judgment entered before the conclusion of an action in a circuit court for the partition
21 of real property, defining the rights of the parties to the action and directing sale or partition;

22 (c) An interlocutory judgment foreclosing an interest in real property; and

23 (d) A judgment rendered before entry of a general judgment in an action that disposes of at least

39 18.228. (1) If a support award is paid to the Department of Justice, the judgment creditor may
40 receive credit for satisfaction of the judgment only in the manner provided by this section. The de-
41 partment may provide judgment creditors with forms and instructions for satisfaction of support
42 awards under this section.

43 (2) Any satisfaction document for a support award described in subsection (1) of this section
44 must be mailed to or delivered to the Department of Justice, and not to the court administrator.
45 The department shall credit the amounts reflected in the satisfaction document to the support award

1 pay records maintained by the department. Except as provided in subsection (3) of this section, the
 2 department [*shall*] **may** not credit amounts against the support award pay records to the extent that

6 (A) A contribution that, at the time of the contribution, is not taxable income to the beneficiary
7 and, if the sponsor is a taxable entity, is tax deductible to the sponsor;

8 (B) A nondeductible contribution by a beneficiary to a retirement plan to the extent that the
9 contribution is permitted to be made under the Internal Revenue Code;

10 (C) A deductible or nondeductible contribution to an individual retirement account to the extent
11 the contribution is not subject to federal excise tax as an excess contribution;

12 (D) A contribution, pursuant to a rollover or transfer, from one retirement plan to another, to

INSTRUCTIONS TO GARNISHEE

Except as specifically provided in these instructions, you must complete and deliver the Garnishee Response within seven calendar days after you receive the writ of garnishment. If the writ does not comply with Oregon law, the writ is not effective to garnish any property of the Debtor, but you still must complete and deliver the Garnishee Response. You must complete and deliver the response even though you cannot determine from the writ whether you hold any property or owe any debt to the Debtor. If the seventh calendar day is a Saturday, Sunday or legal holiday, you must deliver your response on or before the next following day that is not a Saturday, Sunday or legal holiday.

The writ is not effective, and you need not make a Garnishee Response, if:

- You do not receive the writ within 60 days after the date of issuance shown on the face of the writ.
- You do not receive an original writ of garnishment or a copy of the writ.

Statutes that may affect your rights and duties under the writ can be found in ORS 18.600 to 18.850.

NOTE: The Garnishor may be the Creditor, the attorney for the Creditor or some other person who is authorized by law to issue the writ of garnishment. See the writ to determine who the Garnishor is.

STEP 1. FILL OUT THE GARNISHEE RESPONSE.

All garnishees who are required to deliver a garnishee response must fill in Part I of the Garnishee Response. Garnishees who employ the Debtor must also fill in Part II of the response. You should keep a copy of the response for your records.

Completing Part I of the Garnishee Response. If you discover before you deliver your response that a bankruptcy petition has been filed by or on behalf of the Debtor, and the bankruptcy petition was filed after a judgment was entered against the Debtor or after the debt otherwise became subject to garnishment (see the date specified in the writ), you must put a check by the appropriate statement in Part I. If a bankruptcy petition has been filed, you should not make any payments to the Garnishor unless the court orders otherwise. You need not complete any other part of the response, but you still must sign the response and deliver it in the manner described in Step 2 of these instructions.

In all other cases you must list in Part I all money and personal property of the Debtor that is in your possession, control or custody at the time of delivery of the writ. You must also list all debts that you owe to the Debtor, whether or not those debts are currently due (e.g., money loaned to you by the Debtor that is to be repaid at a later time).

If you are the employer of the Debtor at the time the writ is delivered to you, you must put a

1 check by the appropriate statement in Part I. In addition, you must complete Part II of the response.

2 If you believe that you may hold property of the Debtor or that you owe a debt to the Debtor,
3 but you are not sure, you must put a check by the appropriate statement and provide an explana-
4 tion. When you find out what property you hold that belongs to the Debtor, or you find out whether
5 you owe money to the Debtor and how much, you must prepare and deliver an amended response.
6 You must do this even if you find out that you have no property of the Debtor or that you do not
7 owe anything to the Debtor.

8 If you determine that the writ, on its face, does not comply with Oregon laws governing writs
9 of garnishment, or if you are unable to determine the identity of the Debtor from the information
10 in the writ, then the writ is not effective to garnish any property of the Debtor. You must put a
11 check by the appropriate statement in Part I and provide an explanation. You still must complete
12 the response and deliver the response in the manner described in Step 2 of these instructions.

13 If you have received an order to withhold income that applies to the income of the Debtor and
14 that order has priority over the garnishment, and if compliance with the order will reduce or elim-
15 inate the money or property that you would otherwise deliver under the garnishment, you must put
16 a check by the appropriate statement in Part I. You still must fill out the remainder of the response
17 and deliver the response in the manner described in Step 2 of these instructions. If you employ the
18 Debtor, you still must complete Part II of the response.

19 If you receive notice of a challenge to the garnishment before you send your response, you must
20 complete and deliver your response as otherwise required by these instructions. However, see Step
21 3 of these instructions regarding payment of money or delivery of property after receipt of notice
22 of a challenge to the garnishment.

23 If you owe a debt to the Debtor and the Debtor owes a debt to the holder of an underlying lien
24 on your property, you may be able to offset the amount payable to the underlying lienholder. See
25 ORS 18.620. You must note that you have made the offset in Part I of the response (under
26 "Other") and specify the amount that was offset.

27
28 Completing Part II of the Garnishee Response (employers only). You must fill in Part II of the
29 response if you employ the Debtor on the date the writ of garnishment is delivered to you, or if you
30 previously employed the Debtor and still owe wages to the Debtor on the date the writ is delivered
31 to you.

32
33 Wages affected. Except as provided below, the writ garnishes all wages that you owe to the
34 Debtor for work performed before the date you received the writ, even though the wages will not
35 be paid until a later date. The writ also garnishes all wages that are attributable to services per-
36 formed during the 90-day period following the date you received the writ, even though you would
37 not pay the Debtor for all or part of those services until after the end of the 90-day period. Wages
38 subject to garnishment under the writ include all amounts paid by you as an employer, whether on
39 an hourly, weekly or monthly basis, and include commission payments and bonuses.

40
41 Example 1: Debtor A is employed by you and is paid a monthly salary on the first day of
42 each month. You receive a writ of garnishment on July 17. The writ garnishes all wages
43 that you owe to Debtor A for work performed on or before July 17. If Debtor A was paid
44 on July 1 for services performed in the month of June, the writ garnishes Debtor A's salary
45 for the period beginning July 1 and ending October 15 (90 days after receipt of the writ).

1 The writ does not garnish any wages you owe to a Debtor for a specific pay period if:

2 (a) The writ is delivered to you within two business days before the Debtor's normal payday for
3 the pay period;

4 (b) When the writ is delivered to you, the Debtor's wages are paid by direct deposit to a finan-
5 cial institution, or you use an independent contractor as payroll administrator for your payroll; and

6 (c) Before the writ was delivered to you, you issued instructions to the financial institution or
7 the payroll administrator to pay the Debtor for the pay period.

8 If any wages are not garnishable by reason of the issuance of instructions to a financial insti-
9 tution or a payroll administrator as described above, you must so note in the Garnishee Response.
10 Thereafter, you must pay to the Garnishor all wages that are subject to garnishment that are at-
11 tributable to services performed by the Debtor during the 90-day period following the date you re-
12 ceived the writ.

13
14 Calculation of wages subject to garnishment. A Wage Exemption Calculation form is attached
15 to the writ of garnishment. You must use this form to calculate the amount of the Debtor's wages
16 that is subject to garnishment. You should read the instructions printed on the Wage Exemption
17 Calculation form to determine the normal wage exemption and the minimum wage exemption for
18 each payment you make under the writ.

19 A Wage Exemption Calculation form must be sent with the first payment you make under the
20 writ. For the 90-day period during which the writ is effective, you must also fill out and return a
21 Wage Exemption Calculation form with a subsequent payment any time the initial calculation
22 changes. Finally, you must fill out and return a Wage Exemption Calculation form with the final
23 payment that you make under the writ.

24
25 Payment of amount subject to garnishment. Payments under the writ must be made at the fol-
26 lowing times, unless the amount owing on the judgment or other debt is fully paid before the final
27 payment is made or the writ is released:

28 (a) You must make a payment to the Garnishor of all wages subject to garnishment at the time
29 you next pay wages to the Debtor. Complete the wage exemption computation, using the Wage Ex-
30 emption Calculation form, to determine the portion of the Debtor's wages that is subject to
31 garnishment. Be sure to adjust the minimum exemption amount for any payment that covers less
32 than a full pay period. You must include a copy of the Wage Exemption Calculation form with this
33 first payment.

34
35 Example 2: Using the facts given in Example 1, when you next make any payment of wages
36 to Debtor A after you receive the writ on July 17, you must complete the Wage Exemption
37 Calculation form and send the form to the Garnishor along with all amounts determined to
38 be subject to garnishment that are attributable to the period covered by the payment. If you
39 pay Debtor A on August 1, the payment will be for all wages attributable to the period be-
40 ginning July 1 and ending July 31.

41
42 (b) Unless the writ of garnishment is satisfied or released, during the 90-day period following the
43 date you received the writ, you must pay to the Garnishor all wages that are determined to be
44 subject to garnishment whenever you issue a paycheck to the Debtor. If the Debtor is paid on a
45 weekly basis, you must make payment under the writ on a weekly basis. If the Debtor is paid on a

1 monthly basis, you must make payment under the writ on a monthly basis. If the amount paid to the
2 Debtor varies from paycheck to paycheck, or changes at any time from the amount being paid at the
3 time the writ was delivered to you, you must perform a new wage exemption computation to deter-
4 mine the amount of wages subject to garnishment under the writ. You must send a copy of the new
5 Wage Exemption Calculation form with your payment to the Garnishor.

6
7 Example 3: Using the facts given above, as you make each subsequent payment of wages to
8 Debtor A you must make a payment of that portion of the Debtor's wages that are subject
9 to garnishment. If you continue to pay Debtor A on the first of each month, payments must
10 be made on September 1 and October 1.

11
12 (c) Upon the expiration of the 90-day period, you must make a final payment to the Garnishor
13 for all wages that were owing to the Debtor for the work performed by the Debtor through the 90th
14 day following your receipt of the writ. This payment may be made at the time of the Debtor's next
15 paycheck. You will need to complete another Wage Exemption Calculation form to determine the
16 amount of the wages subject to garnishment.

17
18 Example 4: Using the facts given above, you must make a final payment for the wages owing
19 to Debtor A for the period beginning October 1 and ending October 15. You may make this
20 payment at the time you issue Debtor A's paycheck on November 1, but you must make the
21 payment at any time you issue a paycheck to Debtor A after October 15. Be sure that in
22 completing the wage exemption computation for the final payment you adjust the minimum
23 exemption amount to take into account the fact that the period covered is only 15 days of
24 the full month (see instructions on Wage Exemption Calculation form).

25
26 Processing fee. You may collect a \$2 processing fee for each week of wages, or fraction of a
27 week of wages, for which a payment is made under the writ. The fee must be collected after you
28 make the last payment under the writ. The fee must be withheld from the wages of the debtor, and
29 is in addition to the amounts withheld for payment to the Garnishor under the writ or under any
30 other writ you have received.

31
32 If you receive more than one writ of garnishment. If you receive a second writ of garnishment
33 for the same Debtor from another Garnishor, the first writ will have priority for wages. The priority
34 of the first writ lasts for the 90-day period following delivery of that writ to you, or until the first
35 writ is paid in full, whichever comes first. In your response to the second writ, you must put a check
36 by the appropriate statement in Part II and indicate the date on which the first writ will expire (90
37 days after the date you received the writ). You should make no payments under the second writ
38 until expiration of the first writ. The expiration date of the second writ is 90 days after the date
39 you received the second writ; the expiration date is not affected by any delay in payment attribut-
40 able to the priority of the first writ.

41
42 STEP 2. DELIVER THE GARNISHEE RESPONSE.

43
44 You must deliver your Garnishee Response and copies of the response in the manner provided
45 in this step. The response and copies may be mailed or delivered personally.

1 You must complete and deliver the Garnishee Response within seven calendar days after you
2 receive the writ of garnishment. If the seventh calendar day is a Saturday, Sunday or legal holiday,
3 you must deliver your response on or before the next following day that is not a Saturday, Sunday
4 or legal holiday.

5
6 If you are required to hold any property under the writ or make any payment under the writ,
7 either at the time of making your response or later, you must:

8 (a) Send the original of your Garnishee Response to the Garnishor at the address indicated on
9 the writ under Important Addresses.

10 (b) Send a copy of your Garnishee Response to the court administrator at the address indicated
11 on the writ under Important Addresses.

12 (c) Send a copy of your Garnishee Response to the Debtor if an address is indicated on the writ
13 under Important Addresses.

14
15 If you are not required to hold any property under the writ or make any payment under the
16 writ, either at the time of making your response or later, you must:

17 (a) Send the original of your Garnishee Response to the Garnishor at the address indicated on
18 the writ under Important Addresses.

19 (b) Send a copy of your Garnishee Response to the Debtor if an address is indicated on the writ
20 under Important Addresses.

21
22 STEP 3. DELIVER THE FUNDS OR OTHER PROPERTY.

23
24 As long as the writ is in effect, you may be liable to the Creditor if you pay any debt or turn
25 over any property to the Debtor except as specifically allowed by law. If you have any money or
26 property of the Debtor in your possession, control or custody at the time of delivery of the writ, or
27 owe any debt to the Debtor, you must pay the money or hold the property as required by this step.
28 Exceptions to this requirement are listed below.

29
30 IF YOU ARE HOLDING MONEY FOR THE DEBTOR OR OWE A DEBT THAT IS CUR-
31 RENTLY DUE, you must pay the money to the Garnishor with your response. You must send your
32 payment to the Garnishor at the address indicated on the writ under Important Addresses. Make
33 your check payable to the Garnishor.

34
35 IF YOU OWE A DEBT TO THE DEBTOR THAT WILL BECOME DUE WITHIN 45 DAYS
36 AFTER THE DATE YOU RECEIVED THE WRIT, you must send your payment directly to the
37 Garnishor at the address provided in the writ when the debt becomes due. Make your check payable
38 to the Garnishor.

39
40 IF YOU ARE HOLDING PROPERTY THAT BELONGS TO THE DEBTOR, OR OWE A DEBT
41 TO THE DEBTOR THAT WILL NOT BECOME DUE WITHIN 45 DAYS AFTER THE DATE YOU
42 RECEIVED THE WRIT, you must keep the property or debt in your possession, control or custody
43 until you receive written notice from the Sheriff. The Sheriff's notice will tell you what to do with
44 the property or debt. If you have followed all of the instructions in the writ and you receive no
45 notice from the Sheriff within 30 days after the date on which you delivered your Garnishee Re-

1 sponse, you may treat the writ as being of no further force or effect.

2
3 **EXCEPTIONS:**

4
5 1. Challenge to garnishment or specific directions from court. If you are making any payments
6 under the garnishment and before making a payment you receive notice of a challenge to the
7 garnishment from the court, or receive a specific direction from the court to make payments to the
8 court, you must send or deliver the payment directly to the court administrator. If the money is
9 currently due when you receive the notice, send the payment promptly to the court. If the payment
10 is for a debt that is payable within 45 days after you receive the writ, make the payment to the
11 court promptly when it becomes due. If you make payment by check, make the check payable to the
12 State of Oregon. Because you may be liable for any payment that does not reach the court, it is
13 better not to send cash by mail.

14 A challenge to the garnishment does not affect your duty to follow the instructions you receive
15 from the Sheriff for property that belongs to the Debtor and debts that you owe to the Debtor that
16 do not become due within 45 days.

17
18 2. Previous writ of garnishment. If you receive a second writ of garnishment for the same Debtor
19 from another Garnishor, the first writ will have priority and you need not make payments or deliver
20 property under the second writ to the extent that compliance with the first writ will reduce or
21 eliminate the payment of money or delivery of property that you would otherwise make under the
22 garnishment. You must still deliver a Garnishee Response to the second writ, and must commence
23 payment under the second writ as soon as the first writ is satisfied or expires.

24
25 3. Offset for payment of underlying lien. If you owe a debt to the Debtor and the Debtor owes
26 a debt to the holder of an underlying lien on your property, you may be able to offset the amount
27 payable to the underlying lienholder. See ORS 18.620.

28
29 4. Subsequent events:

30
31 (a) Bankruptcy. If you make your response and then discover that a voluntary or involuntary
32 bankruptcy petition has been filed by or on behalf of the Debtor after the judgment was entered
33 against the Debtor or after the debt otherwise became subject to garnishment (see date in writ), you
34 may not make any further payments or delivery of property under the writ unless the court orders
35 otherwise. If you have not delivered all property that is subject to garnishment under this writ when
36 you discover that a bankruptcy petition has been filed, you must mail the following notice to the
37 Garnishor and to the Debtor.

38
39 (b) Order to withhold income. If you make your response and then receive an order to withhold
40 income that has priority over the writ, you may make payments or deliver property under the writ
41 only after payment of the amounts required under the order to withhold income. If you have not
42 delivered all property that is subject to garnishment under this writ when you receive an order to
43 withhold income that has priority, you must mail the following notice to the Garnishor and to the
44 Debtor.

(1)(a) If you receive a writ of garnishment for a Debtor who has an account with your institution, you must first determine whether a Notice of Right to Garnish Federal Benefits from the United States Government or from a state child support [*enforcement agency*] **program**, as provided in 31 C.F.R. part 212, accompanies the writ of garnishment.

(b) If a Notice of Right to Garnish Federal Benefits accompanies the writ of garnishment, you must proceed with the garnishment in the normal manner.

(c) If the writ of garnishment is attached to an attestation that a debt arises out of a child

1 support or spousal support obligation or a judgment that contains a money award of restitution, the
2 base protected account balance does not apply and you should not perform the calculation provided
3 by (1)(d), (2), (3), (5) and (6) below, but you must perform a garnishment account review as provided

24 (b) You must provide full customary access to the base protected account balance shown on the

27 (4) In a garnishment account review, you must determine whether any of the following payments
28 were made by direct deposit or electronic transfer to any of the Debtor's accounts with your insti-

30 preceding the date of your garnishment account review and that ends on the corresponding date of
31 the month two months earlier, or on the last day of the month two months earlier if the corre-
32 sponding date does not exist):

33 (a) Federal benefit payments as defined in ORS 18.600 (benefit payments from the United States
34 Social Security Administration, the United States Department of Veterans Affairs, the United States
35 Office of Personnel Management or the Railroad Retirement Board);

36 (b) Payments from a public or private retirement plan as defined in ORS 18.358;

37 (c) Public assistance payments or medical assistance, as defined in ORS 414.025, from the State
38 of Oregon or an agency of the State of Oregon;

39 (d) Unemployment compensation payments from the State of Oregon or an agency of the State
40 of Oregon;

41 (e) Black lung benefits payments from the United States Department of Labor; or

42 (f) Workers' compensation payments from a workers' compensation carrier.

43 (5) If in the garnishment account review you determine that any of the payments listed in (4)
44 above were made by direct deposit or electronic transfer to any of the Debtor's accounts with your
45 institution within the lookback period, you may not garnish, and must provide full customary access

1 to, the sum of:

2 (a) The base protected account balance shown on the Oregon Judicial Department website as
3 exempt from garnishment; and

4 (b) The amount by which the sum of all payments described in (4) above exceeds the base pro-
5 tected account balance.

6 (6) Any amount in the Debtor's accounts that exceeds the amounts described in (5) above is
7 subject to garnishment and you must proceed with garnishment in the ordinary manner.

8 (7) If the writ of garnishment is attached to an attestation that a debt arises out of a child
9 support or spousal support obligation or a judgment that contains a money award of restitution, you
10 must provide the Debtor with full customary access to all payments listed in (4) above that were
11 made by direct deposit or electronic transfer to an account within the lookback period the Debtor
12 has with your institution.

14 If the Garnishor fails to pay the search fee required by ORS 18.790 and you do not employ the
15 Debtor, you are not required to deliver a Garnishee Response and you may deal with any property

2 (b) May request notice of any proceeding initiated by the administrator to modify a support or-
 3 der that may affect the child's rights as a child attending school. To receive notice, the child shall
 4 provide an address to the administrator, and the administrator shall notify the child of any modifi-
 5 cation proceeding by **regular** first class mail **or, if authorized by the child, by electronic mail**
 6 **or other electronic delivery method as described by the administrator by rule.** To be a party
 7 to a proceeding, the child must send a written request to the administrator within 30 days after the
 8 date of the notice of the proceeding.

9 (5)(a) If a support order provides for the support or maintenance of a child attending school and
 10 the child qualifies as a child attending school, unless good cause is found for the distribution of the
 11 payment to be made in some other manner, support shall be distributed to the child if services are
 12 being provided under ORS 25.080 or shall be paid directly to the child if those services are not being
 13 provided.

43 (a) The court may allow a credit against child support arrearages for periods of time, excluding
44 reasonable parenting time unless otherwise provided by order or judgment, during which the obligor,
45 with the knowledge and consent of the obligee or pursuant to court order, has physical custody of

1 the child; and

2 (b) The court may allow, as provided in the rules of the **Oregon** Child Support Program, a
3 dollar-for-dollar credit against child support arrearages for any Social Security or Veterans' benefits
4 paid retroactively to the child, or to a representative payee administering the funds for the child's
5 use and benefit, as a result of an obligor's disability or retirement.

6 (8) In a proceeding under subsection (1) of this section, the court may assess against either party
7 a reasonable attorney fee and costs for the benefit of the other party. If a party is found to have
8 acted in bad faith, the court shall order that party to pay a reasonable attorney fee and costs of the
9 defending party.

10 (9) Whenever a motion to establish, modify or terminate child support or satisfy or alter support
11 arrearages is filed and the child support rights of one of the parties or of a child of both of the
12 parties have been assigned to the state, a true copy of the motion shall be served by mail or per-
13 sonal delivery on the Administrator of the Division of Child Support of the Department of Justice
14 or on the branch office providing support services to the county in which the motion is filed.

15 (10)(a) Except as provided in ORS 109.701 to 109.834, the courts of Oregon, having once acquired
16 personal and subject matter jurisdiction in a domestic relations action, retain such jurisdiction re-
17 gardless of any change of domicile.

18 (b) The courts of Oregon, in a proceeding to establish, enforce or modify a child support order,
19 shall recognize the provisions of the federal Full Faith and Credit for Child Support Orders Act (28
20 U.S.C. 1738B).

21 (11) In a proceeding under this section to reconsider provisions in a judgment relating to cus-
22 tody or parenting time, the court may consider repeated and unreasonable denial of, or interference
23 with, parenting time to be a substantial change of circumstances.

24 (12) In a proceeding under this section to reconsider provisions in a judgment relating to par-
25 enting time, the court may suspend or terminate a parent's parenting time with a child if the court
26 finds that the parent has abused a controlled substance and that the parenting time is not in the
27 best interests of the child. If a court has suspended or terminated a parent's parenting time with
28 a child for reasons described in this subsection, the court may not grant the parent future parenting
29 time until the parent has shown that the reasons for the suspension or termination are resolved and
30 that reinstated parenting time is in the best interests of the child. Nothing in this subsection limits
31 the court's authority under subsection (1)(a) of this section.

32 (13) In a proceeding under this section to reconsider provisions in a judgment relating to cus-
33 tody, temporary placement of the child by the custodial parent pursuant to ORS 109.056 (3) with the
34 noncustodial parent as a result of military deployment of the custodial parent is not, by itself, a
35 change of circumstances. Any fact relating to the child and the parties occurring subsequent to the
36 last custody judgment, other than the custodial parent's temporary placement of the child pursuant
37 to ORS 109.056 (3) with the noncustodial parent, may be considered by the court when making a
38 change of circumstances determination.

39 (14) Within 30 days after service of notice under subsection (1) of this section, the party served
40 shall file a written response with the court.

41 (15)(a) It is the policy of this state:

42 (A) To encourage the settlement of cases brought under this section; and

43 (B) For courts to enforce the terms of settlements described in paragraph (b) of this subsection
44 to the fullest extent possible, except when to do so would violate the law or would clearly
45 contravene public policy.

1 (b) In a proceeding under subsection (1) of this section, the court may enforce the terms set
2 forth in a stipulated order or judgment signed by the parties, an order or judgment resulting from
3 a settlement on the record or an order or judgment incorporating a settlement agreement:

4 (A) As contract terms using contract remedies;

5 (B) By imposing any remedy available to enforce an order or judgment, including but not limited
6 to contempt; or

7 (C) By any combination of the provisions of subparagraphs (A) and (B) of this paragraph.

8 (c) A party may seek to enforce an agreement and obtain remedies described in paragraph (b)
9 of this subsection by filing a motion, serving notice on the other party in the manner provided by
10 ORCP 7 and, if a remedy under paragraph (b)(B) of this subsection is sought, complying with the
11 statutory requirements for that remedy. All claims for relief arising out of the same acts or omis-
12 sions must be joined in the same proceeding.

13 (d) Nothing in paragraph (b) or (c) of this subsection limits a party's ability, in a separate pro-
14 ceeding, to file a motion to modify an order or judgment under subsection (1) of this section or to
15 seek enforcement of an ancillary agreement to the order or judgment.

16 **SECTION 77.** ORS 180.345 is amended to read:

17 180.345. (1) The Department of Justice is responsible for the administration, supervision and
18 operation of the program authorized by Title IV-D of the Social Security Act (42 U.S.C. 651 et seq.),
19 hereinafter the **Oregon** Child Support Program. The Administrator of the Division of Child Support
20 of the Department of Justice is the **Oregon** Child Support Program Director for the State of Oregon.

21 (2) The Department of Justice, by and through the director, may:

22 (a) Enter into cooperative agreements with appropriate courts, law enforcement officials, district
23 attorneys, Indian tribes or tribal organizations and state agencies to provide assistance in carrying
24 out **services provided by the Oregon** Child Support Program [*services*] and any other matters of
25 common concern;

26 (b) Provide billing, receipting, record keeping, accounting and distribution services for child and
27 spousal support cases that receive services required under state and federal law;

28 (c) Maintain the state plan required under federal law and act as the liaison for the **Oregon**
29 Child Support Program with the United States Department of Health and Human Services;

30 (d) Establish policy and adopt rules for the operation of the **Oregon** Child Support Program by
31 the Department of Justice and by entities entering into cooperative agreements under this section;

32 (e) Conduct performance and program audits of entities entering into cooperative agreements
33 under this section; and

34 (f) Perform any other act necessary or desirable to ensure the effective administration of the
35 **Oregon** Child Support Program under state and federal law.

36 (3) The Department of Justice shall accept and disburse federal funds made available to the
37 state for provision of the **Oregon** Child Support Program and all related functions in a manner
38 consistent with federal law. The department may retain the state share of moneys recovered under
39 child support assignments for the administration of the **Oregon** Child Support Program as allowed
40 under federal regulations.

41 (4) It is the policy of the **Oregon** Child Support Program to inform persons served by the pro-
42 gram, in a manner consistent with federal law, of resources not provided by the program that are
43 available for assistance in family law matters including, but not limited to, services provided
44 through the courts of this state, the Oregon State Bar, law schools and legal service providers that
45 receive funding from the Legal Services Program established under ORS 9.572. The program shall

1 consult with the local family law advisory committees established under ORS 3.434 to ensure that
2 eligible individuals are aware of the services offered by the program. The policy described in this
3 subsection shall be incorporated into staff training and is applicable to all entities that have entered
4 into cooperative agreements with the Department of Justice under this section.

5 (5) The director shall ensure that **Oregon** Child Support Program policy and rules, to the max-
6 imum extent practicable, meet the needs of the majority of families served by the program. The di-
7 rector shall guide program staff regarding implementation of the policy and rules.
