## House Bill 3439

Sponsored by Representatives NOSSE, HELFRICH

## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Makes insurers pay naturopathic doctors the same as a doctor, PA or NP when they do the same work. (Flesch Readability Score: 67.3).

Requires individual and group health benefit plans and benefit plans offered by the Public Employees' Benefit Board and the Oregon Educators Benefit Board to reimburse services provided by naturopathic physicians within the scope of their practice if the services are reimbursed when provided by licensed physicians, physician associates or nurse practioners. Requires reimbursement paid to a naturopathic physician in independent practice to be in the same amount as reimbursement paid to a physician, physician associate or nurse practioner.

## A BILL FOR AN ACT

- 2 Relating to naturopathic physicians; creating new provisions; and amending ORS 243.144 and 243.877.
- 4 Be It Enacted by the People of the State of Oregon:
- 5 SECTION 1. Section 2 of this 2025 Act is added to and made a part of the Insurance Code.
- 6 SECTION 2. (1) As used in this section:
  - (a) "Health benefit plan" has the meaning given that term in ORS 743B.005.
- 8 (b) "Independent practice" means a practice at which a naturopathic physician bills 9 insurers for services provided by the naturopathic physician using the:
  - (A) Diagnosis and procedure codes applicable to the services;
- 11 (B) Naturopathic physician's own name; and
  - (C) Naturopathic physician's national provider identifier.
- 13 (c) "Naturopathic physician" has the meaning given that term in ORS 685.010.
- 14 (d) "Nurse Practioner" has the meaning given that term in ORS 678.010.
- 15 (e) "Physician" has the meaning given that term in ORS 677.010.
  - (f) "Physician associate" has the meaning given that term in ORS 677.495.
  - (2) An individual or group health benefit plan that reimburses the cost of a service provided by a physician, physician associate or nurse practitioner shall reimburse the cost of the same service provided by a naturopathic physician if the service is within the scope of practice of the naturopathic physician.
  - (3) An individual or group health benefit plan shall reimburse the cost of a service provided by a naturopathic physician who is in an independent practice in the same amount and using the same payment methodology as the reimbursement paid under the plan to a physician, physician associate or nurse practitioner providing the service in the same setting and geographic area.
  - (4) An insurer may not reduce the reimbursement paid to a physician, physician associate or nurse practitioner in order to comply with this section.
