

House Bill 3872

Sponsored by Representatives DRAZAN, RESCHKE, HELFRICH, BOICE, YUNKER; Representatives ELMER, MCINTIRE, OSBORNE, SCHARF, WRIGHT

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Makes voting in person the normal method for voting. Requires voters to show picture ID when voting or requesting a ballot. Refers the Act to the people at the next general election. (Flesch Readability Score: 63.8).

Makes in-person voting on the date of an election the standard method for conducting an election. Allows an elector to request a ballot that may be voted by mail if the elector is unable to vote in person on the date of the election. Retains vote by mail as the primary method for conducting elections for military and overseas electors and for electors who have a mailing address outside of Oregon.

Requires electors to present valid government-issued identification when appearing in-person to vote or when requesting a ballot be sent by mail. Requires all ballots to be returned by the date of an election.

Removes a requirement that the state pay postage for ballots returned by mail.

Refers the Act to the people for their approval or rejection at the next regular general election.

ELECTIONS CONDUCTED IN PERSON ON DATE OF ELECTION

11 **SECTION 1.** ORS 254.465 is amended to read:

12 254.465. (1) County clerks shall conduct all elections in this state [*by mail*] **in person, on the**
13 **date of the election and at a voting booth maintained under ORS 254.474.**

14 **(2) Notwithstanding subsection (1) of this section, any elector may request that the**
15 **county clerk provide the elector with a ballot that may be returned by mail if the elector:**

16 **(a) Is for any reason unable to vote in person on the date of the election; and**

17 **(b) Requests a ballot that may be returned by mail no later than 21 days before the date**
18 **of the election.**

19 [(2)] **(3)** The Secretary of State shall adopt rules to:

20 (a) Provide for uniformity in the conduct of **in-person voting for** state elections [*by mail*], **in-**
21 **cluding a requirement that an elector must present valid government-issued identification**
22 **that contains a photographic image of the elector prior to voting; and**

23 (b) Govern the procedures for [*conducting elections by mail.*]:

24 **(A) Electors to request a ballot that may be returned by mail under subsection (2) of this**

1 **section, including the requirements that:**

2 (i) **Any request be submitted either in person or on the Internet; and**

3 (ii) **An elector must verify the elector’s identity upon submitting a request under sub-**
 4 **section (2) of this section;**

5 (B) **County clerks to provide ballots that may be returned by mail to a person who makes**
 6 **a request under subsection (2) of this section; and**

7 (C) **Ensuring that ballots that are returned by mail are transported, stored and tallied**
 8 **in a secure and accurate manner.**

9 (4) **This section does not apply to:**

10 (a) **Military or overseas electors as defined in ORS 253.510; or**

11 (b) **Absent electors as defined in ORS 253.005.**

12 (5) **For purposes of this section, “valid government-issued identification” includes:**

13 (a) **An Oregon driver license, driver permit or state identification card issued under ORS**
 14 **807.400; and**

15 (b) **A United States passport or United States military identification card.**

16 **SECTION 2.** ORS 254.474 is amended to read:

17 254.474. *[(1) At each primary election and general election, the county clerk shall maintain voting*
 18 *booths in the county as follows:]*

19 *[(a) In each county with 35,000 or more electors in the county, the county clerk shall maintain a*
 20 *number of voting booths equal to at least one voting booth for every 20,000 electors in the county;*
 21 *and]*

22 *[(b) In each county with fewer than 35,000 electors in the county, the county clerk shall maintain*
 23 *at least one voting booth.]*

24 (1)(a) **The Secretary of State, in consultation with county clerks, shall establish by rule**
 25 **the minimum number of voting booths that must be maintained in each precinct and county**
 26 **for each election in order to ensure that all electors are provided with the opportunity to**
 27 **cast a ballot in person on the date of the election.**

28 (b) **Rules adopted under this subsection shall also specify the dates and times the voting**
 29 **booths must be open and the security requirements for the voting booths. At a minimum,**
 30 **the voting booths designated under this section must be open on the date of the election for**
 31 **a period of eight or more hours, but must be open until at least 8 p.m. At each voting booth**
 32 **designated under this section, the county clerk shall prominently display a sign stating that**
 33 **the location is an official voting booth.**

34 (2) **The county clerk may:**

35 (a) **At the county’s expense, increase the number of voting booths operated during an**
 36 **election; and**

37 (b) **Determine the location of the voting booths required under this section.**

38 (3) **At 8 p.m. on election day, electors who are at the county clerk’s office, a voting booth**
 39 **described under subsection (1) of this section or any location described in ORS 254.472 and**
 40 **who are in line waiting to vote or deposit a voted ballot shall be considered to have begun**
 41 **the act of voting.**

42 **SECTION 3.** Section 4 of this 2025 Act is added to and made a part of ORS chapter 254.

43 **SECTION 4.** For an election held on the date of a primary election:

44 (1) **The county clerk shall provide the official ballot of a major political party to each**
 45 **elector who is registered as being affiliated with the major political party as of the 21st day**

1 before the date of the election and who provides the county clerk with valid government-
 2 issued identification that contains a photographic image of the elector.

3 (2) The county clerk shall provide the official ballot of a major political party to an
 4 elector not affiliated with any political party if the elector:

5 (a) Has applied for the ballot as provided in subsection (3) of this section and that party
 6 has provided under ORS 254.365 for a primary election that admits electors not affiliated with
 7 any political party; and

8 (b) Provides the county clerk with valid government-issued identification.

9 (3) An elector not affiliated with any political party who wishes to vote in the primary
 10 election of a major political party shall apply to the county clerk in writing. The application
 11 must be completed, signed and submitted by the elector electronically, in person or by mail,
 12 in a manner determined by the Secretary of State by rule, and must indicate which major
 13 political party ballot the elector wishes to receive. Subject to ORS 247.203, the application
 14 must be received by the county clerk not later than 5 p.m. of the 21st day before the date
 15 of the election.

16 (4) If the primary election ballot includes city, county or nonpartisan offices or measures,
 17 the county clerk shall provide to each elector who is not eligible to vote for party candidates
 18 a ballot limited to those offices and measures for which the elector is eligible to vote.

19 (5) For purposes of this section, “valid government-issued identification” includes:

20 (a) An Oregon driver license, driver permit or state identification card issued under ORS
 21 807.400 that contains the elector’s current residence address; and

22 (b) A United States passport or United States military identification card.

23 **SECTION 5.** ORS 254.470 is amended to read:

24 254.470. [(1) *The Secretary of State by rule shall establish requirements and criteria for the desig-*
 25 *nation of places of deposit for the ballots cast in an election. The rules shall also specify the dates and*
 26 *times the places of deposit must be open and the security requirements for the places of deposit. At a*
 27 *minimum, the places designated under this section shall be open on the date of the election for a period*
 28 *of eight or more hours, but must be open until at least 8 p.m. At each place of deposit designated under*
 29 *this section, the county clerk shall prominently display a sign stating that the location is an official*
 30 *ballot drop site.*]

31 [(2)(a) *Except as provided in paragraphs (b) to (e) of this subsection, the county clerk shall mail*
 32 *by nonforwardable mail an official ballot with a return identification envelope and a secrecy envelope*
 33 *not sooner than the 20th day before the date of an election and not later than the 14th day before the*
 34 *date of the election, to each active elector of the electoral district as of the 21st day before the date of*
 35 *the election.*]

36 [(b) *If the county clerk determines that an active elector of the electoral district as of the 21st day*
 37 *before the date of the election does not receive daily mail service from the United States Postal Service,*
 38 *the county clerk shall mail by nonforwardable mail an official ballot with a return identification en-*
 39 *velope and a secrecy envelope to the elector not sooner than the 20th day before the date of an election*
 40 *and not later than the 18th day before the date of the election.*]

41 [(c) *In the case of ballots to be mailed to addresses outside this state to electors who are not mili-*
 42 *tary or overseas electors, the county clerk may mail the ballots not sooner than the 29th day before the*
 43 *date of the election.*]

44 [(d) *If an active elector of the electoral district requests an absentee ballot because the elector will*
 45 *be absent from the electoral district during the period of time described in paragraph (a) of this sub-*

1 *section, the county clerk may, if the elector's ballot is available:]*

2 *[(A) Allow the elector to receive the elector's ballot in person at the office of the county clerk not*
 3 *sooner than the 43rd day before the date of the election; or]*

4 *[(B) Mail by nonforwardable mail an official ballot with a return identification envelope and a*
 5 *secrecy envelope to the elector not sooner than the 43rd day before the date of the election.]*

6 *[(e) The county clerk is not required to mail a secrecy envelope under this subsection if the Secre-*
 7 *tary of State has approved a different procedure under ORS 254.458 that provides substantially the*
 8 *same degree of secrecy.]*

9 *[(3) For an election held on the date of a primary election:]*

10 *[(a) The county clerk shall mail the official ballot of a major political party to each elector who is*
 11 *registered as being affiliated with the major political party as of the 21st day before the date of the*
 12 *election.]*

13 *[(b) The county clerk shall mail the official ballot of a major political party to an elector not af-*
 14 *iliated with any political party if the elector has applied for the ballot as provided in this subsection*
 15 *and that party has provided under ORS 254.365 for a primary election that admits electors not affil-*
 16 *iated with any political party.]*

17 *[(c) An elector not affiliated with any political party who wishes to vote in the primary election of*
 18 *a major political party shall apply to the county clerk in writing. The application must be completed,*
 19 *signed and submitted by the elector electronically, in person or by mail, in a manner determined by the*
 20 *secretary by rule and must indicate which major political party ballot the elector wishes to receive.*
 21 *Except for electors described in subsection (4) of this section, and subject to ORS 247.203, the applica-*
 22 *tion must be received by the county clerk not later than 5 p.m. of the 21st day before the date of the*
 23 *election.]*

24 *[(d) If the primary election ballot includes city, county or nonpartisan offices or measures, the*
 25 *county clerk shall mail to each elector who is not eligible to vote for party candidates a ballot limited*
 26 *to those offices and measures for which the elector is eligible to vote.]*

27 *[(4)(a) For each elector who updates a voter registration after the deadline in ORS 247.025, the*
 28 *county clerk shall make the official ballot, the return identification envelope and the secrecy envelope*
 29 *available either by mail or at the county clerk's office or at another place designated by the county*
 30 *clerk. An elector to whom this subsection applies must request a ballot from the county clerk.]*

31 *[(b) The county clerk is not required to make available a secrecy envelope under this subsection if*
 32 *the Secretary of State has approved a different procedure under ORS 254.458 that provides substan-*
 33 *tially the same degree of secrecy.]*

34 **In addition to any rules adopted by the Secretary of State under ORS 254.465, for any**
 35 **ballot that may be returned by mail:**

36 *[(5)] (1) The ballot shall contain the following warning:*

 39 Any person who, by use of force or other means, unduly influences an elector to vote in any
 40 particular manner or to refrain from voting is subject to a fine.

 43 *[(6)(a)] (2)(a) Upon receipt of [any ballot described in this section] **the ballot**, the elector shall*
 44 *mark the ballot, sign the return identification envelope supplied with the ballot and comply with the*
 45 *instructions provided with the ballot.*

1 (b) The elector may return the marked ballot to the county clerk by United States mail or by
2 depositing the ballot at the office of the county clerk[, *at any place of deposit designated by the*
3 *county clerk or at any location described in ORS 254.472 or 254.474*].

4 (c) The ballot must be returned in the return identification envelope.

5 (d) Subject to paragraph (e) of this subsection, if a person returns a ballot for an elector, the
6 person shall deposit the ballot in a manner described in paragraph (b) of this subsection not later
7 than two days after receiving the ballot.

8 (e) [*If the elector deposits the ballot at the office of the county clerk, at any place of deposit des-*
9 *ignated by the county clerk or at any location described in ORS 254.472 or 254.474, the*] **The** ballot
10 must be received at the office of the county clerk[, *at the designated place of deposit or at any lo-*
11 *cation described in ORS 254.472 or 254.474*] not later than [*the end of the period determined under*
12 *subsection (1) of this section*] **8 p.m.** on the date of the election. [*If the elector returns the ballot by*
13 *mail:*]

14 [(A) *The ballot must be received at the office of the county clerk not later than the end of the period*
15 *determined under subsection (1) of this section on the date of the election; or*]

16 [(B) *The ballot must:*]

17 [(i) *Have a postal indicator showing that the ballot was mailed not later than the date of the*
18 *election; and*]

19 [(ii) *Be received at the office of the county clerk not later than seven calendar days after the date*
20 *of the election.*]

21 [(f) *If a county clerk receives a marked ballot for an elector who does not reside in the clerk's*
22 *county, the ballot shall be forwarded to the county clerk of the county in which the elector resides not*
23 *later than the eighth day after the election.*]

24 [(7) *The following shall appear on the return identification envelope:*]

25 [(a) *Space for the elector to sign the envelope.*]

26 [(b) *A notice designed by rule by the Secretary of State, in consultation with the county clerks,*
27 *explaining that by signing the ballot the elector is attesting under penalty of perjury that the ballot*
28 *was mailed no later than the date of the election.*]

29 [(c) *A summary of the applicable penalties for knowingly making a false statement, oath or affidavit*
30 *under the election laws.*]

31 [(8) *If the elector returns the ballot by mail, and a postal indicator is not present or legible, the*
32 *ballot shall be considered to be mailed on the date of the election and may be counted if the ballot is*
33 *received no later than seven calendar days after the election.*]

34 [(9)] **(3)** An elector may obtain a replacement ballot if the ballot is destroyed, spoiled, lost or
35 not received by the elector. Replacement ballots shall be issued and processed as described in this
36 section and ORS 254.480. The county clerk shall keep a record of each replacement ballot provided
37 under this subsection. [*Notwithstanding any deadline for mailing ballots in subsection (2) of this*
38 *section, a*] **A** replacement ballot may be mailed, made available in the office of the county clerk or
39 made available at one central location in the electoral district in which the election is conducted.
40 The county clerk shall designate the central location. A replacement ballot need not be mailed after
41 the fifth day before the date of the election.

42 [(10)] **(4)** [A] **The** ballot shall be counted only if:

43 (a) It is returned in the return identification envelope;

44 (b) The envelope is signed by the elector to whom the ballot is issued, unless a certified state-
45 ment is submitted under ORS 254.431; and

(c) The signature is verified as provided in subsection [(11)] **(5)** of this section.

[(11)] **(5)** The county clerk shall verify the signature of *[each]* **the** elector on the return identification envelope with the signature on the elector’s registration record, according to the procedure provided by rules adopted by the Secretary of State. Rules adopted by the secretary under this subsection must limit personnel authorized to verify signatures to the personnel authorized to count ballots under ORS 254.476. If the county clerk determines that an elector to whom a replacement ballot has been issued has voted more than once, the county clerk shall count only one ballot cast by that elector.

[(12) *At 8 p.m. on election day, electors who are at the county clerk’s office, a place of deposit designated under subsection (1) of this section or any location described in ORS 254.472 or 254.474 and who are in line waiting to vote or deposit a voted ballot shall be considered to have begun the act of voting.*]

[(13)(a)(A)] **(6)(a)(A)** Except as provided in subparagraph (B) of this paragraph, the name of the Secretary of State may not appear in the secretary’s official capacity on the return identification envelope or on any instructions or materials included with the ballot if the secretary is a candidate in the election for which the ballot is printed.

(B) This paragraph does not prohibit the name of the Secretary of State from appearing in the secretary’s official capacity in the voters’ pamphlet.

(b) The name of the county clerk or other filing officer may not appear in the official capacity of the county clerk or filing officer on the return identification envelope or on any instructions or materials included with the ballot if the county clerk or filing officer is a candidate in the election for which the ballot is printed.

(c) As used in this subsection, “filing officer” has the meaning given that term in ORS 254.165.

[(14) *As used in this section, “postal indicator” means a postmark or other indicator on a mailed ballot, identified by the Secretary of State by rule, that demonstrates the date or time at which a ballot was mailed.*]

BALLOTS MUST BE RECEIVED BY DATE OF ELECTION

SECTION 6. ORS 253.065 is amended to read:

253.065. (1) For electors with mailing addresses outside this state, the county clerk shall deliver a ballot:

(a) Not later than the 45th day before the election to each military or overseas elector; and

(b) Not sooner than the 29th day before the election to each absent elector *[with a mailing address outside this state who is not a military or overseas elector]*.

(2) The clerk shall deliver with the ballot instructions for marking and returning the ballot, a return identification envelope and, if used, a secrecy envelope. *[Except as provided in subsection (3) of this section, the return identification envelope must contain:]* **The back of the envelope must include a statement to be signed by the absent elector, stating that the elector:**

(a) Is qualified to vote;

(b) Unless prevented by physical disability, has personally marked the ballot; and

(c) Has not unnecessarily exhibited the marked ballot to any other person.

[(a) Space for the elector to sign the envelope.]

[(b) A notice designed by rule by the Secretary of State, in consultation with the county clerks, explaining that by signing the ballot the elector is attesting under penalty of perjury that the ballot

1 *was mailed no later than the date of the election.]*

2 *[(c) A summary of the applicable penalties for knowingly making a false statement, oath or affidavit*
 3 *under the election laws.]*

4 *[(3) For a military or overseas elector as defined in ORS 253.501, the return identification envelope*
 5 *provided under subsection (2) of this section must contain:]*

6 *[(a) Any information that a military or overseas elector is required to sign under the federal Help*
 7 *America Vote Act of 2002 (P.L. 107-252) or other federal law;]*

8 *[(b) Space for the elector to sign; and]*

9 *[(c) To the extent not required under paragraph (a) of this subsection, a notice designed by rule*
 10 *by the Secretary of State that ensures that any military or overseas elector who returns a ballot by*
 11 *mail makes a legally binding assertion that the ballot was mailed no later than the date of the*
 12 *election.]*

13 *[(4)] (3) An absent elector may obtain a replacement ballot if the ballot delivered under this*
 14 *section is destroyed, spoiled, lost or not received by the elector. The county clerk shall keep a re-*
 15 *cord of each replacement ballot provided under this subsection.*

16 *[(5)] (4) A replacement ballot provided under subsection [(4)] (3) of this section may be mailed*
 17 *or shall be made available in the office of the county clerk.*

18 *[(6)] (5) If the county clerk determines that an absent elector to whom a replacement ballot has*
 19 *been issued at the request of the elector has voted more than once, the county clerk shall count only*
 20 *the first ballot received by the clerk and provide the elector's name to the Secretary of State for*
 21 *further review. If the county clerk is required to reissue ballots due to a change on the ballot for*
 22 *any reason, that ballot shall be counted in lieu of any previous ballot issued unless:*

23 *(a) Only the original ballot was voted and returned; or*

24 *(b) The county clerk issued a supplemental ballot that is not a complete replacement of the or-*
 25 *iginal ballot.*

26 **SECTION 7.** ORS 253.070 is amended to read:

27 *253.070. [(1) Upon receipt of a ballot the absent elector shall mark it and comply with the in-*
 28 *structions provided with the ballot. The absent elector may return the marked ballot to the office of the*
 29 *clerk, by any appropriate means.]*

30 *[(2) If the absent elector returns the marked ballot by any means other than by mail, the ballot*
 31 *must be received by a county clerk not later than 8 p.m. of the day of the election.]*

32 *[(3) If the absent elector returns the marked ballot by mail:]*

33 *[(a) The ballot must be received by a county clerk not later than 8 p.m. on the day of the election;*
 34 *or]*

35 *[(b) The ballot must:]*

36 *[(A) Have a postal indicator showing that the ballot was mailed not later than the date of the*
 37 *election; and]*

38 *[(B) Be received at the office of the county clerk not later than seven calendar days after the date*
 39 *of the election.]*

40 *[(4) If the elector returns the ballot by mail, and a postal indicator is not present or legible, the*
 41 *ballot shall be considered to be mailed on the date of the election and may be counted if the ballot is*
 42 *received no later than seven calendar days after the election.]*

43 *[(5) If a county clerk receives a marked ballot for an elector who does not reside in the clerk's*
 44 *county, the ballot shall be forwarded to the county clerk of the county in which the elector resides not*
 45 *later than the eighth day after the election.]*

1 [(6) As used in this section, “postal indicator” has the meaning given that term in ORS 254.470.]

2 **A ballot from an absent elector must be received by a county clerk not later than 8 p.m. on**
 3 **the date of the election.**

4 **SECTION 8.** ORS 254.485, as amended by section 3, chapter 56, Oregon Laws 2024, is amended
 5 to read:

6 254.485. (1) Ballots may be tallied by a vote tally system or by a counting board. A counting
 7 board may tally ballots at the precinct or in the office of the county clerk. In any event, the ballots
 8 shall be tallied and returned by precinct.

9 (2) If a counting board has been appointed, the tally of ballots may begin on the date of the
 10 election.

11 (3)(a) If ballots are tallied by a counting board, after the tally has begun it shall continue until
 12 completed. Except as provided in paragraph (b) of this subsection, a counting board shall tally
 13 without adjournment and in the presence of the clerks and persons authorized to attend.

14 (b) A counting board may be relieved by another board if the tally is not completed after 12
 15 hours.

16 (4) A counting board shall audibly announce the tally as it proceeds. The board shall use only
 17 pen and ink to tally.

18 (5) For ballots cast using a voting machine, the county clerk shall:

19 (a) Enter the ballots cast using the machine into the vote tally system; and

20 (b) In the event of a recount, provide the paper record copy recorded by the machine to the
 21 counting board.

22 (6) A person other than the county clerk, a member of a counting board or any other elections
 23 official designated by the county clerk may not tally ballots under this chapter.

24 [(7) *The Secretary of State shall by rule establish a procedure for announcing the status of the tally*
 25 *of the ballots received after the date of the election. Rules adopted under this subsection must:]*

26 [(a) *Consider the number of ballots being released in relation to the size of the district;*]

27 [(b) *Prioritize voter anonymity; and*]

28 [(c) *After prioritizing voter anonymity under paragraph (b) of this subsection, prioritize the im-*
 29 *portance of timely reporting election results.]*

30 **NOTE:** Section 9 was deleted. Subsequent sections were not renumbered.

31 **SECTION 10.** ORS 253.690 is amended to read:

32 253.690. (1) A military or overseas elector described in ORS 253.510 may cast a ballot using a
 33 facsimile machine or by electronic mail as provided in this section. Notwithstanding ORS 254.470
 34 [(10)] (4), a ballot cast under this section shall be counted only if the ballot:

35 (a) Is received in the office of the county clerk not later than 8 p.m. on the day of the election;

36 (b) Is accompanied by a return identification envelope containing the signature of the elector
 37 and a signed waiver described in subsection (2) of this section; and

38 (c) The signature is verified as provided in subsection (4) of this section.

39 (2) Each elector who casts a ballot under this section shall complete and submit a waiver de-
 40 scribed in this subsection. The elector shall attest to the information supplied on the waiver by
 41 signing the completed waiver. The Secretary of State by rule shall design the form of the waiver,
 42 which shall include all of the following:

43 (a) Space for the elector to provide the elector’s full name, residence or mailing address, an
 44 electronic mail address, phone or facsimile number where the elector may be contacted and any
 45 other necessary information.

1 (b) A waiver in substantially the following form:

8 (c) A statement to notify the elector that the elector’s ballot will not be counted unless the
9 elector has complied with the provisions of this section.

10 (d) Space for the elector to provide the elector’s signature to attest to the information supplied.

11 (3)(a) If a ballot is cast under this section using a facsimile machine, the return identification
12 envelope and waiver shall also be submitted using a facsimile machine.

13 (b) If a ballot is cast under this section by electronic mail, the return identification envelope
14 and waiver shall also be submitted by electronic mail.

15 (4) The county clerk shall verify the signature of each elector on the return identification en-

24 (A) The imitation ballot or sample ballot and the back of any return envelope enclosed with the

26 TO VOTE.” The statement on the imitation ballot or sample ballot shall be in bold print that is at

38 251 and likely misleads or confuses a reasonable person as to whether the document is an official
39 voters’ pamphlet or a portion of an official voters’ pamphlet in the absence of the required state-
40 ment.

41 (b) If a person prints or circulates an imitation voters’ pamphlet, including by electronic means:

42 (A)(i) The imitation voters’ pamphlet shall state the following: “THIS IS NOT THE OFFICIAL
43 VOTERS’ PAMPHLET.” Except as provided in sub-subparagraph (ii) of this subparagraph, the
44 statement on the imitation voters’ pamphlet shall be in bold print that is at least 36-point type.

45 (ii) For an imitation voters’ pamphlet that is circulated electronically, the statement described

2 and in a font size that is at least three times as large as the font size used for the majority of the
3 text in the imitation voters' pamphlet.

4 (B) The word "UNOFFICIAL" must be superimposed on each page of the imitation voters'
5 pamphlet so that the word extends diagonally across the imitation voters' pamphlet from one margin
6 of text to the other. The superimposed word may be printed or displayed in lighter ink than other
7 text on the imitation voters' pamphlet.

8 (3) A person may not do any electioneering, including circulating any cards or handbills, or so-
9 liciting of signatures to any petition, within any building in which any state or local government
10 elections office [*designated for the deposit of ballots under ORS 254.470*] **maintained as a voting**
11 **booth under ORS 254.474** is located, or within 100 feet measured radially from any entrance to the
12 building. A person may not do any electioneering by public address system located more than 100
13 feet from an entrance to the building if the person is capable of being understood within 100 feet

15 applies during the business hours of the building or, if the building is a county elections office,

14 entations.

15 (d) Provide individual students and student groups the opportunity to provide nonpartisan voter
16 registration services throughout the academic term in any nonreserved public space on the school's
17 property, provided that the nonpartisan voter registration services conform to the rules of conduct
18 and rules for reserving space at the school. This paragraph applies only to students enrolled at the
19 school and does not alter in any way the rights of a person who is not enrolled as a student at the
20 school.

21 (e) If the school owns and operates any student housing, at least three months prior to each
22 primary or general election:

23 (A) Obtain from the local county elections office what address information students living in
24 on-campus housing must provide in order to receive election ballots in the event a student chooses
25 to vote using the student's campus address; and

26 (B) Make the information obtained under subparagraph (A) of this paragraph available to the
27 school's official student government or its equivalent.

28 **SECTION 24.** ORS 247.948 is amended to read:

29 247.948. (1)(a) Except as set forth in ORS 247.965 or 247.967, or as otherwise prohibited by law,
30 the following information about an elector contained within an elector's registration file is subject
31 to inspection as a public record under ORS 192.311 to 192.478 and shall be included in lists delivered
32 under ORS 247.940 and 247.945:

33 (A) The major political party or minor political party, if any, with which an elector is affiliated;

34 (B) Except as provided in subsection (3) of this section, the residence address of an elector;

35 (C) Except as provided in subsection (3) of this section, the address where an elector receives
36 a ballot;

37 (D) The year in which an elector was born;

38 (E) The name or number of the precinct in which the elector resides;

39 (F) The precinct split of an elector;

40 (G) The administrative number for an elector that is used by the Secretary of State to determine
41 which elections an elector may vote in;

42 (H) The telephone number of an elector;

43 (I) Whether or not an elector voted in previous elections; and

44 (J) During an election period, the ballot status of an elector. In order to comply with this sub-
45 paragraph, during the election period, the secretary shall maintain a list of the ballot status of

1 electors. The secretary shall update the list, and make available an updated version of the list, on
 2 each business day of the election period.

3 (b) As used in this subsection:

4 (A) "Ballot status" means whether or not an elector has cast a ballot in the election;

5 (B) "Election period" means the period of time beginning [*on the date that ballots for an election*
 6 *are first mailed to electors*] **21 days before the date of the election** and ending on the date of the
 7 election; and

8 (C) "Precinct split" means the enhanced precinct name or number used to determine the specific
 9 ballot configuration that will be received by an elector who resides in a precinct that:

10 (i) Has more than one election district subdivision; and

11 (ii) Requires more than one ballot configuration for electors in the precinct.

12 (2) Except as set forth in ORS 247.973 or as otherwise required by law, the following information
 13 about an elector contained within an elector's registration file is not subject to inspection as a
 14 public record under ORS 192.311 to 192.478 and may not be disclosed by the Secretary of State or
 15 a county clerk:

16 (a) Information that is required to be kept confidential under ORS 247.965 or as part of the
 17 Address Confidentiality Program under ORS 192.820 to 192.868;

18 (b) The birth month of an elector;

19 (c) The day of the month on which an elector was born;

20 (d) The Social Security number of an elector;

21 (e) The driver license number of an elector; and

22 (f) The signature of an elector.

23 (3) The residence address of an elector may not be included in lists delivered under ORS 247.940
 24 and 247.945 if the elector:

25 (a) Is either a candidate for elected office or a holder of elected office; and

26 (b) Has chosen to limit the public accessibility of the elector's residence address in the manner
 27 described in ORS 249.021.

28 (4) Nothing in this section is intended to limit or restrict the disclosure of information that is
 29 otherwise subject to inspection as a public record under ORS 192.311 to 192.478.

30 **SECTION 25.** ORS 247.965 is amended to read:

31 247.965. (1) Any elector may request the county clerk to keep the residence address of the
 32 elector and any family member residing with the elector exempt from disclosure as a public record
 33 under ORS 192.311 to 192.478.

34 (2) The county clerk shall keep the residence address of an elector and any family member re-
 35 siding with the elector exempt from disclosure as a public record under ORS 192.311 to 192.478 if:

36 (a) The elector making the request demonstrates to the satisfaction of the county clerk that the
 37 elector's personal safety or the safety of any family member residing with the elector is in danger
 38 if the elector's address remains available for public inspection; or

39 (b) The elector has been identified as an election worker by the Secretary of State, county clerk

2 [(5)] (4) An exemption from disclosure granted under this section includes an exemption from

5 (a) Granting or denying an exemption from disclosure under this section; or

6 (b) Any unauthorized release of a residence address granted an exemption from disclosure under
7 this section.

8 [(7)] (6) As used in this section, "election worker" means an individual employed full-time,
9 part-time or as a volunteer:

10 (a) Who is serving the State of Oregon or any other public body, as defined in ORS 174.109, as
11 an elected official, appointed official, employee or agent; and

12 (b) Whose official duties include carrying out any duty, function or power set forth in ORS
13 chapters 246 to 260.

15 254.321. At any election in which the question of establishing or changing the exterior bounda-
16 ries of a county or city is submitted to a vote, the county clerk shall[:]

17 [(1) *Include with every mailed ballot a map indicating the proposed boundaries; or*]

18 [(2)] print in a voters' pamphlet prepared for the election a map indicating the proposed bound-

24 Plan, containing the legal name, age, residence and citizenship information for, and, if any, the
