## House Bill 3927

Sponsored by Representative EDWARDS

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Tells ODOE to study the need to build more electric transmission lines. Tells ODOE to

build two electric transmission projects. (Flesch Readability Score: 61.3). Requires the State Department of Energy to study the need to expand electric transmission infrastructure in this state. Directs the department to submit findings to the interim committees of the Legislative Assembly related to energy no later than September 15, 2026.

Establishes the Oregon Electric Transmission Expansion Fund. Requires the State Department of Energy to develop two electric transmission expansion projects no later than January 1, 2036. Appropriates moneys to the fund over five biennia.

Sunsets the fund on January 2, 2036.

## A BILL FOR AN ACT

2 Relating to electric transmission infrastructure.

3 Be It Enacted by the People of the State of Oregon:

SECTION 1. The State Department of Energy shall study the need to expand electric 4 transmission infrastructure in this state. The department shall submit a report in the 5 manner provided by ORS 192.245, and may include recommendations for legislation, to the 6 7 interim committees of the Legislative Assembly related to energy no later than September 15, 2026. 8

SECTION 2. Section 1 of this 2025 Act is repealed on January 2, 2027. 9

10 SECTION 3. (1) The Oregon Electric Transmission Expansion Fund is established in the State Treasury, separate and distinct from the General Fund. Moneys in the fund are con-11 12 tinuously appropriated to the State Department of Energy for the purpose described in subsection (4) of this section. 13

(2) The fund consists of moneys appropriated, allocated, deposited or transferred to the 14 fund by the Legislative Assembly or otherwise. 15

(3) Moneys in the fund may be invested as provided in ORS 293.701 to 293.857, and interest 16 17earned on the moneys in the fund must be credited to the fund.

18 (4) The department shall use moneys in the fund to develop two electric transmission expansion projects. The department shall complete the two projects no later than January 19 1, 2036. 20

21SECTION 4. In addition to and not in lieu of any other appropriation, there is appropriated to the State Department of Energy, for the biennium beginning July 1, 2025, out of the 22 23General Fund, the amount of \$8,000,000,000, for deposit in the Oregon Electric Transmission 24Expansion Fund established in section 3 of this 2025 Act.

25SECTION 5. In addition to and not in lieu of any other appropriation, there is appropriated to the State Department of Energy, for the biennium beginning July 1, 2027, out of the 26General Fund, the amount of \$8,000,000,000, for deposit in the Oregon Electric Transmission 27

11 ated to the State Department of Energy, for the biennium beginning July 1, 2033, out of the

12 General Fund, the amount of \$8,000,000, for deposit in the Oregon Electric Transmission

13 Expansion Fund established in section 3 of this 2025 Act.

14 SECTION 9. (1) Section 3 of this 2025 Act is repealed on January 2, 2036.

15 (2) Unobligated moneys remaining in the Oregon Electric Transmission Expansion Fund

16 on the date described in subsection (1) of this section shall revert to the General Fund.
