

## HOUSE AMENDMENTS TO HOUSE BILL 3940

By COMMITTEE ON CLIMATE, ENERGY, AND ENVIRONMENT

April 15

On page 1 of the printed bill, line 2, after “wildfire,” delete the rest of the line and lines 3 through 5 and insert “creating new provisions; amending ORS 242.702, 291.055, 321.005, 321.015, 476.565, 477.001, 477.205, 477.230, 477.270, 477.277, 477.281, 477.295, 477.440, 477.445, 477.450, 477.455, 477.460, 477.750, 477.755, 477.760, 477.775, 477.777, 478.010, 478.120 and 478.140; repealing ORS 476.310, 476.320, 476.330, 476.340, 477.415, 477.880, 477.960 and 477.970; prescribing an effective date; and providing for revenue raising that requires approval by a three-fifths majority.”.

Delete lines 7 through 22 and delete pages 2 through 11 and insert:

### “BEVERAGE CONTAINER SURCHARGE

“**SECTION 1.** Section 2 of this 2025 Act is added to and made a part of ORS 459A.700 to 459A.744.

“**SECTION 2.** (1) A dealer shall collect a five cent surcharge on each beverage container sold in this state. At least once per quarter, a dealer shall transfer the full amount of surcharges collected under this section to the Department of the State Fire Marshal.

“(2)(a) The department shall deposit half of the amounts received under this section in the State Fire Marshal Mobilization Fund established under ORS 476.565.

“(b) The department shall transfer half of the amounts received under this section to the State Forestry Department for deposit in the Landscape Resiliency Fund established under ORS 477.502.

“(3) The Oregon Liquor and Cannabis Commission, in consultation with the Department of the State Fire Marshal, shall adopt rules necessary for the administration of this section.

### “INSURANCE RETALIATORY TAX

“**SECTION 3.** (1) Once per year, the Department of Consumer and Business Services shall determine the aggregate amount of revenue collected by the department pursuant to the retaliatory tax imposed on insurers under ORS 731.854.

“(2)(a) The department shall transfer an amount equal to half of the amount determined under subsection (1) of this section to the Department of the State Fire Marshal for deposit in the State Fire Marshal Mobilization Fund established under ORS 476.565.

“(b) The Department of Consumer and Business Services shall transfer an amount equal to half of the amount determined under subsection (1) of this section to the State Forestry Department for deposit in the Landscape Resiliency Fund established under ORS 477.502.

1 "ENDING BALANCE

2  
3 "SECTION 4. (1) Except as provided in subsection (2) of this section, immediately after  
4 the time of each transfer to the Oregon Rainy Day Fund under ORS 293.146, an amount equal  
5 to one-half percent of the amount of General Fund appropriations for the preceding biennium  
6 shall be transferred in equal shares from the General Fund to the State Fire Marshal  
7 Mobilization Fund established under ORS 476.565 and to the Landscape Resiliency Fund es-  
8 tablished under ORS 477.502.

9 "(2) If the remaining ending balance does not equal or exceed the amount required to be  
10 transferred under subsection (1) of this section, then an amount equal to the remaining  
11 ending balance shall be transferred in equal shares from the General Fund to the State Fire  
12 Marshal Mobilization Fund established under ORS 476.565 and to the Landscape Resiliency  
13 Fund established under ORS 477.502.

14 "(3) As used in this section:

15 "(a) 'Ending balance' has the meaning given that term in ORS 293.146.

16 "(b) 'General Fund appropriations' has the meaning given that term in ORS 293.146.

17 "(c) 'Remaining ending balance' means an ending balance, minus the amount actually  
18 transferred to the Oregon Rainy Day Fund under ORS 293.146 after the biennium to which  
19 the ending balance relates.

20  
21 "OREGON RAINY DAY FUND

22  
23 "SECTION 5. (1) Notwithstanding ORS 293.144, an amount equal to 25 percent of the  
24 amount held in the Oregon Rainy Day Fund immediately prior to the transfers required un-  
25 der this section is transferred from the Oregon Rainy Day Fund to the State Fire Marshal  
26 Mobilization Fund established under ORS 476.565. The transfer shall be made on September  
27 1, 2025.

28 "(2) Notwithstanding ORS 293.144, an amount equal to 25 percent of the amount held in  
29 the Oregon Rainy Day Fund immediately prior to the transfers required under this section  
30 is transferred from the Oregon Rainy Day Fund to the Landscape Resiliency Fund estab-  
31 lished under ORS 477.502. The transfer shall be made on September 1, 2025.

32  
33 "FOREST PRODUCTS HARVEST TAX FOR  
34 WILDFIRE MITIGATION AND SUPPRESSION

35  
36 "SECTION 6. ORS 321.015 is amended to read:

37 "321.015. (1) For the calendar years beginning January 1, [2024] **2026**, and January 1, [2025]  
38 **2027**, there is levied a privilege tax of 90.00 cents per thousand feet, board measure, upon taxpayers  
39 for the privilege of harvesting of all merchantable forest products harvested on forestlands. Subject  
40 to ORS 321.145, the proceeds of the tax shall be transferred as provided in ORS 321.152 (2) to the  
41 Forest Research and Experiment Account for use for the forest resource research, experimentation  
42 and studies described in ORS 526.215 and for the Forest Research Laboratory established under ORS  
43 526.225.

44 "(2)(a) [Except as provided in ORS 477.760,] In addition to the tax levied by subsection (1) of this  
45 section, there is levied a forest products harvest tax upon taxpayers of [62.5] **100** cents per thousand

1 feet, board measure, for the privilege of harvesting all merchantable forest products harvested on  
2 forestlands for the payment of benefits related to fire suppression as provided in ORS 321.005 to  
3 321.185, 321.560 to 321.600 and 477.440 to 477.460.

4 **“(b)(A) The rate set under paragraph (a) of this subsection for any calendar year shall**  
5 **be adjusted by the percentage, if any, by which the monthly averaged Consumer Price Index**  
6 **for All Urban Consumers, West Region (All Items) for the 12 consecutive months ending**  
7 **August 31 of the prior calendar year exceeds the monthly averaged index for the 12 consec-**  
8 **utive months ending August 31, 2024.**

9 **“(B) The adjustment computed under subparagraph (A) of this paragraph shall be**  
10 **rounded to the nearest one-tenth of a cent.**

11 **“(3) For the calendar years beginning January 1, [2024] 2026, and January 1, [2025] 2027, in ad-**  
12 **dition to the taxes levied under subsections (1) and (2) of this section, there is levied a privilege tax**  
13 **upon taxpayers for the privilege of harvesting all merchantable forest products harvested on**  
14 **forestlands in the amount of 253.46 cents per thousand feet, board measure, for the purpose of ad-**  
15 **ministering the Oregon Forest Practices Act in an amount not to exceed 40 percent of the total**  
16 **expenditures approved by the Legislative Assembly for this purpose, including salary adjustments**  
17 **approved by the Legislative Assembly for fiscal years [2024] 2026 and [2025] 2027.**

18 **“(4) For the calendar years beginning January 1, 2024, and January 1, 2025, in addition to the**  
19 **taxes levied by subsections (1) to (3) of this section, there is levied a privilege tax of 21 cents per**  
20 **thousand feet, board measure, upon taxpayers for the privilege of harvesting all merchantable forest**  
21 **products harvested on forestlands. Subject to ORS 321.145, the proceeds of the tax shall be trans-**  
22 **ferred as provided in ORS 321.152 (5) to the subaccount established pursuant to ORS 350.520 for use**  
23 **by Oregon State University for the purpose of making investments in professional forestry education**  
24 **at the College of Forestry.**

25 **“(5) Subject to subsection (6) of this section, the taxes shall be measured by and be applicable**  
26 **to each per thousand feet, board measure, on the total quantity of forest products harvested in this**  
27 **state measured by use of any log scale which is or may be in general use in the logging industry**  
28 **and which is designed to measure total volume of merchantable forest products in board feet. How-**  
29 **ever, if the Department of Revenue finds that the scale used by any taxpayer in computing the taxes**  
30 **due under ORS 321.005 to 321.185 and 321.560 to 321.600 does not accurately reflect the total**  
31 **quantity of merchantable forest products harvested by the taxpayer, it may require the taxpayer to**  
32 **adopt another log scale in general use in the industry which in the department’s opinion will accu-**  
33 **rately reflect merchantable harvest in board feet.**

34 **“(6) The first 25,000 feet, board measure, of forest products harvested annually by any taxpayer**  
35 **during each calendar year shall be excluded from the total quantity of harvested forest products that**  
36 **constitutes the measure of the taxes under ORS 321.005 to 321.185 and 321.560 to 321.600.**

37 **“(7)(a) Not later than March 10 of each odd-numbered year, the Legislative Assembly shall begin**  
38 **considering the biennial forest products harvest tax rates levied under subsections (1), (3) and (4)**  
39 **of this section.**

40 **“(b) Upon request of the Legislative Revenue Officer or the Legislative Fiscal Officer, the State**  
41 **Forestry Department shall provide the respective officers with relevant timber harvest data for the**  
42 **purposes of paragraph (a) of this subsection.**

43 **“SECTION 7. The amendments to 321.015 by section 6 of this 2025 Act apply to calendar**  
44 **years beginning on or after January 1, 2026.**

45 **“SECTION 8. ORS 321.005 is amended to read:**

1 “321.005. As used in ORS 321.005 to 321.185[,] **and** 321.560 to 321.600 [*and 477.440 to 477.460*],  
2 unless the context requires otherwise:

3 “[*(1) ‘Board’ means the State Board of Forestry.*]

4 “[*(2) ‘Protected forestlands’ means those lands which are protected from the starting or spread of*  
5 *fire thereon or therefrom by:*]

6 “[*(a) The State Forester, with the approval of the board;*]

7 “[*(b) The United States of America through contract with the State Forester;*]

8 “[*(c) Any forest protective agency under contract with the State Forester or the board pursuant to*  
9 *ORS 477.406; or*]

10 “[*(d) Any forest protective agency, described in paragraph (c) of this subsection, under an agree-*  
11 *ment with the United States of America wherein such agency agrees to protect specific federal*  
12 *forestlands and, in return, the United States of America agrees to protect specific lands of such*  
13 *agency.*]

14 “[*(3) ‘Department’ means the Department of Revenue.*]

15 “[*(4) ‘Committee’ means the Emergency Fire Cost Committee.*]

16 “**(1) ‘Consumer Price Index for All Urban Consumers, West Region (All Items)’ means**  
17 **the Consumer Price Index for All Urban Consumers, West Region (All Items), as published**  
18 **by the Bureau of Labor Statistics of the United States Department of Labor.**

19 “[*(5)*] **(2) ‘Forestland’ means any land producing forest products.**

20 “[*(6)*] **(3) ‘Forest products’ means products from harvested timber, but does not include products**  
21 **from short rotation fiber grown under agricultural conditions as described in ORS 321.267 (3) or**  
22 **321.824 (3), western juniper or products from harvested western juniper.**

23 “[*(7)*] **(4) ‘Harvest’ means the point at which timber that has been cut, severed, or removed for**  
24 **purposes of sale or use is first measured in the ordinary course of business as determined by refer-**  
25 **ence to common practice in the timber industry.**

26 “[*(8)*] **(5) ‘Merchantable stand of timber’ means any stand on forestlands containing living or**  
27 **dead timber which is being or can be harvested.**

28 “[*(9) ‘Taxpayer’ means the owner of timber at time of harvest.*]

29 “**(6) ‘Owner of timber’ means any individual or combination of individuals, partnership,**  
30 **firm, corporation or association of whatever nature holding title to harvested timber by**  
31 **virtue of:**

32 “**(a) An instrument of conveyance;**

33 “**(b) The harvesting of the timber; or**

34 “**(c) The harvesting of the timber and payment therefor.**

35 “[*(10)*] **(7) ‘Taxes’ means the taxes provided for in ORS 321.015.**

36 “[*(11) ‘Owner of timber’ means any individual or combination of individuals, partnership, firm,*  
37 *corporation or association of whatever nature holding title to harvested timber by virtue of:*]

38 “[*(a) An instrument of conveyance;*]

39 “[*(b) The harvesting of the timber; or*]

40 “[*(c) The harvesting of the timber and payment therefor.*]

41 “**(8) ‘Taxpayer’ means the owner of timber at time of harvest.**

42 “[*(12)*] **(9) ‘Timber’ means all logs which can be measured in board feet and other forest products**  
43 **as determined by department rule.**

44 “**SECTION 9. ORS 477.415 is repealed.**

1                   **“STATE FORESTRY DEPARTMENT LARGE WILDFIRE FUND**

2  
3           **“SECTION 10. (1) The State Forestry Department Large Wildfire Fund is established in**  
4 **the State Treasury, separate and distinct from the General Fund.**

5           **“(2) The State Forestry Department Large Wildfire Fund shall be held by the State**  
6 **Treasurer as a fund for use by the State Forestry Department for wildfire mitigation and**  
7 **suppression. The State Treasurer shall deposit and invest moneys in the fund as provided by**  
8 **law, taking into account its uses. Interest earned by the fund shall be credited to the fund.**

9           **“(3) The fund consists of moneys appropriated by the Legislative Assembly for deposit in**  
10 **the fund and other moneys appropriated to, allocated to, deposited in or transferred to the**  
11 **fund by the Legislative Assembly or otherwise.**

12  
13                   **“DEFINITION OF ‘CENTRALIZED ADMINISTRATION COSTS’**

14  
15           **“SECTION 11. ORS 477.001 is amended to read:**

16           **“477.001. As used in this chapter[, unless the context otherwise requires]:**

17           **“(1) ‘Additional fire hazard’ means a hazard that has been determined to exist by the forester**  
18 **pursuant to ORS 477.580.**

19           **“(2) ‘Board’ means the State Board of Forestry.**

20           **“(3) ‘Campfire’ means any open fire used for cooking, personal warmth, lighting, ceremonial or**  
21 **aesthetic purposes that is hand built and that is not associated with any debris disposal activities.**

22           **“(4) ‘Centralized administration costs’ means all costs associated with:**

23           **“(a) Administration of the State Forestry Department;**

24           **“(b) The following services, provided statewide and in areas of this state by the depart-**  
25 **ment:**

26           **“(A) Fire management on forestland;**

27           **“(B) Emergency response and support; and**

28           **“(C) Other services not described in this paragraph; and**

29           **“(c) The procurement of supplies related to purposes described in this subsection.**

30           **“[(4)] (5) ‘Department’ means the State Forestry Department.**

31           **“[(5)] (6) ‘District’ means a forest protection district organized under ORS 477.225.**

32           **“[(6)] (7) ‘Every reasonable effort’ means the use of the reasonably available personnel and**  
33 **equipment under the supervision and control of an owner or operator, which are needed and effec-**  
34 **tive to fight the fire in the judgment of the forester and which can be brought to bear on the fire**  
35 **in a timely fashion.**

36           **“[(7)] (8) ‘Fire season’ means a period designated pursuant to ORS 477.505.**

37           **“[(8)] (9) ‘Fiscal year’ means the period beginning on July 1 of any year and ending on June 30**  
38 **of the next year.**

39           **“[(9)] (10) ‘Forestland’ means any woodland, brushland, timberland, grazing land or clearing that,**  
40 **during any time of the year, contains enough forest growth, slashing or vegetation to constitute, in**  
41 **the judgment of the forester, a fire hazard, regardless of how the land is zoned or taxed. As used in**  
42 **this subsection, ‘clearing’ means any grassland, improved area, lake, meadow, mechanically or man-**  
43 **ually cleared area, road, rocky area, stream or other similar forestland opening that is surrounded**  
44 **by or contiguous to forestland and that has been included in areas classified as forestland under**  
45 **ORS 526.305 to 526.370.**

1       “[(10)] (11) ‘Forest patrol assessment’ means the costs levied and assessed under ORS 477.270.

2       “[(11)] (12) ‘Forest protective association’ or ‘association’ means an association, group or agency

3 composed of owners of forestlands, organized for the purpose of protecting such forestlands from

4 fire.

5       “[(12)] (13) ‘Forest resource’ means the various types of vegetation normally growing on

6 Oregon’s forestland, the associated harvested products and the associated residue, including but not

7 limited to brush, grass, logs, saplings, seedlings, trees and slashing.

8       “[(13)] (14) ‘Forester’ means the State Forester or authorized representative.

9       “[(14)] (15) ‘Governing body’ of a county means the county court or board of county commis-

10 sioners.

11       “[(15)] (16) ‘Grazing land’ is defined by ORS 477.205.

12       “[(16)] (17) ‘Open fire’ means any outdoor fire that occurs in such a manner that combustion air

13 is not effectively controlled and combustion products are not effectively vented through a stack or

14 chimney.

15       “[(17)] (18) ‘Operation’ means any industrial activity, any development or any improvement on

16 forestland inside or within one-eighth of one mile of a forest protection district, including but not

17 limited to the harvesting of forest tree species, the clearing of land, the use of power-driven ma-

18 chinery and the use of fire, excluding, however, the culture and harvesting of agricultural crops.

19       “[(18)] (19) ‘Operation area’ means the area on which an operation is being conducted and the

20 area on which operation activity may have resulted in the ignition of a fire.

21       “[(19)] (20) ‘Operation in progress’ means that time when workers are on an operation area for

22 the purpose of an operation, including the period of time when fire watches are required to be on

23 the operation area pursuant to ORS 477.665.

24       “[(20)] (21) ‘Operator’ means any person who, either personally or through employees, agents,

25 representatives or contractors, is carrying on or has carried on any operation.

26       “[(21)] (22) ‘Owner’ means an individual, a combination of individuals, a partnership, a corpo-

27 ration, the State of Oregon or a political subdivision thereof, or an association of any nature that

28 holds an ownership interest in land.

29       “[(22)] (23) ‘Political subdivision’ includes, but is not limited to, counties, cities and special dis-

30 tricts.

31       “[(23)] (24) ‘Rangeland’ is defined by ORS 477.315.

32       “[(24)] (25) ‘Routine road maintenance’ is defined by ORS 477.625.

33       “[(25)] (26) ‘Side’ means any single unit of a logging operation employing power-driven machin-

34 ery.

35       “[(26)] (27) ‘Slashing’ means the forest debris or refuse on any forestland resulting from the

36 cutting, killing, pruning, severing or removal of brush, trees or other forest growth.

37       “[(27)] (28) ‘State Forester’ means the person appointed State Forester pursuant to ORS 526.031

38 or the person serving in the position on an interim or delegated basis.

39       “[(28)] (29) ‘Summit of the Cascade Mountains’ is considered to be a line beginning at the

40 intersection of the northern boundary of the State of Oregon and the western boundary of Wasco

41 County; thence southerly along the western boundaries of Wasco, Jefferson, Deschutes and Klamath

42 Counties to the southern boundary of the State of Oregon.

43       “[(29)] (30) ‘Timberland’ is defined by ORS 477.205.

44       “[(30)] (31) ‘Warden’ means a fire warden appointed under ORS 477.355.

“477.205. As used in ORS 477.205 to 477.281[, *unless the context requires otherwise*]:

“[(1)] (2) ‘Grazing land’ means forestland, within a forest protection district, that has been classified as Class 3, agricultural class, as provided by ORS 526.305 to 526.370.

**“SECTION 13.** ORS 477.230 is amended to read:

“(a) (2)(a) Grazing land within the district shall be protected by the [forester] **State Forester** at a pro rata cost of **not less than 30 cents** per acre for all grazing land within the district boundary. However, forest patrol assessments levied and assessed under ORS 477.270 against such lands that are not owned by public agencies, **including grazing land owned in fee by a federally recognized Indian tribe in this state or by a member of a federally recognized Indian tribe in this state**, may not exceed one-half of the pro rata cost per acre[, *exclusive of any assessment acre under ORS 477.880*].

**“(B) If the annual adjustment under this paragraph results in a rate that is lower than the rate for the previous year, the rate shall remain unchanged from the previous year.**

“[(2)] (4) The cost of protection described in this section shall be in accordance with a budget for the district approved by the State Board of Forestry.

**“SECTION 14. ORS 477.270 is amended to read:**

“477.270. (1) Subject to the forest patrol assessment limitations set forth in ORS 477.230:

“(a) The budgeted cost of the forester, as provided for in ORS 477.205 to 477.281, in providing protection for privately owned forestland shall be a lien upon such property, shall be reported by the forester to the governing body of the county in which the lands are situated on or after July 1 of each fiscal year, and shall be levied and collected by the governing body with the next taxes on the land in the same manner and with the same interest, penalty and cost charges as apply to ad valorem property taxes in this state. The governing body shall instruct the proper officer to extend the amounts on the assessment roll in a separate account, and the procedure provided by law for

1 the collection of taxes and delinquent taxes shall apply. Upon collection thereof, the governing body  
2 shall repay the entire amount collected to the forester.

3 “(b) In lieu of the procedures under paragraph (a) of this subsection, the forester, under the di-  
4 rection of the State Board of Forestry, may make direct billing of the budgeted cost to owners of  
5 forestland and receive payment of the cost therefrom. In the event that under such billing proce-  
6 dures any owners fail to make payment, the unpaid budgeted cost shall become a lien against the  
7 property so billed and shall be levied and collected with the next taxes on such property as de-  
8 scribed in paragraph (a) of this subsection.

9 “(c) The budgeted cost of the forester in providing protection for forestland owned by the state  
10 or by a political subdivision shall be paid to the forester on or before the first day of January of the  
11 fiscal year for which such protection is to be provided.

12 “(2) Except as provided in ORS 477.230 [(2)] (4), all moneys received by the forester pursuant  
13 to this section shall be paid into the State Treasury, credited to the State Forestry Department  
14 Account and used exclusively for the purposes of ORS 477.205 to 477.281.

#### 15 16 “MINIMUM ASSESSMENT AND SURCHARGE

17  
18 “**SECTION 15.** ORS 477.277 is amended to read:

19 “477.277. (1)(a) In addition to any other assessment prescribed by ORS 477.205 to 477.281, [in  
20 any fiscal year in which the Emergency Fire Cost Committee determines pursuant to ORS 477.760 that  
21 the unencumbered balance of the Oregon Forest Land Protection Fund is less than \$22.5 million,] a  
22 surcharge shall **annually** be levied and assessed in the amount of [\$47.50] **\$58** for each improved lot  
23 or parcel[, *except as provided in ORS 477.760,*] to defray the increased cost of fire suppression on  
24 forestland that is caused by the existence of the improvements.

25 “(b)(A) **Except as provided in subparagraph (B) of this paragraph, the surcharge estab-**  
26 **lished by paragraph (a) of this subsection shall be adjusted annually for inflation since 2025**  
27 **based on the Consumer Price Index for All Urban Consumers, West Region (All Items), as**  
28 **published by the Bureau of Labor Statistics of the United States Department of Labor.**

29 “(B) **If the annual adjustment under this paragraph results in a surcharge that is lower**  
30 **than the surcharge for the previous year, the surcharge shall remain unchanged from the**  
31 **previous year.**

32 “(2) All surcharge moneys collected pursuant to this section shall be paid into the Oregon For-  
33 est Land Protection Fund.

34 “(3) If an owner of forestland files a forest protection plan with the forester which is approved  
35 by the State Board of Forestry under ORS 477.210 (2), the owner shall not be required to pay the  
36 surcharge levied under subsection (1) of this section.

37 “(4) Contiguous lots included in a combined lot that is described in ORS 477.295 [(3)(a)] (2)(a)  
38 and whose owner has made application to the forester under ORS 477.295 [(4)] (3) are considered  
39 one lot for purposes of subsection (1) of this section.

40 “(5) As used in this section, a lot or parcel is ‘improved’ if it is indicated as improved in the  
41 county assessor’s property classification files or if a manufactured dwelling is sited on the lot or  
42 parcel.

43 “**SECTION 16.** ORS 477.281 is amended to read:

44 “477.281. (1) The obligation of an owner of timberland or grazing land for payment of assess-  
45 ments and taxes for fire protection of forestland is limited to:



1 “(a) The payment of moneys pursuant to ORS 321.015 (2), 477.277[,] **and** 477.295[, 477.760 (4) and

2 477.880 to maintain] **into** the Oregon Forest Land Protection Fund; and

3 “(b) The payment of forest protection district assessments pursuant to ORS 477.205 to 477.281.

4 “(2) As used in this section, ‘obligation of an owner of timberland or grazing land for payment

5 of assessments and taxes for fire protection of forestland’ does not include the duties or obligations

44 “(n) Portal provider fees as defined in ORS 276A.270 and established by the State Chief Infor-  
45 mation Officer under ORS 276A.276 (3) and recommended by the Electronic Government Portal Ad-



visory Board.

“(o) Fees set by the State Parks and Recreation Director and approved by the State Parks and Recreation Commission under ORS 390.124 (2)(b).

“(3)(a) Fees temporarily decreased for competitive or promotional reasons or because of unexpected and temporary revenue surpluses may be increased to not more than their prior level without compliance with subsection (1) of this section if, at the time the fee is decreased, the state agency specifies the following:

“(A) The reason for the fee decrease; and

“(B) The conditions under which the fee will be increased to not more than its prior level.

“(b) Fees that are decreased for reasons other than those described in paragraph (a) of this subsection may not be subsequently increased except as allowed by ORS 291.050 to 291.060 and 294.160.

## “ACREAGE ASSESSMENT

“**SECTION 30. ORS 477.880, 477.960 and 477.970 are repealed.**

## “ZONING OF CERTAIN LANDS

“**SECTION 31. ORS 476.310, 476.320, 476.330, and 476.340 are repealed.**

“**SECTION 32. Lands that are classified under ORS 476.310 as zone 1 lands immediately prior to the effective date of this 2025 Act are classified as Class 3 lands, as defined in ORS 526.324, unless and until reclassified.**

“**SECTION 33.** ORS 242.702 is amended to read:

“242.702. As used in ORS 242.702 to 242.824, unless the context requires otherwise:

“(1) ‘Appointing power’ includes every person or group of persons who, acting singly or as a board, council or commission, are vested with authority to select, appoint or employ any person to hold any position subject to civil service under ORS 242.702 to 242.824.

“(2) ‘Appointment’ includes all means of selecting or employing any person to hold any position subject to civil service under ORS 242.702 to 242.824.

“(3) ‘Civil service’ means the civil service system established under ORS 242.702 to 242.824.

“(4) ‘Commission’ means a civil service commission created under ORS 242.702 to 242.824.

“(5) ‘Commissioner’ means a member of the civil service commission created under ORS 242.702 to 242.824.

“(6) ‘Employees’ means persons whose principal duties consist of preventing or combating fire or preventing the loss of life or property from fire.

“(7) ‘Fire department’ means any organization maintained by any political subdivision for the purpose of preventing or combating fire.

“(8) ‘Governing body’ means the council or city commissioners of a city, the county court or board of county commissioners of a county, the board of directors of a rural fire protection district[,], **and** the board of commissioners of a domestic water supply corporation [*and the county court or board of county commissioners acting under ORS 476.310 to 476.340 for the purposes of preventing and controlling fire on zone 2 rural lands*].

“(9) ‘Political subdivision’ means any city, county, municipal corporation, rural fire protection district[,], **or** domestic water supply corporation [*or organization authorized under ORS 476.310 to*

1 476.340 to combat fire on zone 2 rural lands which employs four or more full-time firefighters, not in-  
2 cluding the chief of the fire department].

3 “(10) ‘Position’ includes any office, place or employment.

7 “**SECTION 34.** ORS 478.010 is amended to read:

8 “478.010. (1) A rural fire protection district may be formed in the manner set forth in ORS  
9 478.010 to 478.100.

11 “[*(a) Territory within a city unless otherwise authorized by law.*]

12 “[*(b)*] **(a)** Territory within a water supply district organized under ORS chapter 264 if the dis-  
13 trict has previously been authorized by its electors to exercise the fire protection powers prescribed  
14 by ORS 264.340.

15 “[*(c)*] **(b)** [*Forestlands*] **Forestland** included within a forest protection district under ORS 477.205  
16 to 477.281 unless the owner consents and notifies the rural fire protection district[, *however,*  
17 *forestland protected pursuant to ORS 477.205 to 477.281 and not exceeding five acres in one ownership*  
18 *shall be included in the rural fire protection district without the owner’s consent if the ownership in-*  
19 *cludes any structures subject to damage by fire*], **except as provided in subsection (3) of this sec-**  
20 **tion.** [*Forestland included in a rural fire protection district under this subsection subjects the*  
21 *forestland to assessments for fire protection by the rural fire protection district and the forest protection*  
22 *district.*]

23 “[*(d)*] **(c)** Railroad rights of way or improvements thereon or rolling stock moving thereover  
24 unless the owner of such property consents.

25 “[*(e)*] **(d)** Ocean shores as defined by ORS 390.605.

26 “**(3)(a) Notwithstanding subsection (2)(b) of this section, forestland protected pursuant**  
27 **to ORS 477.205 to 477.281 that is within the exterior boundaries of an existing rural fire**  
28 **protection district shall be included in the rural fire protection district without the owner’s**  
29 **consent.**

30 “**(b) Forestland described in paragraph (a) of this subsection is subject to limitations on**  
31 **assessment as described in section 36 of this 2025 Act.**

32 “**(4) Forestland protected pursuant to ORS 477.205 to 477.281 that is included in a rural**  
33 **fire protection district is subject to assessments for fire protection by the rural fire pro-**  
34 **tection district and the forest protection district.**

35 “**SECTION 35.** The amendments to ORS 478.010 by section 34 of this 2025 Act apply to all

16       **“SECTION 39.** ORS 476.565 is amended to read:

17       “476.565. (1)(a) The State Fire Marshal Mobilization Fund is established in the State Treasury,  
18 separate and distinct from the General Fund.

19       “(b) The State Fire Marshal Mobilization Fund consists of moneys appropriated by the Legisla-  
20 tive Assembly for deposit in the fund, grant funds received by the Department of the State Fire  
21 Marshal from the Federal Emergency Management Agency, and other moneys appropriated, allo-  
22 cated, deposited or transferred to the fund by the Legislative Assembly or otherwise.

23       “(c) Moneys in the fund are continuously appropriated to the department for:

24       **“(A) Eligible mobilization costs incurred by the department and reimbursements pursuant to**  
25 **ORS 476.560[.]; and**

26       **“(B) Transfers pursuant to subsection (2) of this section.**

27       **“(2) The department may transfer moneys from the fund to the following funds as the**

32 **emergency mobilization and pre-positioning activities in Oregon.**

#### 33 34                               **“TREASURY LOANS**

36       **“SECTION 40. (1) If the State Treasurer transfers moneys under ORS 293.210 from funds**  
37 **having excess moneys to funds under the administration of the State Forestry Department**  
38 **or the Department of the State Fire Marshal during the biennium ending June 30, 2027, for**  
39 **the purpose of enabling those agencies to pay for wildfire suppression costs, the Legislative**  
40 **Assembly shall appropriate moneys or otherwise make moneys available to the borrowing**  
41 **funds in an amount sufficient to repay the lending funds.**

42       **“(2) As used in this section, ‘borrowing fund’ and ‘lending fund’ have the meanings given**  
43 **those terms in ORS 293.205.**

#### 44 45                               **“FIRE PROTECTION COST OFFSET**

**“SECTION 41. (1) In each biennium, the State Forestry Department shall apply an offset against the annual costs of fire protection provided by the department for forestland that is:**

**“(a) Classified as Class 3 under ORS 526.324; and**

**“(b) Located within a forest protection district.**

**“(2) The department shall apply the offset equally to each acre of forestland subject to the offset.**

**“SECTION 42.** In addition to and not in lieu of any other appropriation, there is appropriated to the State Forestry Department, for the biennium beginning July 1, 2025, out of the General Fund, the amount of \$1,500,000 to carry out the provisions of section 41 of this 2025 Act.

**“SECTION 43.** The unit captions used in this 2025 Act are provided only for the convenience of the reader and do not become part of the statutory law of this state or express any legislative intent in the enactment of this 2025 Act.

**“EFFECTIVE DATE**

**“SECTION 44. This 2025 Act takes effect on the 91st day after the date on which the 2025 regular session of the Eighty-third Legislative Assembly adjourns sine die.”.**
