

# A-Engrossed House Bill 5015

Ordered by the House June 23  
Including House Amendments dated June 23

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act creates an agency budget. (Flesch Readability Score: 73.8).

Appropriates moneys from the General Fund to the Bureau of Labor and Industries for biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the bureau.

*[Limits biennial expenditures by the bureau from the Wage Security Fund.]*

Authorizes specified nonlimited expenditures.

Limits biennial expenditures by the bureau from federal funds.

Limits biennial expenditures by the bureau from certain lottery moneys.

Declares an emergency, effective July 1, 2025.

## A BILL FOR AN ACT

1  
2 Relating to the financial administration of the Bureau of Labor and Industries; and declaring an  
3 emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There is appropriated to the Bureau of Labor and Industries, for the**  
6 **biennium beginning July 1, 2025, out of the General Fund, the amount of \$35,167,209.**

7 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**  
8 **\$40,452,909 is established for the biennium beginning July 1, 2025, as the maximum limit for**  
9 **payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,**  
10 **but excluding lottery funds and federal funds, collected or received by the Bureau of Labor**  
11 **and Industries.**

12 **SECTION 3. For the biennium beginning July 1, 2025, expenditures by the Bureau of La-**  
13 **bor and Industries for wage claim payments from the Wage Security Fund are not limited.**

14 **SECTION 4. Notwithstanding any other law limiting expenditures, the amount of**  
15 **\$2,366,174 is established for the biennium beginning July 1, 2025, as the maximum limit for**  
16 **payment of expenses from federal funds collected or received by the Bureau of Labor and**  
17 **Industries.**

18 **SECTION 5. Notwithstanding any other law limiting expenditures, the amount of \$307,006**  
19 **is established for the biennium beginning July 1, 2025, as the maximum limit for payment of**  
20 **expenses from lottery moneys allocated from the Veterans' Services Fund established under**  
21 **ORS 406.140 to the Bureau of Labor and Industries for the purpose of implementing the**  
22 **provisions of ORS 660.220.**

23 **SECTION 6. This 2025 Act being necessary for the immediate preservation of the public**

1 **peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect**  
2 **July 1, 2025.**
