House Bill 5034

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act creates an agency budget. (Flesch Readability Score: 73.8).

Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Public Utility Commission of Oregon.

Limits biennial expenditures by the commission from federal funds.

Authorizes specified nonlimited expenditures.

Declares an emergency, effective July 1, 2025.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> Notwithstanding any other law limiting expenditures, the following amounts 6 are established for the biennium beginning July 1, 2025, as the maximum limits for payment

7 of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-

8 cluding lottery funds and federal funds, collected or received by the Public Utility Commis-

9 sion of Oregon, for the following purposes:

10 (1) Utility program \$ 47,755,437

- 11 (2) Residential Service
- 12 Protection Fund...... \$ 12,684,468
- 13 (3) Administration...... \$ 12,109,535
- 14 (4) Oregon Board of Maritime
 - Pilots..... \$ 1,044,834

16 <u>SECTION 2.</u> Notwithstanding any other law limiting expenditures, the amount of 17 \$1,510,497 is established for the biennium beginning July 1, 2025, as the maximum limit for 18 payment of expenses from federal funds collected or received by the Public Utility Commis-19 sion of Oregon.

20 <u>SECTION 3.</u> For the biennium beginning July 1, 2025, expenditures by the Public Utility 21 Commission of Oregon from the universal service fund established in ORS 759.425 are not 22 limited.

23 <u>SECTION 4.</u> This 2025 Act being necessary for the immediate preservation of the public 24 peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect 25 July 1, 2025.
