## A-Engrossed Senate Bill 1047

Ordered by the Senate April 14 Including Senate Amendments dated April 14

Sponsored by Senator SMITH DB, Representative BOICE

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: This Act makes the county and OWRD speed review of permits for specific projects. (Flesch Readability Score: 71.1).

[Digest: This Act makes OBDD study resources for progress in Curry County. (Flesch Readability Score: 72.6).]

[Requires the Oregon Business Development Department to study access to resources for development in Curry County and submit findings to the interim committees of the Legislative Assembly related to natural resources no later than September 15, 2026.]

Requires Curry County and the Water Resources Department to expedite review of applications for use on specified lands.

Appropriates moneys to the Oregon Department of Administrative Services for distribution to Curry County to expedite review.

Declares an emergency, effective on passage.

## A BILL FOR AN ACT

2 Relating to access to resources for development in Curry County; and declaring an emergency.

**3 Be It Enacted by the People of the State of Oregon:** 

4 <u>SECTION 1.</u> On or before June 30, 2027, Curry County shall expedite any applications for

5 land use planning, building permits, business licensing, public health or restaurant licensing,

6 or any other permit related to the operation or use of the land for any development on lands

7 within the county that are:

8 (1) On a tract, as defined in ORS 215.010, that is larger than 125 acres; and

9 (2) Sited north of the city limits of the City of Port Orford, west of U.S. Highway 101 and 10 south of the Elk River.

11 SECTION 2. In addition to and not in lieu of any other appropriation, there is appropri-

12 ated to the Oregon Department of Administrative Services, for the biennium beginning July

13 1, 2025, out of the General Fund, the amount of \$55,000, to disburse to Curry County to take

14 actions authorized under section 1 of this 2025 Act.

15 <u>SECTION 3.</u> Notwithstanding any other provision of law, the Water Resources Depart-

16 ment shall expedite the review of any complete application or subsequent application decision

17 related to the authorization for the development and use of groundwater, including storage

18 of groundwater, on the lands described in section 1 of this 2025 Act.

19 <u>SECTION 4.</u> This 2025 Act being necessary for the immediate preservation of the public 20 peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect 21 on its passage.
