Senate Bill 1075

Sponsored by Senator THATCHER, Representative RESCHKE; Representatives HARBICK, JAVADI, MANNIX, OWENS, WRIGHT

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act tells a person to show certain forms to register to vote. The Act declares an emergency and becomes law when the Governor signs it. (Flesch Readability Score: 73.2). Requires evidence of United States citizenship for persons registering to vote in this state.

Declares an emergency, effective on passage.
