## B-Engrossed Senate Bill 1125

Ordered by the House June 25 Including Senate Amendments dated March 28 and House Amendments dated June 25

Sponsored by COMMITTEE ON JUDICIARY

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

# Digest: The Act makes it a worse crime to use a drone to meddle in an emergency. The Act says that it is a crime to cause death or serious injury by using a drone to meddle in an emergency. (Flesch Readability Score: 72.3).

[Digest: The Act makes it a worse crime to use a drone to meddle in a wildfire emergency. The Act says that it is a crime to cause death or serious injury by using a drone to meddle in an emergency. (Flesch Readability Score: 72.3).]

Increases the penalties for using an unmanned aircraft system to interfere with a [wildfire suppression effort] law enforcement, firefighting, search and rescue or emergency response effort.

Modifies the felony of causing death or serious physical injury using an unmanned aircraft system to include causing death or serious physical injury by causing an unmanned aircraft system to interfere with a [wildfire suppression, law enforcement or emergency response effort] law enforcement, firefighting, search and rescue or emergency response effort.

[(4)] (6) Notwithstanding [subsection] subsections (1) and (2) of this section, a person commits 13 a Class A misdemeanor if the person violates subsection (1) or (2) of this section and the person 14 15 has one or more convictions under subsection (1) or (2) of this section at the time of the offense. 16 [(5)] (7) In addition to and not in lieu of any other sentence the court may impose, upon a person's second or subsequent conviction under this section, the court shall, at the time of sen-17 tencing, declare the unmanned aircraft system used in the offense to be contraband and order that 18 19 the unmanned aircraft system be forfeited.
