# Senate Bill 1125

Ordered by the House June 25  
Including Senate Amendments dated March 28 and House Amendments

### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

**Digest: The Act makes it a worse crime to use a drone to meddle in an emergency. The Act says that it is a crime to cause death or serious injury by using a drone to meddle in an emergency. (Flesch Readability Score: 72.3).**

*[Digest: The Act makes it a worse crime to use a drone to meddle in a wildfire emergency. The Act says that it is a crime to cause death or serious injury by using a drone to meddle in an emergency. (Flesch Readability Score: 72.3).]*

Increases the penalties for using an unmanned aircraft system to interfere with a *[wildfire suppression effort]* **law enforcement, firefighting, search and rescue or emergency response effort.**

Modifies the felony of causing death or serious physical injury using an unmanned aircraft system to include causing death or serious physical injury by causing an unmanned aircraft system to interfere with a *[wildfire suppression, law enforcement or emergency response effort]* **law enforcement, firefighting, search and rescue or emergency response effort.**

### A BILL FOR AN ACT

Relating to unmanned aircraft systems; creating new provisions; and amending ORS 837.374.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1.** ORS 837.374 is amended to read:

837.374. (1) Except as provided in subsection [(3)] (5) of this section, a person commits a Class A violation if the person possesses or controls an unmanned aircraft system and recklessly causes the unmanned aircraft system to:

(a) Direct a laser at an aircraft while the aircraft is in the air;

(b) Crash into an aircraft while the aircraft is in the air; **or**

(c) Prevent the takeoff or landing of an aircraft[; *or*].

*[(d) Interfere with a wildfire suppression, law enforcement or emergency response effort.]*

**(2) A person commits a Class B misdemeanor if the person possesses or controls an unmanned aircraft system and recklessly causes the unmanned aircraft system to interfere with a law enforcement, firefighting, search and rescue or emergency response effort.**

[(2)] (3) Except as provided in subsection [(3)] (5) of this section, a person commits a Class A misdemeanor if the person possesses or controls an unmanned aircraft system and knowingly or intentionally causes the unmanned aircraft system to:

(a) Direct a laser at an aircraft while the aircraft is in the air;

(b) Crash into an aircraft while the aircraft is in the air; **or**

(c) Prevent the takeoff or landing of an aircraft[; *or*].

*[(d) Interfere with a wildfire suppression, law enforcement or emergency response effort.]*

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1       **(4) Except as provided in subsection (5) of this section, a person commits a Class C felony**  
2 **if the person possesses or controls an unmanned aircraft system and knowingly or inten-**  
3 **tionally causes the unmanned aircraft system to interfere with a law enforcement,**  
4 **firefighting, search and rescue or emergency response effort.**

5       [(3)] **(5)** A person commits a Class A felony if the person possesses or controls an unmanned  
6 aircraft system and knowingly, intentionally or recklessly causes death or serious physical injury,  
7 as defined in ORS 161.015, to another person by causing the unmanned aircraft system to:

8       (a) Direct a laser at an aircraft while the aircraft is in the air;

9       (b) Crash into an aircraft while the aircraft is in the air; [or]

10       (c) Prevent the takeoff or landing of an aircraft[.]; **or**

11       **(d) Interfere with a law enforcement, firefighting, search and rescue or emergency re-**  
12 **sponse effort.**

13       [(4)] **(6)** Notwithstanding [subsection] **subsections (1) and (2)** of this section, a person commits  
14 a Class A misdemeanor if the person violates subsection (1) **or (2)** of this section and the person  
15 has one or more convictions under subsection (1) **or (2)** of this section at the time of the offense.

16       [(5)] **(7)** In addition to and not in lieu of any other sentence the court may impose, upon a  
17 person's second or subsequent conviction under this section, the court shall, at the time of sen-  
18 tencing, declare the unmanned aircraft system used in the offense to be contraband and order that  
19 the unmanned aircraft system be forfeited.

20       **SECTION 2. The amendments to ORS 837.374 by section 1 of this 2025 Act apply to con-**  
21 **duct occurring on or after the effective date of this 2025 Act.**
