SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Tells DHS to contract to provide support services to refugees. (Flesch Readability Score: 61.3).

[Digest: Makes DHS do a study on immigration and submit a report on its findings. (Flesch Readability Score: 65.7).]

[Requires the Department of Human Services to study immigration. Directs the department to submit findings to the interim committees of the Legislative Assembly related to human services not later than September 15, 2026.]

[Sunsets on January 2, 2027.]

Requires the Department of Human Services to contract with eligible entities to provide support services to refugees residing in this state, for up to 24 months, and immigration assistance and referrals to individuals who are seeking a refugee status. Defines "eligible entity" and modifies definition of "refugee."

- (a) "Eligible [agency] entity" means: 6
- 7 (A) An [agency] entity that has, or previously had, contracted with the United States Department of State under 8 U.S.C. [1522(c)] 1522(b) or (c) to provide initial resettlement and case 8 management services to refugees. 9

(B) A culturally responsive or specific organization that is designed to effectively meet 10 the needs of individuals from diverse cultural backgrounds and experiences through an

understanding and respect for the beliefs, practices, culture and linguistic needs of the di-12

verse populations and communities that the entity serves. 13

(b) "Refugee" means an individual who is not a United States citizen, who has been in the 14 United States for 60 months or less and who is or has been any of the following: 15

- (A) A refugee admitted under 8 U.S.C. 1157. 16
- (B) An asylee admitted under 8 U.S.C. 1158. 17
- (C) A Cuban or Haitian entrant as defined in 45 C.F.R. 401.2. 18
- (D) A parolee admitted under 8 U.S.C. 1182(d)(5). 19
- 20 (E) An Amerasian immigrant lawfully admitted to the United States who is described in 8 U.S.C.

1612(a)(2)(A)(v). 21

(F) A victim of a severe form of trafficking in persons and the victim's family members who are 22

16	(A) Referring refugees to the department [within three days of the refugee's arrival in this

18	(B) Completing applications for assistance;
19	(C) Transporting the refugee to the initial appointments with the department;
20	(D) Providing to the department all necessary eligibility information known to the eligible
21	[agency] entity; and
22	(E) Coordinating services of the department with other social service [agencies] entities.
23	(b) Assisting refugees with:
24	(A) Navigating the health care and mental health systems, including providing assistance in
25	applying for medical assistance;
26	(B) Accessing housing [assistance] and finding stable housing;
27	(C) Setting up utilities and paying utility bills;
28	(D) Issues with landlords;
29	(E) Navigating legal or criminal issues including services for victims of crime;
30	(F) Accessing in-home services including parenting assistance, English as a second language in-
31	struction, medical and psychosocial support; and
32	(G) Navigating the culture of the United States.
33	(c) Providing transportation to appointments.
34	(d) Training refugees on using public transportation.
35	(e) Providing immigration assistance and referrals.
36	(f) Advocating on behalf of refugees regarding domestic violence, federal laws and hate crimes.
37	(g) Providing refugees with interpretation services and assistance with access to language ser-
38	vices.
39	(h) Providing referrals for refugees to culturally specific support groups and services, including
40	religious organizations.
41	(i) Pairing refugees with volunteers for English as a second language training and ongoing lan-
42	guage support.
43	(j) Providing support to refugees in budgeting and achieving financial literacy.
44	(k) Identifying refugees' employment skills and providing referrals to employment skills training
45	and other job support services.

1 (L) Problem solving with refugees and assisting refugees with life skills development.

2 (m) Ensuring that refugees have access to psychosocial support and emotional wellness educa-3 tion.

4 (n) Coordinating medical services for refugees including referring to and coordinating with 5 [agencies] **entities** that determine eligibility for disability benefits.

6 (o) Providing family preservation services, legal services and social service support for domestic 7 violence and child welfare issues.

8 (p) Assisting newly arrived refugee children in accessing services to strengthen the children's
9 academic performance and successful integration into the community.

(q) Other services necessary to assist refugees in accessing programs administered by the de-partment.

12 (3) In addition to the services listed under subsection (2) of this section, the department 13 shall award contracts to eligible entities to provide immigration assistance and referrals to

14 individuals who are seeking a status listed under subsection (1)(b)(A) to (G) of this section.
