“PARENTAGE ESTABLISHMENT, PRESUMPTIONS, VOLUNTARY ACKNOWLEDGMENT

“SECTION 1. Sections 2, 39 to 51, 55 to 62, 63 to 74, 84 to 88 and 102 of this 2025 Act and ORS 109.259 are added to and made a part of ORS chapter 109.

“SECTION 2. Definitions. As used in ORS chapter 109:

“(1) ‘Acknowledged parent’ means an individual who has signed an effective acknowledgment of parentage, as described in ORS 109.070.

“(2) ‘Adjudicated parent’ means an individual who has been adjudicated to be a parent of a child by a court with jurisdiction.

“(3)(a) ‘Alleged genetic parent’ means an individual who is alleged to be, or alleges that the individual is, a genetic parent or possible genetic parent of a child whose parentage has not been adjudicated.

“(b) ‘Alleged genetic parent’ does not include a presumed parent, an individual whose parentage rights have been terminated or declared not to exist, an individual whose nonparentage of the child has been adjudicated or a donor.

“(4) ‘Assisted reproduction’ means:

“(a) Intrauterine or intracervical insemination;

“(b) Donation of gametes;

“(c) Donation of embryos;

“(d) In-vitro fertilization and transfer of embryos;

“(e) Intracytoplasmic sperm injection; or

1 “(f) Any other method of causing pregnancy other than sexual intercourse.

2 “(5)(a) ‘Determination of parentage’ means the establishment of a parent-child relation-
3 ship by a judicial or administrative proceeding or signing of a valid acknowledgment of par-
4 entage under ORS 109.119.

5 “(b) ‘Determination of parentage’ does not include an order or judgment entered under
6 ORS 109.119.

7 “(6)(a) ‘Donor’ means an individual who provides gametes or embryos intended for use
8 in assisted reproduction, whether or not for consideration.

9 “(b) ‘Donor’ does not include:

10 “(A) Except as provided in section 70 of this 2025 Act, the parent who gives birth to a
11 child conceived by assisted reproduction, a gestational surrogate or a genetic surrogate; or

12 “(B) An intended parent of a child conceived by assisted reproduction, including under a
13 surrogacy agreement.

14 “(7) ‘Gamete’ means sperm, egg or any part of a sperm or egg.

15 “(8) ‘Genetic testing’ means an analysis of genetic markers to identify or exclude a ge-
16 netic relationship.

17 “(9) ‘Gestational surrogate’ means an individual who is not an intended parent and who
18 agrees to become pregnant through assisted reproduction using embryos that are not the
19 individual’s own, under a gestational surrogacy agreement.

20 “(10)(a) ‘Intended parent’ means an individual, married or unmarried, who manifests an
21 intent to be legally bound as a parent of a child conceived by assisted reproduction, including
22 under a gestational surrogacy agreement.

23 “(b) ‘Intended parent’ does not include the parent who gives birth to the child conceived
24 by assisted reproduction.

25 “(11) ‘Presumed parent’ means an individual who is presumed to be a parent of a child
26 under section 6 of this 2025 Act.

27 “(12) ‘Surrogacy agreement’ means an agreement between one or more intended parents
28 and an individual who is not an intended parent in which the individual agrees to become
29 pregnant through assisted reproduction and which provides that each intended parent is a
30 parent of a child conceived under the agreement. Unless otherwise specified, the term refers
31 to both a gestational surrogacy agreement and a genetic surrogacy agreement.

32 “(13) ‘Transfer’ means a procedure for assisted reproduction by which an embryo or
33 sperm is placed in the body of the person who will give birth to the child.

34 “**SECTION 3.** ORS 109.065 is amended to read:

35 “109.065. [(1)] Parentage may be established between a person and a child by:

36 “[(a)] (1) The person having given birth to the child, **unless the child was conceived by as-**
37 **sisted reproduction under a gestational surrogacy agreement;**

38 “[(b)] (2) An un rebutted presumption of parentage under [ORS 109.070] **section 6 of this 2025**
39 **Act;**

40 “[(c)] (3) An adjudication of the person’s [*maternity or paternity*] **parentage by judicial pro-**
41 **ceeding;**

42 “[(d)] (4) Adoption of the child by the person;

43 “[(e)] (5) An effective acknowledgment of [*paternity by the man*] **parentage** under ORS 109.070
44 or pursuant to the laws of another state, unless the acknowledgment has been rescinded or suc-
45 cessfully challenged;

1 “[(f)] (6) [*Establishment of paternity*] **An adjudication of parentage** by an administrative order
2 issued pursuant to ORS 25.501 to 25.556;

3 “[(g) *Filiation Proceedings*; or]

4 “(7) **Establishment of parentage under sections 55 to 62 of this 2025 Act of a child con-**
5 **ceived by assisted reproduction other than under a surrogacy agreement;**

6 “(8) **Establishment of parentage under sections 63 to 74 of this 2025 Act of a child con-**
7 **ceived by assisted reproduction under a gestational surrogacy agreement; or**

8 “[(h)] (9) Parentage being established or declared by another provision of law.

9 “[(2) *A person is the mother of a child to whom the person gives birth.*]

10 “**SECTION 4. Section 5 and 6 of this 2025 Act and ORS 109.065 and 109.072 are added to**
11 **and made a part of ORS 109.060 to 109.090.**

12 “**SECTION 5. UPA 618. Child as a party; representation.** (1) In a proceeding to adjudicate
13 the parentage of a child, other than a proceeding under ORS chapter 419B, the child is a
14 permissive party to the proceeding if the child has not attained 18 years of age.

15 “(2) The court shall appoint an attorney to represent a child who has not attained 18
16 years of age in a proceeding described in subsection (1) of this section if requested by the
17 child or, if the court finds that the interests of the child are not adequately represented, on
18 the court’s own motion or on the motion of a party. A reasonable fee for an attorney so
19 appointed under this paragraph may be charged against one or more of the parties or as a
20 cost in the proceedings, but may not be charged against funds appropriated for public defense
21 services.

22 “**SECTION 6. UPA 204/608. Presumption of parentage.** (1) An individual is rebuttably
23 presumed to be the parent of a child if, unless the child was conceived by assisted reprod-
24 uction under a gestational surrogacy agreement:

25 “(a) The individual is married to the parent who gave birth to the child at the time of
26 the child’s birth, without a judgment of separation, regardless of whether the marriage is
27 void; or

28 “(b) The individual was married to the parent who gave birth to the child and the child
29 is born within 300 days after the marriage is terminated by death, annulment or dissolution
30 or after entry of a judgment of separation.

31 “(2) The parentage of a child that is established under subsection (1)(a) of this section
32 may be challenged by the parent who gave birth to the child or by the child’s presumed
33 parent. The parentage may not be challenged by any other person as long as the parent who
34 gave birth to the child and the child’s presumed parent are cohabiting, unless the parent who
35 gave birth to the child and the child’s presumed parent both consent to the challenge.

36 “(3)(a) An action or proceeding to challenge parentage of a child established under this
37 section must be initiated before the child attains 18 years of age unless the child initiates the
38 action or proceeding.

39 “(b) If the court finds that it is just and equitable, giving consideration to the interests
40 of the parties and the child, the court shall admit evidence offered to rebut the presumption.

41 “(c) A presumption of parentage cannot be rebutted after the child attains four years of
42 age unless the court determines:

43 “(A) The presumed parent is not a genetic parent, never resided with the child and never
44 held the child out as the presumed parent’s child;

45 “(B) The child has more than one presumed parent; or

1 “(C) The presumption arose due to fraud, duress or a material mistake of fact.

2 “(d) The four-year statute of limitation under paragraph (c) of this subsection does not
3 apply if the presumed parent’s parentage of the child is being challenged:

4 “(A) Under section 28 of this 2025 Act based on the presumed parent having committed
5 an act constituting rape, as defined in section 28 of this 2025 Act, that resulted in the child’s
6 conception; or

7 “(B) Under section 59 (2) of this 2025 Act, if the child was conceived by assisted reprod-
8 uction, other than under a surrogacy agreement.

9 “(4) Except as provided in section 28 or 59 of this 2025 Act, if the parent who gave birth
10 to a child is the only other person with a claim to parentage of the child in a proceeding to
11 adjudicate a presumed parent’s parentage of the child, the court shall:

12 “(a) Adjudicate the presumed parent to be a parent of the child if:

13 “(A) No party to the proceeding challenges the presumed parent’s parentage of the child;
14 or

15 “(B) The presumed parent is identified under section 45 of this 2025 Act as a genetic
16 parent of the child and that identification is not successfully challenged under section 45 of
17 this 2025 Act; or

18 “(b) Adjudicate the parentage of the child in the best interests of the child based on the
19 factors under section 54 of this 2025 Act if:

20 “(A) The presumed parent is not identified under section 45 of this 2025 Act as a genetic
21 parent of the child and the presumed parent or the parent who gave birth to the child chal-
22 lenges the presumed parent’s parentage of the child; or

23 “(B) If another person, other than the presumed parent or the parent who gave birth to
24 the child, asserts a claim to parentage of the child.

25 “(5) The court may enter a judgment under this section before the child’s birth but shall
26 stay enforcement of the judgment until the birth of the child and shall order one or more
27 of the parties to notify the court of the child’s birth.

28 “SECTION 7. Section 6 of this 2025 Act is amended to read:

29 “**Sec. 6.** (1) An individual is rebuttably presumed to be the parent of a child if, unless the child
30 was conceived by assisted reproduction under a gestational surrogacy agreement:

31 “(a) The individual is married to the parent who gave birth to the child at the time of the child’s
32 birth, without a judgment of separation, regardless of whether the marriage is void; [or]

33 “(b) The individual was married to the parent who gave birth to the child and the child is born
34 within 300 days after the marriage is terminated by death, annulment or dissolution or after entry
35 of a judgment of separation[.]; or

36 “(c) The individual is not married to the parent who gave birth to the child at the time
37 of the child’s birth but the individual and the parent who gave birth intend to be married and
38 the individual agrees to be and is named as a parent of the child on the child’s record of live
39 birth.

40 “(2) The parentage of a child that is established under subsection (1)(a) of this section may be
41 challenged by the parent who gave birth to the child or by the child’s presumed parent. The par-
42 entage may not be challenged by any other person as long as the parent who gave birth to the child
43 and the child’s presumed parent are cohabiting, unless the parent who gave birth to the child and
44 the child’s presumed parent both consent to the challenge.

45 “(3)(a) An action or proceeding to challenge parentage of a child established under this section

1 must be initiated before the child attains 18 years of age unless the child initiates the action or
2 proceeding.

3 “(b) If the court finds that it is just and equitable, giving consideration to the interests of the
4 parties and the child, the court shall admit evidence offered to rebut the presumption.

5 “(c) A presumption of parentage cannot be rebutted after the child attains four years of age
6 unless the court determines:

7 “(A) The presumed parent is not a genetic parent, never resided with the child and never held
8 the child out as the presumed parent’s child;

9 “(B) The child has more than one presumed parent;

10 “(C) **The presumption arose under subsection (1)(c) of this section but the presumed**
11 **parent did not marry the person who gave birth to the child; or**

12 “[C)] (D) The presumption arose due to fraud, duress or a material mistake of fact.

13 “(d) The four-year statute of limitation under paragraph (c) of this subsection does not apply if
14 the presumed parent’s parentage of the child is being challenged:

15 “(A) Under section 28 of this 2025 Act based on the presumed parent having committed an act
16 constituting rape, as defined in section 28 of this 2025 Act, that resulted in the child’s conception;
17 or

18 “(B) Under section 59 (2) of this 2025 Act, if the child was conceived by assisted reproduction,
19 other than under a surrogacy agreement.

20 “(4) Except as provided in section 28 or 59 of this 2025 Act, if the parent who gave birth to a
21 child is the only other person with a claim to parentage of the child in a proceeding to adjudicate
22 a presumed parent’s parentage of the child, the court shall:

23 “(a) Adjudicate the presumed parent to be a parent of the child if:

24 “(A) No party to the proceeding challenges the presumed parent’s parentage of the child; or

25 “(B) The presumed parent is identified under section 45 of this 2025 Act as a genetic parent of
26 the child and that identification is not successfully challenged under section 45 of this 2025 Act; or

27 “(b) Adjudicate the parentage of the child in the best interests of the child based on the factors
28 under section 54 of this 2025 Act if:

29 “(A) The presumed parent is not identified under section 45 of this 2025 Act as a genetic parent
30 of the child and the presumed parent or the parent who gave birth to the child challenges the pre-
31 sumed parent’s parentage of the child; or

32 “(B) If another person, other than the presumed parent or the parent who gave birth to the
33 child, asserts a claim to parentage of the child.

34 “(5) The court may enter a judgment under this section before the child’s birth but shall stay
35 enforcement of the judgment until the birth of the child and shall order one or more of the parties
36 to notify the court of the child’s birth.

37 “**SECTION 8.** ORS 109.070 is amended to read:

38 “109.070. *[(1) The parentage of a person is rebuttably presumed if:]*

39 “*[(a) The person is married to the birth mother at the time of the child’s birth, without a judgment*
40 *of separation, regardless of whether the marriage is void.]*

41 “*[(b) The person is married to the birth mother and the child is born within 300 days after the*
42 *marriage is terminated by death, annulment or dissolution or after entry of a judgment of separation.]*

43 “*[(2) The parentage of a child established under subsection (1)(a) or (4)(a) of this section may be*
44 *challenged in an action or proceeding by either spouse. The parentage may not be challenged by a*
45 *person other than a spouse as long as the spouses are married and are cohabiting, unless both spouses*

1 consent to the challenge.]

2 “[(3) If the court finds that it is just and equitable, giving consideration to the interests of the
3 parties and the child, the court shall admit evidence offered to rebut the presumption of parentage in
4 subsection (1) of this section.]

5 “[(4) The paternity of a person may be established by a voluntary acknowledgment as follows:]

6 “[(a) By the marriage of the parents of a child after the birth of the child, and the parents filing
7 with the State Registrar of the Center for Health Statistics the voluntary acknowledgment of paternity
8 form as provided by ORS 432.098.]

9 “[(b) By filing with the state registrar of the Center for Health Statistics the voluntary acknowl-
10 edgment of paternity form as provided under ORS 432.098. Except as otherwise provided in subsections
11 (5) and (8) of this section, a filing under this paragraph establishes paternity for all purposes.]

12 “(1) A parent who gave birth to a child and a child’s alleged genetic parent may establish
13 parentage of the child:

14 “(a) By filing with the State Registrar of the Center for Health Statistics a voluntary
15 acknowledgment of parentage form as prescribed by rule under ORS 432.098:

16 “(A) On or after the child’s date of birth; or

17 “(B) After the child’s date of birth if the child’s parents marry after the child’s birth;

18 or

19 “[(c)] (b) By establishment of [paternity] parentage through a voluntary acknowledgment of
20 [paternity] parentage in another state.

21 “(2) Except as otherwise provided in subsections (5) and (8) of this section, a filing under
22 subsection (1)(a) of this section establishes parentage for all purposes.

23 “(3) The voluntary acknowledgment of parentage form must contain:

24 “(a) A statement that the child whose parentage is being acknowledged does not have a
25 presumed parent, other acknowledged parent, adjudicated parent or intended parent other
26 than the parent who gave birth to the child;

27 “(b) A statement of the parents’ rights and responsibilities including any rights afforded
28 to a parent who is under 18 years of age;

29 “(c) A statement of the alternatives to and consequences of signing the acknowledgment;

30 “(d) Lines for the Social Security numbers and addresses of the parents;

31 “(e) If the acknowledgment is witnessed by staff in the health care facility, a statement
32 that the witness read to the parties the rights, responsibilities, alternatives and conse-
33 quences listed on the acknowledgment prior to signing the acknowledgment;

34 “(f) A statement that the parties to the acknowledgment understand that the acknowl-
35 edgment is the equivalent of an adjudication of parentage of the child and that a challenge
36 to the acknowledgment is permitted only under limited circumstances; and

37 “(g) A place for the signatures of the parent who gave birth to the child and the indi-
38 vidual whose parentage is being acknowledged to be:

39 “(A) Notarized; or

40 “(B) Witnessed by a staff member of the health facility where the child was born if wit-
41 nessed within five days following the child’s birth.

42 “(4) Unless rescinded under subsection (5) of this section or successfully challenged under
43 subsection (6) of this section an acknowledgment of parentage that complies with this section
44 and ORS 432.098 and has become effective as described in ORS 432.098 is equivalent to an
45 adjudication of parentage of the child and confers on the acknowledged parent all rights and

1 **duties of a parent.**

2 “(5)(a) A party to a voluntary acknowledgment of [paternity] **parentage** may rescind the ac-
3 knowledgment **by filing with the state registrar a written rescission, signed by the party and**
4 **notarized.**

5 “(b) **The rescission must be filed with the state registrar** within the earlier of:

6 “(A) Sixty days after [filing] the acknowledgment **becomes effective as described in ORS**
7 **432.098; or**

8 “(B) The date of **the first hearing before the court in** a proceeding relating to the child, in-
9 cluding a proceeding to establish a support order, in which the party wishing to rescind the ac-
10 knowledgment is also a party. *[For the purposes of this subparagraph, the date of a proceeding is the*
11 *date on which an order is entered in the proceeding.]*

12 “[b] *To rescind the acknowledgment, the party shall sign and file with the State Registrar of the*
13 *Center for Health Statistics a written document declaring the rescission.*]

14 “(6)(a) A signed voluntary acknowledgment of [paternity] **parentage** filed in this state may be
15 challenged and set aside in circuit court at any time after the 60-day period referred to in subsection
16 (5) of this section on the basis of fraud, duress or a material mistake of fact.

17 “(b) The challenge may be brought by:

18 “(A) A party to the acknowledgment;

19 “(B) The child named in the acknowledgment; or

20 “(C) The Department of Human Services or the administrator, as defined in ORS 25.010, if the
21 child named in the acknowledgment is in the care and custody of the department under ORS chapter
22 419B and the department or the administrator reasonably believes that the acknowledgment was
23 signed because of fraud, duress or a material mistake of fact.

24 “(c) **Notwithstanding paragraph (b) of this subsection, an acknowledgment of parentage**
25 **described in subsection (1)(a)(B) of this section may be challenged by the parent who gave**
26 **birth to the child or by the child’s acknowledged parent. The parentage may not be chal-**
27 **lenged by any other person as long as the parent who gave birth to the child and the ac-**
28 **knowledge parent are married and cohabiting, unless the parent who gave birth to the child**
29 **and the acknowledged parent both consent to the challenge.**

30 “[c] (d) The challenge shall be initiated by filing a petition with the circuit court. Unless oth-
31 erwise specifically provided by law, the challenge shall be conducted pursuant to the Oregon Rules
32 of Civil Procedure.

33 “(e) **Every party to the acknowledgment must be made a party to the proceeding.**

34 “(f) **By signing an acknowledgment of parentage, a party to the acknowledgment submits**
35 **to the personal jurisdiction in this state in a proceeding to challenge the acknowledgment,**
36 **effective on the filing of the acknowledgment with the state registrar.**

37 “[d] (g) The party bringing the challenge has the burden of proof.

38 “[e] (h) Legal responsibilities arising from the acknowledgment, including child support obli-
39 gations, may not be suspended during the challenge, except for good cause.

40 “[f] (i) If the court finds by a preponderance of the evidence that the acknowledgment was
41 signed because of fraud, duress or material mistake of fact, the court shall set aside the acknowl-
42 edgment unless, giving consideration to the interests of the parties and the child, the court finds
43 that setting aside the acknowledgment would be substantially inequitable.

44 “(7) *[Within one year after a voluntary acknowledgment of paternity form is filed in this state and*
45 *if blood tests, as defined in ORS 109.251, have not been completed,]* A party to [the acknowledgment]

1 **a voluntary acknowledgment of parentage**, or the department if the child named in the ac-
2 knowldgment is in the care and custody of the department under ORS chapter 419B, may apply to
3 the administrator for an order for *[blood tests]* **genetic testing** in accordance with ORS 25.554 **if:**

4 **“(a) The application is made within one year after the acknowledgment becomes effective,**
5 **as described in ORS 432.098;**

6 **“(b) Genetic testing has not previously been completed; and**

7 **“(c) The administrator is not prohibited under ORS 25.554 (9) from reopening the issue**
8 **of parentage and ordering genetic testing.**

9 **“(8)(a) A voluntary acknowledgment of *[paternity]* parentage is not valid if, before the party**
10 **signed the acknowledgment:**

11 **“(A) The party signed a consent to the adoption of the child by another individual;**

12 **“(B) The party signed a document relinquishing the child to a child-caring agency as defined in**
13 **ORS 418.205;**

14 **“(C) The party’s parental rights were terminated by a court; or**

15 **“(D) *[In an adjudication, the party was determined not to be the biological]* The party was ad-**
16 **judicated not to be the parent of the child.**

17 **“(b) A voluntary acknowledgment of parentage is not valid if, at the time the acknowl-**
18 **edgment is signed, an individual other than the parent who gave birth to the child is the**
19 **child’s presumed parent, acknowledged parent, adjudicated parent or intended parent, in-**
20 **cluding an intended parent of the child under a surrogacy agreement.**

21 **“*[(b)]* (c) Notwithstanding any provision of subsection *[(4)(a)]* (1)(a) or (b) of this section or ORS**
22 **432.098 to the contrary, an acknowledgment **does not establish parentage and is void if:****

23 **“(A) The acknowledgment is signed by a party described in paragraph (a) of this subsection[**
24 ***and filed with the State Registrar of the Center for Health Statistics does not establish paternity and***
25 ***is void.*]; or**

26 **“(B) The acknowledgment is signed under the circumstances described in paragraph (b)**
27 **of this subsection.**

28 **“(9) An unchallenged acknowledgment of parentage may not be ratified by a court or an**
29 **administrative agency.**

30 **“SECTION 9. ORS 109.070, as amended by section 8 of this 2025 Act, is amended to read:**

31 **“109.070. (1) A parent who gave **or will give** birth to a child and a child’s alleged genetic**
32 **parent, **presumed parent or, if the child was conceived by assisted reproduction, other than****
33 ****under a surrogacy agreement, intended parent** may establish parentage of the child:**

34 **“(a) By filing with the State Registrar of the Center for Health Statistics a voluntary acknowl-**
35 **edgment of parentage form as prescribed by rule under ORS 432.098:**

36 **“(A) **Before**, on or after the child’s date of birth; or**

37 **“(B) After the child’s date of birth if the child’s parents marry after the child’s birth; or**

38 **“(b) By establishment of parentage through a voluntary acknowledgment of parentage in another**
39 **state.**

40 **“(2) Except as otherwise provided in subsections *[(5)]* (6) and *[(8)]* (9) of this section, a filing**
41 **under subsection (1)(a) of this section establishes parentage for all purposes.**

42 **“(3) The voluntary acknowledgment of parentage form must contain:**

43 **“(a) A statement that the child whose parentage is being acknowledged:**

44 **“(A) Does not have a presumed parent[,]** **other than the individual seeking to establish par-**
45 **entage or has a presumed parent whose denial of parentage is being filed with the acknowl-**

1 **edgment; and**

2 **“(B) Does not have another** acknowledged parent, adjudicated parent or intended parent other
3 than the parent who gave **or will give** birth to the child;

4 **“(b)** A statement of the parents’ rights and responsibilities including any rights afforded to a
5 parent who is under 18 years of age;

6 **“(c)** A statement of the alternatives to and consequences of signing the acknowledgment;

7 **“(d)** Lines for the Social Security numbers and addresses of the parents;

8 **“(e)** If the acknowledgment is witnessed by staff in the health care facility, a statement that the
9 witness read to the parties the rights, responsibilities, alternatives and consequences listed on the
10 acknowledgment prior to signing the acknowledgment;

11 **“(f)** A statement that the parties to the acknowledgment understand that the acknowledgment
12 is the equivalent of an adjudication of parentage of the child and that a challenge to the acknowl-
13 edgment is permitted only under limited circumstances; and

14 **“(g)** A place for the signatures of the parent who gave **or will give** birth to the child and the
15 individual whose parentage is being acknowledged to be:

16 **“(A)** Notarized; or

17 **“(B)** Witnessed by a staff member of the health facility where the child was born if witnessed
18 within five days following the child’s birth.

19 **“(4)(a) A presumed parent or an alleged genetic parent may deny parentage by signing a**
20 **written denial of parentage.**

21 **“(b) The denial of parentage is effective only if:**

22 **“(A) An acknowledgment of parentage by another individual is filed with the state**
23 **registrar before, concurrently or after the denial of parentage is filed with the state**
24 **registrar;**

25 **“(B) The signature of the presumed parent or alleged genetic parent is notarized; and**

26 **“(C) The presumed parent or alleged genetic parent has not previously been adjudicated**
27 **to be a parent of the child or signed a valid acknowledgment of parentage, unless the previ-**
28 **ous acknowledgment of parentage was rescinded under subsection (6) of this section or**
29 **challenged successfully under subsection (7) of this section.**

30 **“[(4)] (5) Unless rescinded under subsection [(5)] (6) of this section or successfully challenged**
31 **under subsection [(6)] (7) of this section:**

32 **“(a)** An acknowledgment of parentage that complies with this section and ORS 432.098 and has
33 become effective as described in ORS 432.098 is equivalent to an adjudication of parentage of the
34 child and confers on the acknowledged parent all rights and duties of a parent.

35 **“(b) A denial of parentage by a presumed parent or alleged genetic parent that complies**
36 **with this section and ORS 432.098 and has become effective as described in ORS 432.098 is**
37 **equivalent to an adjudication of nonparentage.**

38 **“[(5)(a)] (6)(a)** A party to a voluntary acknowledgment **or denial** of parentage may rescind the
39 acknowledgment **or denial** by filing with the state registrar a written rescission, signed by the party
40 and notarized.

41 **“(b)** The rescission must be filed with the state registrar within the earlier of:

42 **“(A)** Sixty days after the acknowledgment **or denial** becomes effective as described in ORS
43 432.098; or

44 **“(B)** The date of the first hearing before the court in a proceeding relating to the child, includ-
45 ing a proceeding to establish a support order, in which the party wishing to rescind the acknowl-

edgment **or denial** is also a party.

“[(6)(a)] (7)(a) A signed voluntary acknowledgment of parentage **and, if applicable, denial of parentage** filed in this state may be challenged and set aside in circuit court at any time after the 60-day period referred to in subsection [(5)] (6) of this section on the basis of fraud, duress or a material mistake of fact.

“(b) The challenge may be brought by:

“(A) A party to the acknowledgment **and, if applicable, the denial**;

“(B) The child named in the acknowledgment **and, if applicable, the denial**; or

“(C) The Department of Human Services or the administrator, as defined in ORS 25.010, if the child named in the acknowledgment **and, if applicable, the denial** is in the care and custody of the department under ORS chapter 419B and the department or the administrator reasonably believes that the acknowledgment **or denial** was signed because of fraud, duress or a material mistake of fact.

“(c) Notwithstanding paragraph (b) of this subsection, an acknowledgment of parentage described in subsection (1)(a)(B) of this section may be challenged by the parent who gave birth to the child or by the child’s acknowledged parent. The parentage may not be challenged by any other person as long as the parent who gave birth to the child and the acknowledged parent are married and cohabiting, unless the parent who gave birth to the child and the acknowledged parent both consent to the challenge.

“(d) The challenge shall be initiated by filing a petition with the circuit court. Unless otherwise specifically provided by law, the challenge shall be conducted pursuant to the Oregon Rules of Civil Procedure.

“(e) Every party to the acknowledgment **and, if applicable, the denial** must be made a party to the proceeding.

“(f) By signing an acknowledgment of parentage **or denial of parentage**, a party to the acknowledgment **or denial** submits to the personal jurisdiction in this state in a proceeding to challenge the acknowledgment **or denial**, effective on the filing of the acknowledgment **or denial** with the state registrar.

“(g) The party bringing the challenge has the burden of proof.

“(h) Legal responsibilities arising from the acknowledgment, including child support obligations, may not be suspended during the challenge, except for good cause.

“(i) If the court finds by a preponderance of the evidence that the acknowledgment **or denial** was signed because of fraud, duress or material mistake of fact, the court shall set aside the acknowledgment **and, if applicable, the denial** unless, giving consideration to the interests of the parties and the child, the court finds that setting aside the acknowledgment **or denial** would be substantially inequitable.

“[(7)] (8) A party to a voluntary acknowledgment of parentage **or denial of parentage**, or the department if the child named in the acknowledgment **and, if applicable, the denial** is in the care and custody of the department under ORS chapter 419B, may apply to the administrator for an order for genetic testing in accordance with ORS 25.554 if:

“(a) The application is made within one year after the acknowledgment **or denial** becomes ef-

fective, as described in ORS 432.098;

“(b) Genetic testing has not previously been completed; and

“(c) The administrator is not prohibited under ORS 25.554 (9) from reopening the issue of parentage and ordering genetic testing.

“[(8)(a)] **(9)(a)** A voluntary acknowledgment of parentage is not valid if, before the party signed the acknowledgment:

“(A) The party signed a consent to the adoption of the child by another individual;

“(B) The party signed a document relinquishing the child to a child-caring agency as defined in ORS 418.205;

“(C) The party’s parental rights were terminated by a court; or

“(D) The party was adjudicated not to be the parent of the child.

“(b) A voluntary acknowledgment of parentage **and, if applicable, denial of parentage** is not valid if, at the time the acknowledgment **or denial** is signed[.]:

“(A) An individual other than the **individual seeking to establish parentage or the individual seeking to deny parentage is the presumed parent of the child; or**

“(B) **An individual other than the** parent who gave **or will give** birth to the child **or the individual seeking to establish parentage**, is the child’s [*presumed parent*,] acknowledged parent, adjudicated parent or intended parent, including an intended parent of the child under a surrogacy agreement.

“(c) Notwithstanding any provision of subsection (1)(a) or (b) of this section or ORS 432.098 to the contrary, an acknowledgment **or denial** does not establish **or disestablish** parentage and is void if:

“(A) The acknowledgment is signed by a party described in paragraph (a) of this subsection; or

“(B) The acknowledgment **or denial** is signed under the circumstances described in paragraph (b) of this subsection.

“[(9)] **(10)** An unchallenged acknowledgment of parentage may not be ratified by a court or an administrative agency.

“**SECTION 10.** ORS 109.072 is amended to read:

“109.072. (1) As used in this section:

“[(a) ‘Blood tests’ has the meaning given that term in ORS 109.251.]

“[(b)(A)] **(a)(A)** ‘Parentage judgment’ means a judgment or administrative order that:

“(i) Expressly or by inference determines the parentage of a child, or that imposes a child support obligation based on the parentage of a child; and

“(ii) Resulted from a proceeding in which [*blood tests were*] **genetic testing was** not performed and the issue of parentage was not challenged.

“(B) ‘Parentage judgment’ does not include a judgment or administrative order that determines [*paternity or*] parentage of a child conceived by assisted reproduction [*as defined in ORS 109.239*].

“[(c)] **(b)** ‘Petition’ means a petition or motion filed under this section.

“[(d)] **(c)** ‘Petitioner’ means the person filing a petition or motion under this section.

“(2)(a) The following may file in circuit court a petition to vacate or set aside the parentage determination of a parentage judgment, including any child support obligations established in the parentage judgment, and for a judgment of nonparentage:

“(A) A party to the parentage judgment.

“(B) The Department of Human Services if the child is in the care and custody of the Department of Human Services under ORS chapter 419B.

1 “(C) The Division of Child Support of the Department of Justice if the child support rights of
2 the child or of one of the parties to the parentage judgment have been assigned to the state.

3 “(b) The petitioner may file the petition in the circuit court proceeding in which the parentage
4 judgment was entered, in a related proceeding or in a separate action. The petitioner shall attach
5 a copy of the parentage judgment to the petition.

6 “(c) If the ground for the petition is that the parentage determination was obtained by or was
7 the result of mistake, inadvertence, surprise or excusable neglect, the petitioner may not file the
8 petition more than one year after entry of the parentage judgment.

9 “(d) If the ground for the petition is that the parentage determination was obtained by or was
10 the result of fraud, misrepresentation or other misconduct of an adverse party, the petitioner may
11 not file the petition more than one year after the petitioner discovers the fraud, misrepresentation
12 or other misconduct.

13 “(3) In the petition, the petitioner shall:

14 “(a) Designate as parties:

15 “(A) All persons who were parties to the parentage judgment;

16 “(B) The child if the child is a child attending school, as defined in ORS 107.108;

18 ment of Human Services under ORS chapter 419B; and

27 copy of the petition on all parties as provided in ORCP 7.

28 “(5) The court, on its own motion or on the motion of a party, may appoint counsel for the child.
29 However, if requested to do so by the child, the court shall appoint counsel for the child. A rea-
30 sonable fee for an attorney so appointed may be charged against one or more of the parties or as

1 to relieve a party from a judgment, to vacate or set aside a judgment for fraud upon the court or
2 to render a declaratory judgment under ORS chapter 28.

3 “(17) This section shall be liberally construed to the end of achieving substantial justice.

4 “**SECTION 11.** ORS 109.092 is amended to read:

5 “109.092. (1) When it is determined that a [woman] **person** is pregnant with a child, the
6 [woman] **person** and any [man] **individual** to whom [she] **the pregnant person** is not married and
7 with whom [she] **the pregnant person** engaged in sexual intercourse at approximately the time of
8 conception have an obligation to recognize that the [man] **individual** may be the other person re-
9 sponsible for the conception.

10 “(2)(a) During the months of pregnancy, the [man] **individual** may join the [woman] **pregnant**
11 **person** in acknowledging [paternity] **parentage** and assuming the rights and duties of expectant
12 parenthood.

13 “(b) If the [man] **individual** acknowledges [paternity] **parentage** of the expected child and the

31 not been established or acknowledged under ORS 419B.609, the [putative father] **alleged genetic**
32 **parent** is entitled to reasonable notice in adoption or other court proceedings concerning the cus-
33 tody of the child, except for juvenile court proceedings, if the petitioner knows, or by the exercise
34 of ordinary diligence should have known:

35 “(a) That the child resided with the [putative father] **alleged genetic parent** at any time during

Evidence that shows the existence of community or family poverty, isolation, single parenthood, custodian age, crowded or inadequate housing, substance abuse or nonconforming social behavior does not, by itself, establish a causal relationship as required by this paragraph.

"(13) There shall be sufficient proof to enable the court to grant the relief sought without notice to the spouse if:

"(a) The affidavit of the parent who gave birth to the child, of the spouse of the parent who gave birth to the child or of another person with knowledge of the facts filed in the proceeding states or the court finds from other competent evidence:

"(A) That the parent who gave birth to the child was not cohabiting with the spouse of the parent who gave birth to the child at the time of conception of the child and that the spouse is not the parent of the child;

"(B) That the spouse has not been judicially determined to be the parent of the child **or the spouse has signed an effective denial of parentage;**

"(C) That the child has not resided with the spouse; and

"(D) That the spouse has not contributed or tried to contribute to the support of the child; and

44 “(2) The Center for Health Statistics shall file immediately the notice, or a copy thereof, with
45 the record of the birth of the child or in the same manner as its filing of records of birth if the

center does not have a record of the birth. The center shall only provide the information contained in the notice to persons whose names appear in the notice or to persons or agencies showing a legitimate interest in the parent-child relationship including, but not limited to, parties to adoption, juvenile court or heirship proceedings.

“**SECTION 37.** ORS 109.230 is amended to read:

“109.230. Any contract between *[the mother and father of a child born out of wedlock]* **a parent who gave birth to a child and the child’s alleged genetic parent** is a legal contract, and the admission by the *[father of his fatherhood]* **alleged genetic parent of parentage** of the child is sufficient consideration to support the contract.

“**SECTION 38.** ORS 109.231 is amended to read:

“109.231. Records of *[filiation]* proceedings **to adjudicate the parentage of a child’s alleged genetic parent** filed in circuit court shall be open for inspection by any person without order of the court.

“GENETIC TESTING

“**SECTION 39. UPA 501. Definitions.** As used in sections 39 to 51 of this 2025 Act:

“(1) ‘Combined relationship index’ means the product of all tested relationship indices.

“(2) ‘Ethnic or racial group’ means, for the purpose of genetic testing, a recognized group that an individual identifies as the individual’s ancestry or part of the individual’s ancestry or that is identified by other information.

“(3) ‘Hypothesized genetic relationship’ means an asserted genetic relationship between an individual and a child.

“(4) ‘Probability of parentage’ means, for the ethnic or racial group to which an individual alleged to be a parent belongs, the probability that a hypothesized genetic relationship is supported, compared to the probability that a genetic relationship is supported between the child and a random individual of the ethnic or racial group used in the hypothesized genetic relationship, expressed as a percentage incorporating the combined relationship index and a prior probability.

“(5) ‘Relationship index’ means a likelihood ratio that compares the probability of a genetic marker given a hypothesized genetic relationship and the probability of the genetic marker given a genetic relationship between the child and a random individual of the ethnic or racial group used in the hypothesized genetic relationship.

“**SECTION 40. UPA 502. Scope; limitation on use of genetic testing.** (1) Sections 39 to 51 of this 2025 Act govern genetic testing of an individual in a proceeding to adjudicate parentage, whether the individual:

“(a) Voluntarily submits to testing; or

“(b) Is tested under an order of the court or a child support agency.

“(2) Genetic testing may not be used:

“(a) Except as provided in section 70 (3) of this 2025 Act, to challenge the parentage of a child who was conceived by assisted reproduction, including under a gestational surrogacy agreement; or

“(b) To establish a donor’s parentage of a child who was conceived by assisted reproduction.

“**SECTION 41. UPA 503. Authority to order or deny genetic testing.** (1) Except as other-

1 wise provided in sections 39 to 51 of this 2025 Act, in a proceeding in this state in which
2 parentage is a relevant fact, the court or the administrator:

3 “(a) May order the child and any other individual to submit to genetic testing:

4 “(A) Upon the court’s or administrator’s own initiative;

5 “(B) At the request of or on behalf of any person whose genetic material is involved;

6 “(C) At the request of the Department of Human Services if the child is in the care and
7 custody of the department under ORS chapter 419B; or

8 “(D) At the request of a party to the action if the request is made at a time so as not
9 to unduly delay the proceedings; and

10 “(b) Shall order the child and any other individual to submit to genetic testing if a re-
11 quest for testing is supported by the sworn statement of a party:

12 “(A) Alleging a reasonable possibility that the individual is the child’s genetic parent; or

13 “(B) Denying genetic parentage of the child and stating facts establishing a reasonable
14 possibility that the individual is not a genetic parent.

15 “(2) The court or administrator agency may not order in utero genetic testing.

16 “(3) If two or more individuals are subject to court-ordered genetic testing, the court
17 may order that testing be completed concurrently or sequentially.

18 “(4) Genetic testing of the person who gave birth to the child is not a condition precedent
19 to testing of the child and an individual whose genetic parentage of the child is being deter-
20 mined. If the person who gave birth to the child is unavailable or declines to submit to ge-
21 netic testing, the court may order genetic testing of the child and each individual whose
22 genetic parentage of the child is being adjudicated.

23 “(5) The court may deny a motion for genetic testing of the child and any other individual
24 after considering the factors in section 54 of this 2025 Act if the genetic testing is requested
25 in a proceeding:

26 “(a) To adjudicate the parentage of a child having a presumed parent;

27 “(b) To challenge an acknowledgment of parentage; or

28 “(c) Except as provided in section 70 (3) of this 2025 Act, to determine whether a
29 gestational surrogate is the genetic parent of a child believed to have been conceived by as-
30 sisted reproduction under a gestational surrogacy agreement.

31 “(6) The court may only approve an individual’s request for genetic testing if the indi-
32 vidual has standing to maintain a proceeding to adjudicate parentage and any statute of
33 limitations or time limits for initiating a proceeding to adjudicate parentage that are appli-
34 cable to the individual have not expired.

35 “(7) If any individual declines to submit to genetic testing ordered by the court, the court
36 or administrator may:

37 “(a) If the rights of others and the interests of justice so require, resolve the question
38 of parentage against such person or enforce the court’s or administrator’s order; or

39 “(b) Find the individual in contempt of court.

40 “(8) Subject to the limitations in section 6 (2) of this 2025 Act and ORS 109.070 (6)(c), the
41 Department of Human Services is not required to obtain a court order under this section to
42 make a referral for genetic testing at the request of a party or a child’s alleged genetic
43 parent if the child is in the department’s care and custody.

44 “SECTION 42. UPA 504. Requirements for genetic testing. (1) Genetic testing must be of
45 a type reasonably relied on by experts in the field of genetic testing and performed in a

1 testing laboratory accredited by:

2 “(a) The Association for the Advancement of Blood and Biotherapies, or a successor to
3 its functions; or

4 “(b) An accrediting body designated by the Oregon Health Authority by rule, consistent
5 with any applicable designation by the Secretary of the United States Department of Health
6 and Human Services.

7 “(2) A specimen used in genetic testing may consist of a sample or a combination of
8 samples of blood, buccal cells, bone, hair or other body tissue or fluid. The specimen used in
9 the testing need not be of the same kind for each individual undergoing genetic testing.

10 “(3) Based on the ethnic or racial group of an individual undergoing genetic testing, a
11 testing laboratory shall determine the databases from which to select frequencies for use in
12 calculating a relationship index. If an individual or the administrator objects to the
13 laboratory’s database determination, the following rules apply:

14 “(a) Not later than 30 days after receipt of the report of the test, the objecting individual
15 or administrator may request the court to require the laboratory to recalculate the re-
16 lationship index using an ethnic or racial group different from that used by the laboratory.

17 “(b) The individual or the administrator objecting to the laboratory’s database determi-
18 nation under this subsection shall:

19 “(A) If the requested frequencies are not available to the laboratory for the ethnic or
20 racial group requested, provide the requested frequencies compiled in a manner recognized
21 by accrediting bodies; or

22 “(B) Engage another laboratory to perform the calculations.

23 “(c) The laboratory may use its own statistical estimate if there is a question about
24 which ethnic or racial group is appropriate. The laboratory shall calculate the frequencies
25 using statistics, if available, for any other ethnic or racial group requested.

26 “(4) If, after recalculation of the relationship index under subsection (3) of this section
27 using a different ethnic or racial group, genetic testing under section 45 of this 2025 Act does
28 not identify an individual as a genetic parent of a child, the court may require an individual
29 who has been tested to submit to additional genetic testing to identify a genetic parent.

30 “SECTION 43. UPA 505. Report of genetic testing. (1) A report of genetic testing must
31 be in writing and signed under penalty of perjury by a designee of the testing laboratory. A
32 report complying with the requirements of sections 39 to 51 of this 2025 Act is self-
33 authenticating.

34 “(2) Documentation from a testing laboratory of the following information is sufficient
35 to establish a reliable chain of custody and allow the results of genetic testing to be admis-
36 sible without testimony:

37 “(a) The name and photograph of each individual whose specimen has been taken;

38 “(b) The name of the individual who collected each specimen;

39 “(c) The place and date each specimen was collected;

40 “(d) The name of the individual who received each specimen in the testing laboratory;
41 and

42 “(e) The date each specimen was received.

43 “SECTION 44. UPA 606. Admissibility of results of genetic testing. (1) Except as other-
44 wise provided in section 40 (2) of this 2025 Act, the court shall admit a report of genetic
45 testing ordered by the court under section 41 of this 2025 Act as evidence of the truth of the

1 facts asserted in the report.

2 “(2) A party may object to the admission of a report described in subsection (1) of this
3 section, not later than 14 days after the party receives the report. The party shall cite spe-
4 cific grounds for exclusion.

5 “(3) A party that objects to the results of the genetic testing may call a genetic testing
6 expert to testify in person or by another method approved by the court. Unless the court
7 orders otherwise, the party offering the testimony bears the expense for the expert testify-
8 ing.

9 “(4) Admissibility of a report of genetic testing is not affected by whether the testing
10 was performed:

11 “(a) Voluntarily or under an order of the court or the administrator; or

12 “(b) Before, on or after commencement of the proceeding.

13 “SECTION 45. UPA 506. Genetic testing results; challenge to results. (1) An individual is
14 rebuttably presumed to be a genetic parent of a child if genetic testing complies with
15 sections 39 to 51 of this 2025 Act and the results of the testing disclose:

16 “(a) The individual has at least a 99 percent probability of parentage, using a prior
17 probability of 0.50, as calculated by using the combined relationship index obtained in the
18 testing; and

19 “(b) A combined relationship index of at least 100 to 1.

20 “(2) An individual presumed to be a genetic parent of the child under this section may
21 challenge the genetic testing results only by other genetic testing satisfying the require-
22 ments of sections 39 to 51 of this 2025 Act that:

23 “(a) Excludes the individual as a genetic parent of the child; or

24 “(b) Identifies another individual as a possible genetic parent of the child other than:

25 “(A) The person who gave birth to the child; or

26 “(B) The individual identified under subsection (1) of this section.

27 “(3) Except as otherwise provided in section 50 of this 2025 Act, if more than one indi-
28 vidual other than the person who gave birth is identified by genetic testing as a possible ge-
29 netic parent of the child, the court shall order each individual to submit to further genetic
30 testing to identify a genetic parent.

31 “SECTION 46. UPA 507. Cost of genetic testing. (1) Payment of the cost of initial genetic
32 testing must be made:

33 “(a) By the Child Support Program if child support enforcement services are being pro-
34 vided under ORS 25.080;

35 “(b) By the individual or agency that made the request for genetic testing;

36 “(c) As agreed by the parties; or

37 “(d) As ordered by the court.

38 “(2) If the cost of genetic testing is paid by the Child Support Program, the program may
39 seek reimbursement from the person or agency that requested the tests.

40 “(3) If the original test result is contested prior to the entry of an order or judgment
41 establishing parentage, the court or the administrator shall order additional testing upon
42 request and advance payment by the party making the request.

43 “SECTION 47. UPA 508. Additional genetic testing. The court or the administrator shall
44 order additional genetic testing at the request of an individual who contests the result of the
45 initial testing under section 45 of this 2025 Act. If initial genetic testing under section 45 of

1 this 2025 Act identified an individual as a genetic parent of the child, the court or the ad-
2 ministrator may not order additional testing unless the contesting individual pays for the
3 testing in advance.

4 **“SECTION 48. UPA 509. Genetic testing when specimen not available.** (1) The court may
5 order relatives of an alleged genetic parent to submit specimens for testing if:

6 **“(a) A genetic testing specimen is not available from the alleged genetic parent;**

7 **“(b) The individual seeking genetic testing demonstrates good cause and the court finds**
8 **that the circumstances are just; and**

9 **“(c) The court finds that the need for genetic testing outweighs the legitimate interests**
10 **of the individual sought to be tested.**

11 **“(2) The court may order any of the following individuals to submit specimens for genetic**
12 **testing under this section:**

13 **“(a) A parent of the alleged genetic parent;**

14 **“(b) A sibling of the alleged genetic parent;**

15 **“(c) Another child of the alleged genetic parent and the person who gave birth to the**
16 **other child; and**

17 **“(d) another relative of the alleged genetic parent as necessary to complete genetic**
18 **testing.**

19 **“SECTION 49. UPA 510. Deceased individual.** If an individual seeking genetic testing
20 demonstrates good cause, the court may order genetic testing of a deceased individual.

21 **“SECTION 50. UPA 511. Identical siblings.** (1) If the court finds there is reason to believe
22 that an alleged genetic parent has an identical sibling and evidence that the sibling may be
23 a genetic parent of the child, the court may order genetic testing of the sibling.

24 **“(2) If more than one sibling is identified under section 45 of this 2025 Act as a genetic**
25 **parent of the child, the court may rely on nongenetic evidence to adjudicate which sibling is**
26 **a genetic parent of the child.**

27 **“SECTION 51. UPA 512. Confidentiality of genetic testing.** Release of a report of genetic
28 testing for parentage is subject to the privacy protections under ORS 192.531 to 192.549.

29 **“SECTION 52.** ORS 109.260 is amended to read:

30 **“109.260. [ORS 109.250 to 109.262] Sections 39 to 51 of this 2025 Act** apply to criminal cases
31 for nonsupport under ORS 163.555 subject to the following limitations and provisions:

32 **“(1) An order for the tests shall be made only upon application of a party or on the court’s in-**
33 **itiative.**

34 **“(2) The compensation of the experts shall be paid by the county in which the proceedings are**
35 **had under order of court.**

36 **“(3) The court may direct a verdict of acquittal upon the conclusions of all the experts under**
37 **the provisions of [ORS 109.258] section 45 of this 2025 Act, otherwise the case shall be submitted**
38 **for determination upon all evidence.**

39 **“SECTION 53. ORS 109.250, 109.251, 109.252, 109.254, 109.256, 109.258, 109.262 and 109.264**
40 **are repealed.**

41 42 **“COMPETING CLAIMS OF PARENTAGE**

43
44 **“SECTION 54. UPA 613. Adjudicating competing claims of parentage.** (1) Except as oth-
45 **erwise provided in section 28 of this 2025 Act, in a proceeding to adjudicate competing claims**

of, or challenges under ORS 109.070 or 109.072 or section 6 (3) of this 2025 Act to, parentage of a child by two or more individuals, the court shall adjudicate parentage in the best interest of the child, taking into consideration, at a minimum:

“(a) The age of the child;

“(b) The length of time during which each individual assumed the role of parent of the child;

“(c) The nature of the relationship between the child and each individual;

“(d) The harm to the child if the relationship between the child and each individual is not recognized;

“(e) The basis for each individual’s claim to parentage of the child; and

“(f) Other equitable factors arising from the disruption of the relationship between the child and each individual or the likelihood of other harm to the child.

“(2) If an individual challenges parentage based on the results of genetic testing, in addition to the factors listed in subsection (1) of this section, the court shall consider:

“(a) The facts surrounding the discovery the individual might not be a genetic parent of the child; and

“(b) The length of time between the time that the individual was placed on notice that the individual might not be a genetic parent and the commencement of the proceeding.

“ASSISTED REPRODUCTION

“(Generally)

“SECTION 55. UPA 612. Adjudicating parentage of child of assisted reproduction, other than under a surrogacy agreement. (1) Except as provided in subsection (2) of this section, a proceeding under sections 55 to 62 of this 2025 Act to adjudicate the parentage of a child conceived by assisted reproduction, other than under a surrogacy agreement, may be commenced by:

“(a) An alleged intended parent;

“(b) The parent who gave birth to the child; or

“(c) The child’s presumed parent.

“(2) If the child was conceived by assisted reproduction, other than under a surrogacy agreement, the parentage of an individual who is the child’s presumed parent may be challenged under this section:

“(a) By the parent who gave birth to the child and the child’s presumed parent;

“(b) If the parent who gave birth to the child and the child’s presumed parent are married and cohabiting, by any person with standing under subsection (1) of this section if the parent who gave birth to the child and the child’s presumed parent both consent to the challenge; or

“(c) If the parent who gave birth to the child and the child’s presumed parent are no longer married and cohabiting, by any person with standing under subsection (1) of this section.

“(3)(a) The court shall adjudicate an individual’s parentage of a child in a proceeding commenced under this section as provided in sections 55 to 62 of this 2025 Act.

“(b) If the child was conceived by assisted reproduction, other than under a surrogacy agreement, and a person other than the individual or the parent who gave birth to the child

1 is a parent under sections 55 to 62 of this 2025 Act, the court shall adjudicate the individual's
2 parentage of the child under section 54 of this 2025 Act.

3 “(4) Nothing in this section prohibits an individual from asserting a claim to or com-
4 mencing an action to adjudicate the parentage of a child conceived by assisted reproduction,
5 other than under a surrogacy agreement, under section 6 of this 2025 Act or ORS 109.070 or
6 109.072, as applicable.

7 “**SECTION 56.** Section 55 of this 2025 Act is amended to read:

8 “**Sec. 55.** (1) Except as provided in subsection (2) of this section, a proceeding under sections
9 55 to 62 of this 2025 Act to adjudicate the parentage of a child conceived by assisted reproduction,
10 other than under a surrogacy agreement, may be commenced by:

11 “(a) An alleged intended parent;

12 “(b) The parent who gave birth to the child; [or]

13 “(c) The child’s presumed parent; **or**

14 “(d) **The child’s acknowledged parent.**

15 “(2) If the child was conceived by assisted reproduction, other than under a surrogacy agree-
16 ment, the parentage of an individual who is the child’s presumed parent **or acknowledged parent**
17 **under ORS 109.070 (1)(a)(B)** may be challenged under this section:

18 “(a) By the parent who gave birth to the child and the child’s presumed parent **or acknowl-**
19 **edged parent;**

20 “(b) If the parent who gave birth to the child and the child’s presumed parent **or acknowledged**
21 **parent** are married and cohabiting, by any person with standing under subsection (1) of this section
22 if the parent who gave birth to the child and the child’s presumed parent **or acknowledged parent**
23 both consent to the challenge; or

24 “(c) If the parent who gave birth to the child and the child’s presumed parent **or acknowledged**
25 **parent** are no longer married and cohabiting, by any person with standing under subsection (1) of
26 this section.

27 “(3)(a) The court shall adjudicate an individual’s parentage of a child in a proceeding com-
28 menced under this section as provided in sections 55 to 62 of this 2025 Act.

29 “(b) If the child was conceived by assisted reproduction, other than under a surrogacy agree-
30 ment, and a person other than the individual or the parent who gave birth to the child is a parent
31 under sections 55 to 62 of this 2025 Act, the court shall adjudicate the individual’s parentage of the
32 child under section 54 of this 2025 Act.

33 “(4) Nothing in this section prohibits an individual from commencing an action to adjudicate or
34 asserting a claim to the parentage of a child conceived by assisted reproduction, other than under
35 a surrogacy agreement, under section 6 of this 2025 Act or ORS 109.070 or 109.072, as applicable.

36 “**SECTION 57. UPA 702. Parental status of donor.** A donor is not a parent of a child
37 conceived by assisted reproduction.

38 “**SECTION 58. UPA 703/704. Parentage of child of assisted reproduction; consent.** (1) An
39 individual’s parentage of a child conceived by assisted reproduction, other than under a
40 surrogacy agreement:

41 “(a) Is established by operation of law if:

42 “(A) Before, on or after the child’s birth, the individual consents in writing to the as-
43 sisted reproduction;

44 “(B) The writing states that the individual intends to be a parent of the child; and

45 “(C) The writing is signed by the individual and the parent who gave birth to the child;

1 or

2 “(b) May be established by judgment of the court if the individual did not consent in
3 writing or the writing does not meet the requirements of paragraph (a) of this subsection
4 and a court finds by clear and convincing evidence that:

5 “(A) The individual and the parent who gave birth to the child entered into an express
6 agreement before the child’s conception that the individual and the parent who gave birth
7 to the child both would be parents of the child; or

8 “(B) The individual and the parent who gave birth to the child resided together in the
9 same household with the child and both openly held out the child as the individual’s child:

10 “(i) For the first two years of the child’s life, including any period of temporary absence;
11 or

12 “(ii) From the child’s birth until the death of the child or the death or incapacity of the
13 individual, if, before the child attains two years of age, the child dies or the individual dies
14 or becomes incapacitated, and a party proves by clear and convincing evidence that the
15 parent who gave birth to the child and the individual both intended the individual would
16 openly hold out the child as the individual’s child, but the individual was prevented from
17 carrying out that intent by the death of the child or the individual’s death or incapacity.

18 “(2) When determining whether an individual’s absence was temporary under subsection
19 (1) of this section, the court shall consider the totality of the circumstances, including
20 whether the individual’s absence was due to military service.

21 “SECTION 59. UPA 705. Limitation on spouse’s dispute of parentage. The court shall find
22 that an individual who is the presumed parent of a child conceived by assisted reproduction,
23 other than under a surrogacy agreement, is not the parent of the child and that the
24 presumption is rebutted if:

25 “(1)(a) The individual provided the gametes used in the assisted reproduction;

26 “(b) The individual challenges the presumption within two years following the birth of the
27 child; and

28 “(c) The court finds that the individual did not consent to the assisted reproduction be-
29 fore, on or after the birth of the child or withdrew consent as provided in section 61 of this
30 2025 Act; or

31 “(2)(a) The individual did not provide the gametes used in the assisted reproduction;

32 “(b) The individual did not consent to the assisted reproduction;

33 “(c) The individual and the parent who gave birth to the child have not cohabited since
34 the date of the transfer that resulted in the pregnancy; and

35 “(d) The individual never openly held out the child as the individual’s child.

36 “SECTION 60. UPA 706. Effect of certain legal proceedings regarding marriage. If the
37 marriage of a parent who gave birth to a child conceived by assisted reproduction, other than
38 under a surrogacy agreement, is terminated through dissolution, annulment or legal sepa-
39 ration before the transfer that results in a pregnancy, the former spouse of the parent who
40 gave birth to the child conceived by the assisted reproduction is not a parent of the child
41 unless the former spouse consented in writing that the former spouse would be a parent of
42 the child if a transfer resulting in pregnancy were to occur after a dissolution, annulment
43 or legal separation, and the former spouse did not withdraw consent as provided in section
44 61 of this 2025 Act.

45 “SECTION 61. UPA 707. Withdrawal of consent. (1) An individual who consents to as-

1 sisted reproduction, other than under a surrogacy agreement, may withdraw consent any
2 time before a transfer that results in a pregnancy by giving written notice of the withdrawal
3 of consent to the person who agreed to give birth to a child conceived by the assisted re-
4 production.

5 “(2) An individual who withdraws consent under subsection (1) of this section:

6 “(a) Is not a parent of a child conceived by the assisted reproduction under sections 55
7 to 62 of this 2025 Act; and

8 “(b) Is a donor if the individual provided the gametes that resulted in the pregnancy.

9 “(3) An individual who withdraws consent as provided in this section shall provide a copy
10 of the withdrawal to the clinic or health care provider facilitating the assisted reproduction.
11 Failure to give notice to the clinic or health care provider does not affect the validity of the
12 withdrawal.

13 “SECTION 62. UPA 708. Parental status of deceased individual. (1) If an individual who
14 intends to be a parent of a child conceived by assisted reproduction, other than under a
15 surrogacy agreement, dies during the period between the date of transfer and the birth of
16 the child, the individual’s death does not preclude the establishment of the individual’s par-
17 entage of the child in the same manner as if the individual had died after the birth of the
18 child.

19 “(2) If an individual who consented in writing to assisted reproduction as described in
20 section 58 (1)(a) of this 2025 Act dies before a transfer that results in pregnancy, the de-
21 ceased individual is a parent of a child conceived by the transfer only if:

22 “(a)(A) The individual consented in writing that if assisted reproduction were to occur
23 after the death of the individual, the individual would be a parent of the child; or

24 “(B) The individual’s intent to be a parent of a child conceived by assisted reproduction
25 after the individual’s death is established by clear and convincing evidence; and

26 “(b) The embryo is in utero not later than 24 months after the individual’s death.

27
28 “(Under gestational surrogacy agreement)

29
30 “SECTION 63. UPA 802. Eligibility to enter gestational surrogacy agreement. (1) An in-
31 dividual may enter into an agreement to act as a gestational surrogate only if the individual:

32 “(a) Has attained 21 years of age;

33 “(b) Has previously given birth to at least one child;

34 “(c) Has completed a medical evaluation related to the surrogacy arrangement and the
35 medical evaluation was conducted by a licensed health care provider;

36 “(d) Has completed a mental health consultation by a licensed mental health care pro-
37 vider; and

38 “(e) Has retained, at the expense of the intended parent or parents, independent legal
39 representation of the individual’s choice to represent the individual throughout the
40 surrogacy arrangement regarding the terms of the surrogacy agreement and the potential
41 legal consequences of the agreement.

42 “(2) An individual who intends to be a parent of a child conceived by assisted reprod-
43 uction under a gestational surrogacy arrangement may enter into an agreement with a
44 gestational surrogate if the individual:

45 “(a) Has attained 21 years of age;

1 “(b) Has completed a medical evaluation related to the surrogacy arrangement and the
2 medical evaluation was conducted by a licensed health care provider;

3 “(c) Has completed a mental health consultation by a licensed mental health care pro-
4 vider; and

5 “(d) Has retained legal representation of the individual’s choice to represent the individ-
6 ual throughout the surrogacy arrangement regarding the terms of the surrogacy agreement
7 and the potential legal consequences of the agreement.

8 “SECTION 64. UPA 803. Requirements of gestational surrogacy agreement; process. A
9 gestational surrogacy agreement must be executed in compliance with the following rules:

10 “(1)(a) At least one party must be a resident of this state;

11 “(b) The transfer that results in the pregnancy must occur in this state; or

12 “(c) The parties must all intend that the child be born in this state.

13 “(2) A gestational surrogate and each intended parent must meet the requirements of
14 section 63 of this 2025 Act.

15 “(3) Each intended parent, the surrogate and the surrogate’s spouse, if any, must be
16 parties to the agreement.

17 “(4) The agreement must be in writing and signed by each party listed in subsection (3)
18 of this section.

19 “(5) The surrogate and each intended parent must acknowledge in writing receipt of a
20 copy of the agreement.

21 “(6) The signature of each party to the agreement must be made under penalty of perjury
22 or notarized.

23 “(7) The agreement must identify the attorneys the parties have retained to provide legal
24 representation throughout the surrogacy arrangement.

25 “(8) The intended parent or parents must agree to pay for independent legal represen-
26 tation for the surrogate.

27 “(9) The agreement must be executed before a transfer that results in the agreed upon
28 pregnancy.

29 “SECTION 65. UPA 804. Requirements of gestational or genetic surrogacy agreement;
30 content. (1) A gestational surrogacy agreement must comply with the following require-
31 ments:

32 “(a) A surrogate agrees to attempt to become pregnant by means of assisted reprod-
33 uction.

34 “(b) The surrogate and the surrogate’s spouse or former spouse, if any, have no claim
35 to parentage of a child conceived by assisted reproduction under the agreement.

36 “(c) The surrogate’s spouse, if any, must acknowledge and agree to comply with the ob-
37 ligations imposed on the surrogate by the agreement.

38 “(d) Except as otherwise provided in section 102 of this 2025 Act, the intended parent or,
39 if there are two intended parents, each one jointly and severally, immediately on birth will
40 be the exclusive parent or parents of the child, regardless of number of children born or
41 gender or mental or physical condition of each child.

42 “(e) Except as otherwise provided in section 102 of this 2025 Act, the intended parent or,
43 if there are two intended parents, each parent jointly and severally, immediately on birth
44 will assume responsibility for the financial support of the child, regardless of number of
45 children born or gender or mental or physical condition of each child.

1 “(f) The agreement must include information disclosing how each intended parent will
2 cover the surrogacy-related expenses of the surrogate and the medical expenses of the child.
3 If health care coverage is used to cover the medical expenses, the disclosure must include
4 a summary of the health care policy provisions related to coverage for surrogate pregnancy,
5 including any possible liability of the surrogate, third party liability liens, other insurance
6 coverage, and any notice requirement that could affect coverage or liability of the surrogate.
7 Unless the agreement expressly provides otherwise, the review and disclosure do not con-
8 stitute legal advice. If the extent of coverage is uncertain, a statement of that fact is suffi-
9 cient to comply with this paragraph.

10 “(g) The agreement must permit the surrogate to make all health and welfare decisions
11 regarding the surrogate and the pregnancy, including decisions regarding reproductive health
12 care, as defined in ORS 435.190.

13 “(h) The agreement must include information about each party’s right under section 69
14 of this 2025 Act to terminate the surrogacy agreement.

15 “(2) A gestational surrogacy agreement may provide for:

16 “(a) Payment of consideration and reasonable expenses; and

17 “(b) Reimbursement of specific expenses if the agreement is terminated under section
18 69 of this 2025 Act.

19 “(3) A right created under a surrogacy agreement is not assignable and there is no third
20 party beneficiary of the agreement other than the child.

21 “SECTION 66. UPA 805. Surrogacy agreement; effect of subsequent change of marital
22 status. (1) Unless a gestational surrogacy agreement expressly provides otherwise, after the
23 agreement is signed by all of the parties:

24 “(a) The subsequent marriage of a surrogate does not affect the validity of the agree-
25 ment, the consent of the surrogate’s new spouse to the agreement is not required and the
26 surrogate’s new spouse is not a presumed parent of a child conceived by assisted reprod-
27 uction under the agreement; and

28 “(b) The subsequent dissolution, annulment or legal separation of the surrogate does not
29 affect the validity of the agreement.

30 “(2) Unless a gestational surrogacy agreement expressly provides otherwise, after the
31 agreement is signed by all of the parties:

32 “(a) The marriage of an intended parent does not affect the validity of a surrogacy
33 agreement, the consent of the new spouse of the intended parent is not required and the new
34 spouse of the intended parent is not, based on the agreement, a parent of a child conceived
35 by assisted reproduction under the agreement; and

36 “(b) The dissolution, annulment or legal separation of an intended parent does not affect
37 the validity of the agreement and unless the agreement is terminated under section 69 of this
38 2025 Act, the intended parents are the parents of any child conceived by assisted reprod-
39 uction under the agreement.

40 “(3) Nothing in this section prohibits the parties before an embryo transfer that results
41 in the agreed upon pregnancy from jointly amending the existing agreement.

42 “SECTION 67. UPA 806. Inspection of documents. (1) A petition and any other document
43 related to a surrogacy agreement filed with the court shall be sealed, exempt from public
44 disclosure under ORS 192.311 to 192.478 and may not be disclosed except:

45 “(a) To a party to the proceeding;

1 “(b) To a child conceived by assisted reproduction under the agreement;

2 “(c) To an attorney of a party to the proceeding or a child conceived by assisted repro-
3 duction under the agreement;

4 “(d) The court; or

5 “(e) Pursuant to a court order for good cause shown, and subject to the provisions of
6 ORS 192.324.

7 “(2) The individual seeking to inspect the document may be required to pay the expense
8 of preparing a copy of the document to be inspected.

9 “SECTION 68. UPA 807. Exclusive, continuing jurisdiction. During the period after the
10 execution of a gestational surrogacy agreement until 90 days after the birth of a child con-
11 ceived by assisted reproduction under the agreement, a court of this state conducting a
12 proceeding in which the parentage of the child is a relevant fact has exclusive, continuing
13 jurisdiction over all matters arising out of the agreement. Nothing in this section grants the
14 court jurisdiction to make or enforce a judgment of support or a child custody determination
15 if the court does not otherwise have such jurisdiction.

16 “SECTION 69. UPA 808. Termination of gestational surrogacy agreement. (1) A party to
17 a gestational surrogacy agreement may terminate the agreement, at any time before an
18 embryo transfer, by giving written notice of termination to all other parties. If an embryo
19 transfer does not result in a pregnancy, a party may terminate the agreement at any time
20 before a subsequent embryo transfer.

27 spouse or former spouse, if any, is liable to the intended parent or parents for a penalty or
28 liquidated damages, for terminating a gestational surrogacy agreement under this section.

29 “SECTION 70. UPA 809. Parentage under gestational surrogacy agreement. (1) Except as
30 otherwise provided in subsection (3) of this section or section 71 (2) or 74 of this 2025 Act,
31 on birth of a child conceived by assisted reproduction under a gestational surrogacy agree-
32 ment, each intended parent is, by operation of law, a parent of the child.

33 “(2) Except as otherwise provided in subsection (3) of this section or section 74 of this
34 2025 Act, neither a gestational surrogate nor the surrogate’s spouse or former spouse, if any,
35 is a parent of the child.

36 “(3)(a) If a child is alleged to be a genetic child of the individual who agreed to be a
37 gestational surrogate, the court:

38 “(A) Shall order genetic testing of the child as provided in sections 39 to 51 of this 2025
39 Act; or

40 “(B) Upon the joint request of the individual and the intended parent or parents, shall
41 admit a report of genetic testing as evidence of the truth of the facts asserted in the report
42 if the parties voluntarily consent to genetic testing that complies with sections 39 to 51 of
43 this 2025 Act.

44 “(b) If the individual is presumed to be a genetic parent of the child as provided in section
45 45 of this 2025 Act, the child is not a child conceived by assisted reproduction under a

1 surrogacy agreement for purposes of establishing parentage of the child under ORS 109.065.

2 “(4) Except as otherwise provided in subsection (3) of this section or section 71 (2) or 74
3 of this 2025 Act, each intended parent of a child conceived by assisted reproduction under a
4 gestational surrogacy agreement is a parent of the child if, due to a clinical or laboratory
5 error, the child is not genetically related to an intended parent or to a donor who donated
6 to the intended parent or parents, subject to any other claim of parentage.

7 “SECTION 71. UPA 810. Gestational surrogacy agreement; parentage of deceased in-
8 tended parent. (1) Section 70 of this 2025 Act applies to an intended parent even if the in-
9 tended parent dies during the period between the transfer resulting in a pregnancy and the
10 birth of the child.

11 “(2) Except as otherwise provided in section 74 of this 2025 Act, an intended parent who

28 “(d) If necessary, that the child be surrendered to the intended parent or parents; and

29 “(e) For other relief the court determines necessary and proper.

30 “(2) The court may issue a judgment under subsection (1) of this section before the birth
31 of the child but the court shall stay enforcement of the judgment until the birth of the child
32 and shall order one or more of the parties to notify the court of the child’s birth.

33 “(3) Neither this state nor the state registrar is a necessary party to a proceeding under
34 subsection (1) of this section.

35 “SECTION 73. Section 72 of this 2025 Act is amended to read:

36 “Sec. 72. (1) Except as otherwise provided in section 70 (3) of this 2025 Act, before, on or after
37 the birth of a child conceived by assisted reproduction under a gestational surrogacy agreement, a
38 party to the agreement may commence a proceeding in the circuit court for a judgment:

39 “(a) Declaring that each intended parent is a parent of the child and ordering that parental
40 rights and duties vest immediately on the birth of the child exclusively in each intended parent;

41 “(b) Declaring that the gestational surrogate and the surrogate’s spouse or former spouse, if any,
42 are not the parents of the child;

43 “(c) **Directing the State Registrar of the Center for Health Statistics to designate each**
44 **intended parent as a parent of the child on the birth record;**

11 **“(2) If a child was conceived by assisted reproduction under a gestational surrogacy**
12 **agreement that does not comply with sections 63 to 74 of this 2025 Act, the court shall de-**
13 **termine the rights and duties of the parties to the agreement consistent with the intent of**
14 **the parties at the time of the execution of the agreement. Each party to the agreement and**
15 **any individual who at the time of the execution of the agreement was a spouse of a party to**
16 **the agreement has standing to maintain a proceeding to adjudicate an issue related to the**
17 **enforcement of the agreement.**

29 **the full rights of parentage; or**

30 **“(b) Breach by the intended parent that prevents the intended parent’s acceptance, im-**
31 **mediately on birth of the child conceived by assisted reproduction under the agreement, of**

36 **“(1) ‘Abate’ means to reduce a devise on account of the insufficiency of the estate to pay all**
37 **claims, expenses and devises in full.**

38 **“(2) ‘Action’ includes suits and legal proceedings.**

16 "(11) 'Party' or 'parties' means parties to a proceeding, as described in ORS 419B.875.

17 "(12) 'Reservation' means Indian country as defined in 18 U.S.C. 1151 and any lands not covered
18 under that section, title to which is held by the United States in trust for the benefit of an Indian
19 tribe or individual or held by an Indian tribe or individual subject to a restriction by the United
20 States against alienation.

21 "(13) 'Tribal court' means a court with jurisdiction over Indian child custody proceedings and
22 that is either a Court of Indian Offenses, a court established and operated under the code or custom
23 of an Indian tribe or any other administrative body of a tribe that is vested with authority over

7 “25.080. (1) The following entity is primarily responsible for providing the support enforcement
8 services described in subsection (4) of this section when an application as described in ORS 25.084
9 is made, or when an assignment of support rights is made to the state:

10 “(a) The Division of Child Support of the Department of Justice:

11 “(A) If support rights are, or were within the past five months, assigned to this or another state;
12 or

13 “(B) In any case where arrearage under a support order is assigned or owed to or the right to
14 recover back support or state debt is held by this state or another state.

15 “(b) Except as provided in subsection (6) of this section, the district attorney in cases other than
16 those described in paragraph (a) of this subsection if an application as described in ORS 25.084 is
17 made by the obligee, by the obligor, by a person having physical custody of a minor child or by a
18 child attending school, as defined in ORS 107.108.

19 “(2) The provisions of this section apply to support enforcement services for any order or judg-
20 ment that is or could be entered under ORS 25.501 to 25.556 or 419B.400 or ORS chapter 107, 108,
21 109 or 110. The entity specified in subsection (1) of this section shall provide the support enforce-
22 ment services on behalf of the State of Oregon and not on behalf of any other party or on behalf
23 of a parent. The Department of Justice shall adopt rules addressing the provision of support
24 enforcement services when the purposes of the state in providing those services may be contradic-
25 tory in individual cases.

43 based upon a modification conducted under ORS 25.287 concerning existing child support orders;

44 “(g) Shall establish and enforce obligations to provide medical insurance coverage for dependent
45 children;

1 “(h) Shall ensure compliance with the provisions of 42 U.S.C. 651 to 669 and 45 C.F.R. Chapter
2 III as authorized by state law;

3 “(i) Shall carry out the policy of the State of Oregon regarding child support obligations as ex-
4 pressed in ORS 25.502; and

5 “(j) Shall ensure that child support orders are in compliance with the formula established by this
6 chapter.

7 “(5) In any proceeding under subsection (4) of this section, the parties are those described in
8 ORS 25.503.

9 “(6) The district attorney of any county and the department may provide by agreement for as-
10 sumption by the Division of Child Support of the functions of the district attorney under subsection
11 (1) of this section or for redistribution between the district attorney and the Division of Child Sup-
12 port of all or any portion of the duties, responsibilities and functions set forth in subsections (1) and
13 (4) of this section.

14 “(7) All county governing bodies and all district attorneys shall enter into child support coop-
15 erative agreements with the department. The following apply to this subsection:

16 “(a) The agreements shall contain appropriate terms and conditions sufficient for the state to
17 comply with all child support enforcement service requirements under federal law; and

18 “(b) If this state loses any federal funds due to the failure of a county governing body or district
19 attorney to either enter into an agreement under this subsection or to provide sufficient support

17 “(8) **‘Genetic testing’ means an analysis of genetic markers to identify or exclude a ge-**
18 **netic relationship.**

19 “[6] (9) ‘Office’ means the office of the Division of Child Support or the office of the district

21 “[7] (10) ‘Parent’ means:

22 “(a) The natural or adoptive [*father or mother*] **parent** of a dependent child or adjudicated youth;

23 “(b) A person whose parentage has been established under ORS 109.065; or

24 “(c) A stepparent when the person has an obligation to support a dependent child under ORS

14 “(d) A statement that, if the parent is represented by an attorney, the parent has the responsi-
15 bility to maintain contact with the parent’s attorney and to keep the attorney advised of the parent’s
16 whereabouts.

17 “(e) A statement that, if the parent is represented by an attorney, the parent must appear per-
18 sonally at any hearing where the parent is required to appear. The statement must explain that
19 ‘appear personally’ does not include appearance through the parent’s attorney.

20 “(f) A statement that, if the court has granted the parent an exception in advance under ORS
21 419B.918, the parent may appear in any manner permitted by the court under ORS 419B.918.

22 “(5) If the summons requires the parent to appear before the court to admit or deny the

25 within the time fixed by law for seizure or commencement;

26 “(e) The commencement or continuation of an action or proceeding by a governmental unit to
27 enforce its police or regulatory power;

28 “(f) The enforcement of a judgment, other than a money judgment, obtained in an action or
29 proceeding by a governmental unit to enforce its police or regulatory power, or with respect to any
30 licensure of the owner; or

31 “(g) The establishment by a governmental unit of any tax liability and any appeal thereof.

32 “(6) The court may void an act that violates the stay imposed by this section.

33 “(7) If a person knowingly violates the stay imposed by this section, the court may:

34 “(a) Award actual damages caused by the violation, reasonable attorney fees and costs; and

35 “(b) Sanction the violation as civil contempt.

38 “107.105. (1) Whenever the court renders a judgment of marital annulment, dissolution or sepa-

41 born, adopted or conceived during the marriage and for minor children born to the parties prior to
42 the marriage, as the court may deem just and proper under ORS 107.137. The court may hold a
43 hearing to decide the custody issue prior to any other issues. When appropriate, the court shall
44 recognize the value of close contact with both parents and encourage joint parental custody and
45 joint responsibility for the welfare of the children.

3 developed as required by ORS 107.102, the court shall review the parenting plan and, if approved,

15 Disabilities Act of 1990 (42 U.S.C. 12101 et seq.), the court may consider the noncustodial parent’s
16 disability in determining parenting time only if the court finds that behaviors or limitations related
17 to the noncustodial parent’s disability are endangering or will likely endanger the health, safety or
18 welfare of the child. The court shall recognize the value of close contact with both parents and
19 encourage, when practicable, joint responsibility for the welfare of such children and extensive
20 contact between the minor children of the divided marriage and the parties. If the court awards
21 parenting time to a noncustodial parent who has committed abuse, other than being convicted for
22 rape as described in this paragraph, the court shall make adequate provision for the safety of the
23 child and the other parent in accordance with the provisions of ORS 107.718 (6).

24 “(c) For the support of the children of the marriage by the parties. In ordering child support,
25 the formula established under ORS 25.275 shall apply. The court may at any time require an ac-
26 counting from the custodial parent with reference to the use of the money received as child support.
27 The court is not required to order support for any minor child who has become self-supporting,
28 emancipated or married or for any child who has ceased to attend school after becoming 18 years
29 of age. A general judgment entered under this section may include an amount for support as re-
30 quested in a petition filed under ORS 107.085 or under a motion for relief made pursuant to ORS
31 107.095 (1)(b) for which a limited judgment was not entered, payment of which commences no earlier
32 than the date the petition or motion was served on the nonrequesting party, and the amount shall
33 be considered a request for relief that has been decided by the general judgment for purposes of

36 for one party to contribute to the other, in gross or in installments or both. Unless otherwise ex-
37 pressly provided in the judgment and except for any unpaid balance of previously ordered spousal
38 support, liability for the payment of spousal support shall terminate on the death of either party,
39 and there shall be no liability for either the payment of spousal support or for any payment in cash
40 or property as a substitute for the payment of spousal support after the death of either party. The
41 court may approve an agreement for the entry of an order for the support of a party. A general
42 judgment entered under this section may include an amount for support as requested in a petition

11 “(iv) The financial needs and resources of each party;

12 “(v) The tax consequences to each party;

13 “(vi) A party’s custodial and child support responsibilities; and

14 “(vii) Any other factors the court deems just and equitable.

15 “(B) Compensatory spousal support when there has been a significant financial or other contri-
16 bution by one party to the education, training, vocational skills, career or earning capacity of the
17 other party and when an order for compensatory spousal support is otherwise just and equitable in
18 all of the circumstances. The factors to be considered by the court in awarding compensatory
19 spousal support include but are not limited to:

20 “(i) The amount, duration and nature of the contribution;

21 “(ii) The duration of the marriage;

22 “(iii) The relative earning capacity of the parties;

23 “(iv) The extent to which the marital estate has already benefited from the contribution;

24 “(v) The tax consequences to each party; and

25 “(vi) Any other factors the court deems just and equitable.

26 “(C) Spousal maintenance as a contribution by one spouse to the support of the other for either
27 a specified or an indefinite period. The factors to be considered by the court in awarding spousal
28 maintenance include but are not limited to:

29 “(i) The duration of the marriage;

30 “(ii) The age of the parties;

31 “(iii) The health of the parties, including their physical, mental and emotional condition;

32 “(iv) The standard of living established during the marriage;

33 “(v) The relative income and earning capacity of the parties, recognizing that the wage earner’s
34 continuing income may be a basis for support distinct from the income that the supported spouse
35 may receive from the distribution of marital property;

36 “(vi) A party’s training and employment skills;

37 “(vii) A party’s work experience;

38 “(viii) The financial needs and resources of each party;

39 “(ix) The tax consequences to each party;

40 “(x) A party’s custodial and child support responsibilities; and

41 “(xi) Any other factors the court deems just and equitable.

42 “(e) For the delivery to one party of such party’s personal property in the possession or control
43 of the other at the time of the giving of the judgment.

44 “(f) For the division or other disposition between the parties of the real or personal property,
45 or both, of either or both of the parties as may be just and proper in all the circumstances. In de-

1 terminating the division of property under this paragraph, the following apply:

2 “(A) A retirement plan or pension or an interest therein shall be considered as property.

3 “(B) The court shall consider the contribution of a party as a homemaker as a contribution to
4 the acquisition of marital assets.

5 “(C) Except as provided in subparagraph (D) of this paragraph, there is a rebuttable presumption
6 that both parties have contributed equally to the acquisition of property during the marriage,
7 whether such property is jointly or separately held.

8 “(D)(i) Property acquired by gift to one party during the marriage and separately held by that
9 party on a continuing basis from the time of receipt is not subject to a presumption of equal con-
10 tribution under subparagraph (C) of this paragraph.

11 “(ii) For purposes of this subparagraph, ‘property acquired by gift’ means property acquired by
12 one party through gift, devise, bequest, operation of law, beneficiary designation or inheritance.

13 “(E) Subsequent to the filing of a petition for annulment or dissolution of marriage or sepa-
14 ration, the rights of the parties in the marital assets shall be considered a species of co-ownership,
15 and a transfer of marital assets under a judgment of annulment or dissolution of marriage or of
16 separation entered on or after October 4, 1977, shall be considered a partitioning of jointly owned
17 property.

18 “(F) The court shall require full disclosure of all assets by the parties in arriving at a just
19 property division.

20 “(G) In arriving at a just and proper division of property, the court shall consider reasonable
21 costs of sale of assets, taxes and any other costs reasonably anticipated by the parties.

22 “(H)(i) If a party has been awarded spousal support in lieu of a share of property, the court shall
23 so state on the record and shall order the obligor to provide for and maintain life insurance in an
24 amount commensurate with the obligation and designating the obligee as beneficiary for the dura-
25 tion of the obligation.

26 “(ii) The obligee or attorney of the obligee shall cause a certified copy of the judgment to be
27 delivered to the life insurance company or companies.

10 107.095, the limited judgment shall continue to be enforceable for any amounts not paid under the
11 limited judgment unless those amounts are included in the money award made by the general judg-
12 ment.

13 “(j) For an award of reasonable attorney fees and costs and expenses reasonably incurred in the
14 action in favor of a party or in favor of a party’s attorney.

31 interests and welfare of the child. In determining the best interests and welfare of the child, the
32 court shall consider the following relevant factors:

33 “(a) The emotional ties between the child and other family members;

34 “(b) The interest of the parties in and attitude toward the child;

35 “(c) The desirability of continuing an existing relationship;

29 “(A) Criminal prosecution based on the violation; or

30 “(B) Imposition of punitive sanctions under ORS 33.065 based on the violation.

32 “109.116. Any authorization, release or waiver given by *[the putative father]* **a child’s alleged**
33 **genetic parent** with reference to the custody or adoption of the child or the termination of parental
34 rights shall be valid even if given prior to the child’s birth.

35 “**SECTION 123.** ORS 109.276 is amended to read:

36 “109.276. (1) Any person may petition the circuit court for leave to adopt another person and,
37 if desired, for a change of the other person’s name. Except as provided in ORS 419B.529 or 419B.656,
38 a separate petition must be filed for each person for whom leave to adopt is sought.

39 “(2) One petitioner, the child, one parent or the person, who is not an adoption agency, con-

29 “(9) ‘Guardian’ means a person appointed by a court as guardian of a minor under ORS chapter
30 125 or the laws of any other state.

31 “(10) ‘Health history’ means a comprehensive report, when obtainable, of the child’s health sta-
32 tus and medical history at the time of placement for adoption, including neonatal, psychological,
33 physiological and medical care history.

34 “(11) ‘Minor’ means a person under 18 years of age.

35 “(12) ‘Progeny’ means the children or descendants of a person and the person’s descendants in
36 successive generations.

37 “[(13) ‘Putative father’ means a man who, under the laws of this state, is not legally presumed to
38 be the father of genetic origin of a child, but who claims or is alleged to be the father of genetic origin

10 Services and who has a permanency plan or concurrent permanent plan of adoption; and

11 “(b) Who has cared for the ward, or at least one sibling of the ward, for at least 12 cumulative
12 months or for one-half of the ward’s or sibling’s life where the ward or sibling is younger than two
13 years of age, calculated cumulatively.

14 “[(13)] (14) ‘Department’ means the Department of Human Services.

15 “[(14)] (15) ‘Detention’ or ‘detention facility’ means a facility established under ORS 419A.010
16 to 419A.020 and 419A.050 to 419A.063 for the detention of youths or adjudicated youths pursuant to
17 a judicial commitment or order.

18 “[(15)] (16) ‘Director’ means the director of a juvenile department established under ORS
19 419A.010 to 419A.020 and 419A.050 to 419A.063.

20 “[(16)] (17) ‘Guardian’ means guardian of the person and not guardian of the estate.

21 “[(17)] (18) ‘Indian child’ has the meaning given that term in ORS 419B.603.

22 “[(18)] (19) ‘Juvenile court’ means the court having jurisdiction of juvenile matters in the several
23 counties of this state.

24 “[(19)] (20) ‘Local citizen review board’ means the board specified by ORS 419A.090 and
25 419A.092.

26 “[(20)] (21) ‘Parent’ means the *[biological]* **genetic** or adoptive mother and the legal parent of
27 the child, ward, youth or adjudicated youth. As used in this subsection, ‘legal parent’ means:

28 “(a) A person who has adopted the child, ward, youth or adjudicated youth or whose parentage
29 has been established or declared under ORS 25.501 to 25.556 or 109.065 or by a juvenile court; and

30 “(b) If the child is an Indian child, a man whose parentage has been established as described in

39 “[(25)] (26) ‘Reasonable and prudent parent standard’ means the standard, characterized by
40 careful and sensible parental decisions that maintain the health, safety and best interests of a child
41 or ward while encouraging the emotional and developmental growth of the child or ward, that a
42 substitute care provider shall use when determining whether to allow a child or ward in substitute
43 care to participate in extracurricular, enrichment, cultural and social activities.

44 “[(26)] (27) ‘Reasonable time’ means a period of time that is reasonable given a child or ward’s
45 emotional and developmental needs and ability to form and maintain lasting attachments.

1 “[27)] (28) ‘Records’ means any information in written form, pictures, photographs, charts,
2 graphs, recordings or documents pertaining to a case.

3 “[28)] (29) ‘Resides’ or ‘residence,’ when used in reference to the residence of a child, ward,
4 youth or adjudicated youth, means the place where the child, ward, youth or adjudicated youth is
5 actually living or the jurisdiction in which wardship or jurisdiction has been established.

6 “[29)] (30) ‘Restitution’ has the meaning given that term in ORS 137.103.

7 “[30)] (31) ‘Serious physical injury’ means:

8 “(a) A serious physical injury as defined in ORS 161.015; or

9 “(b) A physical injury that:

10 “(A) Has a permanent or protracted significant effect on a child’s daily activities;

11 “(B) Results in substantial and recurring pain; or

12 “(C) In the case of a child under 10 years of age, is a broken bone.

13 “[31)] (32) ‘Shelter care’ means a home or other facility suitable for the safekeeping of a child,
14 ward, youth or adjudicated youth who is taken into temporary custody pending investigation and
15 disposition.

16 “[32)] (33) ‘Short-term detention facility’ means a facility established under ORS 419A.050 (3) for
17 holding youths and adjudicated youths pending further placement.

18 “[33)] (34) ‘Sibling’ means one of two or more children or wards related:

19 “(a) By blood or adoption through a common legal parent; or

20 “(b) Through the marriage of the children’s or wards’ legal or *[biological]* **genetic** parents.

21 “[34)] (35)(a) ‘Substitute care’ means an out-of-home placement directly supervised by the de-

12 affidavit from the personal representative or a relative of the person attesting that the person is a
13 [biological] **genetic** parent of the applicant and that the name to be entered is that of the
14 [biological] **genetic** parent that was omitted from the original record of live birth.

15 “(3) If the name of a [biological] **genetic** parent is entered on an original record of live birth
16 under this section:

17 “(a) A person may only obtain a noncertified copy of a record of live birth amended under this
18 section.

19 “(b) A notation indicating that the record was amended must be shown on all copies of the re-
20 cord.

21 “(c) The center shall prominently display the following language on all copies of the record:
22 ‘THIS RECORD OF LIVE BIRTH MAY NOT BE USED FOR ANY LEGAL PURPOSE AND DOES
23 NOT CREATE ANY LEGAL RIGHTS FOR THE CHILD OR THE PARENTS LISTED ON THE
24 RECORD.’

34 Health Statistics shall develop and implement a preservation management program to preserve vital
35 record documents and information and meet generally accepted standards for permanent preserva-

37 “(2) The state registrar shall prepare typewritten, photographic, electronic or other reprod-
38 uctions of vital records or reports kept and maintained in the Center for Health Statistics. These
39 reproductions, when verified and approved by the state registrar, shall be accepted as the original

41 have been made may be disposed of as described in ORS 192.105 or as provided by rule of the state

3 toric vital record documents and information for research and related purposes. Vital records are
4 historic when 100 years have elapsed after the date of live birth for births occurring after 1914, 50
5 years have elapsed after the date of death for deaths occurring after 1964, 50 years have elapsed
6 after the date of fetal death for fetal deaths occurring after 1964 or 50 years have elapsed after the
7 date of marriage, domestic partnership, dissolution of marriage or dissolution of domestic partner-
8 ship for such events occurring after 1964. Supporting documents, including corrections and ac-
9 knowledgments of paternity **or parentage**, may be included with historic vital records. Records
10 under seal are not historic unless unsealed by court order.

11 “(5) Historic vital records shall be transferred to the State Archives in accordance with archival
12 procedures for the continued safekeeping of the vital records. The State Archives may not charge
13 the Center for Health Statistics for the transfer and maintenance of historic vital records under this
14 subsection. The state registrar shall adopt rules to ensure that the release of information contained
15 in records of birth, death, marriage, domestic partnership and dissolution of marriage or domestic
16 partnership, and reports of fetal death, comply with federal and state laws, regulations and rules.
