

Senate Bill 174

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Judiciary)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Adds bad acts done with respect to insurance to the list of bad acts that are subject to the Unlawful Trade Practices Act. Lets a person get from a court relief in addition to damages under the UTPA. Tells a district attorney to get permission from a state agency to take action under the UTPA in relation to insurance. (Flesch Readability Score: 60.6).

Provides that a violation of prohibitions against certain practices with respect to insurance is subject to an enforcement action under the Unlawful Trade Practices Act.

Permits a person to obtain, and a court to award, appropriate equitable relief in addition to monetary damages under the Unlawful Trade Practices Act.

Requires the Director of the Department of Consumer and Business Services to request action before a prosecuting attorney may take action under the Unlawful Trade Practices Act against an act or practice related to insurance.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 646.605 is amended to read:

6 646.605. As used in ORS 336.184 and 646.605 to 646.652:

7 (1) "Appropriate court" means the circuit court of a county:

8 (a) [*Where one or more of the defendants reside*] **In which a defendant resides;**

9 (b) [*Where one or more of the defendants maintain*] **In which a defendant maintains** a principal
10 place of business;

11 (c) [*Where one or more of the defendants are*] **In which a defendant is** alleged to have committed
12 an act prohibited by ORS 336.184 and 646.605 to 646.652; or

13 (d) With [*the*] a defendant's consent, [*where*] **in which** the prosecuting attorney maintains an
14 office.

15 (2) "Documentary material" means the original or a copy of any book, record, report, memo-
16 randum, paper, communication, tabulation, map, chart, photograph, mechanical transcription, or
17 other tangible document or recording, wherever situated.

18 (3) "Examination" of documentary material [*includes inspection, study*] **means inspecting,**
19 **studying** or copying [*of*] any documentary material[,] and taking testimony under oath or acknowl-
20 edgment [*regarding any documentary material or copy thereof*] **about the documentary material**
21 **or a copy of the documentary material.**

22 (4) "Person" means a natural [*persons, corporations, trusts, partnerships,*] **person, a corporation,**
23 **a trust, a partnership, an** incorporated or unincorporated [*associations*] **association** and any other
24 legal entity except [*bodies or officers*] **a body or officer that is** acting under **the** statutory authority

2 (5) "Prosecuting attorney" means the Attorney General or the district attorney of any county
3 in which a violation of ORS 336.184 and 646.605 to 646.652 is alleged to have occurred.

4 (6)(a) "Real estate, goods or services" means those that are or may be obtained primarily for
5 personal, family or household purposes, or that are or may be obtained for any purposes as a result
6 of a telephone solicitation, and includes loans and extensions of credit, and franchises,
7 distributorships and other similar business opportunities[, *but does not include insurance*].

8 (b) Notwithstanding paragraph (a) of this subsection:

9 (A) "Real estate" does not cover conduct covered by ORS chapter 90.

10 (B) "Loans and extensions of credit" does not include transactions involving a pawnbroker, as
11 defined in ORS 726.010, that is required to be licensed under ORS chapter 726.

12 (7) "Telephone solicitation" means a solicitation [*where*] **in which** a person, in the course of the
13 person's business, vocation or occupation, uses a telephone or an automatic dialing-announcing de-
14 vice to initiate telephonic contact with a potential customer and the person is not one of the fol-
15 lowing:

16 (a) [*A person who is*] A broker-dealer or salesperson licensed under ORS 59.175, or a mortgage
17 banker or mortgage broker licensed under ORS 86A.106, [*when*] **if** the solicitation is for a security
18 qualified for sale [*pursuant to*] **under** ORS 59.055.

19 (b) A real estate licensee or a person who is otherwise authorized to engage in professional real
20 estate activity [*pursuant to*] **under** ORS chapter 696, [*when*] **if** the solicitation involves professional
21 real estate activity.

22 (c) A person licensed or exempt from licensure as a builder [*pursuant to*] **under** ORS chapter
23 701, [*when*] **if** the solicitation involves [*the construction, alteration, repair, improvement or demolition*
24 *of*] **constructing, altering, repairing, improving or demolishing** a structure.

25 [*(d) A person licensed or otherwise authorized to sell insurance as an insurance producer pursuant*
26 *to ORS chapter 744, when the solicitation involves insurance.*]

27 [*(e)*] **(d)** A person [*soliciting*] **that solicits** the sale of a newspaper of general circulation, a
28 magazine or membership in a book or record club who complies with ORS 646.611, [*when*] **if** the
29 solicitation involves newspapers, magazines or membership in a book or record club.

30 [*(f)*] **(e)** A person [*soliciting*] **that solicits**, without the intent to complete, and who does not
31 complete [*the*] **a** sales presentation during the telephone solicitation and [*who*] **that** only completes
32 the sales presentation at a later face-to-face meeting between the [*solicitor*] **person** and the pro-
33 spective purchaser.

34 [*(g)*] **(f)** A supervised financial institution or parent, subsidiary or affiliate [*thereof*] **of a super-**
35 **vised financial institution**. As used in this paragraph, "supervised financial institution" means any
36 financial institution or trust company, as those terms are defined in ORS 706.008, or any personal
37 property broker, consumer finance lender, commercial finance lender or insurer that is subject to
38 regulation by an official or agency of this state or of the United States.

39 [*(h)*] **(g)** A person [*who*] **that** is authorized to conduct prearrangement or preconstruction fu-
40 neral or cemetery sales, [*pursuant to*] **under** ORS chapter 692, [*when*] **if** the solicitation involves
41 prearrangement or preconstruction funeral or cemetery plans.

42 [*(i)*] **(h)** A person [*who*] **that** solicits the services [*provided by*] **that** a cable television system
43 licensed or franchised [*pursuant to*] **under** state, local or federal law **provides**, [*when*] **if** the sol-
44 icitation involves cable television services.

45 [*(j)*] **(i)** A person or affiliate of a person [*whose*] **the** business [*is regulated by*] **of which** the

1 Public Utility Commission [*of Oregon*] **regulates.**

2 [(k)] (j) A person who sells farm products, as defined [by] **in** ORS 576.006, if the [*solicitation*
3 *neither intends to nor actually results*] **person does not intend to complete a sale and the solici-**
4 **itation does not actually result** in a sale that costs the purchaser in excess of \$100.

5 [(L)] (k) An issuer or subsidiary of an issuer that has a class of securities that is subject to
6 section 12 of the Securities Exchange Act of 1934 and that is either registered or exempt from reg-
7 istration under paragraph (A), (B), (C), (E), (F), (G) or (H) or subsection (g) of that section.

8 [(m)] (L) A person [*soliciting exclusively*] **that solicits only** the sale of telephone answering
9 services [*to be provided by*] that **the** person or [*that*] **the** person's employer [*when*] **will provide, if**
10 **the solicitation involves answering services.**

11 [(n)] (m) A telecommunications utility with access lines of 15,000 or less or a cooperative tele-
12 phone association, [*when*] **if** the solicitation involves regulated goods or services.

13 (8) "Trade" and "commerce" mean advertising, offering or distributing, whether by sale, rental
14 or otherwise, any real estate, goods or services, and include any trade or commerce **that** directly
15 or indirectly [*affecting*] **affects** the people of this state.

16 (9) "Unconscionable tactics" include, but are not limited to, actions by which a person:

17 (a) Knowingly takes advantage of a customer's physical infirmity, ignorance, illiteracy or ina-
18 bility to understand the language of the agreement;

19 (b) Knowingly permits a customer to enter into a transaction from which the customer will
20 derive no material benefit;

21 (c) Permits a customer to enter into a transaction [*with knowledge that there is no reasonable*
22 *probability of payment of the attendant financial obligation in full by the customer when due*] **knowing**
23 **that the customer does not have a reasonable probability of paying the attendant financial**
24 **obligations in full when due; or**

25 (d) Knowingly takes advantage of a customer who is a disabled veteran, a disabled
26 servicemember or a servicemember in active service, or the spouse of a disabled veteran, disabled
27 servicemember or servicemember in active service. For purposes of this paragraph:

28 (A) "Disabled veteran" has the meaning given that term in ORS 408.225.

29 (B) "Disabled servicemember" means a servicemember, as defined in 50 U.S.C. 3911 as in effect
30 on [*January 1, 2010*] **the effective date of this 2025 Act**, who may be entitled to disability com-
31 pensation under laws administered by the United States Department of Veterans Affairs.

32 (C) "Servicemember in active service" means:

33 (i) A servicemember called into active service under Title 10 or Title 32 of the United States
34 Code as in effect on [*January 1, 2010*] **the effective date of this 2025 Act**; or

35 (ii) A servicemember on state active duty, as defined in the Oregon Code of Military Justice.

36 (10) A willful violation occurs when the person committing the violation knew or should have
37 known that the conduct of the person was a violation.

38 [(11) A loan is made "*in close connection with the sale of a manufactured dwelling*" if:]

39 [(a) The lender directly or indirectly controls, is controlled by or is under common control with the
40 seller, unless the relationship is remote and is not a factor in the transaction;]

41 [(b) The lender gives a commission, rebate or credit in any form to a seller who refers the borrower
42 to the lender, other than payment of the proceeds of the loan jointly to the seller and the borrower;]

43 [(c) The lender is related to the seller by blood or marriage;]

44 [(d) The seller directly and materially assists the borrower in obtaining the loan;]

45 [(e) The seller prepares documents that are given to the lender and used in connection with the

2 *[(f) The lender supplies documents to the seller used by the borrower in obtaining the loan.]*

3 **SECTION 2.** ORS 646.608 is amended to read:

4 646.608. (1) A person engages in an unlawful practice if in the course of the person's business,
5 vocation or occupation the person does any of the following:

6 (a) Passes off real estate, goods or services as the real estate, goods or services of another.

7 (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-
8 proval, or certification of real estate, goods or services.

9 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-
10 ciation with, or certification by, another.

11 (d) Uses deceptive representations or designations of geographic origin in connection with real
12 estate, goods or services.

13 (e) Represents that real estate, goods or services have sponsorship, approval, characteristics,
14 ingredients, uses, benefits, quantities or qualities that the real estate, goods or services do not have
15 or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the
16 person does not have.

17 (f) Represents that real estate or goods are original or new if the real estate or goods are de-
18 teriorated, altered, reconditioned, reclaimed, used or secondhand.

19 (g) Represents that real estate, goods or services are of a particular standard, quality, or grade,
20 or that real estate or goods are of a particular style or model, if the real estate, goods or services
21 are of another.

22 (h) Disparages the real estate, goods, services, property or business of a customer or another
23 by false or misleading representations of fact.

24 (i) Advertises real estate, goods or services with intent not to provide the real estate, goods or
25 services as advertised, or with intent not to supply reasonably expectable public demand, unless the
26 advertisement discloses a limitation of quantity.

27 (j) Makes false or misleading representations of fact concerning the reasons for, existence of,
28 or amounts of price reductions.

29 (k) Makes false or misleading representations concerning credit availability or the nature of the
30 transaction or obligation incurred.

31 (L) Makes false or misleading representations relating to commissions or other compensation to
32 be paid in exchange for permitting real estate, goods or services to be used for model or demon-
33 stration purposes or in exchange for submitting names of potential customers.

34 (m) Performs service on or dismantles any goods or real estate if the owner or apparent owner
35 of the goods or real estate does not authorize the service or dismantling.

36 (n) Solicits potential customers by telephone or door to door as a seller unless the person pro-
37 vides the information required under ORS 646.611.

38 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give
39 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of
40 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or
41 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,
42 discount or other value is contingent upon an event occurring after the time the customer enters
43 into the transaction.

44 (p) Makes any false or misleading statement about a prize, contest or promotion used to publi-
45 cize a product, business or service.

- 1 (q) Promises to deliver real estate, goods or services within a certain period of time with intent
2 not to deliver the real estate, goods or services as promised.
- 3 (r) Organizes or induces or attempts to induce membership in a pyramid club.
- 4 (s) Makes false or misleading representations of fact concerning the offering price of, or the
5 person's cost for real estate, goods or services.
- 6 (t) Concurrent with tender or delivery of any real estate, goods or services, fails to disclose any
7 known material defect or material nonconformity.
- 8 (u) Engages in any other unfair or deceptive conduct in trade or commerce.
- 9 (v) Violates any of the provisions relating to auction sales, consignment sales, auctioneers,
10 consignees or auction marts under ORS 698.640, whether in a commercial or noncommercial situ-
11 ation.
- 12 (w) Manufactures mercury fever thermometers.
- 13 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal
14 law, or is:

25 an ascertainable loss of money or property, real or personal, as a result of another person's willful
26 use or employment of a method, act or practice declared unlawful under ORS 646.608, may bring an
27 individual action in an appropriate court to recover actual damages or statutory damages of \$200,
28 whichever is greater, **and to obtain appropriate equitable relief**. The court or the jury may award
29 punitive damages and the court may provide any equitable relief the court considers necessary or
30 proper.

31 (2)(a) A person that brings an action under subsection (1) of this section shall mail a copy of
32 the complaint or other initial pleading to the Attorney General at the time the action commences
33 and, upon entry of any judgment in the action, shall mail a copy of the judgment to the Attorney

 7 of the unlawful method, act or practice. Notwithstanding this limitation, if a prosecuting attorney
 8 filed a complaint to prevent, restrain or punish a violation of ORS 646.608, the complaint tolls the
 9 statute of limitations with respect to every private right of action under this section that is based
 10 in whole or in part on any matter set forth in the prosecuting attorney’s complaint for the period
 11 of time in which the proceeding that the prosecuting attorney initiated is pending.

31 (b) “Cash sale price” means the price for which a manufactured dwelling dealer would sell to
 32 a buyer, and the buyer would buy from a dealer, a manufactured dwelling that is covered by a
 33 purchase agreement, if the sale were a sale for cash instead of a retail installment sale.

34 (c) “Manufactured dwelling” has the meaning given that term in ORS 446.003.

35 (d) “Manufactured dwelling dealer” means a person licensed under ORS 446.691 or 446.696 or a
 36 temporary manufactured structure dealer licensee under ORS 446.701.

37 (e) “Retail installment sale” has the meaning given that term in ORS 83.510.

38 (2) A manufactured dwelling dealer engages in an unlawful practice when, in a sale of a manu-
 39 factured dwelling, the dealer does any of the following:

40 (a) Misrepresents to a buyer that, as a condition of financing, the buyer must purchase:

41 (A) Credit life insurance;

42 (B) Credit disability insurance;

43 (C) Credit unemployment insurance;

44 (D) Credit property insurance;

45 (E) Health insurance;

1 (F) Life insurance; or

2 (G) An extended warranty.

3 (b) In close connection with the sale, misrepresents to a lender:

4 (A) The cash sale price;

5 (B) The amount of the buyer's down payment; or

6 (C) The buyer's credit or employment history.

7 **(3) For purposes of subsection (2)(b) of this section, a loan is made in close connection**
8 **with the sale of a manufactured dwelling if:**

9 **(a) The lender directly or indirectly controls, is controlled by or is under common control**
10 **with the seller, unless the relationship is remote and is not a factor in the transaction;**

11 **(b) The lender gives a commission, rebate or credit in any form to a seller who refers the**
12 **borrower to the lender, other than paying the proceeds of the loan jointly to the seller and**
13 **the borrower;**

14 **(c) The lender is related to the seller by blood or marriage;**

15 **(d) The seller directly and materially assists the borrower in obtaining the loan;**

16 **(e) The seller prepares documents that are given to the lender and used in connection**
17 **with the loan; or**

18 **(f) The lender supplies documents to the seller that the borrower uses in obtaining the**
19 **loan.**

20 **SECTION 7. Section 8 of this 2025 Act is added to and made a part of ORS 646.605 to**
21 **646.652.**

22 **SECTION 8. A prosecuting attorney may not take action under ORS 646.618 or 646.632**
23 **with respect to an act or practice declared to be unlawful under ORS 646.608 (1)(bbbb) unless**
24 **the Director of the Department of Consumer and Business Services first requests the pros-**
25 **ecuting attorney to take action. The director may elect to be named as a party in any action**
26 **or proceeding that the prosecuting attorney commences at the director's request.**

27 **SECTION 9. Section 8 of this 2025 Act and the amendments to ORS 646.605, 646.608,**
28 **646.612, 646.636, 646.638 and 646.648 by sections 1 to 6 of this 2025 Act apply to acts that occur**
29 **on or after the effective date of this 2025 Act.**

30
