

# Senate Bill 272

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Judiciary)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act tells the State Court Administrator to look at receivership and make a report. (Flesch Readability Score: 61.8).

Requires the State Court Administrator to study receivership and submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.

Sunsets on January 2, 2027.

## A BILL FOR AN ACT

2 Relating to receivership.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. The State Court Administrator shall study receivership. The State Court**  
5 **Administrator shall submit a report in the manner provided by ORS 192.245, and may include**  
6 **recommendations for legislation, to the interim committees of the Legislative Assembly re-**  
7 **lated to the judiciary no later than September 15, 2026.**

8 **SECTION 2. Section 1 of this 2025 Act is repealed on January 2, 2027.**
