A-Engrossed Senate Bill 430

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Says that a person may not show or offer a price for goods or services online that does not include all of the fees and charges that a buyer must pay. Says that taxes and fees to ship the goods or provide the services do not need to be shown. (Flesch Readability Score: 79.9).

[Digest: Tells an online seller to show a summary of all of the fees that come with a sale to a buyer before making the sale. Says that the buyer has to have a chance to approve the summary before buying. (Flesch Readability Score: 74.4).]

[Specifies disclosures that a retail seller must make to a retail buyer for a transaction in goods or services that concludes online by means of a website or other electronic method. Provides that the retail buyer must approve the disclosures before the transaction concludes.]

Prohibits a person that offers of sells goods or services online to a resident of this state from advertising, displaying or offering a price for the goods or services that does not include all fees or charges that a purchaser must pay to complete a transaction for the goods or services, other than taxes or fees that a governmental body imposes on the transaction or reasonable charges that the person actually incurs to ship the goods or provide the services. Specifies exemptions.

Punishes a violation of the Act as a unlawful practice under the Unlawful Trade Practices Act.

Takes effect on the 91st day following adjournment sine die.

 amending ORS 646.608; and prescribing an effective date.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> (1) A person that offers or sells goods or services online to a resident of this 6 state may not advertise, display or offer a price for the goods or services that does not in-

7 clude all fees or charges that a purchaser must pay to complete a transaction for the goods

8 or services other than:

(a) Taxes or fees that a governmental body imposes on the transaction; or

(b) Reasonable charges that the person actually incurs to ship the goods or provide the services to the purchaser.

12 (2) A violation of this section is an unlawful practice under ORS 646.608.

13 (3) This section does not apply to:

(a) A financial institution, as defined in ORS 706.008, a mortgage banker or mortgage
broker, both as defined in ORS 86A.100, or a licensee, as defined in ORS 725.010, to the extent
that the financial institution, mortgage banker or mortgage broker or licensee must provide
disclosures for a transaction under any of the following federal laws, or under regulations
adopted under the following federal laws, all as in effect on the effective date of this 2025

19	proval, or certification of real estate, goods or services.
20	(c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-
21	ciation with, or certification by, another.
22	(d) Uses deceptive representations or designations of geographic origin in connection with real
23	estate, goods or services.
24	(e) Represents that real estate, goods or services have sponsorship, approval, characteristics,
25	ingredients, uses, benefits, quantities or qualities that the real estate, goods or services do not have
26	or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the

28	(f) Represents that real estate or goods are original or new if the real estate or goods are de-

30	(g) Represents that real estate, goods or services are of a particular standard, quality, or grade,
31	or that real estate or goods are of a particular style or model, if the real estate, goods or services
32	are of another.
33	(h) Disparages the real estate, goods, services, property or business of a customer or another
34	by false or misleading representations of fact.
35	(i) Advertises real estate, goods or services with intent not to provide the real estate, goods or
36	services as advertised, or with intent not to supply reasonably expectable public demand, unless the
37	advertisement discloses a limitation of quantity.
38	(j) Makes false or misleading representations of fact concerning the reasons for, existence of,
39	or amounts of price reductions.
40	(k) Makes false or misleading representations concerning credit availability or the nature of the
41	transaction or obligation incurred.

(2) A representation under subsection (1) of this section or ORS 646.607 may be any manifestation of any assertion by words or conduct, including, but not limited to, a failure to disclose a fact.
(3) In order to prevail in an action or suit under ORS 336.184 and 646.605 to 646.652, a prose-

10 cuting attorney need not prove competition between the parties or actual confusion or misunder-11 standing.

(4) An action or suit may not be brought under subsection (1)(u) of this section unless the Attorney General has first established a rule in accordance with the provisions of ORS chapter 183
declaring the conduct to be unfair or deceptive in trade or commerce.

(5) Notwithstanding any other provision of ORS 336.184 and 646.605 to 646.652, if an action or suit is brought under subsection (1)(xx) of this section by a person other than a prosecuting attorney, relief is limited to an injunction, and the prevailing party may be awarded reasonable attorney fees.

SECTION 3. Section 1 of this 2025 Act and the amendments to ORS 646.608 by section 2
 of this 2025 Act apply to transactions that conclude on or after the effective date of this 2025
 Act.

22 <u>SECTION 4.</u> This 2025 Act takes effect on the 91st day after the date on which the 2025 23 regular session of the Eighty-third Legislative Assembly adjourns sine die.
