SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act tells ODEM to give grants to counties to pay for emergency coordinators. The Act tells the EPAC to make a group to study the emergency readiness of counties. (Flesch Readability Score: 61.8).

Directs the Oregon Department of Emergency Management to develop and implement a grant

program to distribute moneys to certain counties to fund emergency preparedness coordinators. Directs the Emergency Preparedness Advisory Council to convene a Committee on County Emergency Management to study and make recommendations regarding the capacity of counties in Oregon to prepare for, respond to and recover from emergencies.

3	Whereas it is critical for communities to prepare for disasters and other emergencies, including
4	a Cascadia Subduction Zone earthquake and tsunami; and
5	Whereas statewide emergency preparedness is dependent on local preparedness; now, therefore,
6	Be It Enacted by the People of the State of Oregon:
7	SECTION 1. (1) The Oregon Department of Emergency Management shall, by rule, de-
8	velop and implement a grant program to distribute moneys to eligible counties to fund
9	emergency preparedness coordinators at the county level.
10	(2) A county is eligible for a grant under the program if:
11	(a) The county is one of Clatsop, Coos, Curry, Douglas, Lane, Lincoln or Tillamook
12	Counties; and
13	(b) The emergency management agency of the county is funded by federal moneys dis-
14	tributed through the Emergency Management Performance Grant administered by the Fed-
15	eral Emergency Management Agency.
16	(3) The department shall prescribe the process for eligible counties to apply for a grant
17	under this section, including application timelines and the form and contents of an applica-
18	tion.
19	(4) The department shall award grants to selected applicants in an amount sufficient to
20	fund a county emergency preparedness coordinator for one biennium. In selecting counties
21	to be awarded grants under this section, the department shall seek to maximize the overall
22	emergency preparedness of this state, with consideration given to geographic differences in
23	types and severity of potential emergencies.
24	SECTION 2. In addition to and not in lieu of any other appropriation, there is appropri-
25	ated to the Oregon Department of Emergency Management, for the biennium beginning July

1 1, 2025, out of the General Fund, the amount of \$2,380,000 to carry out the purposes of sec-2 tion 1 of this 2025 Act.

3 <u>SECTION 3.</u> (1) The Emergency Preparedness Advisory Council established under section
 4 151, chapter 539, Oregon Laws 2021, shall convene a Committee on County Emergency Man 5 agement.

6 (2) The committee must consist of not more than half of the members of the council.
7 The council shall appoint a chairperson and vice chairperson for the committee.

8 (3) The committee shall study and make recommendations regarding the capacity of 9 counties in Oregon to prepare for, respond to and recover from emergencies. The recom-10 mendations must include recommendations for methods to establish dedicated funding for 11 county emergency management staff, including at least a director and deputy director of 12 emergency management in each county.

(4) On or before December 31, 2026, the committee shall transmit a report describing its
 findings and recommendations to the standing or interim committees of the Legislative Assembly relating to emergency management.

(5) The Legislative Revenue Officer is directed to assist the Committee on County
 Emergency Management in carrying out revenue projections and any other tasks the com mittee deems necessary for the performance of its duties.

19 SECTION 4. Section 3 of this 2025 Act is repealed on January 2, 2027.
