## Senate Bill 5504

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act creates an agency budget. (Flesch Readability Score: 73.8).

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Re-ceipts, but excluding lottery funds and federal funds, collected or received by the Oregon Department of Aviation.

Limits biennial expenditures by the department from federal funds. Declares an emergency, effective July 1, 2025.
