

Senate Bill 5517

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act creates an agency budget. (Flesch Readability Score: 73.8).

Appropriates moneys from the General Fund to the Oregon Department of Emergency Management for certain biennial expenses.

Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the department.

Limits certain biennial expenditures by the department from federal funds.

Declares an emergency, effective July 1, 2025.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There are appropriated to the Oregon Department of Emergency Manage-**
6 **ment, for the biennium beginning July 1, 2025, out of the General Fund, the following**
7 **amounts, for the following purposes:**

- 8 (1) Administration..... \$ 21,861,888
- 9 (2) 9-1-1 Emergency Program..... \$ 1,400,084
- 10 (3) Preparedness and Response.. \$ 6,587,299
- 11 (4) Mitigation and Recovery..... \$ 497,289
- 12 (5) Debt Service..... \$ 5,765,853

13 **SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts**
14 **are established for the biennium beginning July 1, 2025, as the maximum limits for payment**
15 **of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
16 **cluding lottery funds and federal funds, collected or received by the Oregon Department of**
17 **Emergency Management, for the following purposes:**

- 18 (1) Administration..... \$ 454,992
- 19 (2) 9-1-1 Emergency Program..... \$ 149,533,661
- 20 (3) Preparedness and Response.. \$ 11,152,319
- 21 (4) Mitigation and Recovery..... \$ 24,525,466

22 **SECTION 3. Notwithstanding any other law limiting expenditures, the following amounts**
23 **are established for the biennium beginning July 1, 2025, as the maximum limit for payment**
24 **of expenses from federal funds collected or received by the Oregon Department of Emer-**
25 **gency Management, for the following purposes:**

- 26 (1) Administration..... \$ 646,011
