SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act creates an agency budget. (Flesch Readability Score: 73.8).

Appropriates moneys from the General Fund to the Department of Environmental Quality for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, specified bond proceeds and specified federal funds, but excluding lottery funds and other federal funds, collected or received by the department.

Limits biennial expenditures from lottery moneys allocated from the Parks and Natural Resources Fund to the department.

Authorizes specified nonlimited expenditures. Limits certain biennial expenditures by the department from federal funds. Declares an emergency, effective July 1, 2025.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> There are appropriated to the Department of Environmental Quality, for the

6 biennium beginning July 1, 2025, out of the General Fund, the following amounts, for the

7 following purposes:

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts 13 are established for the biennium beginning July 1, 2025, as the maximum limits for payment 14 of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, the 15 proceeds of bonds for the Orphan Site Account and federal funds from congestion mitigation 16 and air quality grants, drinking water protection, laboratory accreditation and woodstove 17grants and for smoke monitoring laboratory services, but excluding lottery funds and federal 18 funds not described in this section, collected or received by the Department of Environ-19 mental Quality, for the following purposes: 20
