12 "<u>SECTION 3.</u> Notwithstanding any other law limiting expenditures, the amount of 13 \$797,539 is established for the biennium beginning July 1, 2025, as the maximum limit for 14 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, 15 but excluding lottery funds and federal funds, collected or received by the Occupational 16 Therapy Licensing Board.

17 "<u>SECTION 4.</u> Notwithstanding any other law limiting expenditures, the amount of \$1,828,620 is established for the biennium beginning July 1, 2025, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Board of Medical Imaging.

22 "<u>SECTION 5.</u> Notwithstanding any other law limiting expenditures, the amount of 23 \$1,332,798 is established for the biennium beginning July 1, 2025, as the maximum limit for 24 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, 25 but excluding lottery funds and federal funds, collected or received by the State Board of 26 Examiners for Speech-Language Pathology and Audiology.

27 "<u>SECTION 6.</u> Notwithstanding any other law limiting expenditures, the amount of 28 \$1,940,027 is established for the biennium beginning July 1, 2025, as the maximum limit for 29 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, 30 but excluding lottery funds and federal funds, collected or received by the Oregon State 31 Veterinary Medical Examining Board.

32 "<u>SECTION 7.</u> Notwithstanding any other law limiting expenditures, the limitation on 33 expenditures established by section 6, chapter 62, Oregon Laws 2023, for the biennium ending 34 June 30, 2025, as the maximum limit for payment of expenses from fees, moneys or other 35 revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, 1 collected or received by the Oregon State Veterinary Medical Examining Board, is increased

2 by \$31,500, for legal expenses.

3 "<u>SECTION 8.</u> This 2025 Act being necessary for the immediate preservation of the public

4 peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect
5 on its passage.".
