

A-Engrossed Senate Bill 5539

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act creates an agency budget. (Flesch Readability Score: 73.8).

[Appropriates moneys from the General Fund to the Department of State Lands for biennial expenses.]

Limits biennial expenditures from certain fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the *[department]* **Department of State Lands** for certain purposes.

Limits biennial expenditures by the department from specified continuously appropriated funds.

Limits certain biennial expenditures by the department from federal funds.

Authorizes specified nonlimited expenditures.

Declares an emergency, effective July 1, 2025.

A BILL FOR AN ACT

Relating to the financial administration of the Department of State Lands; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2025, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds, federal funds and funds described in sections 2 to 6 of this 2025 Act, collected or received by the Department of State Lands, for the following purposes:

(1) Common School Fund

programs..... \$ 59,265,951

(2) South Slough National

Estuarine Research

Reserve operations..... \$ 4,039,329

(3) Elliott State Research Forest... \$ 12,086,084

(4) Capital improvements \$ 596,145

SECTION 2. Notwithstanding any other law limiting expenditures, the amount of \$2,019,000 is established for the biennium beginning July 1, 2025, as the maximum limit for payment of expenses by the Department of State Lands from the Portland Harbor Cleanup Fund established by ORS 274.064.

SECTION 3. Notwithstanding any other law limiting expenditures, the amount of \$213,600 is established for the biennium beginning July 1, 2025, as the maximum limit for payment of

2 established by ORS 274.388.

3 **SECTION 4.** Notwithstanding any other law limiting expenditures, the amount of
4 \$2,282,425 is established for the biennium beginning July 1, 2025, as the maximum limit for
5 payment of expenses by the Department of State Lands from the Oregon Removal-Fill Miti-
6 gation Fund established by ORS 196.640.

7 **SECTION 5.** Notwithstanding any other law limiting expenditures, the amount of \$250,000
8 is established for the biennium beginning July 1, 2025, as the maximum limit for payment of
9 expenses by the Department of State Lands from the Oregon Ocean Science Fund established
10 by ORS 196.567.

11 **SECTION 6.** Notwithstanding any other law limiting expenditures, the amount of
12 \$11,151,895 is established for the biennium beginning July 1, 2025, as the maximum limit for
13 payment of expenses by the Department of State Lands from the Oregon Abandoned and
14 Derelict Vessel Fund established by ORS 274.371.

15 **SECTION 7.** Notwithstanding any other law limiting expenditures, the following amounts
16 are established for the biennium beginning July 1, 2025, as the maximum limits for payment
17 of expenses from federal funds collected or received by the Department of State Lands for
18 the following purposes:

- 19 (1) South Slough National
20 Estuarine Research
21 Reserve operations..... \$ 4,325,973
22 (2) Common School Fund
23 programs..... \$ 116,945

24 **SECTION 8.** For the biennium beginning July 1, 2025, expenditures by the Department
25 of State Lands for tenant-incurred utility charges and State Treasurer charges for
26 investment-related transactions are not limited.

27 **SECTION 9.** This 2025 Act being necessary for the immediate preservation of the public
28 peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect
29 July 1, 2025.
