# Senate Bill 643

Sponsored by Senator BONHAM (Presession filed.)

# SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: This Act allows landlords to end tenancies and raise rents without limit. (Flesch Readability Score: 67.7).

Allows landlords to terminate month-to-month residential tenancies without cause. Repeals limits on increases to rent.

5 **SECTION 1.** ORS 90.427 is amended to read:

6 90.427. (1) As used in this section[:],

7  $[(\alpha)]$  "first year of occupancy" includes all periods in which any of the tenants has resided in

8 the dwelling unit for one year or less.

9 [(b) "Immediate family" means:]

10 [(A) An adult person related by blood, adoption, marriage or domestic partnership, as defined in

11 ORS 106.310, or as defined or described in similar law in another jurisdiction;]

12 [(B) An unmarried parent of a joint child;]

13 [(C) A child, grandchild, foster child, ward or guardian; or]

14 [(D) A child, grandchild, foster child, ward or guardian of any person listed in subparagraph (A)

15 or (B) of this paragraph.]

(2) If a tenancy is a week-to-week tenancy, the landlord or the tenant may terminate the tenancy
by [a written notice given] giving a written termination notice to the other at least 10 days before

18 the termination date specified in the notice.

19 [(3) If a tenancy is a month-to-month tenancy:]

[(a) At any time during the tenancy, the tenant may terminate the tenancy by giving the landlord notice in writing not less than 30 days prior to the date designated in the notice for the termination of the tenancy.]

[(b) At any time during the first year of occupancy, the landlord may terminate the tenancy by giving the tenant notice in writing not less than 30 days prior to the date designated in the notice for the termination of the tenancy.]

[(A) For a tenant cause and with notice in writing as specified in ORS 86.782 (6)(c), 90.380 (5),

 than residential use within a reasonable time;]

27 [(A) The premises is unsafe or unfit for occupancy; or]

[(c) The landlord intends for the landlord or a member of the landlord's immediate family to occupy the dwelling unit as a primary residence and the landlord does not own a comparable unit in the same building that is available for occupancy at the same time that the tenant receives notice to terminate the tenancy; or]

[(A) Accepted an offer to purchase the dwelling unit separately from any other dwelling unit from
a person who intends in good faith to occupy the dwelling unit as the person's primary residence;

19 [(C) Is delivered to the tenant concurrent with or after the third or subsequent written warning 20 notice.]

[(8) If the tenancy is for occupancy in a dwelling unit that is located in the same building or on the same property as the landlord's primary residence, and the building or the property contains not more than two dwelling units, the landlord may terminate the tenancy at any time after the first year of occupancy:]

[(11)] (7) If the tenant remains in possession without the landlord's consent after expiration of the term of the rental agreement or its termination, the landlord may bring an action for possession. In addition, the landlord may recover from the tenant any actual damages resulting from the tenant holding over, including the value of any rent accruing from the expiration or termination of the rental agreement until the landlord knows or should know that the tenant has relinquished possession to the landlord. If the landlord consents to the tenant's continued occupancy, ORS 90.220 (7) applies.

(11) "Dealer" means any person in the business of selling, leasing or distributing new or used

7 (19) "Fixed term tenancy" means a tenancy that has a fixed term of existence, continuing to a 8 specific ending date and terminating on that date without requiring further notice to effect the ter-9 mination.

(20) "Floating home" has the meaning given that term in ORS 830.700. "Floating home" includes
 an accessory building or structure.

12 (21) "Good faith" means honesty in fact in the conduct of the transaction concerned.

(25) "Landlord" means the owner, lessor or sublessor of the dwelling unit or the building or
premises of which it is a part. "Landlord" includes a person who is authorized by the owner, lessor
or sublessor to manage the premises or to enter into a rental agreement.

(26) "Landlord's agent" means a person who has oral or written authority, either express or
 implied, to act for or on behalf of a landlord.

(27) "Last month's rent deposit" means a type of security deposit, however designated, the pri mary function of which is to secure the payment of rent for the last month of the tenancy.

(28) "Manufactured dwelling" means a residential trailer, a mobile home or a manufactured
 home as those terms are defined in ORS 446.003 or a prefabricated structure. "Manufactured
 dwelling" includes an accessory building or structure.

(29) "Manufactured dwelling park" means a place where four or more manufactured dwellings
are located, the primary purpose of which is to rent space or keep space for rent to any person for
a charge or fee.

(30) "Marina" means a moorage of contiguous dwelling units that may be legally transferred as
a single unit and are owned by one person where four or more floating homes are secured, the primary purpose of which is to rent space or keep space for rent to any person for a charge or fee.

(31) "Marina purchase association" means a group of three or more tenants who reside in a
 marina and have organized for the purpose of eventual purchase of the marina.

(32) "Month-to-month tenancy" means a tenancy that automatically renews and continues for
successive monthly periods on the same terms and conditions originally agreed to, or as revised by
the parties, until terminated by one or both of the parties.

44 (33) "Organization" includes a corporation, government, governmental subdivision or agency,
 45 business trust, estate, trust, partnership or association, two or more persons having a joint or com-

1 mon interest, and any other legal or commercial entity.

2 (34) "Owner" includes a mortgagee in possession and means one or more persons, jointly or se-3 verally, in whom is vested:

4 (a) All or part of the legal title to property; or

5 (b) All or part of the beneficial ownership and a right to present use and enjoyment of the 6 premises.

(35) "Person" includes an individual or organization.

8 (36) "Prefabricated structure" means a structure that is substantially constructed or assembled 9 using closed construction at an off-site location in compliance with the state building code and that 10 is sited and occupied by the owner in compliance with local codes.

(a) A dwelling unit and the structure of which it is a part and facilities and appurtenancestherein;

(b) Grounds, areas and facilities held out for the use of tenants generally or the use of whichis promised to the tenant; and

(38) "Prepaid rent" means any payment of money to the landlord for a rent obligation not yet
 due. In addition, "prepaid rent" means rent paid for a period extending beyond a termination date.

(39) "Recreational vehicle" has the meaning given that term in ORS 174.101.
