83rd OREGON LEGISLATIVE ASSEMBLY--2025 Regular Session

Senate Bill 646

Sponsored by Senator BONHAM (at the request of former Senator Dennis Linthicum) (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Allows resident students of this state to attend any public school of this state. (Flesch Readability Score: 65.7).

Allows a student who is a resident of this state to attend any public school of this state.

Requires a student to receive consent from a district school board to attend the schools of the school district if the student is a nonresident student. Requires the district school board to give consent, with limited exceptions.

Prohibits school districts from charging tuition or entering into contracts for admission of nonresident students.

Removes the cap on the percentage of students from school districts who may attend certain virtual public charter schools.

6	SECTION 1. (1) A resident of this state may enroll in any of the public schools of this
7	state as provided by this section.
8	(2) A student may enroll in a school of another school district by receiving consent under

11	(3) A student may enroll in any school of a school district without consideration of at-
12	tendance boundaries.

[(6) If a district school board decides to not give consent to a student, the board must provide a

(b) Notwithstanding paragraph (a)(A) of this subsection, if a school is located outside the

boundaries of the school district, the school district may advertise openings for nonresident students

provided pursuant to ORS 343.224 and 343.533;

1 (E) Students who require payment of room and board in lieu of transportation;

2 (F) A student transported from one school or facility to another school or facility when the 3 student attends both schools or facilities during the day or week; and

(5) "Net operating expenditures" means the sum of expenditures of a school district in kindergarten through grade 12 for administration, instruction, attendance and health services, operation of plant, maintenance of plant, fixed charges and tuition for resident students attending in another [*district*] **state**, as determined in accordance with the rules of the State Board of Education, but net operating expenditures does not include transportation, food service, student body activities, community services, capital outlay, debt service or expenses incurred for nonresident students.

6 (2) The board may furnish board and room for pupils in lieu of transportation when reasonable 7 board and room can be provided at equal or less expense than transportation. (1) Except as provided in ORS 339.141, authorizing tuition for courses not part of the 28regular school program, the district school board shall admit free of charge to the schools of the 2930 district all persons between the ages of 5 and 19 who reside within [the school district] this state. 31 A person whose 19th birthday occurs during the school year shall continue to be eligible for a free and appropriate public education for the remainder of the school year. A district school board shall 32admit nonresident persons as provided by ORS 339.127 and may admit [nonresident persons, de-33 34 termine who is not a resident of the district] persons who are not residents of this state and fix 35rates of tuition for [nonresidents] those persons.

36 (2)(a) A district must admit an otherwise eligible person who has not yet attained 21 years of
 37 age prior to the beginning of the current school year if the person is:

(A) Receiving special education and has not yet received a high school diploma as described in
 ORS 329.451; or

(3) The obligation to make a free appropriate public education available to individuals with 1 2 disabilities 18 through 21 years of age who are incarcerated in an adult correctional facility applies 3 only to those individuals who, in their last educational placement prior to their incarceration in the adult correctional facility: 4

- 5 (a) Were identified as being a child with a disability as defined in ORS 343.035; or
- (b) Had an individualized education program as described in ORS 343.151. 6

(c) A Department of Corrections institution as defined in ORS 421.005.

- (4) For purposes of subsection (3) of this section, "adult correctional facility" means: 7
- (a) A local correctional facility as defined in ORS 169.005; 8
- 9 (b) A regional correctional facility as defined in ORS 169.620; or

11 (5) An otherwise eligible person under subsection (2) of this section whose 21st birthday occurs 12 during the school year shall continue to be eligible for a free appropriate public education for the 13 remainder of the school year.

(6) The person may apply to the board of directors of the school district [of residence] for ad-14 15 mission after the 19th birthday as provided in subsection (1) of this section. A person aggrieved by 16 a decision of the local board may appeal to the State Board of Education. The decision of the state board is final and not subject to appeal. 17

339.133. (1) As used in this section: 35

(a)(A) "Foster care" means substitute care for children placed by the Department of Human 36 37 Services or a tribal child welfare agency away from their parents and for whom the department or 38 agency has placement and care responsibility, including placements in foster family homes, foster homes of relatives, group homes, emergency shelters, residential facilities, child care institutions and 39 preadoptive homes. 40

(B) "Foster care" does not mean care for children whose parent or guardian voluntarily placed 41 the child outside the child's home with a public or private agency and for whom the child's parent 42 or guardian retains legal guardianship. 43

(b)(A) "Person in parental relationship" means an adult who has physical custody of an indi-44 vidual or resides in the same household as the individual, interacts with the individual daily, pro-45

1 vides the individual with food, clothing, shelter and incidental necessaries and provides the 2 individual with necessary care, education and discipline.

3 (B) "Person in parental relationship" does not mean a person with a power of attorney or other 4 written delegation of parental responsibilities if the person does not have other evidence of a par-5 ental relationship.

6 (c) "School district of origin" means the school district where an individual was a resident be-7 fore:

8 (A) The individual was placed into foster care; or

9 (B) The foster care placement of the individual changed.

10 (d) "School of origin" means the school that an individual attended before:

11 (A) The individual was placed into foster care; or

12 (B) The foster care placement of the individual changed.

(2)(a) Except as provided in subsections (3) to (5) of this section, individuals between the ages
of 4 and 18 shall be considered resident for school purposes in the school district in which their
parents, their guardians or persons in parental relationship to them reside.

(b) Nonemancipated individuals between the ages of 4 and 18 living outside the geographic area of the school district for such reasons as attending college, military service, hospital confinement or employment away from home shall be considered resident in the district in which their parents, their guardians or persons in parental relationship to them reside.

(c) Individuals living temporarily in a school district for the primary purpose of attending a
district school may not be considered resident in the district in which they are living temporarily,
but shall be considered resident in the district in which they, their parents, their guardians or persons in parental relationship to them reside.

(b) If a juvenile court makes a determination that it is not in the best interest of the individual
to continue attending the school of origin, the individual shall be immediately enrolled in a new
school, even if the individual is unable to produce records normally required for enrollment.

(c) Individuals who are residents of their school district of origin pursuant to paragraph (a)(A)
 of this subsection shall:

(A) Remain in the individual's school district of origin and, if applicable, the individual's school
