

## SENATE AMENDMENTS TO SENATE BILL 844

1 On page 1 of the printed bill, line 4, after “438.990,” insert “475A.380, 475A.483,”.

2 On page 2, line 1, after the period insert “The report must include the most recently available  
3 relevant data.”.

4 In line 3, after “report” delete the rest of the line and insert “required under ORS 432.141 (3)  
5 in 2027.”.

6 In line 4, after “Notwithstanding” delete the rest of the line and delete line 5 and insert “ORS  
7 432.141 (3), the report required under ORS 432.141 (3) is not required to be submitted in 2026.”.

8 Delete lines 34 and 35 and insert:

9 “(3) If the authority issues a notice of intent to deny a license or permit, a notice of intent to  
10 impose a disciplinary sanction or a notice of intent to deny training program course approval, the  
11 authority:”.

12 In line 44, before “training” insert “provider of a”.

13 On page 3, delete lines 2 through 6 and insert:

14 “(4) If the authority issues a notice of intent to deny a license or permit, a notice of intent to  
15 impose a disciplinary sanction or a notice of intent to deny a training program course approval, the  
16 applicant, permittee, provider of a training program or licensee that is the subject of the notice may  
17 request, and the authority shall disclose to the applicant, permittee, provider of a training program  
18 or licensee all information obtained by the authority in the investigation of the allegations in the  
19 notice except:”.

20 Delete lines 15 through 18 and insert:

21 “(a) A notice of intent issued by the authority to deny a license or permit, to impose a disci-  
22 plinary sanction against an applicant, permittee, provider of a training program or licensee or to  
23 deny training program course approval;

24 “(b) A final order that results from a notice described in paragraph (a) of this subsection;”.

25 After line 38, insert:

26 “**SECTION 7.** ORS 475A.380 is amended to read:

27 “475A.380. Minimum standards of education and training for psilocybin service facilitators;  
28 rules.] (1) The Oregon Health Authority shall adopt by rule minimum standards of education and  
29 training requirements for psilocybin service facilitators.

30 “(2) The authority shall approve **training program** courses for psilocybin service facilitators.  
31 To obtain approval of a **training program** course, the provider of a **training program** course must  
32 submit an outline of instruction to the authority. The outline must include the approved **training**  
33 **program** courses, total hours of instruction, hours of lectures in theory and the hours of instruction  
34 in application of practical skills.

35 “**SECTION 8.** ORS 475A.483 is amended to read:

1       “475A.483. [*Issuing, renewing permits; fees; rules.*] (1) The Oregon Health Authority shall issue  
2 permits to qualified applicants to perform work described in ORS 475A.480. The authority shall  
3 adopt rules establishing:

4       “(a) The qualifications for performing work described in ORS 475A.480;

5       “(b) The term of a permit issued under this section;

6       “(c) Procedures for applying for and renewing a permit issued under this section; and

7       “(d) Reasonable application, issuance and renewal fees for a permit issued under this section.

8       “(2)(a) The authority may require an individual applying for a permit under this section to suc-  
9 cessfully complete a **training program** course, made available by or through the authority, through  
10 which the individual receives training on:

11       “(A) Checking identification;

12       “(B) Detecting intoxication;

13       “(C) Handling psilocybin products;

14       “(D) If applicable, the manufacturing of psilocybin products;

15       “(E) The content of ORS 475A.210 to 475A.722 and rules adopted under ORS 475A.210 to  
16 475A.722; or

17       “(F) Any matter deemed necessary by the authority to protect the public health and safety.

18       “(b) The authority or other provider of a **training program** course may charge a reasonable fee  
19 for the **training program** course.

20       “(c) The authority may not require an individual to successfully complete a **training program**  
21 course more than once, except that:

22       “(A) As part of a final order suspending a permit issued under this section, the authority may  
23 require a permit holder to successfully complete the **training program** course as a condition of  
24 lifting the suspension; and

25       “(B) As part of a final order revoking a permit issued under this section, the authority shall  
26 require an individual to successfully complete the **training program** course prior to applying for a  
27 new permit.

28       “(3) The authority shall conduct a criminal records check under ORS 181A.195 on an individual  
29 applying for a permit under this section.

30       “(4) Subject to the applicable provisions of ORS chapter 183, the authority may suspend, revoke  
31 or refuse to issue or renew a permit if the individual who is applying for or who holds the permit:

32       “(a) Is convicted of a felony or is convicted of an offense under ORS 475A.210 to 475A.722, ex-  
33 cept that the authority may not consider a conviction for an offense under ORS 475A.210 to  
34 475A.722 if the date of the conviction is two or more years before the date of the application or  
35 renewal;

36       “(b) Violates any provision of ORS 475A.210 to 475A.722 or any rule adopted under ORS  
37 475A.210 to 475A.722; or

38       “(c) Makes a false statement to the authority.

39       “(5) A permit issued under this section is a personal privilege and permits work described under  
40 ORS 475A.480 only for the individual who holds the permit.”.

41       In line 39, delete “7” and insert “9”.

42       On page 4, line 17, delete “8” and insert “10”.

43       On page 5, delete lines 10 through 13 and insert:

44       “**SECTION 11. Sections 5 and 6 of this 2025 Act and the amendments to ORS 475A.380,**  
45 **475A.483, 475A.586 and 676.177 by sections 7 to 10 of this 2025 Act apply to information ob-**

1 **tained by the Oregon Health Authority or health professional regulatory board on or after**  
2 **the effective date of this 2025 Act.”.**

3 In line 17, delete “10” and insert “12”.

4 On page 6, line 5, delete “11” and insert “13”.

5 In line 24, delete “12” and insert “14”.

6 On page 7, line 21, delete “13” and insert “15”.

7 On page 8, line 10, delete “14” and insert “16”.
