## Senate Bill 905

Sponsored by Senator TAYLOR (at the request of Portland Public Schools)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Removes the need for extra reports under a Healthy and Safe Schools Plan. (Flesch Readability Score: 76.5).

Eliminates reporting redundancies required under a Healthy and Safe Schools Plan.

A BILL FOR AN ACT

Relating to the accessibility of information under a Healthy and Safe Schools Plan; amending ORS
 332.334.

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 332.334 is amended to read:

6 332.334. (1)(a) A school district, education service district or public charter school shall make 7 the results of any testing conducted under a plan described in ORS 332.331 available to the public 8 no later than 10 business days after receiving the test results. As used in this paragraph, "business 9 day" means a day that is not a Saturday, a legal holiday under ORS 187.010 or 187.020 or a day on 10 which the administrative headquarters for the district or school is closed.

- 11 (b) The district or school shall make the test results available **to the public**:
- 12 (A) [*If the district or school maintains a public website*,] By posting the test results on the 13 website[;] **maintained by the district or school; and**
- (B) By sending electronic mail to staff, students and parents of minor students for whom the district or school has electronic mail addresses on file.[; and]
- 16 [(C) By making the test results available in printed form at the administrative headquarters for the 17 district or school.]
- (2) A school district, education service district or public charter school shall provide an annual
  statement regarding the plan developed and adopted by the district or school under ORS 332.331.
- 20 The district or school shall provide the statement to:
- 21 (a) The governing body for the district or school;
- 22 (b) The parents of minor students; and
- 23 (c) Any students 18 years of age or older.

(3) The annual statement under subsection (2) of this section must include[, but need not be
 *limited to*,] the following information:

- (a) Identification of, and contact information for, the position within the administration of the
  school district, education service district or public charter school having responsibility for main taining and overseeing performance of the plan;
- 29 (b) Information regarding where copies of the plan are available;
- 30 (c) A certification that the district or school is in compliance with any testing requirements

1 under the plan;

2 (d) Information about how to obtain the results of any testing conducted under the plan; and

3 (e) A summary of major exposure reduction activities conducted under the plan since the pre4 ceding annual statement.

5 (4) [If] A school district, education service district or public charter school [maintains a publicly 6 available website, the district or school] shall post the annual statement described in subsection (3) 7 of this section on the website **maintained by the district or school**. [The district or school shall 8 make the annual statement available in printed form at the administrative headquarters for the district 9 or school.] 10 (5) The Department of Education shall adopt, in consultation with the Oregon Health Authority,

11 representatives of school districts, education service districts and public charter schools and other 12 interested stakeholders, rules for carrying out this section.
