

## SENATE AMENDMENTS TO SENATE BILL 96

- 1 On page 1 of the printed bill, delete lines 5 through 29 and delete page 2 and insert:
- 2 **“SECTION 1.** ORS 292.406 is amended to read:
- 3 “292.406. (1)(a) The annual salary of the Chief Judge of the Court of Appeals shall be \$154,040
- 4 for the period beginning on January 1, 2019, and ending on June 30, 2020.
- 5 “(b) On July 1, 2020, the annual salary of the Chief Judge of the Court of Appeals, as adjusted
- 6 under ORS 292.428, shall be increased by \$5,000.
- 7 **“ (c) On July 1, 2025, the annual salary of the Chief Judge of the Court of Appeals shall**

- 9 “(2)(a) The annual salary of each other judge of the Court of Appeals shall be \$150,980 for the

- 11 “(b) On July 1, 2020, the annual salary of each other judge of the Court of Appeals, as adjusted
- 12 under ORS 292.428, shall be increased by \$5,000.
- 13 **“ (c) On July 1, 2025, the annual salary of each other judge of the Court of Appeals shall**
- 14 **be \$254,484.**
- 15 **“SECTION 2.** ORS 292.411 is amended to read:
- 16 “292.411. (1)(a) The annual salary of the Chief Justice of the Supreme Court shall be \$157,076
- 17 for the period beginning on January 1, 2019, and ending on June 30, 2020.
- 18 “(b) On July 1, 2020, the annual salary of the Chief Justice of the Supreme Court, as adjusted
- 19 under ORS 292.428, shall be increased by \$5,000.
- 20 **“ (c) On July 1, 2025, the annual salary of the Chief Justice of the Supreme Court shall**
- 21 **be \$264,432.**
- 22 “(2)(a) The annual salary of each other judge of the Supreme Court shall be \$154,040 for the
- 23 period beginning on January 1, 2019, and ending on June 30, 2020.
- 24 “(b) On July 1, 2020, the annual salary of each other judge of the Supreme Court, as adjusted
- 25 under ORS 292.428, shall be increased by \$5,000.
- 26 **“ (c) On July 1, 2025, the annual salary of each other judge of the Supreme Court shall**
- 27 **be \$259,500.**
- 28 **“SECTION 3.** ORS 292.416 is amended to read:
- 29 “292.416. (1) The annual salary of each judge of a circuit court shall be \$142,136 for the period
- 30 beginning on January 1, 2019, and ending on June 30, 2020.
- 31 “(2) On July 1, 2020, the annual salary of each judge of a circuit court, as adjusted under ORS
- 32 292.428, shall be increased by \$5,000.
- 33 **“ (3) On July 1, 2025, the annual salary of each judge of a circuit court shall be \$240,048.**
- 34 **“SECTION 4.** ORS 292.426 is amended to read:
- 35 “292.426. (1) The annual salary of the judge of the Oregon Tax Court shall be \$146,048 for the

1 period beginning on January 1, 2019, and ending on June 30, 2020.

2 “(2) On July 1, 2020, the annual salary of the judge of the Oregon Tax Court, as adjusted under  
3 ORS 292.428, shall be increased by \$5,000.

4 “(3) On July 1, 2025, the annual salary of the judge of the Oregon Tax Court shall be  
5 \$246,492.

6 “**SECTION 5.** This 2025 Act being necessary for the immediate preservation of the public  
7 peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect  
8 on its passage.”
