SUMMARY

Digest: Names a day in April 2025 Purple Up! Day for Month of the Military Child in Oregon. (Flesch Readability Score: 63.8).

Designates April 10, 2025, as Purple Up! Day for Month of the Military Child.

CONCURRENT RESOLUTION

2 Whereas Oregonians appreciate the sacrifices made by our servicemen and women who defend 3 our country against all enemies, foreign and domestic; and

Whereas the children of military families face unique challenges and we appreciate their strength and sacrifices as they support their enlisted family members, at times enduring long periods of separation; and

7 Whereas the children of military families are directly impacted by the deployment of one, and 8 sometimes both, parents on full-time duty status in military service, including members of the Na-9 tional Guard and Reserves on active duty orders; and

10 Whereas we acknowledge the role we play in supporting the children of military families to help 11 them be successful in life, in educational pursuits and in community involvement while their parents 12 are deployed; and

13 Whereas Month of the Military Child was established in 1986 to recognize military children for 14 their commitment, sacrifice, strength and unconditional support of our troops and to remind us of 15 the opportunity to provide support and encouragement; and

16 Whereas as part of Month of the Military Child, there has been a growing trend to establish a 17 day of recognition honoring the children of servicemen and women, and this day of recognition is 18 known as Purple Up! Day; and

19 Whereas thousands of brave Oregonians are demonstrating their courage and commitment to 20 freedom by serving in the Armed Forces of the United States of America here at home and abroad; 21 and

22 Whereas Oregon has more than 10,000 children with a parent or parents currently serving in 23 the military, and hundreds more children in Oregon are connected to the military through the ser-24 vice of siblings, aunts, uncles or grandparents; and

Whereas these children are a source of pride and honor for us all, and it is only fitting that we take time to recognize their contributions, celebrate their spirit and let our men and women in uniform know that while they are taking care of us, we are taking care of their children; now, therefore,

29 Be It Resolved by the Legislative Assembly of the State of Oregon:

SCR 30

1 That we, the members of the Eighty-third Legislative Assembly, designate April 10, 2025, as 2 Purple Up! Day for Month of the Military Child in Oregon; and be it further

Resolved, That we encourage all Oregonians to wear purple, the color symbolizing all branches of the military, as a visible show of support and appreciation for military children for their commitment, their sacrifice and their unconditional support of our service members, because when par-

6 ents serve in the military, their children serve too.
