7 **"SECTION 5a.** ORS 197A.100 is amended to read:

8 "197A.100. (1) A city with a population of 10,000 or greater shall develop
9 and adopt a housing production strategy under this section no later than the
10 latter of the date:

"(a) One year after the city's deadline for completing a housing capacity
determination under ORS 197A.270 (2), 197A.280 (2) or 197A.335 (1); or

"(b) If the city was referred to the housing acceleration program under
 ORS 197A.130, three years following the most recent adoption of a strategy.
 "(2) A housing production strategy must include a list of specific actions,

including the adoption of measures and policies, that the city shall undertake
 to promote:

18 "(a) The development of needed housing;

"(b) The development and maintenance of housing that is of diverse
housing types, high-quality, affordable and accessible;

21 "(c) Housing with access to economic opportunities, services and amen-

1 ities; and

2 "(d) Affirmatively furthering fair housing.

"(3) Actions that may be included in a housing production strategy include:

5 "(a) The reduction of financial and regulatory impediments to developing 6 needed housing, including removing or easing approval standards or proce-7 dures for needed housing at higher densities or that is affordable;

8 "(b) The creation of financial and regulatory incentives for development 9 of needed housing, including creating incentives for needed housing at higher 10 densities or that is affordable;

"(c) The development of a plan to access resources available at local, regional, state and national levels to increase the availability and affordability of needed housing;

14 "(d) Target development on identified development-ready lands;

16 "(f) Actions that:

"(A) Increase housing diversity, efficiency and affordability, including
 new construction and the preservation of naturally occurring affordable
 housing;

"(B) Allow greater housing choice for households and greater flexibility

"(C) Reduce cost or delay and increase procedural certainty for the pro duction of housing; or

"(i) Public facilities planning and other investment strategies that in crease the readiness of land for development for housing production;

1 lands for housing or a mix of housing and commercial uses; or

"(g) Any other actions identified by rule of the Land Conservation and
Development Commission intended to promote housing production,
affordability and choice.

"(4) Actions proposed in a city's housing production strategy shall include
clear deadlines by which the city expects to undertake the action.

"(5) In creating a housing production strategy, a city shall review and
consider:

9 "(a) Socioeconomic and demographic characteristics of households living
10 in existing needed housing;

11 "(b) Market conditions affecting the provision of needed housing;

"(c) Measures already adopted by the city to promote the development of
 needed housing;

"(d) Existing and expected barriers to the development of needed housing;and

"(e) For each action the city includes in its housing production strategy:
"(A) The schedule for its adoption;

18 "(B) The schedule for its implementation;

"(C) Its expected magnitude of impact on the development of neededhousing; and

"(D) The time frame over which it is expected to impact needed housing.
"(6) The housing production strategy must include within its index a copy
of the city's most recently completed [*survey under ORS 197A.110*] housing
production strategy implementation report under ORS 197A.115.

 "(7) The adoption of a housing production strategy is not a land use de-

26 cision and is not subject to appeal or review except as provided in ORS
27 197A.103.

"(8) A city with a population of less than 10,000 may develop a housing
 production strategy as provided in this section.

30 "(9) As used in this section, 'affirmatively furthering fair housing' means

1 meaningful actions that, when taken together, address significant disparities 2 in housing needs and access to opportunity and replace segregated living 3 patterns with truly integrated and balanced living patterns to transform ra-4 cially and ethnically concentrated areas of poverty into areas of opportunity 5 and foster and maintain compliance with civil rights and fair housing 6 laws.".

7 On page 8, after line 18 insert:

8 "SECTION 8a. Section 8b of this 2025 Act is added to and made a
9 part of ORS chapter 197.

10 "<u>SECTION 8b.</u> (1) For the purpose of harmonizing and clarifying 11 land use law, a state agency or local government may, wherever the 12 terms appear within land use regulations, zoning maps, comprehensive 13 plans, regional framework plans or administrative rules, substitute the 14 terms:

"(a) 'Single-unit housing' for 'single-family housing' or similar
 terms; and

17 "(b) 'Multiunit housing' for 'multifamily housing' or similar terms.

18 **"(2) A substitution of terms under this section:**

"(b) May be done by ordinance or resolution of a local government
without requiring any notice or hearing, notwithstanding any provision of ORS chapter 215 or 227.".
