**PROPOSED AMENDMENTS TO  
HOUSE BILL 2802**

1 In line 2 of the printed bill, after the semicolon insert “creating new  
2 provisions; and”.

3 Delete lines 4 through 23 and insert:

4 **“SECTION 1.** ORS 656.230 is amended to read:

5 “656.230. (1) When a worker has been awarded compensation for perma-  
6 nent partial disability, **and the total amount of the award does not ex-**  
7 **ceed \$9,000, the insurer or the self-insured employer shall pay the total**  
8 **amount of the award to the worker in a lump sum payment.**

9 **“(2)(a) Subject to paragraph (b) of this subsection, when a worker**  
10 **has been awarded compensation for permanent partial disability, the**  
11 **total amount of the award exceeds \$9,000 and the worker requests pay-**  
12 **ment of all or part of the award in a lump sum payment, the insurer or**  
13 **self-insured employer shall make the payment requested [unless the] if:**

14 “[*a*] **(A) The worker has [not] waived the right to [appeal the adequacy**  
15 **of the award;] request reconsideration of the notice of closure; or**

16 “[*b*] **(B) The award has [not] become final by operation of law[;].**

17 **“(b) The insurer or self-insured employer is not required to make**  
18 **the payment requested if:**

19 **“(A) The insurer or self-insured employer timely requests recon-**  
20 **sideration of the notice of closure under ORS 656.268 (5)(e) and the**  
21 **reconsideration proceeding has not yet been completed;**

1       “[(c)] (B) Payment of compensation has been stayed pending a request for  
2 hearing or review under ORS 656.313; or

3       “[(d)] (C) **The** worker is enrolled and actively engaged in training ac-  
4 cording to rules adopted pursuant to ORS 656.340 and 656.726.

5       “[(2)] (3) Any unpaid balance of the award **that is** not paid in a lump sum  
6 payment shall be paid pursuant to ORS 656.216.

7       “[(3) *In all cases where the award for permanent partial disability does not*  
8 *exceed \$6,000, the insurer or the self-insured employer shall pay all of the*  
9 *award to the worker in a lump sum.*]

10       “**SECTION 2. The amendments to ORS 656.230 by section 1 of this**  
11 **2025 Act apply to claims in which a notice of closure is issued on or**  
12 **after January 1, 2026.”.**
