**PROPOSED AMENDMENTS TO  
SENATE BILL 795**

1 On page 1 of the printed bill, delete lines 6 through 25.

2 On page 2, delete lines 1 through 12 and insert:

3 **“SECTION 1. ORS 830.908 is amended to read:**

4 **“830.908. As used in ORS 830.908 to 830.948:**

5 **“(1) ‘Abandoned vessel’ means a vessel that [*has been left without au-***  
6 ***thorization on public or private land, the waters of this state, or any other***  
7 ***water*] **is on public or private land, the waters of this state or any other****  
8 ****water without authorization.****

9 **“(2) ‘Authorized agency’ means a law enforcement agency, a federal**  
10 **agency, the State Marine Board or any other public body, as defined**  
11 **in ORS 174.109.**

12 **“[(2)] (3) ‘Business day’ means any day other than a Saturday, a Sunday**  
13 **or a legal holiday as described in ORS 187.010.**

14 **“[(3)] (4) ‘Derelict vessel’ means a vessel that is on the waters of this**  
15 **state **or is in such close proximity to the waters of this state that the****  
16 ****vessel is likely to enter the water** and that is:**

17 **“(a) Sunk or in imminent danger of sinking;**

18 **“(b) Obstructing a waterway;**

19 **“(c) Endangering life or property; [*or*]**

20 **“(d) In such dilapidated condition that it is in danger of becoming [*a***  
21 ***significant*] **an environmental hazard, which may be evidenced by in-****

1 **stances of leaking fuel, sewage or other pollutants** [*as evidenced by re-*  
2 *peated and documented instances of leaking fuel, sewage or other*  
3 *pollutants.*]; **or**

4 **“(e) Likely to meet one of the conditions listed in this subsection**  
5 **if the vessel enters the water.**

6 “[~~(4)~~ *‘Enforcement agency’ means a law enforcement agency, a federal*  
7 *agency, the State Marine Board or any other public body, as defined in ORS*  
8 *174.109, that has responsibility for land or water on which an abandoned ves-*  
9 *sel or a derelict vessel is located.*]

10 **“(5) ‘Marine debris’ has the meaning given that term in ORS 274.376.**

11 “[~~(5)~~ **(6) ‘Owner’ means a person who** [*has a property interest in a*  
12 *vessel*] **is listed as the owner of a vessel in the records of the State**  
13 **Marine Board or another state agency.**

14 “[~~(6)(a)~~ **(7)(a) ‘Vessel’ means a boat, a boathouse as defined in ORS**  
15 **830.700, a floating home as defined in ORS 830.700, or any other floating**  
16 **structure that is normally secured to a pier or pilings.**

17 **“(b) ‘Vessel’ does not include:**

18 **“(A) A dock as defined in ORS 307.120;**

19 **“(B) A boat that is no longer capable of being used as a means of**  
20 **transportation on the water due its dilapidated condition; or**

21 **“(C) Any structure or component of a structure that, in its current**  
22 **state, does not meet the definition of boathouse or floating home in**  
23 **ORS 830.700.”.**
