**PROPOSED AMENDMENTS TO  
HOUSE BILL 2676**

1 On page 13 of the printed bill, line 33, delete “B.1.” and insert “B.”.

2 Delete lines 38 through 41.

3 On page 18, after line 34, insert:

4 **“SECTION 3. (1) When the Dentist and Dental Hygienist Compact**  
5 **Commission described in section 1 of this 2025 Act adopts a rule pur-**  
6 **suant to the Dentist and Dental Hygienist Compact described in sec-**  
7 **tion 1 of this 2025 Act, the Oregon Board of Dentistry shall, within 90**  
8 **days after the date on which the rule is adopted by the commission,**  
9 **adopt the rule of the commission as a rule of the board.**

10 **“(2) Failure of the board to adopt the rule of the commission as a**  
11 **rule of the board within the time described in this section shall con-**  
12 **stitute default under the Dentist and Dental Hygienist Compact de-**  
13 **scribed in section 1 of this 2025 Act.”.**

14 In line 35, delete “3” and insert “4”.

15 On page 19, line 17, delete “4” and insert “5”.

16 On page 20, line 21, delete “5” and insert “6”.

17 In line 36, delete “6” and insert “7”.

18 On page 21, delete lines 39 through 45 and delete page 22 and insert:

19 **“SECTION 8. (1) The amendments to ORS 676.177 by section 4 of this**  
20 **2025 Act apply to information disclosed on or after the operative date**  
21 **specified in section 9 of this 2025 Act.**

1       **“(2) The amendments to ORS 679.025 by section 5 of this 2025 Act**  
2 **apply to persons authorized to practice by compact privilege on or af-**  
3 **ter the operative date specified in section 9 of this 2025 Act.**

4       **“(3) The amendments to ORS 679.260 by section 6 of this 2025 Act**  
5 **apply to moneys received by the Oregon Board of Dentistry on or after**  
6 **the operative date specified in section 9 of this 2025 Act.**

7       **“(4) The amendments to ORS 680.020 by section 7 of this 2025 Act**  
8 **apply to persons authorized to practice by compact privilege on or af-**  
9 **ter the operative date specified in section 9 of this 2025 Act.**

10       **“SECTION 9. (1) Sections 1 to 3 of this 2025 Act and the amend-**  
11 **ments to ORS 676.177, 679.025, 679.260 and 680.020 by sections 4 to 7 of**  
12 **this 2025 Act become operative on January 1, 2026.**

13       **“(2) The Oregon Board of Dentistry may take any action before the**  
14 **operative date specified in subsection (1) of this section that is neces-**  
15 **sary to enable the board to exercise, on and after the operative date**  
16 **specified in subsection (1) of this section, all of the duties, functions**  
17 **and powers conferred on the board by sections 1 to 3 of this 2025 Act**  
18 **and the amendments to ORS 676.177, 679.025, 679.260 and 680.020 by**  
19 **sections 4 to 7 of this 2025 Act.**

20       **“SECTION 10. This 2025 Act takes effect on the 91st day after the**  
21 **date on which the 2025 regular session of the Eighty-third Legislative**  
22 **Assembly adjourns sine die.”.**
