**PROPOSED AMENDMENTS TO  
SENATE BILL 96**

1 On page 1 of the printed bill, delete lines 5 through 29 and delete page  
2 2 and insert:

3 **“SECTION 1.** ORS 292.406 is amended to read:

4 “292.406. (1)(a) The annual salary of the Chief Judge of the Court of Ap-  
5 peals shall be \$154,040 for the period beginning on January 1, 2019, and  
6 ending on June 30, 2020.

7 “(b) On July 1, 2020, the annual salary of the Chief Judge of the Court  
8 of Appeals, as adjusted under ORS 292.428, shall be increased by \$5,000.

9 **“(c) On July 1, 2025, the annual salary of the Chief Judge of the**  
10 **Court of Appeals shall be \$259,500.**

11 “(2)(a) The annual salary of each other judge of the Court of Appeals  
12 shall be \$150,980 for the period beginning on January 1, 2019, and ending on  
13 June 30, 2020.

14 “(b) On July 1, 2020, the annual salary of each other judge of the Court  
15 of Appeals, as adjusted under ORS 292.428, shall be increased by \$5,000.

16 **“(c) On July 1, 2025, the annual salary of each other judge of the**  
17 **Court of Appeals shall be \$254,484.**

18 **“SECTION 2.** ORS 292.411 is amended to read:

19 “292.411. (1)(a) The annual salary of the Chief Justice of the Supreme  
20 Court shall be \$157,076 for the period beginning on January 1, 2019, and  
21 ending on June 30, 2020.

1 “(b) On July 1, 2020, the annual salary of the Chief Justice of the Supreme  
2 Court, as adjusted under ORS 292.428, shall be increased by \$5,000.

3 **“(c) On July 1, 2025, the annual salary of the Chief Justice of the  
4 Supreme Court shall be \$264,432.**

5 “(2)(a) The annual salary of each other judge of the Supreme Court shall  
6 be \$154,040 for the period beginning on January 1, 2019, and ending on June  
7 30, 2020.

8 “(b) On July 1, 2020, the annual salary of each other judge of the Supreme  
9 Court, as adjusted under ORS 292.428, shall be increased by \$5,000.

10 **“(c) On July 1, 2025, the annual salary of each other judge of the  
11 Supreme Court shall be \$259,500.**

12 **“SECTION 3.** ORS 292.416 is amended to read:

13 “292.416. (1) The annual salary of each judge of a circuit court shall be  
14 \$142,136 for the period beginning on January 1, 2019, and ending on June 30,  
15 2020.

16 “(2) On July 1, 2020, the annual salary of each judge of a circuit court,  
17 as adjusted under ORS 292.428, shall be increased by \$5,000.

18 **“(3) On July 1, 2025, the annual salary of each judge of a circuit  
19 court shall be \$240,048.**

20 **“SECTION 4.** ORS 292.426 is amended to read:

21 “292.426. (1) The annual salary of the judge of the Oregon Tax Court shall  
22 be \$146,048 for the period beginning on January 1, 2019, and ending on June  
23 30, 2020.

24 “(2) On July 1, 2020, the annual salary of the judge of the Oregon Tax  
25 Court, as adjusted under ORS 292.428, shall be increased by \$5,000.

26 **“(3) On July 1, 2025, the annual salary of the judge of the Oregon  
27 Tax Court shall be \$246,492.**

28 **“SECTION 5. This 2025 Act being necessary for the immediate  
29 preservation of the public peace, health and safety, an emergency is  
30 declared to exist, and this 2025 Act takes effect on its passage.”.**
