**PROPOSED AMENDMENTS TO  
HOUSE BILL 2208**

1 On page 1 of the printed bill, delete lines 5 through 29 and delete page  
2 2 and insert:

3 **“SECTION 1. ORS 414.577 is added to and made a part of ORS**  
4 **chapter 414.**

5 **“SECTION 2. ORS 414.577 is amended to read:**

6 **“414.577. (1) As used in this section:**

7 **“(a) ‘Health-related services’ means non-covered services under the**  
8 **state plan for medical assistance to improve care delivery and overall**  
9 **member and community health and well-being.**

10 **“(b) ‘Local mental health authority’ has the meaning given that**  
11 **term in ORS 430.630.**

12 **“(c) ‘Local planning committee’ has the meaning given that term**  
13 **in ORS 430.306.**

14 **“[(1)] (2) A coordinated care organization shall collaborate with local**  
15 **public health authorities, community mental health programs, local**  
16 **planning committees** and hospitals located in areas served by the coordi-  
17 nated care organization to conduct a community health assessment and adopt  
18 a community health improvement plan, shared with and endorsed by the co-  
19 ordinated care organization, local public health authorities, **community**  
20 **mental health programs, local planning committees** and hospitals, to  
21 serve as a strategic population health and health care services plan for the

1 residents of the areas served by the coordinated care organization, local  
2 public health authorities, **community mental health programs, local**  
3 **planning committees** and hospitals. The **community** health improvement  
4 plan must include strategies for achieving shared priorities.

5 “(3)(a) **Local public health authorities, community mental health**  
6 **programs and coordinated care organizations shall include in the**  
7 **community health improvement plan any behavioral health plans re-**  
8 **quired by law or by the Oregon Health Authority, including:**

9 “(A) **Comprehensive local plans adopted by local mental health au-**  
10 **thorities under ORS 430.630 (9); and**

11 “(B) **Comprehensive behavioral health plans developed by coordi-**  
12 **nated care organizations.**

13 “(b) **The inclusion in the community health improvement plan of**  
14 **the behavioral health plans described in paragraph (a) of this sub-**  
15 **section does not change the party that is responsible for developing**  
16 **or implementing a behavioral health plan described in paragraph (a)**  
17 **of this subsection.**

18 “[2)] (4) The coordinated care organization shall post the **community**  
19 health improvement plan to the coordinated care organization’s website.

20 “(5) **A coordinated care organization or hospital may designate the**  
21 **coordinated care organization’s or hospital’s expenses in developing**  
22 **the community health improvement plan as spending on health-related**  
23 **services.**

24 “[3)] (6) The [*Oregon Health*] authority [*may*] **shall** prescribe by rule re-  
25 quirements for **community** health improvement plans and provide guidance  
26 for aligning:

27 “(a) **The timelines for the development of the community health assess-**  
28 **ments and community health improvement plans by coordinated care or-**  
29 **ganizations, local public health authorities, community mental health**  
30 **programs, local planning committees and hospitals; and**

1       **“(b) The requirements of this section with other planning or re-**  
2 **porting requirements that coordinated care organizations are subject**  
3 **to, including planning or reporting requirements regarding:**

4       **“(A) Health inequities;**

5       **“(B) Social determinants of health;**

6       **“(C) Health technology;**

7       **“(D) Payment models;**

8       **“(E) Oral health integration;**

9       **“(F) Language access; and**

10       **“(G) Traditional health worker integration and utilization.**

11       **“SECTION 3. The amendments to ORS 414.577 by section 2 of this**  
12 **2025 Act apply to community health improvement plans adopted on or**  
13 **after the effective date of this 2025 Act.”.**
