PROPOSED AMENDMENTS TO SENATE BILL 296

1 On page 2 of the printed bill, delete lines 25 through 45.

2 On page 3, delete lines 1 through 23 and insert:

3 **"SECTION 4. (1) As used in this section:**

4 "(a) 'Adult foster home' has the meaning given that term in ORS
5 443.705.

6 "(b) 'Enhanced care services' means intensive behavioral and 7 rehabilitative mental health services provided to eligible seniors or 8 persons with physical disabilities who reside in adult foster homes or 9 residential care facilities licensed by the Department of Human Ser-10 vices.

"(c) 'Residential care facility' has the meaning given that term in
ORS 443.400.

"(d) 'Specific needs contract' means a contract between the Department of Human Services and an adult foster home or residential care facility to reimburse the adult foster home or residential care facility at a higher rate for a resident whose care needs exceed the level of services that the adult foster home or residential care facility would typically provide.

"(2) The Department of Human Services and the Oregon Health
 Authority shall study the regulatory framework for adult foster homes
 and residential care facilities that serve eligible seniors or persons

with physical disabilities who have complex medical or behavioral
health conditions. In conducting the study, the department and the
authority shall:

4 "(a) Assess the resources needed to expand existing enhanced care
5 services and specific needs contracts statewide, including the public
6 and private sector workforce needed to implement:

7 "(A) Any proposed expansion of enhanced care services or specific
8 needs contracts; or

9 "(B) Other models for supporting adult foster homes and residential
10 care facilities that serve eligible seniors or persons with physical dis11 abilities who have complex medical or behavioral health conditions;

12 "(b) Evaluate the impact on eligible seniors and persons with 13 physical disabilities who have complex medical or behavioral health 14 conditions of having separate licensing requirements for adult foster 15 homes and residential care facilities licensed by:

"(A) The division of the department that provides services for sen iors and persons with physical disabilities; and

18 **"(B) The authority; and**

"(c) Review the use and impact of civil penalties assessed against
 residential care facilities and adult foster homes.

"(3) The department and the authority shall submit a report in the manner provided by ORS 192.245, and may include recommendations for legislation, to the interim committees of the Legislative Assembly related to health and human services no later than August 15, 2026.

"(4)(a) The department and the Housing and Community Services
 Department shall study:

"(A) Opportunities to offset the cost of creating new adult foster
 homes and other community-based care settings; and

"(B) The impact on adult foster homes and other community-based
 care settings of new building code requirements, including the instal-

1 lation of automatic sprinkler systems.

"(b) The Department of Human Services and the Housing and
Community Services Department shall submit a report in the manner
provided by ORS 192.245, and may include recommendations for legislation, to the interim committees of the Legislative Assembly related
to health and human services no later than August 15, 2026.".
