**PROPOSED AMENDMENTS TO  
SENATE BILL 716**

1 On page 1 of the printed bill, delete lines 5 through 26 and delete pages  
2 2 through 7 and insert:

3 **“SECTION 1. Section 2 of this 2025 Act is added to and made a part  
4 of the Insurance Code.**

5 **“SECTION 2. (1) As used in this section, ‘urgent care center’ means  
6 a facility or portion of a facility that is open to the public and provides  
7 medical care to individuals on a walk-in and episodic basis for illnesses  
8 or injuries that are acute but not life-threatening or do not require  
9 emergency medical services.**

10 **“(2) A policy or certificate of health insurance issued in this state  
11 that reimburses the cost of medical care provided by urgent care cen-  
12 ters must reimburse the cost of medical services provided by an urgent  
13 care center that has onsite radiology and laboratory services in an  
14 amount that is 20 percent higher than the reimbursement paid for the  
15 same services when provided by an urgent care center that does not  
16 have onsite radiology and laboratory services.**

17 **“(3) This section is exempt from ORS 743A.001.**

18 **“(4) The Department of Business and Consumer Services shall adopt  
19 rules establishing the requirements for qualification as an urgent care  
20 center with onsite radiology and laboratory services.**
