## PROPOSED AMENDMENTS TO SENATE BILL 716

On page 1 of the printed bill, delete lines 5 through 26 and delete pages 2 through 7 and insert:

"SECTION 1. Section 2 of this 2025 Act is added to and made a part of the Insurance Code.

"SECTION 2. (1) As used in this section, 'urgent care center' means a facility or portion of a facility that is open to the public and provides medical care to individuals on a walk-in and episodic basis for illnesses or injuries that are acute but not life-threatening or do not require emergency medical services.

- "(2) A policy or certificate of health insurance issued in this state that reimburses the cost of medical care provided by urgent care centers must reimburse the cost of medical services provided by an urgent care center that has onsite radiology and laboratory services in an amount that is 20 percent higher than the reimbursement paid for the same services when provided by an urgent care center that does not have onsite radiology and laboratory services.
  - "(3) This section is exempt from ORS 743A.001.
- "(4) The Department of Business and Consumer Services shall adopt rules establishing the requirements for qualification as an urgent care center with onsite radiology and laboratory services.
