PROPOSED AMENDMENTS TO SENATE BILL 906

- On page 1 of the printed bill, line 2, after "652.610" insert "and 652.900".
- Delete lines 4 through 30 and delete pages 2 and 3 and insert:
- "SECTION 1. ORS 652.610 is amended to read:
- 4 "652.610. (1)(a) All persons, firms, partnerships, associations, cooperative
- 5 associations, corporations, municipal corporations, the state and its political
- 6 subdivisions, except the federal government and its agencies, employing, in
- 7 this state, during any calendar month one or more persons, shall provide the
- 8 employee on regular paydays and at other times payment of wages, salary
- 9 or commission is made, with an itemized statement as described in paragraph
- 10 (b) of this subsection.
- 11 "(b) The statement required under this subsection must be a written
- 12 statement, sufficiently itemized to show:
- "(A) The date of the payment;
- "(B) The dates of work covered by the payment;
- "(C) The name of the employee;
- 16 "(D) The name and business registry number or business identification
- 17 number;
- 18 "(E) The address and telephone number of the employer;
- "(F) The rate or rates of pay;
- 20 "(G) Whether the employee is paid by the hour, shift, day or week or on
- 21 a salary, piece or commission basis;

- 1 "(H) Gross wages;
- 2 "(I) Net wages;
- 3 "(J) The amount and purpose of each deduction made during the respec-
- 4 tive period of service that the payment covers;
- 5 "(K) Allowances, if any, claimed as part of minimum wage;
- 6 "(L) Unless the employee is paid on a salary basis and is exempt from
- 7 overtime compensation as established by local, state or federal law, the reg-
- 8 ular hourly rate or rates of pay, the overtime rate or rates of pay, the num-
- 9 ber of regular hours worked and pay for those hours, and the number of
- 10 overtime hours worked and pay for those hours; and
- "(M) If the employee is paid a piece rate, the applicable piece rate or
- 12 rates of pay, the number of pieces completed at each piece rate and the total
- 13 pay for each rate.
- "(c) Notwithstanding paragraph (b) of this subsection, the employer may
- provide the statement required under this subsection to the employee in
- electronic form pursuant to ORS 84.001 to 84.061 if:
- "(A) The statement contains the information described in paragraph (b)
- of this [section] **subsection**;
- "(B) The employee expressly agrees to receive the statement in electronic
- 20 form; and
- 21 "(C) The employee has the ability to print or store the statement at the
- 22 time of receipt.
- 23 "(2)(a) The statement may be attached to or be a part of the check, draft,
- voucher or other instrument by which payment is made, or may be delivered
- 25 separately from the instrument.
- 26 "(b) The statement shall be provided electronically at the time payment
- 27 is made to all state officers and employees paid electronically under the state
- payroll system as provided by ORS 292.026.
- 29 "(c) State agencies shall provide access to electronic statements to em-
- 30 ployees who do not have regular access to computers in their workplace.

- "(d) Notwithstanding paragraph (b) of this subsection, if an officer or employee paid under the state payroll system as provided by ORS 292.026 wants to receive payment of net salary and wages by check or to receive a paper statement of itemized payroll deductions, the officer or employee shall request paper statements or payment by check in accordance with the procedures adopted by rule by the Oregon Department of Administrative Services.
- 8 "(3) An employer may not withhold, deduct or divert any portion of an 9 employee's wages unless:
 - "(a) The employer is required to do so by law;

- "(b) The deductions are voluntarily authorized in writing by the employee, are for the employee's benefit and are recorded in the employer's books;
- "(c) The employee has voluntarily signed an authorization for a deduction for any other item, provided that the ultimate recipient of the money withheld is not the employer and that the deduction is recorded in the employer's books;
- "(d) The deduction is authorized by a collective bargaining agreement to which the employer is a party;
 - "(e) The deduction is authorized under ORS 18.736; or
- "(f) The deduction is made from the payment of wages upon termination of employment and is authorized pursuant to a written agreement between the employee and employer for the repayment of a loan made to the employee by the employer, if all of the following conditions are met:
 - "(A) The employee has voluntarily signed the agreement;
- 25 "(B) The loan was paid to the employee in cash or other medium permit-26 ted by ORS 652.110;
- "(C) The loan was made solely for the employee's benefit and was not used, either directly or indirectly, for any purpose required by the employer or connected with the employee's employment with the employer;
 - "(D) The amount of the deduction at termination of employment does not

- exceed the amount permitted to be garnished under ORS 18.385; and 1
- "(E) The deduction is recorded in the employer's books. 2
- "(4) When an employer deducts an amount from an employee's wages as 3 required or authorized by law or agreement, the employer shall pay the 4
- amount deducted to the appropriate recipient as required by the law or 5
- agreement. The employer shall pay the amount deducted within the time re-6
- quired by the law or the agreement or, if the time for payment is not speci-7
- fied by the law or agreement, within seven days after the date the wages 8
- from which the deductions are made are due. Failure to pay the amount as 9
- required constitutes an unlawful deduction. 10

- "(5)(a) An employer shall provide to an employee, at the time of hire and at the request of the employee, within 14 calendar days after 12 the date of the request, a written explanation of earnings and de-13 ductions shown on the itemized statements required under subsection
- 14 (1) of this section. The explanation must be written in plain language 15
- and include general information on: 16
- "(A) The employer's established regular pay period. 17
- "(B) Differences in rates of pay based on factors including hourly 18 pay, salary pay, shift differentials, piece-rate pay and commission-19 based pay. 20
 - "(C) The amount and purpose of deductions that may be made during a regular pay period.
 - "(D) Allowances, if any, claimed as part of minimum wage.
- "(b) An employer shall provide to an employee, within 14 calendar 24 days after receiving an employee's request, or as soon as reasonably 25practicable, but not later than 30 calendar days, a written explanation 26 that is in plain language and that provides a detailed description of the 27 information provided in paragraph (a) of this subsection in relation to 28 a specific itemized statement of the employee. 29
 - "(c) An employer may include additional information in the written

- explanation required under paragraph (a) of this subsection including,
- 2 but not limited to, a supplemental sample tool that demonstrates how
- 3 calculations of earnings and deductions are shown on an itemized
- 4 statement.

- 5 "(d) An employer may satisfy the requirements of this subsection
- 6 by providing to employees, within the time periods specified under this
- 7 subsection, an electronic copy of a written explanation that is made
- 8 accessible to employees through a secure link posted on the intranet
- 9 or on an outward-facing website with a secure login.
- "(e) For purposes of this subsection, a written explanation complies
- with plain language standards if the explanation uses language that
- is easy to understand and, to the extent practicable:
 - "(A) Uses simple words that convey meanings clearly and directly;
- 14 "(B) Uses the present tense and active voice;
 - "(C) Uses short, simple sentences; and
- 16 "(D) Defines only those words that cannot be properly explained or
- 17 qualified in the text, including acronyms and codes that are used to
- 18 represent specific types of deductions or benefits.
- "[(5)] (6) This section does not:
- 20 "(a) Prohibit the withholding of amounts authorized in writing by the
- employee to be contributed by the employee to charitable organizations, in-
- 22 cluding contributions made pursuant to ORS 663.110;
- 23 "(b) Prohibit deductions by checkoff dues to labor organizations or service
- 24 fees when the deductions are not otherwise prohibited by law; or
- 25 "(c) Diminish or enlarge the right of any person to assert and enforce a
- lawful setoff or counterclaim or to attach, take, reach or apply an employee's
- 27 compensation on due legal process.
- "SECTION 2. ORS 652.900 is amended to read:
- 29 "652.900. (1) In addition to any other penalty provided by law, the Com-
- 30 missioner of the Bureau of Labor and Industries may assess a civil penalty

- not to exceed \$1,000 against any person who violates ORS 652.020, 652.110,
- 2 652.140, 652.145, 652.260, 652.610 (4) **or** (5) or 652.750 or any rule adopted
- 3 under those statutes.
- 4 "(2) Civil penalties under this section shall be imposed as provided in 5 ORS 183.745.
- 6 "(3) All sums collected as penalties under this section shall be first applied toward reimbursement of costs incurred in determining the violations,
- 8 conducting hearings under this section and addressing and collecting the
- 9 penalties. The remainder, if any, of the sums collected as penalties under this
- section shall be paid into the State Treasury and credited to the General

11 Fund and is available for general governmental expenses.".
