**PROPOSED AMENDMENTS TO
SENATE BILL 27**

1 In line 2 of the printed bill, after “workforce” insert “; and declaring an
2 emergency”.

3 Delete lines 4 through 8 and insert:

4 **“SECTION 1. In addition to and not in lieu of any other appropri-
5 ation, there is appropriated to the Oregon Health Authority, for the
6 biennium beginning July 1, 2025, out of the General Fund, the amount
7 of \$20,000,000, for the purpose of paying the nonfederal share of ex-
8 penses for the Oregon Essential Workforce Health Care Program es-
9 tablished under ORS 735.520.**

10 **“SECTION 2. In addition to and not in lieu of any other appropri-
11 ation, there is appropriated to the Oregon Health Authority, for the
12 biennium beginning July 1, 2025, out of the General Fund, the amount
13 of \$2,500,000, for the purpose of paying the nonfederal share of ex-
14 penses for the Oregon CareWorks Supplemental Payment Program.**

15 **“SECTION 3. In addition to and not in lieu of any other appropri-
16 ation, there is appropriated to the Oregon Health Authority, for the
17 biennium beginning July 1, 2025, out of the General Fund, the amount
18 of \$2,500,000, for the purpose of carrying out the provisions of ORS
19 676.479.**

20 **“SECTION 4. In addition to and not in lieu of any other appropri-
21 ation, there is appropriated to the Oregon Health Authority, for the**

1 biennium beginning July 1, 2025, out of the General Fund, the amount
2 of \$9,500,000, for the purpose of carrying out the amendments to ORS
3 676.479 by section 2, chapter ____, Oregon Laws 2025 (Senate Bill 283).

4 **“SECTION 5.** In addition to and not in lieu of any other appropri-
5 ation, there is appropriated to the Oregon Health Authority, for the
6 biennium beginning July 1, 2025, out of the General Fund, the amount
7 of \$15,000,000, for the purpose of providing reimbursements to support
8 clinical education at hospitals under ORS 676.476.

9 **“SECTION 6.** In addition to and not in lieu of any other appropri-
10 ation, there is appropriated to the Department of Human Services, for
11 the biennium beginning July 1, 2025, out of the General Fund, the
12 amount of \$10,000,000, for the purpose of providing reimbursements to
13 support clinical education in long term care facilities and residential
14 care facilities under ORS 676.476, as amended by section 1, chapter
15 ____, Oregon Laws 2025 (Senate Bill 283).

16 **“SECTION 7.** This 2025 Act being necessary for the immediate
17 preservation of the public peace, health and safety, an emergency is
18 declared to exist, and this 2025 Act takes effect on its passage.”.
